ORDINANCE 13-30(A)

AN ORDINANCE OF THE HOMER CITY COUNCIL, AMENDING HCC 14.04.040, SEWER RATE SCHEDULE, AND HCC 14.08.080, SCHEDULE OF RATES--RULES AND REGULATIONS; TO PROVIDE THAT SEWER AND WATER RATE SCHEDULE CHANGES SHALL TAKE EFFECT AS OF THE DATE SET FORTH BY RESOLUTION AND THAT RATE REVIEW SHALL OCCUR ANNUALLY.

THE CITY OF HOMER HEREBY ORDAINS:

Section 1. Subsection (a) of HCC 14.04.040, Sewer Rate Schedule, is amended to read as follows:

a. Sewer utility services shall be billed according to the schedule set forth by resolution of the Homer City Council and shall be reviewed annually and amended, as necessary, to take effect as of the date set forth by resolution.

Section 2. Subsection (a) of HCC 14.08.080 Schedule of Rates--Rules and Regulations, is amended to read as follows:

a. Water utility services shall be billed according to the schedule set forth by Resolution of the Homer City Council and shall be reviewed annually and amended, as necessary, to take effect as of the date set forth by resolution.

Section 3. This Ordinance is of a permanent and general character and shall be included in the City Code.
