WHEREAS, This award is not final until written notification is received by Steiner's North Star Construction from the City of Homer.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Homer, Alaska, approves the contract award for the Homer Fire Station #2 Skyline Drive to the firm of Steiner's North Star Construction of Homer, Alaska, in the amount of \$510,800.00 and authorizes the City Manager to execute the appropriate documents.
