Subject: Local Telephone Service

Walt –

Currently we are using ACS for our Local Telephone Service which costs us approximately \$960 a month (\$11,520 annually) for 24 Analog Phone lines.

Steve Bambakidis asked for quotes from GCI and ACS to update our system to a PRI service to include 100 DID numbers. GCI quoted us \$499.20 a month (\$5,990.40 annually) and ACS quoted us \$530 a month (\$6,360 annually). Both of these quotes require a three year contract.

It is our recommendation that we move to GCI for an annual savings of \$5,530 with a three year contract.
