ORDINANCE 83-19

AN ORDINANCE AMENDING TITLE 14, UTILITIES,
OF THE HOMER CITY CODE, REPEALING AND RE-
ENACTING SECTION 14.08.080 AMENDING THE
SCHEDULE OF WATER RATES AND NAMING AN
EFFECTIVE DATE AND REPEALING SECTION
14.08.090.

WHEREAS, the City Council directed the City Administration to
conduct a comprehensive study of water system rates; and

WHEREAS, it was determined in the rate study that the water
system rates for water service do not provide sufficient revenue
for the cost of operation and maintenance, repair and replacement
of water system plant and to meet the annual working cash and debt
service requirements; and

WHEREAS, it was determined that the water system rates for
water service do not recover the cost of water service in rela-
tionship to the cost of service for specific water system users;
and

WHEREAS, an increase of 39 percent overall will provide the
funding level required;

NOW THEREFORE, THE CITY OF HOMER ORDAINS:

Section 1. HCC Section 14.08.080 Schedule of Rates: Rules
and Regulations is hereby repealed and re-enacted to read:

(a) The following schedule of rates shall be effective
July 16, 1983. This schedule supercedes all previously adopted
water rate schedules. All water utility services shall be billed
according to the following schedule. This schedule is for monthly
water consumption and is in addition to any charges for connecting
or disconnecting the service, installation of the service or any
assessments for the improvements.

SERVICE CONNECTION AND DISCONNECTION

A charge of \$10.00 shall be made for connecting and disconnecting water service. This fee shall be in addition to all other charges.


b. The City Manager shall enact and promulgate, with Council approval, all necessary rules and regulations and amendments thereto, which shall govern the sale, service and use of water by City Water Department. Sufficient copies of such rules and regulations shall be filed with the City Clerk for public information purposes.

c. The City Manager shall have printed a sufficient number of copies of the water rate schedule approved and adopted by the Council pursuant to subsection (a) of this section for public use, and the same shall be available upon demand at the office of the City Clerk. (Ord. 82-9 §1, 1982; prior code §14-200.8).

Section 2. HCC Section 14.08.090 Schedule of Rates Outside of the City Limits for Metered Sales is hereby repealed.

Section 3. HCC Section 14.08.080(a) and 14.08.090 are the only sections affected by the amendment.
