4 ORDINANCE 87- 25

5 AN ORDINANCE AMENDING CHAPTER 7.04 GENERAL TRAFFIC
6 PROVISIONS, OF THE HOMER MUNICIPAL CODE BY ADOPTING
7 THE ALASKA SUPREME COURT SCHEDULE OF OFFENSES AND
8 BAIL AMOUNTS FOR VEHICLE AND TRAFFIC VIOLATIONS THAT
9 ARE AMENABLE TO DISPOSITION WITHOUT COURT APPEARANCE.

10 WHEREAS, the legislature under Chapter 76 of the Session
11 Laws of Alaska, 1987; has authorized Alaskan municipalities to
12 establish fine schedules for minor offenses, i.e. violations for
13 which neither incarceration nor loss of a valuable license is a
14 penalty; and

15 WHEREAS, under the new law the City of Homer is responsible
16 as of January 1, 1988, for determining by ordinance those
17 municipal offenses for which no court appearance is required if a
18 plea of no contest is entered and for establishing a schedule of
19 fines for such offenses.

20 NOW, THEREFORE, THE CITY OF HOMER ORDAINS:

21 Section 1. Chapter 7.04 General Traffic Provisions, of the
22 Homer Municipal Code, is hereby amended by the addition of
23 Sections 023 and 025 to read as follows:

24 7.04.023. State Schedule of Minor Traffic Offenses and
25 Bail Forfeiture - Adopted. The City of Homer, pursuant to
26 Chapter 76, SLA, 1987, hereby adopts the schedule of minor
traffic offenses and bail forfeiture amounts contained in
Rule 43.1, of Rules Governing the Administration of All
