ORDINANCE NO. 91-07

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HOMER, ALASKA,
REGARDING THE LOCAL HEALTH AUTHORITY,
AMENDING CHAPTER 1.36, HEALTH OFFICER,
AND REPEALING CHAPTER 1.44, DEPARTMENT OF HEALTH,
OF THE HOMER CITY CODE

WHEREAS, Homer City Code Chapter 1.36 contains provisions regarding the City health officer and Chapter 1.44 contains provisions regarding the City department of health, and;

WHEREAS, it is preferable to combine the provisions of these two chapters into one cohesive unit in order to reduce the potential of confusion and the possibility of overlooking relevant provisions of law;

NOW THEREFORE, THE CITY OF HOMER ORDAINS:

Section 1. Homer City Code Chapter 1.36, Health Officer, is hereby amended to read as follows:

1.36.010 Health Officer--Duties Appointment. a.
Pursuant to A.S. 18.10.020, the Department of Health shall be headed by the City Manager or his designee shall serve as the City Health Officer.

1.36.020 Health Officer--Powers and Duties. The City Health Officer shall:

a. insofar as it may be appropriate, administer State law and the rules and regulations of the State Commissioner of the Department of Health and Social Services and any City ordinances pertaining to health;

b. make recommendations to the State and the City Council regarding matters relating to health, which may include suggested ordinances;

c. perform such duties and have such powers fulfill such responsibilities as may be prescribed by ordinance, law and the rules and regulations of the State Department of Health and Social Services.

Section 2. Homer City Code Chapter 1.44, Department of Health, is hereby repealed in its entirety.

Section 3. This is a general ordinance of a permanent nature and the provisions of Section 1 and Section 2 as contained herein shall be codified for inclusion in the Homer City Code.
