RESOLUTION 85-86

A RESOLUTION OF THE CITY OF HOMER ADOPTING  
CAPITAL IMPROVEMENT PRIORITIES FOR FISCAL YEAR 1987.

WHEREAS, a public hearing was held October 14, 1985 to hear comments on recommended Fiscal Year 1987 Capital Improvement Priorities; and

WHEREAS, it is the intent of the City Council to provide the Governor and legislative delegation from District 5 with adequate information to represent the desires of the community and the necessary funding level requirements.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Homer, Alaska that adequate funding for the Bradley Lake Hydro Electric Project is the number one State priority serving the Kenai Peninsula.

BE IT FURTHER RESOLVED by the Common Council that the following capital improvement projects are identified as the City of Homer priority list and funding level requirements for Fiscal Year 1987.
