RESOLUTION 92-90

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOMER, ALASKA, CERTIFYING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD OCTOBER 6, 1992 FOR ONE-TWO YEAR TERM OF OFFICE FOR MAYOR AND FOR TWO-THREE YEAR TERMS OF OFFICE FOR COUNCILMEMBERS.

WHEREAS, in compliance with the Homer City Code 4.04.190, the Canvass Board of the City of Homer has opened, counted, and tallied the votes on absentee ballots and made determinations on questioned ballots, and has opened, counted, and tallied those questioned ballots found to be valid, cast in the General Municipal Election held on October 6, 1992; and

WHEREAS, in accordance with Homer City Code 4.04.190, the Canvass Board of the City of Homer has opened and inspected the precinct reports and entered the results of the absentee and questioned ballots on the Certification of Election along with the results of the precinct counts.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Homer, Alaska, that the Council hereby accepts and certifies the results of the General Municipal Election for the City of Homer held October 6, 1992, as presented in the Certificate of Election by the Canvass Board, in accordance with the Homer City Code; and


