Description and location of dredge spoils material and bidding instructions and information may be obtained at the City Clerk's Office, Homer, Alaska, and will be mailed or faxed to requesting firms. Bidders must contact the City Clerk's Office to be entered on the Plan Holder's List prior to submitting their bid.

The City of Homer is seeking bids from firms or individuals wishing to purchase dredge materials from the City of Homer's annual harbor dredging project. Firms or individuals that are interested in purchasing and removing dredge material for use on or off the Homer Spit are requested to review the materials description, location, bidding instructions and terms.

Dredge spoils subject to this sealed bid sale must be for a minimum of 100 cubic yards. Minimum acceptable bid per cubic yard is \$5.00. Approximately 5,000 cubic yards will be sold from the stockpile at the dredge materials storage lot adjacent to Freight Dock Road. Proposals may include bids for the minimum (100 yds.) or for the maximum amount (5,000 yds.). Successful bidders will check in with Harbor Officer on duty when commencing load out of purchased materials and again when last load is removed. Prepayment will be made to City of Homer. When removing/loading out purchased materials, successful bidders will not excavate below the grade of the adjacent areas.

All bidders are expected to carefully examine the materials description, location, bidding instructions and terms before submitting a bid. Submission of a bid will be considered prima facie evidence that the bidder has carefully examined this information and is totally satisfied as to the restrictions on use of the material and any and all terms of this Invitation to Bid.

The bid shall include everything necessary for the removal and haul-away of purchased materials, including but not necessarily limited to labor, materials and equipment and to include final grading of the area where dredge spoils had been deposited if successful bidders' removal operation excavated below the adjacent land grade in any spot.

The City of Homer reserves the right to accept or reject any or all bids, to waive irregularities or informalities in the bids, and to award these dredge spoils materials to the highest single bidder or combination of bidders.
