7 AN ORDINANCE OF THE CITY COUNCIL OF HOMER, ALASKA,
8 AMENDING THE FY 2016 OPERATING BUDGET BY
9 APPROPRIATING \$64,149 FROM THE FIRE DONATIONS FUND TO
10 PURCHASE AN ADVANCED PATIENT CARE SIMULATOR.

12 WHEREAS, Training of the fire department’s emergency medical service personnel is
13 an essential and ongoing function of the department; and
14

15 WHEREAS, Realism in training of medical personnel is crucial for gaining practical
16 experience for a wide range of basic and advanced medical procedures; and
17

18 WHEREAS, The fire department’s current SimMan advanced patient care simulator is
19 now obsolete, with no additional parts or repair available from the manufacturer; and
20

21 WHEREAS, A majority of the membership of the department supports the purchase of
22 the advanced patient care simulator from the Fire Donations Fund; and
23

24 WHEREAS, The ‘Fire Donations Fund’ contains monies donated to the Fire Department
25 over the years by individuals and estates expressly for lasting and meaningful purposes and
26 has a current balance of \$102,000.

28 NOW, THEREFORE, THE CITY OF HOMER ORDAINS:

30 Section 1. The Homer City Council hereby amends the FY 2016 Operating Budget by
31 appropriating \$64,149 from the Fire Department Donation Account for the purchase of an
32 advanced care patient simulator.
