7 AN ORDINANCE OF THE CITY COUNCIL OF HOMER, ALASKA,
8 AMENDING THE FY 2016 OPERATING BUDGET BY APPROPRIATING
9 FUNDS IN THE AMOUNT OF \$9,970.00 FROM SEWER RESERVES FOR
10 THE REMOVAL OF AN UNDERGROUND FUEL STORAGE TANK AT THE
11 SEWER TREATMENT PLANT.

13 WHEREAS, Public Works has been removing underground fuel storage tanks (UST's) at
14 City facilities to eliminate potential liability and expensive clean-up costs if leaks were to
15 occur; and
16

17 WHEREAS, Removing UST's decreases the Sewer Fund's pollution liability insurance
18 policy costs and monitoring costs; and
19

20 WHEREAS, Public Works has acquired a replacement above ground tank and is
21 prepared to complete this removal work utilizing in-house personnel with the assistance of
22 an environmental professional (See Memorandum 16-109); and
23

24 WHEREAS, The cost to provide professional environmental oversight and materials is
25 estimated to be \$9,970.00 (\$8,170.00 for oversight and \$1,800.00 for materials).

27 NOW, THEREFORE, THE CITY OF HOMER ORDAINS:

29 Section 1. The Homer City Council hereby amends the FY 2016 Operating Budget by
30 appropriating \$9,970.00 from Sewer Reserves for the removal of the underground storage
31 tank at the Sewer Treatment Plant.
