## ORDINANCE 81-8(s)

AN ORDINANCE AMENDING CHAPTER 14, ARTICLE II OF THE HOMER CITY CODE, CREATING A NEW SECTION 14.200.9, SCHEDULE OF RATES OUTSIDE OF THE CITY LIMITS FOR METERED WATER SALES, RENUMBERING SECTION 14.200.9 TO 14.200.10, AND NAMING AN EFFECTIVE DATE.

WHEREAS, the City of Homer has used a separate rate schedule to charge for providing the service to outside the City users, and

WHEREAS, the additional schedule within the water rates needs to be formalized into an ordinance,

NOW THEREFORE THE CITY OF HOMER ORDAINS:

Section 1. Section 14.200.9. PENALTIES is hereby renumbered as Section 14.200.10.

Section 2. Section 14.200.9 is hereby enacted to read:

Section 14.200.9. SCHEDULE OF RATES OUTSIDE OF THE CITY LIMITS FOR METERED WATER SALES. The following schedule of rates shall be effective commencing with the April, 1981 billing. All water utility services shall be billed according to the following schedule. This schedule is for monthly water consumption and is in addition to any charges for connecting or disconnecting the service, installation of the service or any assessments for the improvement and applies only to service outside the City.
