5 AN ORDINANCE PROHIBITING THE HUNTING OF WILD
6 GAME WITHIN THE CITY OF HOMER BY ANY MEANS.

7 WHEREAS, there have been recent instances of the
8 hunting of wild game within the City of Homer by the use
9 of bow and arrow and other means exclusive of firearms,
10 and

11 WHEREAS, such activity constitutes a danger to the
12 general health, safety, well-being and welfare of the
13 residents of the City.

14 NOW THEREFORE, THE CITY OF HOMER ORDAINS:

15 Section 1. The following Chapter shall be added to
16 Title 5, HEALTH AND PUBLIC SAFETY, of the Homer Municipal
17 Code:

18 Chapter 5.30

19 HUNTING

20 Sections:

- 21 5.30.010 Definitions
22 5.30.020 Hunting prohibited
23 5.30.030 Exceptions
24 5.30.040 Penalty

1 5.30.010. Definitions. In this chapter, unless the
2 context requires otherwise:

3 a. "game" means any species of bird and
4 mammal, including a feral mammal, but
5 excluding domestic birds and mammals;

6 b. "hunting" means the stalking, or other
7 pursuit of game with the intention of
8 capturing and/or killing same, with or
9 without the use of bow and arrow or any
10 other means, exclusive of firearms.

11 5.30.020. Hunting prohibited. Hunting game within the
12 boundaries of the City of Homer with bow and arrow or by any.
13 other means is prohibited.

14 5.30.030. Exceptions. This chapter does not apply to
15 the capture and disposal of game by authorized law enforcement
16 or fish and game protection personnel, or to the protection
17 of life or property.

18 5.30.040. Penalty. The violation of any provision
19 contained in this chapter shall be punished by a fine not to
20 exceed three hundred dollars and/or confiscation of any game
21 killed by the violator.
