ORDINANCE NO. 90-16

AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF HOMER, ALASKA,
AMENDING TITLE 10, PORT AND HARBOR,
REGARDING ABANDONED ITEMS, FREE TIME, FISH DOCK USE,
DOCK FEES, AND RAMP FEES

WHEREAS, in order to provide rate schedules for certain harbor facilities that are competitive with similar state facilities and reflective of associated overhead costs; and,

WHEREAS, in accomplishing certain amendments to Title 10, it is also necessary to provide for inclusion of the Deep Water Dock as part of the various rate structures and facility references; and,

WHEREAS, other technical changes to Title 10 are required;

NOW THEREFORE, BE IT ORDAINED by the City of Homer, Alaska:

Section 1. Section 10.18.020 of the Homer City Code is hereby amended to read as follows:

10.18.020 Abandoned items on docks. Items abandoned or left unattended ~~unaccompanied~~ in the Small Boat Harbor ~~on the Main Dock or the Fish Dock~~ are subject to impound. ~~Free time regulations do not apply to the Fish Dock.~~

Section 2. Section 10.18.040 of the Homer City Code is hereby amended to read as follows:

10.18.040 Free time. Free time not to exceed two days on local freight, and two days on in-transit freight, will be allowed. Free time regulations do not apply to the Fish Dock.

Section 3. Section 10.18.080 of the Homer City Code is hereby repealed and re-enacted to read as follows:

10.18.080 Dockage fees. a. Vessels mooring at City docks shall be charged a dockage fee of one dollar per foot for the overall length of the vessel for each twenty-four hour period or portion thereof.
b. Vessels that are properly registered for dock use (see § 10.12.140) and occupy a reserved or transient moorage

berth, payment for which is current, shall be exempt from the dockage fee set forth at subsection a, for a period not to exceed twelve hours but shall be charged a dockage fee thereafter equal to the transient moorage fee for a vessel of that length pursuant to § 10.12.030 c, for each twenty-four hour period or portion thereof.

Section 4. Section 10.16.250 a. of the Homer City Code is hereby amended to read as follows:

10.16.250 Use of Fish Dock. a. The Fish Dock is to be used primarily for the loading and unloading of fish, fish products and fishing gear. Any other use must be approved in advance by the Harbormaster ~~and may be assessed a dock use fee by the Harbormaster // fee will be the same as for use of the main dock fee section 10.18.080~~. Dock fees shall be those set at § 10.18.080.

Subsections b. and c. remain unchanged.

Section 5. Section 10.18.140 of the Homer City Code is hereby amended to read as follows:

10.18.140 Barge loading ramp. Charges for use of the barge loading ramp shall be one hundred seventy-five dollars per landing.
