CITY OF HOMER, ALASKA ORDINANCE NO. 91-14

AN ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF HOMER, ALASKA,
AMENDING HOMER CITY CODE
SECTIONS 7.08.045 AND 7.08.060,
HANDICAPPED PARKING AND PENALTIES FOR VIOLATIONS

WHEREAS, various amendments to §§ 7.08.045 and 7.08.060 have been recommended to clarify the existing handicapped parking provisions and the general penalty for violating the Homer City Code provisions;

NOW THEREFORE, THE CITY OF HOMER ORDAINS:

<u>Section 1</u>. Section 7.08.045 of the Homer City Code is hereby amended to read as follows:

7.08.045 Handicapped parking. a. No A person may not park or cause to be parked a motor vehicle in a parking space designated reserved for disabled or medically handicapped persons parking/only, whether such parking space is on public or private property, unless such/yehicle displays/a/valid/Nandicapped/parking/permit/issued/or approved/by/the/City/Nanager/or/Nis/designee/:

1. the person has a special permit issued by the State of Alaska under AS 28.10.495;

2. the motor vehicle displays a special license plate issued to disabled or handicapped persons under AS 28.10.181(d); or

3. the motor vehicle displays a special license plate or permit issued to disabled or handicapped persons by another state, province, territory, or country.

- b. Any police officer or parking enforcement officer may enforce this section within any public or private parking area by issuing a citation pursuant to subsection d of this section, or within any public parking area by causing the vehicle to be immediately removed as provided by § 7.08.050 of/this/chapter. Only a person who owns or controls a private parking area containing a designated reserved handicapped-only parking space may cause the vehicle parked in violation of this section to be removed and towed as provided in § 7.08.050 of/this/chapter.
- c. For purposes of this section, a "parking space designated reserved for handicapped parking only" is a parking space conspicuously posted/ot/marked signed as being restricted to vehicles displaying handicapped parking permits, provided that such posting/ot/markings signs shall, conform/to/a/uniform/style/approved/by/the/Traffic/Engineer

as far as practicable, conform to the current edition of the Alaska Traffic Manual prepared by the Alaska Department of Transportation and Public Facilities. Notice of the specific penalty for violating this section shall be posted on the face of all signs erected within the City.

- d. The penalty for violating this section shall be one hundred dollars for each citation issued//nøkwikhskanding the/penalky/provisions/conkained/in/Seckion/7/08/080/06/khis chapker//or/khe/general/penalky/provision/sek/forkh/in Seckion/1/18/010/01/khis/code. Nokice/of/khe/specific penalky/hereunder/shall/be/posked/on/khe/face/of/all/signs erecked/wikhin/khe/Ciky/
- e. The officer responding to an apparent violation may waive/rhe/requirement excuse a violation of subsection a of this section if Ne/or/she the officer finds that the person who parked, or caused to be parked, in a designated reserved handicapped parking spot is actually or recently handicapped or is a handicapped visitor from outside the City.

<u>Section 2</u>. Section 7.08.060 of the Homer City Code is hereby amended to read as follows:

7.08.060 Violation--Penalty. Unless another penalty is expressly provided, tThe penalty for violating on provisions of this chapter are the same as those listed in the State of Alaska Unitoin/Traffic/Bail/Schedule Traffic Bail Forfeiture Schedule pursuant to Rule 43.1 of the Administrative Rules of the Alaska Rules of Court for violation of 13 AAC 02.340 through 13 AAC 02.820377.

Section 3. This is a general ordinance of a permanent nature and the provisions of Sections 1 through 2 as contained herein shall be codified for inclusion in the Homer City Code.
