ORDINANCE 97-14

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
HOMER, ALASKA, AMENDING SECTION 14.04.040(a), SEWER  
RATE SCHEDULE.

WHEREAS, the City Attorney has suggested that there be a clarification that the commodity rate is per thousand gallons of water to prevent future misinterpretations.

NOW, THEREFORE, THE CITY OF HOMER ORDAINS:

Section 1. That Homer City Code Section 14.04.040(a) is hereby amended to read as follows:

14.04.040 Sewer Rate Schedule.

a. All sewer utility services shall be billed according to the following schedule. This schedule is for monthly sewer services and is in addition to any charges for connecting or disconnecting the service, installation of the service or any assessment of the improvements.

Monthly Customer Charge	\$6.91
