RESOLUTION 87-67

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF HOMER CERTIFYING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON OCTOBER 6, 1987 FOR TWO THREE YEAR TERMS OF OFFICE FOR CITY COUNCILMEMBER AND APPROVING AN ADDITIONAL (1/4%) SALES TAX RATE FOR PARTIAL FUNDING FOR DEBT RETIREMENT ON \$4.4 MILLION IMPROVEMENTS TO THE SEWER TREATMENT PLANT AND APPROVING AN ADDITIONAL (3/4%) SALES TAX RATE FOR PARTIAL FUNDING FOR STREET RECONSTRUCTION IMPROVEMENTS AND RELATED UTILITIES.

WHEREAS, in compliance with the Homer City Code 4.04.190, the Canvass Board of the City of Homer has opened, counted, and tallied the votes on absentee ballots and made determinations on questioned ballots, and has opened, counted, and tallied those questioned ballots found to be valid, cast in the General Municipal Election held on October 6, 1987; and

WHEREAS, in accordance with Homer City Code 4.04.190, the Canvass Board of the City of Homer has opened and inspected the precinct reports, and entered the results of the absentee and questioned ballots on the Certification of Election along with the results of the precinct counts;

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of Homer, Alaska, that the Council hereby accepts and certifies the results of the General Municipal Election for the City of Homer held October 6, 1987, as presented in the Certificate of Election by the Canvass Board, in accordance with the Homer City Code;

BE IT FURTHER RESOLVED that the following candidates, having received at least 40% of the votes cast for their respective offices, are hereby declared elected:

COUNCILMEMBER - THREE YEAR TERM - DONALD RONDA
COUNCILMEMBER - THREE YEAR TERM - MARY HENRY

BE IT FURTHER RESOLVED that Proposition 1, "Shall the City of Homer, Alaska provide a partial funding source for debt retirement on \$4.4 million improvements to the Sewer Treatment Plant by an additional one quarter percent (1/4%) dedicated sales tax with such additional sales tax to remain in effect until the debt is retired or for twenty (20) years, whichever occurs first?"

and Proposition 2, "Shall the City of Homer, Alaska provide a partial funding source for street reconstruction improvements and related utilities by an

additional three fourths percent (3/4%) dedicated sales tax, in accordance with the City of Homer Accelerated Roads Program; such additional sales tax to remain in effect for up to twenty years?"

has been approved by the voters of the City of Homer with the results being


PROPOSITION 1 YES: 504
