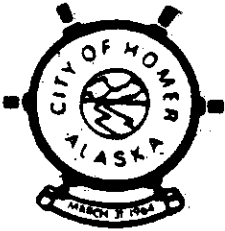

On May 5, 1988, the City of Homer opened responsive bids for Contract No. 1, Spit Outfall Project. The project generally includes, a duplex pumping station and associated valving and piping, and upland, intertidal and submarine outfall and diffuser totaling approximately 1,670 linear feet in length.

The responsive bids were as follow:

1.	Brown Construction	\$199,474.00
2.	American Builders Co.	\$239,000.00
3.	Herndon & Herndon, Inc.	\$282,406.00
4.	Beta Construction	\$298,765.00
5.	Martech	\$317,655.50
6.	Pedco, Inc.	\$469,000.00
7.	Engineer's Estimate	\$364,600.00

Recommendation

Subsequent review of all bid submittals by Brown Construction indicates the bid is responsive. Therefore, I recommend the Brown Construction bid be presented to the Homer City Council for award of a contract to construct the Spit Outfall Project for a sum not-to-exceed \$199,474.00.
