A RESOLUTION OF THE HOMER CITY COUNCIL AWARDING THE ACCELERATED ROADS PROGRAM GROUP I (W. Bayview Avenue, W. Cityview Avenue & W. Danview Avenue) PROFESSIONAL ENGINEER ROAD DESIGNS BID IN THE LUMP SUM AMOUNT OF \$8,475 TO CHARLES MORTIMER, P.E., AND AUTHORIZING THE CITY MANAGER TO SIGN THE APPROPRIATE DOCUMENTS.

WHEREAS, the City of Homer did duly and properly advertise for professional engineer for road design services in conjunction with the City of Homer Accelerated Roads Program (ACRP), Group I encompassing (800 LF) W. Bayview Avenue; (650 LF) W. Cityview Avenue; (250 LF) W. Danview Avenue; and

WHEREAS, the City of Homer held a public bid opening on May 4, 1988 at 2:00 p.m., at Homer City Hall; and

WHEREAS, the lowest responsible bidder was Charles Mortimer, P.E.;

NOW, THEREFORE, BE IT RESOLVED by the Homer City Council that the professional engineer road design services bid for the ACRP Group I be awarded to Charles Mortimer, P.E., in the amount of \$8,475 and that the City Manager be authorized to sign the appropriate documents.
