A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOMER, ALASKA, SETTING FEES FOR PARKING, CAMPING AND USE OF CERTAIN HARBOR FACILITIES

WHEREAS, Homer City Code section 19.08.040 and Ordinance No. 91-13(S) provides for the setting of certain fees by resolution;

NOW, THEREFORE, BE IT RESOLVED:

<u>Section 1</u>: That the following fees are hereby established for the use of the Homer Harbor launch ramp as authorized by Homer City Code § 10.12.100:

## Fees for Use of Harbor Ramps.

- a. There shall be a non-refundable fee of \$ 5.00 per day or \$50.00 per season to launch a vessel at the launch ramp. A person paying a slip fee shall be exempt from the launch ramp fee. (Authority: HCC § 10.12.100)
- b. An hourly fee of \$20.00 may be levied against vessels blocking portions of the ramp or loading floats or vessels left unattended and delaying departure from the area. (Authority: HCC § 10.12.100)
- c. A fee not to exceed \$5.00 per foot may be levied against vessels allowed to go dry on the launch or barge ramps. (Authority: HCC § 10.12.100)

Section 2: The following fees are hereby established for those areas of the Homer Harbor designated for vehicle and trailer storage and parking: (Authority: HCC § 10.16.202)

Section 3: A fee of \$200.00 is hereby established for the annual parking tags available to residents of the Kachemak Bay area as authorized by HCC § 10.16.202 c. Owners of vessels with an annual registration are eligible to receive one vehicle tag for \$10.00.

Section 4: The following fees are hereby established for the approved use of City-owned land designated for camping: (Authority: HCC §§ 10.12.100 and 19.08.040)

# RESOLUTION 91-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOMER, ALASKA ESTABLISHING A RATE LEVY FOR CAMPING ON THE HOMER SPIT PER HOMER CITY CODE SECTION 19.08.040.

NOW, THEREFORE, BE IT RESOLVED by the Homer City Council of the City of Homer, Alaska that the rate levied for camping shall be ten dollars per night or one hundred dollars per two weeks.
