Session 14-02 a Regular Meeting of the Public Arts Committee was called to order on February 13, 2014 at 5:00 pm by Vice Chair Michele Miller at the Homer City Hall Cowles Council Chambers located at 491 E. Pioneer Avenue, Homer, Alaska.

#### **APPROVAL OF THE AGENDA**

Vice Chair Miller requested a motion to approve the agenda.

NEWBY/APLIN - MOVED TO APPROVE THE AGENDA.

There was no discussion.

The agenda was approved by consensus of the Committee.

#### **PUBLIC COMMENTS REGARDING ITEMS ON THE AGENDA**

There were no comments from the public.

# **RECONSIDERATION**

There were no items for reconsideration.

APPROVAL OF THE MINUTES (Minutes are approved during regular or special meetings only)

A. Meeting Minutes for Special Meeting of January 9, 2014

Vice Chair Miller requested a motion to approve the minutes.

APLIN/FELLOWS - MOVED TO APPROVE THE MINUTES.

Vice Chair Miller noted an unfinished sentence on page 1 of the minutes under Visitors, second paragraph. Ms. Aplin noted her name misspelled in the motion on the same page.

The minutes were approved as corrected by consensus of the Committee.

# **VISITORS**

There were no visitors scheduled.

# STAFF & COUNCIL/COMMITTEE REPORTS/ AND BOROUGH REPORTS

Ms. Krause provided a written report and stated that she would entertain questions on the report if any. Vice Chair Miller inquired about the recommendation to work on a mid-year budget request. Ms. Krause explained that the committee could discuss what they wanted to accomplish for the remainder of the year during a worksession before the next meeting in May which would help determine if they needed to submit a budget request since the remaining funds of \$108 did not allow for much to be done.

Chair Miller also confirmed that they had the review of the Strategic Plan on their agenda tonight.

Ms. Newby lost connection at 5:15 p.m.

Ms. Krause confirmed that the signs were awarded and there was a minor hiccup in the startup with the signs being done by Dan Coe but that was straightened out and both artists should be starting production on the signs shortly. Installation is expected to be accomplished by the end of May.

B. Homer Arts and Culture Alliance Meeting Report

Ms. Persons reported that the group HACA has been involved as a participant in the PARC, which stands for Parks Arts Recreation and Culture group which is working on the Needs Assessment. These meetings are not open to the public but are a working group meeting which will bring the work product to the various groups for input. The Parks and Recreation Commission will be addressing the public aspect or component of the Needs Assessment.

Ms. Newby connected back to the meeting at 5:30 p.m.

#### **PUBLIC HEARING**

There were no items for public hearing.

#### **PENDING BUSINESS**

A. Art for the Spit Trail – 1% for Art and Interpretive Signage

Ms. Aplin stated she requested this on the agenda to get some input from the committee. She listed the members of the committee that have participated so far on the interpretative signage on the Spit Trail. Some ideas mentioned were to use Haiku, First Voices, and a giant tide gauge that unveils a poem at different levels of the tide; how select or solicit for a call for artists or poetry instead of the formal RFP, not limit creativity, but there is a need to get something on the ground. Some members of the committee were questioning the interpretive text that teaches or provides information. She wanted to get the input from Carey Meyer and the Public Arts Committee regarding the content and direction that she should take. The project is not a 1% for Art Project it is actually outside of the purview of the committee; the budget is \$40,000.

Mr. Meyer related the outcome of the Beluga Slough Trail signage and how it was developed to provide an idea of what they were driving for on the Spit Trail. Ms. Aplin conveyed what she envisioned the information portion then a small poem related to the information on the sign. They are looking at 8-9 signs one at the End of the Road Park, the Deep Water Dock, the intersection of the Spit Road and Freightdock Road, Fishdock Overlook plus 4 additional locations around the harbor.

Mr. Meyer also noted that they had re-advertised for the 1% for Art in the amount of \$11,000 since they did not get any submittals he was granted permission by the City Manager to contact Mooserun Metalsmiths to see what it would take to encourage them to create the sculpture that was initially proposed. This was done on the further information that one of the main reasons Mooserun declined the award was the amount of the award was not enough. They needed more money. Mr. Meyer stated that if they wanted a few thousand dollars more he could probably swing that but if the amount was greater than it was not happening. Since all the requirements in the Procurement Policy have been followed they are at liberty to hire someone to construct or design and art piece for the location if the second attempt to get the Mooserun sculpture.

Vice Chair Miller asked what they were looking for from this committee if it wasn't really part of their responsibility. Ms. Aplin stated she was looking for some guidance. Mr. Meyer said he felt uncomfortable looking at it strictly from the engineering perspective. He further noted that the funding is coming from the Cruise Ship Head Tax funding.

The committee was appreciative of being included and one suggestion was to alternate the information signs with artistic poetic signage. The committee was really supportive of the incorporation of poetry and art into the information signs. The idea can incorporate and tie all the elements together.

Mr. Meyer questioned how you could write that into the RFP to include all those aspects plus still leave it open to any additional ideas that may be submitted.

It was questioned if the public process was really necessary if they had the resources already. Mr. Meyer stated that they really did not have to go public with a RFP. They could just establish guidelines on requesting submissions of poetry along the themes. The committee agreed that would be fun and include the whole community.

Ms. Aplin thanked the committee for their assistance and input.

Mr. Meyer commented that it provides some similarity with poetry up at Baycrest and poetry at Beluga Slough then Poetry out on the Spit.

B. Establishing a Date for A Public Hearing

Ms. Krause noted that by consensus that February 27, 2014 at 5:30 p.m. in Council Chambers is the best available. Ms. Aplin will not be able to attend. Ms. Newby can attend but we need to have three members present just in case you lose connection. There was a brief discussion on the urgency to have the meeting this month. Ms. Fellows will be able to notify staff if she will be unable to attend this meeting.

There was no further discussion.

#### **NEW BUSINESS**

A. Memorandum to Advisory Bodies from the City Clerk Re: Meeting Schedules

Ms. Krause explained the purpose of the memorandum and how it affects this committee regarding the Special meetings. It was noted that they agreed to have quarterly meetings but then there are things that come up so they have been having quite a few special meetings. Discussion ensued on the need to meet more than the scheduled quarterly meetings especially since they had no budgets. It was noted that they would have to meet to form the various selection committees and that might need a special meeting if they cannot have a timely meeting to establish that selection committee.

Chair Newby argued the need for flexibility to have Special meetings when the need comes up such as the various projects.

Discussion ensued regarding the necessity of having more than the regularly scheduled quarterly committee meetings; they have plenty of notice for projects and they can conduct all required committee work at a regular meeting. Since they really do not have a budget there was no justification on having Special Meetings. It was recommended not to have as many special meetings as they have been.

NEWBY/MILLER - MOVED TO RECOMMEND CITY COUNCIL ALLOW THE PUBLIC ARTS COMMITTEE TO CONDUCT SPECIAL MEETINGS ON AN AS NEEDED BASIS WITHOUT THE APPROVAL OF COUNCIL.

There was a brief discussion regarding the need to schedule meetings when the need arises without having to wait the time it would take to have Council approve the special meeting. A perfect example was the Public Hearing for the Art Donation. The Committee felt that they did not abuse the ability to have Special Meetings and only did so as needed.

VOTE. YES. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

B. Memorandum Reviewing the 2014 Strategic Plan – What Next for Action!

Vice Chair Miller stated that they will address this item at the May regular meeting.

# **INFORMATIONAL MATERIALS**

A. Citizens Academy Advertisement

Ms. Krause commented that this was open to public and if they did not get a few more enrollees then it will be postponed until a later date. She stated that there were 15-20 spots. A comment from committee members noted they may get more interest if it wasn't so long.

There were no further comments.

#### **COMMENTS OF THE AUDIENCE**

Kathy Hill, city resident, stated she was at the meeting tonight to read a statement that was printed in the Homer News, February 6, 2014 and written by Lee Post at the request of Leo Vait. She will be out of town on February 27, 2014 and Ms. Krause stated she should attend tonight, it will be included in the packet of information for the Public Hearing.

"Something is as upside down as the weather. We have somebody funding one of the state's best sculptors to create a sculpture of Asaiah Bates who was one of Homer's most famous and beloved residents in his life. We have a public park that Asaiah donated the land for in the middle of town. We are a town that values the arts and is well known for the quality and quantity of art that comes out of it. Asaiah himself was known to pose for local artists. And we have individuals wishing to stop the creation or display of this public sculpture because? They seem to be saying that Asaiah wouldn't want to be portrayed as a sculpture. They seem to be saying that he wouldn't want this art in the parkland he donated to the public. Someone is saying this might make him a religious figure and thus shouldn't be on public land. That same someone seems to be saying, as a libertarian, that art shouldn't be put in public places.

First, I won't pretend to have a direct line to what Asaiah might or might not have said if he were alive. That's too close to what many religions do with iconic dead people. I can't imagine Brother Asaiah saying he wanted to be depicted as a statue in a local park. But then I can't imagine Abraham Lincoln or Martin Luther King or Nelsen Mandela saying that either. They are now all subjects of great public sculptures. Portrait art is not for the dead. They gave up the right to object when they left. It is for the living and for future generations. It is a way to honor and remember great people and an image of the individual can do that way more effectively than a memorial fund.

Second, shouldn't a libertarian be thrilled that public tax money isn't being used to fund this and even better that it could go onto land that wasn't paid for by public tax funds but was a private donation? Shouldn't they be all about individuals supporting and creating art that is for the public in public places without having the government (or anyone else) put constrictive restrictions on it?

Third, Brother Asaiah was not exactly a private recluse. He wrote many letters to the editor of this paper than probably anyone. He spoke at more council meetings than anyone else ever has. He was kind and gentle and calming and I think we can all agree that the last thing he would have wanted was to have his friends arguing about what he would have said. If he truly felt strongly about this when he was alive, he certainly had opportunities to say something.

What's left is out memories of a great man, and an opportunity to leave something the next generation can appreciate."

#### **COMMENTS OF THE CITY STAFF**

Mr. Meyer commented on the need for a Selection Committee for the Harbormasters office. There was a brief discussion on waiting until the May regular meeting agenda. Ms. Aplin commented that this was another example of the ability to schedule a special meeting. Mr. Meyer went on to describe a submittal from the Bishop's Beach project. He will try to have a draft Request for Proposal ready for the May meeting. He then spoke about the Public Safety Building project that will offer another opportunity. He would expect to have that project at a point by the end of summer. Mr. Carey explained it would be separate buildings but one project.

Vice Chair Miller noted that a Selection Committee can be discussed at the August or November regular meeting.

**COMMENTS OF THE COUNCILMEMBER** (If one is assigned)

No councilmembers were present.

#### **COMMENTS OF THE CHAIR**

Chair Newby asked if establishing a Selection Committee could be added to the agenda for the Special Meeting on February 27, 2014. Vice Chair Miller stressed her desire to keep the agenda for that meeting strictly focused on the subject.

# **COMMENTS FROM THE COMMITTEE**

Ms. Person (Groning) requested that she be noted by her married name now.

There were no other comments from committee members.

#### **ADJOURNMENT**

Dear citizens of Homer,

Thanks to Michael Armstrong and "The Homer News" for his outstanding news article titled "Homer Debates: Where To Place Brother Asaiah's Statue", posted January 26th, 2014. It was this important article, along with other communications, that prompted me to write this letter. I would like to thank everyone who has been thinking about the spirit of Asaiah represented by a real live statue to remind us of those great qualities which Brother Asaiah would claim are there, though sometimes dormant, in each one of us.

I was and <u>am still</u> a close friend of the late Brother Asaiah Bates since 1961, as well as a past member of the W.K.F.L (Wisdom, Knowledge, Faith, Love) movement of which Brother Asaiah was a member and leading supporter.

I have consigned a large bronze statue of Brother Asaiah, by the Homer artist and sculptor Leo Vait, as a donation to the city of Homer. I have done this to emphasize that his spirit and ideals are not dead, but <u>live on</u>.

Asaiah's dead physical body has been well hidden and guarded. My gratitude goes out to those responsible for honoring Asaiah's wish that his physical body should return to the soil of Mother Earth and left unmarked. Having closely known Brother Asaiah, I feel that he would wish that his *living* spirit should remain vibrant and breathing and carried forth into the life of modern day Homer and all those who carry that spirit out into the larger world. Having a sculpture of Asaiah would remind us of Asaiah's thoughts, words, and actions through a *living* memento of his great spirt.

Let me ask some rhetorical questions: Would those of you who knew Asaiah agree that he was both an illuminated person as well as an illuminator to others? Was he not like a lighthouse which guides sailors through darkness and storms towards a safe harbor of the light

Would you place the lighthouse, in a museum or mausoleum, or would you place the source of light, hope, and community pride in a place where all can see and be nurtured and inspired?

If it were up to me - as to where the statue of Asaiah should be placed-I would recommend the following:

- I. W.K.FL. Park, the park that Asaiah graciously donated to the city of Homer, or-
- 2. On the plateau above Homer's entrance where there is a sign stating "Homer: The Halibut Capitol of The World" (This is the top-of-the-hill spot where newcomers first catch that awesome glance of our "Cosmic Hamlet by the Sea", the term coined by Brother Asaiah.)

Bother Asaiah ignited that sense that Homer is OUR community, and whatever our

thoughts were about it, we were free to express them, as long as we listened respectfully to other views. As I have travelled over Alaskan roads, speaking with whoever crossed my path, I noticed that Homer travelers, unlike travelers from other communities, are proud of being from Homer.

So,in the spirit of Brother Asaiah, I invite Homerites to share your views as to where Asaiah's statue should be placed. I thank the former mayors of Homer, both Jack Cushing and James Hornaday, for supporting placement at W.K.F.L. Park. Another close friend of Asaiah's, Ken Landfield, suggests a wider community discussion as to where it should be placed, and in the spirit of Brother Asaiah, I support that also.

Having been inspired by Asaiah's spirit and wisdom:

"Ask not what Brother Asaiah would do for you, but rather what we should do for Brother Asaiah?"

Where shall we keep Asaiah's <u>living</u> statue which would embody his message and example amongst us for both now and future generations? For we are the citizens of the "Cosmic Hamlet By The Sea" and if we truly know Brother Asaiah we would know that he did not think or act in the conventional way, but with an open and loving heart, and a cosmic consciousness whose end has no limits, especially if we carry the torch of his memory forward.

I thank and acknowledge the Homer City Council, the Public Arts Committee, and the Parks and Recreation Commission for voting and approving the submitted proposal for the statue of Asaiah Bates. as the people discuss about where. I also thank the following journalists for their articles about Asaiah's statue: Martha Wagele for her article titled "Asaiah's Thoughtfullness Lives On, posted January 29, 2014 and Lee Post's article titled "A Sculpture of Asaiah Fitting", posted on February 6th, 2014 - this is a very "well said" piece, in my opinion. I also thank both Michael Kennedy and Brad Hughes for expressing their views/opinions in the Armstrong article noted at the beginning of this letter.

For those of you who did not have the privilege of knowing Asaiah in person, I recommend reading his biography, "Brother Asaiah" from the library or bookstores, as remembered by MarthaEllen Anderson and many, many other Homerites who knew him when he walked with us in the flesh in our "Cosmic Hamlet by the Sea". Here you will catch a great sense of the being that Brother Asaiah was and the spirit that he <u>still</u> <u>is</u>.

The Homer Public Library has been approached about the possibility of placing the bust of Asaiah Bates on Library grounds. Because I will be out of town on February 27 for the public hearing, I thought it best to submit to you the Library's current position regarding the matter.

The Homer Public Library is a City of Homer facility. If the community, the Public Arts Committee, and the City decide that they want the bust displayed on Library grounds, the Library has no objection. Our only stipulations are that the bust be placed outside, as space within the building is limited, and that it not be placed in existing gardens or dedicated areas, such as the Margaret Pate Garden.

The Library also has no objection if a location other than the Library is deemed more suitable for the bust.

I should point out that the Library Advisory Board has *not* had an opportunity to offer their opinion on the matter. Perhaps seeking Brother Asaiah's Seek-the-truth-in love spirit can guide you in deciding where it should be placed.

As a holocaust survivor, Corrie ten Boon reminded us that, "Just because a mouse is in the cookie jar does not mean he is a cookie."

I am sad and sorry to hear your story about abuse perpetuated upon you as a youth. Though Brother Asaiah had limited power over what others did, I am certain he would be first in line to support you in your healing. He knew his own need to heal from the Second World War, and he would support your healing too. It could well be that your sharing with Brother Asaiah, way back then, was the reason he fought so intensely and untiringly for years for the "Here's Looking at You" school program on sexual, alcohol and drug abuse, a program to help each young kid to understand and protect their own bodies and souls.

Krishna Venta's daughter told me that the good which Brother Asaiah did in Homer was his own creation, and credit (or blame) should not be given to Krishna Venta or the Fountain. Brother Asaiah began his private work in Homer AFTER the Fountain was no more. It is interesting, especially in light of your Point of View, that Bro's symbol was "Aum Mani Padme Hum" which means a pure lotus flower, untainted by the world, growing through muddy waters into the light. Let's look now at the light, the pure spirit.

"The Kingdom of God is within you," was one of Brother's favorite Biblical quotes. He found this rich treasure in his own soul, originally through words that he learned in the Fountain community, long before he moved to Homer, started his own cleaning business here and began his life work in Homer. In Homer, he was equally excited to find spiritual wisdoms in every Homer church and every individual that crossed his path, and he shared those delightful discoveries with the whole community through hundreds of 'Letters to the Editor.'

Annie Whitney observed that, "Asaiah gave such complete attention to us that we were able to see ourselves as community. Not every community has a catalyst to help them see themselves as Brother did for us."

It is in the hope of reviving that loving community spirit that this statue gift has been given. Let us be gracious receivers of the gift's intent, and shine, untainted through the muddy waters of the past, into a healed and loving "Cosmic Hamlet by the Sea"

#### **BACKGROUND**

The Public Arts Committee (Committee) held a special meeting on January 9, 2014 to review and approve the application for donation of a sculpture. The Committee withheld final approval on placement and acceptance into the City of Homer Municipal Art Collection based on the strong public request/opinion to place it in a more suitable location and/or not at all. The Committee recommended that City Council conduct a Public Hearing to allow more public input. The Committee also referred it to the Parks and Recreation Advisory Commission (PRC) for recommendation/approval on placement in a city park.

On January 16, 2014 the PRC supported the Committee's recommendation for City Council to hold a Public Hearing on the placement of the statue.

At the January 27, 2014 City Council postponed the Resolution 14-023 until the March 24, 2014 meeting and remanded it back to the Public Arts Committee to hold a Public Hearing on the Acceptance and Placement of the Donation of a Bronze bust of Brother Asaiah Bates.

Following is the resolution 14-023 as written, the excerpt of the city council minutes regarding the resolution, the completed application for donating works of art to the city including all pertinent back up materials and photos, the Committee's minutes of the January 9, 2014 special meeting that includes public comments; the memorandum from the PRC and the excerpt from the Administrative Guidelines regarding Accession, Donations and Gifts.

#### RECOMMENDATION

Review all submitted comments and materials. The Committee is tasked to make a recommendation based on the established guidelines and policies for accepting donations of work into the City Municipal Art Collection and the most suitable and appropriate location for such donation.

# **PUBLIC COMMENTS REGARDING ITEMS ON THE AGENDA**

Ken Landfield, city resident commented on the Art Donation and placement in WKFL Park to memorialize Brother Asaiah Bates. He commented against the placement of a statue of Brother Asaiah for the following reasons: the little park is getting cluttered especially since the addition of the new restroom. He opined that a more appropriate location for a statue would be the museum or the old Barefooters property at the head of the bay. He commented that he was not convinced that Brother Asaiah would have necessarily wanted a statue of himself as he recalled a sentiment expressed by Brother Asaiah as, "Throw me in a paper sack, walk away and don't look back."

He went on to further comment that a more fitting memorial would be to endow an annual lecture to the dissemination and propagation of the principles Brother Asaiah held dear, peace and communication and the respectful exchange of ideas. A recurring annual event perhaps on Martin Luther King Jr Day or (9/11) National Day of Service and Remembrance might be a more dynamic, vital memorial and testimonial to our dear departed friend. He opined it could be called "The Brother Asaiah Bates WKFL Memorial Lecture Series". Mr. Landfield believed he would have liked that. Mr. Landfield thanked the committee for their time.

This was done in November and proposals were due on December 19, 2013. Each proposer was given the criteria that was determined and agreed upon by the joint committee which comprised of Commissioner Lowney from the Parks and Recreation Commission; Parks Maintenance Coordinator, Angie Otteson and the Public Arts Committee.

They received two responses. Those were included in the packet. Ms. Krause provided a brief description of the proposal received from the proposers. Due to the time requirements outlined in the Request for a Quote that is the reason why this was added to agenda.

APLIN/NEWBY - MOVED TO SUBMIT RECOMMENDATION TO COUNCIL TO AWARD HANDPAINTED DESIGNS BY DAN COE OF ANCHOR POINT, ALASKA IN THE AMOUNT OF \$1,650.00 FOR THE SMALLER SIGN DESIGN FOR JEFFREY PARK, BAYVIEW PARK AND LOUIE'S LAGOON AND LOST THINGS DESIGNS OF HOMER, ALASKA, IN THE AMOUNT OF \$1,360.00 FOR THE LARGER UNIQUE PARK DESIGN FOR JACK GIST PARK AND FURTHER RECOMMEND COUNCIL APPROVE THESE DESIGNS AS THE STANDARDS FOR CITY PARKS, TRAILS, BEACHES AND RECREATIONAL AREAS.

Vice Chair Miller introduced the item into the record and asked Ms. Krause if there was any action needed.

Ms. Krause explained that it was informational in nature and unless there was any questions on the enclosed materials no action or discussion was required. The Request for Proposals was re-advertised and two proposers are on the plan holder's list. It was noted that the RFP closes on January 23<sup>rd</sup>. The same members of the selection committee have agreed to continue and will meet on February 4, 2014 to review the proposals received.

There were a few comments from the committee on their dismay that Mooserun Metalsmiths were not able to accept the award.

There was no further discussion.

A. Donation of Commissioned Artwork for Placement within WKFL Park

Vice Chair Miller read the title into the record. Ms. Krause noted this started with an inquiry from Ms. Otteson.

Ms. Otteson stated that Leo Vait, local artist, contacted her regarding his commissioned sculpture, stating that he wanted approval before further work was done on the sculpture and submittal to the foundry. Ms.

Otteson felt that it should go before the Parks and Recreation Advisory Commission since it was being requested to be placed in a city park. She contacted Ms. Krause who notified her about the process in place for donating works of art to the city.

Chair Newby expressed appreciation for Ms. Otteson and the city manager for their support of the protocols; she stated that she received emails with photos from Mr. Will Files.

Discussion ensued on the cost of the artwork and what the procedure was regarding the donation application. Chair Newby provided a summary explanation on the background of the application and recalled the donation of the bench as a memorial for the eagle lady. Vice Chair Miller stated that it still did not explain the procedure on what the committee should do now. Ms. Aplin stated that while the idea of the donation is acceptable, it is apparent that the venue may not be acceptable.

Commissioner Lowney was permitted to offer her comment stating that this item was on the Parks and Recreation Commission agenda next week and she believed that due to the conflict on the appropriateness of the suggested placement in WKFL Park that they provide more opportunity for the public to weigh in, she further opined that she understood the concern expressed by Mr. Landfield regarding the overcrowding of the park but she had less concern on that since it would be installed on top of an existing rock, technically it is not taking up space.

The committee discussed the need for further opportunity for a public hearing; that Brother Asaiah was a very unassuming man; why this project needed fast tracking through the process and making a quick decision. The committee expressed concern on the venue being appropriate. It was determine that council was the appropriate forum to get the word out to the public.

Vice Chair Miller requested a motion. Ms. Krause requested a few minutes to draft the appropriate motion for the committee.

APLIN/NEWBY - MOVED TO RECOMMEND THAT THE DONATION OF THE SCULPTURE WOULD BE ACCEPTABLE TO ADD TO THE MUNICIPAL ART COLLECTION HOWEVER THERE IS A QUESTION REGARDING THE LOCATION BEING APPROPRIATE AND THEREFORE RECOMMEND CITY COUNCIL HOLD A PUBLIC HEARING ON THE ISSUE. FURTHERMORE, THE COMMITTEE WOULD ALSO RECOMMEND CITY COUNCIL INCLUDE THE RECOMMENDATION FROM THE PARKS AND RECREATION ADVISORY COMMISSION REGULAR MEETING ON JANUARY 16, 2014 IN THEIR DELIBERATIONS.

There was no further discussion.

VOTE. YES. NON-OBJECTION. UNANIMOUS CONSENT.

Motion carried.

Vice Chair Miller inquired is there was any discussion or question on the memorandum. There was a brief discussion on the error in the meeting dates.

# **COMMENTS OF THE AUDIENCE**

Mike Kennedy, resident, stated he was the person in some of the pictures that were included in the packet, although he did not know why; he stated that Brother Asaiah did not want anyone to know where he was buried and did not want a head stone. Brother Asaiah did not want the park known by his name either. Brother Asaiah did not want to be held on this plane, he believed that his soul, energy and or vibration to travel to other planes. He wanted to be free to keep going and not get sucked back. Mr.

Kennedy had no idea about this sculpture. He does know Leo Vat Will Files and Martha; and he has seen John Nazarian this past summer.

Mr. Kennedy stated that he held conversations with others who knew Brother Asaiah and they all agreed that Brother Asaiah would not want to be memorialized like this. He has called and spoke to the City Manager who was not aware of that information. To put what is basically a tombstone in the center of town is not what Asaiah wanted. Mr. Kennedy felt that it would be wrong to accept this as Public Art and Brother Asaiah would not want everyone fighting about it either. He additionally questioned why it was being fast-tracked too. It was being paid for and would be done with or without the city.

Mr. Kennedy opined that you have to acknowledge that Public Art has a bad reputation being vandalized; every piece of public art has been vandalized; he additionally consulted with his friend and local artist, Brad Hughes who commented that the medium being used, bronze, was an old people thing and most bronze statues have been stolen, cut up and turned in as scrap metal by drug addicts.

Mr. Kennedy strongly opposed the city accepting the sculpture into their collection based on his personal knowledge that Brother Asaiah would not have wanted to be memorialized and tied to this earth. He believed that it would be more important to carry on the message Asaiah tried to impart.

Ms. Krause commented that Mr. Kennedy was very young in the picture.

# **BACKGROUND**

At a regular meeting on January 16, 2014 the Parks and Recreation Advisory Commission heard public testimony for and against placement of a sculpture of Brother Asaiah in WKFL Park. The Commission recommended forwarding a recommendation of support that further opportunity for public comment was needed in the form of a public hearing.

Below is an excerpt from the meeting minutes of the January 16, 2014 regular meeting regarding that discussion.

# **NEW BUSINESS**

A. Recommendation for Support of Placement of Commissioned Sculpture in WKFL Park

Chair Steffy read the title into the record and inquired if more discussion was needed on the subject or if there were additional comments from the commissioners.

Commissioner Brann commented on the statements and comments received on both sides of the issue and he believed a continued discussion would be appreciated. He agreed that no one wanted to fight about the decision but a good discussion would be valuable to making a decision. He appreciated people coming tonight.

Chair Steffy opined on the memorialization of an individual and the contrasts between what the individuals want and what the individual being memorialized might have wanted done. He further stated that there are two questions to ask –

- 1. Are you memorializing the individual for the sake of the individual?
- 2. Are you memorializing the individual for the sake of the people he influenced.

Chair Steffy stated he believed the commission heard that during the public comments tonight. He opined that it would be appropriate for a public hearing to be held by City Council regarding this issue to get more public input on the placement. Chair Steffy requested a motion.

LOWNEY/BRANN - MOVED TO SUPPORT THE ACCEPTANCE OF THE DONATION OF THE ART PIECE TO THE CITY COLLECTION BUT RECOMMEND A PUBLIC FORUM TO FURTHER DISCUSS THE PLACEMENT ON THAT PIECE.

Chair Steffy stated he will attend that meeting to answer any questions regarding the Commission recommendation.

VOTE. YES. NON-OBJECTION. UNANIMOUS CONSENT.

# HOMER PUBLIC ARTS COMMITTEE ADMINISTRATIVE GUIDELINES (Revised January 24, 2011)

The Public Arts Committee, hereafter referred to as PAC, was created in 2002 to administer Ordinance 02-25 (A) of the Homer City Code. Frequently called the "1% for Art Program", the ordinance wishes to foster culture and the arts in our community through the purchase and commissioning of works of art for municipal buildings and facilities. This manual guides the Committee in execution of its responsibilities.

# **Public Arts Committee - Declaration of Purpose**

It is hereby declared as a matter of public policy that support for artists and arts organizations, development and stewardship of public art, cultural tourism, arts education and cultural development are public necessities and essential for the continuing growth and development of Homer's citizens, economy, and quality of life. The primary duty of the Public Arts Committee is to identify and actively encourage the development and sustainability of arts in the City by serving as the City's primary resource in matters of art, culture, public art and cultural tourism.

# **Accession Policy**

To establish an orderly and consistent process for reviewing artwork for acceptance into the Municipal Art Collection ensuring that the collection is comprised of artwork of the highest quality.

#### Definition

Accession is to accept artwork in to the Municipal Art Collection

#### Policy

- 1. Accession procedures insure that the interests of all concerned parties are represented including the Public Arts Committee, the Public, the Artist, the Arts Community and the City of Homer.
- 2. Artwork shall be distinctive artistic merit and aesthetic quality and will enhance the diversity of the Municipal Art Collection.
- 3. Artwork shall be appropriate in and for its site, scale, material, form, and content for both its immediate and general social and physical environment.
- 4. Artwork shall be reasonably durable against theft, vandalism, weather, and excessive maintenance costs.
- 5. Accession implies the responsibility to preserve, protect, and display the artwork for public benefit.
- 6. Accession implies a work's permanency within the Municipal Art Collection, providing that the work retains its physical integrity, identity and authenticity.
- 7. Artwork will be acquired without restrictions as to its future use and disposition except as provided in contracts with artists.
- 8. Artwork will be accessioned into the City of Homer's Municipal Art Collection only upon completion of all facets of the Commissioning or purchasing contract and final approval of City Council.
- 9. Each accessioned work into the Municipal Art Collection will be documented to the fullest extent possible, including artist's last known address and when available photograph.

- 10. The artist's signed contract or release transferring title for the artwork and clearly defining the rights and responsibilities of all parties will accompany every accessioned work and shall be in the documented records of the work.
- 11. In the case of interagency or interlocal agreements a copy of the agreement and signatures of all parties will be kept in the office of the City Clerk.
- 12. Accession results from projects and purchases generated as part of the Municipal Art program except in case of donations which will be reviewed in accordance with the City of Homer Public Arts Committee policy on gifts and if accepted will be accessed pursuant to this accession policy. (Reso. 10-80, 2011.)

# Gift Policy

# Purpose

To identify a procedure and criteria for the Public Arts Committee to review proposed gifts of artwork.

#### Definition

Gifts are personal or real property that is donated or bequeathed with or without restrictions to the City of Homer for actual artwork, property for placement or funds for the acquisition of artwork.

#### Policy

- 1. The Public Arts Committee will review all proposed gifts as defined above and will evaluate the suitability of proposed gifts and make recommendations to the Homer City Council in accordance with Homer City Code which allows acceptance of donations.
- 2. Each Proposed gift will be reviewed for the following:
  - a. Aesthetic Quality the proposed gift has significant aesthetic merit.
  - b. Appropriateness of Chosen Site or Location scale of artwork is appropriate for the site including relationship between the artwork and the site and obstacles of the site.
- c. Restrictions from the Donor any restrictions must be clearly identified and may be a factor in determining whether to accept a gift.
- d. Originality of Artwork artworks must be one of a kind or part of an original series reproductions of originals are not considered eligible for acceptance.
- e. Relationship to the Collection as a Whole the Public Arts Committee is committed to creating a diverse collection of art. The proposed gift must be compatible with the Municipal Art Collection without being over represented.
- f. Technical Feasibility the realistic ability for the proposed project to be built and installed as proposed in the selected location.
- g. Technical Specifications the Public Arts Committee must review the actual work if available or a scale drawing and or model consisting of site plans and elevations describing the following:
  - 1. Surrounding site conditions if applicable
  - 2. Dimensions
  - 3. Materials and finishes
  - 4. Colors
  - 5. Electrical, Plumbing, or other utility requirements
  - 6. Construction and installation method
  - 7. Additional support material such as text verbally describing the artwork and specifications, models, or presentation drawings by a licensed engineer may be required.

- h. Budget cost to manage the project, prepare the site, deliver and or install the work, funds for signage/recognition, and any other cost should be disclosed by the donor in a budget. The Public Arts Committee will determine if the costs are accurate and realistic and that the donor has clearly delineated responsibility for all costs associated with the project.
- i. Timeline expected timeline for donation or installation should be proposed by the donor. The Public Arts Committee will determine if the timeline is realistic.
- j. Durability expected lifetime and staying power of the material used to create the artwork especially if set in the out of doors or in a non-archival exhibition setting and exposed to the elements.
- k. Warranty the donor agrees to be responsible for a warranty period of one (1) year from the date of final installation of the artwork to insure the integrity of the material, fabrication and installation when installed in or on a city owned facility or property.
- l. Vandalism and Safety the artwork will not be prone to vandalism or pose a safety hazard.
- m. Maintenance and Preservation donor's agreement to provide a technical and maintenance record including a plan for routine care with estimated costs. The donor must indicate if there are any unusual or ongoing costs to maintain artwork.
- 3. Donors proposing gifts will be informed of the importance of the above criteria in the Public Arts Committee consideration.
- 4. The Public Arts Committee will have final authority through the City Manager to review and recommend to Homer City Council to accept or reject the donated artwork.
- 5. All gifts that are recommended for acceptance will only be accessed into the Municipal Art Collection pursuant to the Accession Policy. (Reso. 10-80, 2011.)

# Procedure to Propose a Donation of Artwork to the City of Homer

The Public Arts Committee is charged with the responsibility of evaluating the suitability of a proposed artwork and making recommendation to the City Council as to whether or not to accept it as a gift. If accepted, the donated work becomes the responsibility of the City of Homer, which will inventory, insure, maintain and repair it as required by Homer City Code and Alaska State Law.

# Definition

Gifts are personal or real property that is donated, devised or bequeathed with or without restrictions to the City of Homer. Gifts can be actual artwork, property for placement of artwork or funds for the acquisition of artwork.

Gift Policy is the policy that identifies the procedure and criteria for reviewing proposed gifts of artwork to the City of Homer.

Accession Policy is the policy that defines an orderly and consistent process for reviewing artwork for acceptance into the Municipal Art Collection insuring that the collection is comprised of artwork of the highest quality. (Reso. 10-80, 2011.)

#### **Process**

PUBLIC ARTS COMMITTEE ADMINISTRATIVE GUIDELINES Page 4 of 4

The Public Arts Committee will review all proposed gifts according to the Gift Policy. They will evaluate the suitability of the proposed gifts and make recommendations to the Homer City Council through the City Manager.

In order to provide the Public Arts Committee with the information necessary to evaluate the proposed artwork in accordance with the Gift Policy and Accession Policy the potential donor or donor's representative must complete the Gift Proposal Application and submit to the City of Homer, City Clerk's Office. (Reso. 10-80, 2011.)

# Presentation to the Public Arts Committee

If applicable the donor will be scheduled to present his or her proposal to the Public Arts Committee at the next regular meeting. The donor is expected to present the actual artwork or model or scale drawings of the proposed piece. If it is not possible depending on the artwork a photograph may be accepted upon approval of a majority vote of the Public Arts Committee.

The Public Arts Committee will review the proposal consider the presentation and make a recommendation at the meeting. If the proposal materials do not give the Public Arts Committee enough information to make an educated recommendation they may request to postpone recommendation until further information is provided by the donor.
