## ITEM #1 TECHNICAL

- 1. What is the actual electricity consumption for high mast pole #7
- 2. Were the other highmast light poles on or off when staff took the readings shown in attachment #1

Below is a breakdown of Pole #7's annual electricity consumption and a 60 minute consumption sample. Notes for consideration:

- Homer Electric Association, our power supplier, installed a new meter for the 2016 season, which may account for the 2015 spike.
- In attachment #1 the light level readings were taken with only Pole #7 illuminated, the other six poles were shut off so that we could gather isolated readings from Pole #7.
- Attachment #3 light level readings were taken with all high mast lights illuminated.
