Dock fenders will be sold in "as is, where is" condition, no warranties expressed or implied. The City reserves the right, when in its best interest, to reject any and all bids and to waive any informalities or irregularities. **The City will consider all proposals for the salvage and disposal of the equipment offered in this sale.** After purchase, dock fenders must be paid for and removed within thirty (30) working days of the bid opening.

INVITATION TO BID REQUIREMENTS

For Sale of Surplus Dock Fenders

The City of Homer Port and Harbor is inviting bids for the sale of surplus dock fenders that were recently removed from the face of the Port of Homer Deep Water Dock. Sealed bids will be received until 3:00 p.m. Thursday, October 10, 2013 at City Clerk's Office, City of Homer, 491 E. Pioneer Avenue, Homer, AK 99603, at which time they will be publicly opened and read. Sealed bids must be on the proper bid form provided by the City. Plan holder registration forms, detailed description of the dock fenders, minimum bid requirements, and bid form are available on line at <http://www.cityofhomer-ak.gov/rfps>. **All bidders must submit a City of Homer Plan Holders Registration form to be on the Plan Holders List and to be considered responsive.**

ITEM DESCRIPTION

There are ten (10) dock fenders available in the set: two (2) corner fenders and eight (8) inner fenders. All have the same basic dimensions of 16 feet wide, 40 feet long. Each fender structure is made of steel with 12'x12' creosote timbers lining the face. The corner fenders are more heavily built, have one side that is curved to protect a corner, and each weighs approximately 56,000 lbs. The inner fenders weigh approximately 40,000 lbs.

The set of ten fenders comes equipped with the following:

- Seventeen (17) usable, galvanized pin-piles that are 99 feet long, 20 inches wide, 0.5 inch wall thickness. Twenty galvanized pin-piles would be required for the full set of fenders.
- Two 22 inch sleeves to receive the pin-piles.
- Round shock absorbers for the inside fenders.
- Most of the old mounting hardware; there are no rectangular shock absorbers for the corner fenders.

BID FORMAT & REQUIREMENTS

Please read the following. If you do not follow these instructions, your bid will not be opened.

- Bidders must be listed on the Plan Holders list that is maintained by the City Clerk's Office. If you are not on the bidder's list your bid will not be opened.
- Only 1 bid item per sheet, printed legibly or typed
- Only 1 bid sheet per envelope
- Bid sheet must be in an opaque envelope

- Bid envelopes must be sealed

OTHER REQUIREMENTS

- All ten (10) fenders including pin piles and associated equipment will be sold as a lot. Bids proposing portions of the fenders or its associated equipment will be considered, but will be secondary to bids requesting all of the fenders.
- Whole lot base bid is \$120,000 **or best offer.**
- The City will consider all proposals for the salvage and disposal of the equipment offered in this sale. The City may award to the bidder/bidders who make the best overall offer.
- After purchase, dock fenders must be paid for and removed **within thirty (30) working days** of the bid opening.
- Dock fenders will be sold in “as is, where is” condition, no warranties expressed or implied.
