NOTICE OF SALE

Notice is hereby given that the **27' sailing vessel Tarwathie**, AK 6976K, located on A float at the Homer Small Boat Harbor in Homer, Alaska, will be sold by the City of Homer to the highest bidder as is, together with its equipment, gear, furniture, apparel, fixtures, tackle, boats, machinery, anchors and all appurtenances. The Tarwathie is a 27' fiberglass recreational sailboat with a 7 1/2' beam and a 4' draft.


A bidder's packet and bidding instructions are available at Homer City Hall, Office of the City Clerk, 491 E. Pioneer Avenue, Homer, AK 99603, phone (907) 235-3130. Sealed bids will be received at the office of the City Clerk until **2:00 p.m., Wednesday, September 24, 2014**, at which time they will be publicly opened and read. The time of receipt will be determined by the City Clerk's time stamp. Bids received after the time fixed for the receipt of the bids shall not be considered. Bidders are required to be on the City's plan holder's list for their bid to be considered. All bidders must submit a City of Homer Plan Holders Registration form to be on the Plan Holders List and to be considered responsive. Plan holder registration forms are available online at <http://www.cityofhomer-ak.gov/rfps>

The sale will be to the highest bidder. Payments must be made in cash, certified check or cashier's check. There is a minimum acceptable bid of \$1,130.95. Vessel must be removed from city property within 7 calendar days of receipt of quit claim and Bill of Sale, or can be in the Homer Harbor upon execution of a moorage agreement, payment of moorage and proof of insurance. The City of Homer reserves the right to reject all bids.

The winning bidder will receive a Bill of Sale and a quit claim for the City's ownership interest in the Vessel. The winning bidder will take responsibility for any and all liens currently encumbering title to the Vessel. The City makes no guarantees as to the title of the Vessel and/or the existence of any liens, claims, maritime liens, rights in rem, right of redemption or encumbrances whatsoever.

Sealed bids will be accepted at the City of Homer, Clerk's office, Homer City Hall, up to 2:00, Wednesday, September 24, 2014. Sealed bids may be mailed, expressed, or hand delivered but will not be accepted as valid if received after the above deadline. The following boat is being sold as is together with any equipment, gear, furniture, apparel, fixtures, tackle, boats, machinery, anchors and other appurtenances:

If you are the highest bidder, and your bid meets or exceeds the minimum bid amount which is indicated in the column headed "Minimum Bid", you will be awarded the boat unless the City exercises its right to reject the bid. Full payment must be made by cash, cashiers (bank) check, or certified check made payable to City of Homer within seven (7) business days of date of sale. Upon receipt of full payment by the City, a Bill of Sale and quitclaim will be prepared without warranty, conveying the vessel to the buyer. "Without warranty" in this context means that City of Homer can not and will not warranty that the boat has no liens attached. **The Tarwathie purchased under this sale, must be removed from City property within seven (7) calendar days of issuance of the Bill of Sale to the buyer, unless the buyer enters into a moorage agreement with the Harbormaster's Office to keep the boat in the harbor, prepays moorage and provides proof of insurance.**

The attached bid form must be utilized to bid and must be sealed in an envelope marked "Sealed Bid Sale/Impounded Boat" and then enclosed in a separate envelope addressed to City of Homer and delivered or mailed to the City of Homer, Office of the City Clerk, 491 E. Pioneer Avenue, Homer, AK 99603 prior to the 2:00 pm, Wednesday, September 24, 2014 deadline for receipt of bids. The City reserves the right to reject any bid or all bids.
