## General Note 10.

- a. Delete the word "Contractor" in the first sentence and substitute the word "City".
- b. Add the following sentence, "The City will set two GPS points for the Contractor's use in establishing the profile of the rock, as placed. The City will establish the locations of these points in consultation with the Contractor."

## 2. Sheet 00G-02

Surveying Note #5: Delete this note.

### 3. Sheet 00G-03

## Material Requirements – Geotextile Filter Fabric Paragraph 2:

Related to **Tensile Elongation**, change the designation "5 (max)" to "50% min".

### 4. Instructions to Bidders

Item V. Tentative Project Schedule. Change the numeral "16" to "17".

## 5. Instructions to Bidders

### Item X. Equal Employment Opportunity Requirements Apply

Add the following sentence after EEO-1 Certification, "In the event your EEO-1 form has not yet been submitted for 2019, you may use data from your 2018 report."

### 6. Instructions to Bidders

#### Item IX Disadvantaged Business Enterprise Requirements Apply

Add the following paragraph: "The Environmental Protection Agency only recognizes disadvantaged business enterprises who are certified as MBEs and WBEs and these are the only goals that are addressed in this contract. There is no separate goal for firms who may be certified as a DBE, but who are not certified as a MBE or WBE. If a subcontractor is certified as a MBE or a WBE, the bidder can apply said subcontractor's participation as either a MBE or a WBE, but not both."

### 7. Special Provision No. 9 – Access to the Beach in front of the seawall.

When the City commissions maintenance activity on the Seawall, the contractor accesses the beach in front of the Seawall through Mariner Park, which is located near the base of the Spit. The City has not negotiated with any private property owners for closer access to the beach. While the City is not opposed to attempting this, it will not, in all likelihood, be able to do this before the time of bidding.
