INSTRUCTIONS TO BIDDERS

City of Homer, Alaska Small Works Road Repair Project

The City of Homer, Alaska is requesting bids from qualified firms and individuals for the project described herein.

The following subjects are discussed herein to assist in the preparation of bids.

I. <u>Introduction</u>

The City of Homer requests bids for the repair of designated sections of City roads by excavating unsuitable soils, installing geotextile fabric, and backfilling with classified materials. This will be an Indefinite Duration, Indefinite Quantity (IDIQ) contract; that is, the City will designate specific road sections, which will require varying quantities of excavation and backfill as well as varying durations of time required to complete the work. The Contractor will be compensated for the actual quantities of work performed. Work related to a specific road section will be assigned in Task Orders, which will be issued for specific road sections, over the duration of the contract.

II. Scope of Services

The project consists of furnishing all labor, materials, equipment, tools, supervision, and other facilities necessary to repair various road sections in the City of Homer. The work includes, but is not limited to the following:

Excavation and replacement of unsuitable material in gravel road beds to mitigate the potential for frost boils. The City will designate specific road sections, which will require varying quantities of excavation and backfill as well as varying durations of time required to complete the work. The Contractor will be compensated for the actual quantities of work performed.

The proposed work is located within the limits of the City of Homer and specific locations will be designated on the site map, but the City reserves the right to add or remove locations as local conditions require.

III. General Bidding Requirements

The work must be performed by a Contractor skilled and regularly engaged in the type of work called for under the Contract. Bidders must have a current contractor's license issued by the State of Alaska. The license must apply to the work described in the Invitation. The City's local bidder preference requirements apply to this contract. State prevailing wage rates will apply.

An electronic copy of Plans and Specifications is available on the City's website http://www.cityofhomer-ak.gov/rfps or you may purchase hard copies at the Office of the City Clerk upon payment of \$10 per set (\$15 for overnight delivery). City of Homer Standard Construction Specifications 2011 Edition (containing general contract provisions) may also be downloaded from the city's website. All fees are non-refundable. The City of Homer reserves the right to accept or reject any or all bids, to waive irregularities or informalities in the bids, and to award the contract to the lowest responsive, responsible bidder.

Bids must be submitted on the Bid Form and be received by **2:00 PM, Tuesday, July 20, 2021,** at the Office of the City Clerk, City of Homer 491 E. Pioneer Avenue, Homer, Alaska, 99603. A bid bond is **not** required.

A Pre-Bid Conference will be held on Thursday, July 8, 2021 in Cowles Council Chamber at City Hall, 491 E Pioneer Ave Homer, Alaska. Masks are recommended for those not vaccinated. This meeting will be conducted via Zoom simultaneously and invitations will be emailed to all potential bidders listed on the Plan Holder's List.

IV. The Bid Package

The City of Homer requires a two-part Bid Package, Part A and Part B. Each portion of the Bid Package must be submitted in separate envelopes, which shall be combined into one single Bid Package, marked with the name of the project and the time/date of the bid opening. Bidders information should be on the envelope in the upper left corner.

At the bid opening, Part B is opened first and must be complete or Part A will not be opened and the bid will be rejected.

Part A of the bid contains:

a. Bid Form

Part A must be submitted, as part of the Bid Package, in a separate envelope marked Part A.

Part B of the bid contains:

- a. Addenda Acknowledgment form
- b. If signature on the Bid is by an agent, other than an Officer of a Corporation, of a member of a Co-partnership, a Power of Attorney must either be submitted in Part B.

VI. <u>Instructions to Bidders</u>

The City of Homer intends to award the contract to the lowest responsive, responsible bidder but reserves the right to accept or reject any or all proposals, to waive irregularities or informalities in the bids or bid process, and to award the contract to the bidder that best meets the criteria stated below. Local bidder preference will apply when determining the lowest bidder.

A. Qualification of Bidders

It is the intention of the City of Homer to award this contract to the Bidder who furnishes satisfactory evidence they have the requisite experience, ability and sufficient capital, facilities and plant to prosecute the work successfully (and properly) and to complete it within the time allowed in the Contract at the least cost to the City of Homer for dollars spent for value received.

B. Taxes

Attention is directed to the requirements of the General Conditions regarding the payment of taxes. All taxes that are lawfully assessed against Owner or Contractor in connection with the work shall be paid by the Contractor. The Bid prices shall include all such taxes.

The City of Homer is exempt from local sales taxes. The Contractor shall not include sales tax markup in his bid. However, in order to recoup sales tax the Contractor might pay at local vendors, the Contractor must secure a Tax Exempt card from the Kenai Peninsula Borough Tax Department.

C. Familiarization with the Work

Before submitting its Bid, each prospective Bidder shall familiarize itself with the work, labor conditions and all laws, regulations and other factors affecting performance of the work. Bidders shall carefully correlate their observations with the requirements of the Contract Documents and otherwise satisfy themselves of the expense and difficulties attending performance of the work. The submission of a Bid shall constitute an acknowledgement that the Bidder has thoroughly examined and is familiar with the Contract Documents and the provisions thereof. The failure or neglect of a Bidder to receive or examine any of the Bid Documents shall in no way relieve the bidder from any obligations with the respect to their Bid or to the Contract. Misinterpretation or a reputed lack of knowledge concerning the Bid will not serve as a basis for a claim for additional compensation.

Each Bidder shall visit the sites of the Work and completely inform themselves relative to construction hazards and procedures, the availability of lands, the character and quantity of surface and subsurface materials and utilities to be encountered, the arrangement and conditions of existing structures and facilities, the procedure necessary for maintenance of uninterrupted operations of existing facilities, the character of construction equipment and facilities needed for performance of the work, and

facilities for transportation, handling and storage of materials and equipment. All such factors shall be properly investigated and considered in the preparation of the Bid.

D. Interpretation of Bid Documents

All questions about the meaning or intent of the Contract Documents shall be submitted to the Office of the Director of Public Works in writing. Replies will be issued by Addenda emailed or delivered to all parties recorded by the City Clerk's Office as having received the Bidding documents. **The City of Homer will not be held responsible for questions received less than (5) calendar days prior to the date of opening of Bids.** Only questions answered by formal written Addenda will be binding. Oral and other interpretations or clarifications will be without legal effect.

The Bidder shall acknowledge receipt of all Addenda on the Addendum Form, which shall be properly signed by the Bidder and placed in Part B.

It shall be the Bidder's responsibility to inquire as to addenda issued. **Failure to include the Addenda Form in Part B of the Bid Package shall result in the Bid being rejected as non-responsive.**

E. Return of Bid Guarantee (If Applicable)

Within thirty (30) days after the Bids are opened, the City will return the Bid Guarantees accompanying the Bids, which are not to be considered in making the award. The Bid Guarantees of the three (3) lowest responsive Bids will be held until the Contract has been fully executed after which time the Guarantees will be returned to the respective Bidders whose Bids the Guarantees accompanied.

F. Contract Time

This project will be awarded as an Indefinite Duration, Indefinite Quantity (IDIQ) Contract; that is, the work involves road sections, which will require varying quantities of excavation and backfill as well as varying durations of time to complete the designated road sections. The Contract will be active until December 31, 2022. While the Contract is active, work for specific road sections will be assigned to the Contractor via Task Order. Each Task Order will specify the scope, schedule and budget for a specific road section to be repaired.

G. Preparation of Bids

Bids must be submitted on the forms provided by the City and completed in all respects as required by the Bid Documents. Bids shall include all information requested herein, and be manually signed by the Bidder or the Bidder's duly authorized representative, with the Bidder's address and phone number. If the signature is by an agent, other than an Officer of a Corporation, or a member of a Co-partnership, a Power of Attorney must be submitted in Part B of the Bid; otherwise, the Bid will be rejected as non-responsive. All Bids must be regular in every respect, and no alterations shall be made to the Bid form.

If erasures or changes appear on the forms, each must be initialed by the person signing the Bid. No oral, telegraphic or telephone proposals will be considered.

Bid Packages, containing separate envelopes for Part A and Part B of the bid, will be received at the City Clerk's Office located at City of Homer 491 East Pioneer Avenue, Homer, Alaska 99603, until the time indicated on the Invitation to Bid. Each Bid shall be submitted enclosed in a sealed, opaque envelope.

The Bidder shall enter the Bid title and date of Bid opening on the lower left-hand corner of the Bid Package. The City is not responsible for the premature opening of, or failure to open, a bid not properly addressed and identified.

No consideration will be given by the City to a claim or error unless such claim is made to the City in writing within two (2) hours after the time of Bid opening. Written verification and supporting evidence of the error shall be delivered to the City Clerk within 24 hours of the Bid Opening (not including Saturday, Sunday or legal holidays) to allow consideration of the claim for error. Supporting evidence shall be original documents, including cost breakdown sheets, supplier quotes and other documents used to compute the Bid.

It is the bidder's responsibility to see that Bid Packages are deposited at the time and place set forth for the public opening of Bids. Bids not received by the time required will not be accepted and may be returned to the Bidder in the sealed bid package.

VII. Labor Rates

State Labor Rates.

This project is covered by the State of Alaska Title 36 Laborer's and Mechanic's Minimum Rate of Pay (AS 36.05.010 & 36.05.050) Pamphlet No. 600, Issue 41, Effective September 1, 2020. It is the responsibility of the bidder to determine the current rates of pay required and to submit the proper certified payrolls to the State Department of Labor.

Small Works Road Repair Project

The construction contract for this project will be administered in accordance with the General Provisions of the City's Standard Construction Specifications (2011).

MODIFICATIONS TO GENERAL PROVISIONS

SP - 1: Section 10.01 Definitions

Add the following Definitions:

Indefinite Duration, Indefinite Quantity (IDIQ) Contract – A form of contract involving varying quantities of work and varying degrees of time to complete the work. Work is assigned in Task Orders, which designate a scope, schedule and budget for a specific element of work.

<u>Task Order</u> – The means of designating a scope, schedule and budget for a specific element of work in an IDIQ Contract. Task Orders must be fully executed by the City and the Contractor to be effective. No work shall be done without a fully executed Task Order..

SP - 2: Article 4.3 Increased or Decreased Quantities

Delete the entire article except for the first sentence.

SP - 3: Add New Article 4.6

The City needs a firm to provide earthwork construction services for an Indefinite Duration and of an Indefinite Quantity (IDIQ) to help repair specified sections of City roads, which are subject to "frost boils" and other failures. This section describes how the work will be assigned.

1. Term of Agreement

The Term of this Agreement shall be commence on the Effective Date, which shall be the date the Contract is executed by the City and the Contractor, and will expire on December 31, 2022.

2. Task Orders

Work shall be assigned by Task Orders, which shall be issued for specific sections of road that need (a) excavation of unsuitable material, which is subjecting the road to "frost boils" and other failures; (b) placement of geotextile fabric; and (c) backfill and compaction of suitable material. The format of the "Task Order" is shown as Attachment A. No work on a road section shall proceed without a fully executed "Task Order".

Each Task Order will define the section of road that needs work and an estimate of the quantities of excavation/backfill required for that section of road. Compensation will be for the actual quantities of work performed for that road section. The City and the Contractor will negotiate a schedule for completing assigned Task Order(s), based on the severity of the damage in a particular road section and the Contractor's availability.

3. Representative Road Sections

Attachment B shows sections of City Roads, which are representative of road sections, where unsuitable material needs to be excavated and replaced with suitable material. The estimated quantities listed in the Bid Form are based on these sections. The City reserves the right to increase or decrease the quantity of work as excavation proceeds. For example, the City may determine that more unsuitable needs to be excavated for a particular road section than what is shown on Attachment B. Or, the City may determine that sections of different roads need to be excavated.
