Our goal is to provide information that will assist you in getting to know the candidates so that you can make an informed choice when you cast your vote on or before Election Day.

If you will be unable to vote at your designated polling place on Election Day you may vote absentee by mail, by fax or in-person, more information is provided throughout the voter pamphlet. Apply online for an absentee ballot by mail or by fax at www.my.kpb.us/vote.



General Voter Information

Voter Qualifications

A person qualified to vote in a borough-wide election is:

- a citizen of the United States
- at least 18 years of age
- a resident for at least 30 days of the borough and the precinct, Assembly/Board of Education district and/or service area in which voting
- registered to vote at a residence address within the borough at least 30 days before the election

Your voter registration record is important. Please keep it current by contacting your Regional Election Supervisor, the Borough Clerk's Office, or your City Clerk's Office when making changes of name, address or party affiliation.

For specific voting information in your area, contact the City Clerk's Office nearest you, or call the Kenai Peninsula Borough Clerk (toll free within the borough at (833) 796-VOTE (8683) or in the Central Peninsula at 714-VOTE (8683).

A. Precincts where the voter turnout was less than 200 voters at the last regular election may be designated as "absentee by-mail" precincts by resolution of the assembly. In those precincts, no election workers shall be appointed. The procedures outlined in Chapter 4.120 shall be followed with the following exceptions: 1. that ballots shall be sent to each registered voter in the precinct on or before the 15th day prior to the election; and 2. that voted ballots must be postmarked on or before midnight of election day and received by the clerk no later than the Tuesday following the election.

B. Voters wishing to vote absentee in person may do so at any designated absentee voting site.

C. Any precinct designated as an "absentee by-mail" precinct in accordance with the provisions of subsection A, above, will remain an "absentee by-mail" precinct until such time as the "absentee by-mail" status is removed by resolution of the assembly.

Absentee By-Mail Precincts

KPB 4.50.015. Absentee by-mail precincts.

- A. Precincts where the voter turnout was less than 200 voters at the last regular election may be designated as "absentee by-mail" precincts by resolution of the assembly. In those precincts, no election workers shall be appointed. The procedures outlined in Chapter 4.120 shall be followed with the following exceptions: 1. that ballots shall be sent to each registered voter in the precinct on or before the 15th day prior to the election; and 2. that voted ballots must be postmarked on or before midnight of election day and received by the clerk no later than the Tuesday following the election.
- B. Voters wishing to vote absentee in person may do so at any designated absentee voting site.
- C. Any precinct designated as an "absentee by-mail" precinct in accordance with the provisions of subsection A, above, will remain an "absentee by-mail" precinct until such time as the "absentee by-mail" status is removed by resolution of the assembly.

If you are registered to vote in one of these six (6) precincts, you will automatically be mailed a ballot by the Borough Clerk's Office approximately 2 weeks prior to the election. Included with your ballot will be instructions for voting a by-mail ballot, a secrecy sleeve for your voted ballot, and a mailing envelope for returning your voted ballot to the Borough Clerk's Office. This return envelope has been designed to protect any confidential information.

Step 1. Vote ballot.

Step 2. Place voted ballot in the secrecy sleeve and return envelope.

Step 3. Write in ONE Identifier in the space provided and sign the envelope.

Write ONE of the specified identifiers in the space provided on the envelope *[date of birth, last four digits of your social security number or voter identification number]* and sign the return envelope in front of a witness.

Step 4. Have your signature witnessed by someone over 18 years of age or older or an authorized official. *[Notary Public, commissioned officer of the armed forces, district judge or magistrate, registration official or other person qualified to administer oaths. KPB 4.80.070(C)]*

Step 5. Seal the return envelope and mail your ballot to the Borough Clerk's Office.

[MUST be postmarked on or before election day, Tuesday, October 7, 2025.]

General Information

1. You may apply for absentee ballots for any or all elections conducted by the Borough within the calendar year 2025, as long as the ballots for each election will be sent to you at the same address.
2. If you will be in the Kenai Peninsula Borough within 15 days before an election, you may prefer to vote ABSENTEE IN PERSON. Check with the Borough Clerk's Office for locations throughout the Borough.

Instructions

- Apply early to be sure you receive your ballot in time.
- Complete ALL information requested. It is required by law. Omissions will result in your application being rejected.
- You must provide your residence address in the Kenai Peninsula Borough. Use the description of the physical location - street number, trailer court and space number, etc. (Please note: If you give a residence address in another state or country, or use a P.O. Box, PSC or Rural Route Number instead of a physical address, your application will be rejected.)

Notice to active duty military personnel: To remain registered in Alaska you must be an Alaskan resident and provide your physical residence address within the State. If you have been assigned to an active duty station outside Alaska, you may wish to maintain your Alaskan residence address as it appears on your current registration record. If you provide a new residence address, it must be within Alaska.

Sign your application. A friend, spouse or parent may not sign for you.





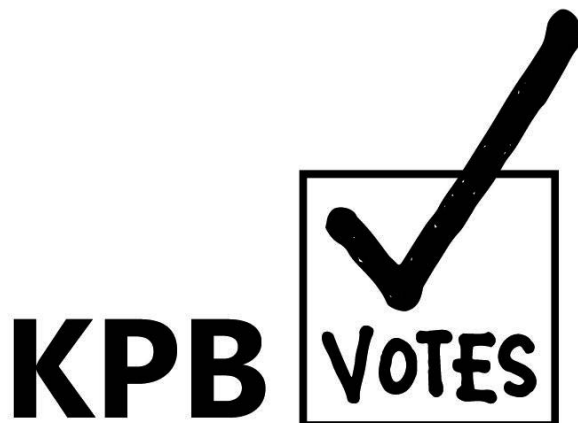

Voter Rights/Assistance While Voting

The following information explains basic voting rights and will help voters with special needs.

Visually-Impaired Voters

A touch screen voting unit will be in each polling place on Election Day and at each absentee in person voting site. Touch screen voting is intended for the blind, disabled and voters with reading difficulties.

The touch screen voting units allow disabled voters to vote unassisted through the use of a magnified, high contrast and audio ballot.

At the end of voting, a voter-verifiable paper ballot is produced by the touch screen unit. This paper print-out is secured behind a screen and allows the voter to verify the electronic ballot for accuracy.

If you need to vote using a touch screen unit, ask an election worker for this voting option.

Assistance While Voting

If you have difficulty voting because of a physical disability or handicap, difficulty reading or writing English, or need any other type of assistance, you may bring someone to help you at the polls. The person you bring may go into the voting booth with you and help you vote. This person may be an election official, family member, friend, bystander, campaign worker or anyone else who is not your employer, agent of your employer, or officer or agent of your union. This is your right under federal law.

Non-English-Speaking Voters

Most polling places within the Borough do not normally have bilingual assistance available. Let the Borough Clerk's Office know ahead of time if you will need this service and every effort will be made to provide it.

Physically-Disabled Voters

If you have difficulty gaining access to your polling place, please let the Borough Clerk's Office know. We are making every effort to ensure that polling places are accessible to everyone.

Emergency Absences

If you are unable to vote at your polling place on Election Day and did not have time to apply for an absentee ballot by mail, you may be able to vote by fax. Applications for voting by fax must be received by the Borough Clerk's Office no later than 5:00 p.m. Alaska Daylight Time (AKDT), Monday, October 6. See Pages 4 and 5 for more information.

Frequently Asked Questions (FAQ)

Election Day is Tuesday; October 7

Polls are open from 7:00 a.m. to 8:00 p.m.

Who may vote in this election? Registered voters of the Kenai Peninsula Borough 18 years of age or older.

How old must I be to register to vote? You may register anytime within 90 days immediately preceding your 18th birthday. If you are 18 years of age or older, you may register at any time. In order for your name to appear on the precinct register, you must be registered 30 days prior to the election.

Where can I register? You may register to vote at the Borough or any City Clerk's Office, public libraries, the Department of Motor Vehicles or online with the Division of Elections: <https://voterregistration.alaska.gov>.

Do I have to register for each election? No. If you are registered to vote in State elections, you are also registered to vote in local elections. Your registration remains active as long as you remain a voting resident of Alaska in good standing. You must, however, re-register if you change your residence to another jurisdiction.

When are elections?

The Kenai Peninsula Borough and cities within the Borough hold regular municipal elections every year on the first Tuesday in October.

- State primary elections are held in even numbered years on the fourth Tuesday in August.
- State general elections are held in even numbered years on the first Tuesday after the first Monday in November.

Who is eligible to vote in a Borough election? Persons who are qualified to vote in State elections and have been registered to vote at an address in the Kenai Peninsula Borough for at least 30 days prior to the election.

When are the polls open? Polls are open on Election Day from 7:00 a.m. to 8:00 p.m.

What will happen on Election Day if I am not registered in the correct district and precinct? You will be required to vote a questioned ballot. This procedure will be explained to you at the polls or you may contact the Borough Clerk's Office.

How do I get an absentee ballot?

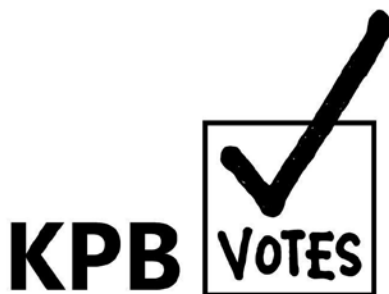
- You may vote absentee in person. Absentee voting begins approximately 2 weeks prior to the election. See Page 7 of this pamphlet for the start-up date and hours of operation.
- You may apply for a ballot to be mailed, faxed or emailed to you. Apply online at my.kpb.us/vote or use application provided on Page 4.

I am disabled and cannot get to the polls. How can I vote? You may apply for a ballot to be mailed to you as indicated above. For information on special needs voting, contact the Borough Clerk's Office or any City Clerk's Office in the borough.

I am in the hospital. How may I vote? For information on special needs voting or absentee voting, contact the Borough Clerk's Office or any City Clerk's Office in the borough.

What happens if I am in line to vote when the polls close? You will be allowed to vote if you are in line when the polls close.

What happens if I make a mistake on my ballot? If you make a mistake, fold and return the ballot to the official in charge. The ballot will be spoiled and destroyed and a new one will be issued to you. A maximum of 3 ballots may be issued.



Safe

The absentee ballot system is a safe way to cast your vote. You may apply for an absentee ballot and vote from home.



Convenient

Avoid lines and crowds at polling places. Absentee ballots are a quick and easy way to vote at your convenience in the weeks leading up to election day.



Secure

For over 20 years, absentee ballots have been a secure option for voting in Kenai Peninsula Borough (KPB) elections.

Central Emergency Service Area and Central Peninsula Emergency Medical Service Area (FY2026 Mill Rate = 2.95 CES; FY2026 Mill Rate = 1.00 CPEMS) – KPB 16.30.090. Board—Powers and duties. The board of directors of the service area, subject to Assembly approval and appropriation of funds, shall have the power to provide for the establishment and maintenance of fire and emergency medical services within the Central Emergency Service Area and of emergency medical services within the Central Peninsula Emergency Medical Service Area and shall promptly furnish accurate and complete copies of minutes of all board meetings to the Mayor and Assembly. *Elected Board Members*

Central Kenai Peninsula Hospital Service Area (FY2026 Mill Rate = .01) – KPB 16.08.015. Authorized functions of the Central Peninsula Hospital Service Area. The Central Kenai Peninsula Hospital Service Area is authorized to construct, maintain, and operate a hospital or hospitals, to establish and to operate, or to participate in the expense of operating, a center for the treatment of alcoholism and chemical dependency, and to provide other health services or health facilities within the service area, including but not limited to: primary health care, health promotion and chronic disease services (including psychiatric treatment, mental health and rehabilitation services), outpatient services, health education, preventive medical care and wellness programs, home health services, personal care services, long term care, and hospice care, subject to such conditions as may be established by ordinance of the Kenai Peninsula Borough. *Assembly Acts as Board pursuant to Ordinance 2016-11*

Eastern Peninsula Highway Emergency Service Area (FY2026 Mill Rate = 0.00 Funded through Federal PILT Funds) – KPB 16.80.050. Board - Powers and duties. The board of directors of the service area, subject to assembly approval and appropriation of funds, shall have the power to provide for fire protection and emergency medical services within the service area, review and recommend the annual service area budget, and perform such additional functions as the assembly may authorize. The service area board shall inform and make recommendations to the mayor and the assembly concerning the administration and operation of the service area and shall promptly furnish accurate and complete copies of the minutes of all board meetings to the mayor and assembly. *Appointed Board Members*

Kachemak Emergency Service Area (FY2026 Mill Rate = 3.26) – KPB 16.20.090. Board—Powers and duties. Pursuant to the provisions of AS 29.35.460 the board of directors of the service area, subject to KPB 16.04.001 and assembly approval and appropriation of funds, shall have the power to supervise the furnishing of fire and emergency medical services within the Kachemak Emergency Service Area and shall promptly provide accurate and complete copies of minutes of all board meetings to the mayor and

assembly. Subject to assembly approval, the board shall be responsible for developing, implementing, and updating a plan for furnishing fire and emergency medical services. *Appointed Board Members*

Nikiski Fire Service Area (FY2026 Mill Rate = 2.45) – KPB 16.12.080. Board—Powers and duties. Pursuant to the provisions of state law and borough ordinances, the board of directors of the service area, subject to assembly approval and appropriation of funds, shall have the power to provide for fire and emergency medical services within the service area, and shall promptly furnish accurate and complete copies of the minutes of all board meetings to the mayor and assembly. *Elected Board Members*

Nikiski Senior Service Area (FY2026 Mill Rate = .25) – KPB 16.70.080. Board—Powers and duties. Pursuant to the provisions of Alaska statute, the board of directors of the service area, subject to assembly approval and appropriation of funds, shall have the power to provide for services and programs for senior citizens within the service area. The board shall promptly furnish accurate and complete copies of minutes of all board meetings to the mayor and the assembly. *Elected Board Members*

North Peninsula Recreation Service Area (FY2026 Mill Rate = 1.15) – KPB 16.16.080. Board—Powers and duties. The board of directors of the service area, subject to assembly approval and appropriation of funds and the provisions of KPB Section 16.04.001, shall provide for recreation services and programs within the service area and may construct, operate and maintain facilities to provide such services. The board shall advise the mayor and the assembly concerning the administration and operation of the service area. The board shall promptly furnish accurate and complete copies of minutes of all board meetings to the mayor and assembly. *Elected Board Members*

Road Service Area (FY2026 Mill Rate = 1.30) – KPB 16.41.070. Board—Powers and duties. A. Powers. Pursuant to the provisions of AS 29.35.490, the board of directors of the service area, subject to assembly approval and appropriation of funds, shall have the power to provide for construction, improvement and maintenance of roads within the service area. B. Duties. The road service area board shall advise and make recommendations to the mayor and assembly concerning road maintenance, construction, and improvement issues, right-of-way regulation, and the operation and management of road service area activities. This chapter shall be interpreted in harmony with other provisions of borough law where possible. Where the provisions of this chapter conflict with other provisions of borough law, this chapter shall control. *Appointed Board Members*

Seldovia Recreational Service Area (FY2026 Mill Rate = 1.00) – KPB 16.55.090. Board—Powers and duties. Pursuant to the provisions of AS 29.35.450 the board of directors of the service area, subject to KPB 16.04.001, and assembly approval and appropriation of funds, shall have the power to supervise the furnishing of recreational services within the service area that are based out of, and utilize the Seldovia Community Center, now known as the Sea Otter Community Center, presently located on Tract 3 B, Fleming Giles Estates No. 2 Subdivision according to Plat No. 96-1, Seldovia Recording District, Third Judicial District, State of Alaska, and other facilities as may be authorized by the borough assembly, and

additional recreational services as are recommended by the service area board and established by the assembly through the budget process. Services to be provided may include but are not limited to senior citizen and youth programs, musical instruction and practice, accommodation of visiting schools during "Sea Week" and other Seldovia field trips, facility rental for organizations and individuals for meetings and celebrations, adult education, high speed internet access, community gatherings such as potlucks and dinners, karate instruction, arts and crafts instruction and facilitation, nature education and outdoor activities. The services shall be different from those provided by the City of Seldovia. The board shall promptly provide accurate and complete copies of minutes of all board meetings to the mayor and assembly. The board shall be responsible for developing, implementing, and updating a plan for furnishing recreational services which shall be subject to assembly approval. *Appointed Board Members*

Seward Bear Creek Flood Service Area (FY2026 Mill Rate = 1.00) – KPB 16.50.090. Board—Powers and duties. Pursuant to the provisions of AS 29.35.460 the board of directors of the service area, subject to KPB 16.04.001, assembly approval and appropriation of funds, shall have the power to provide flood protection, planning and mitigation services. Additionally, subject to assembly approval, the board shall be responsible for developing, implementing, and updating a development plan for furnishing flood protection services, and for determining the level of such services to be provided by the service area. Services shall only be provided that primarily address service area flood issues and that reflect fair use of the tax levy for watershed-wide benefit. Nothing in this ordinance shall be constructed to usurp or otherwise affect the City of Seward's authority regarding any stormwater or surface water projects that primarily impact the City of Seward, and existing flood control projects or contracts with the U.S. Corps of Engineers or other agencies. The board shall develop criteria for determining service area involvement in future flood control projects, and shall coordinate with the City of Seward to ensure there is no duplication or contradiction in flood control projects or services provided. The board shall promptly provide accurate and complete copies of minutes of all board meetings, all board resolutions or other actions taken by the board to the mayor and assembly. *Elected Board Members*

South Kenai Peninsula Hospital Service Area (FY2026 Mill Rate = 1.12; SH TY18 Prior Debt = 0.34) – KPB 16.24.080. - Board—Powers and duties. The service area board shall advise and make recommendations to the mayor and the assembly concerning the operation and management of service area activities, review and recommend the annual service area budget, and perform such additional functions as the assembly may authorize. The board shall promptly furnish accurate and complete copies of the minutes of all board meetings to the mayor and the assembly. *Elected Board Members*

Western Emergency Service Area (FY2026 Mill Rate = 3.15) – KPB 16.60.040. Board - Powers and duties. The board of directors of the service area, subject to assembly approval and appropriation of funds, shall provide for the establishment and operation of the fire and emergency medical services within the service area, and shall inform and make recommendations to the mayor and the assembly concerning the administration and operation of the service area. The service area board shall promptly furnish accurate and complete copies of the minutes of all board meetings to the mayor and assembly. *Appointed Board Members*

PROPOSITION NO. 1

CITIZEN INITIATIVE: HAND COUNT IN PERSON PAPER BALLOTS FOR BOROUGH ELECTIONS

(To be voted on by all borough voters)

Background:

On September 27, 2024 the Borough Clerk issued a petition to sponsors seeking an initiative to require all paper ballots cast in person on election day be counted manually by hand, rather than using electronic tabulating equipment. The petition met the requirements under the law, thus requiring placement of the question on the October 7, 2025 regular election.

Purpose:

The proposed citizen Initiative Ordinance 2024-01 seeks to amend the Kenai Peninsula Borough (KPB) Code of Ordinances, specifically Title 4 – Elections, to change the current election process to require that all paper ballots cast in person on election day would be counted manually by hand, rather than using electronic tabulating equipment. The hand counting would occur immediately after the polls close at local precincts, and the ballots would be counted by registered voters of the Kenai Peninsula Borough.

Key Provisions:

1. Hand Counting of Paper Ballots:

The proposed citizen initiative ordinance mandates that all paper ballots cast in person on election day be manually counted by hand by registered voters of the Kenai Peninsula Borough. The counting would take place after the polls close at local voting precincts.

2. Absentee Ballots:

Absentee ballots would still be accepted and processed according to Alaska State Law and KPB Code of Ordinances, Title 4. These absentee ballots would be added to the election day count after they are processed.

3. Implementation Date:

If approved by the voters at the October 7, 2025 election, this ordinance will be effective on January 1, 2026.

Fiscal Impact:

Complete fiscal impacts are unknown at this time. This change will require additional election workers.

BALLOT LANGUAGE

As approved by the Assembly August 8, 2025

Shall Initiative Ordinance 2024-01, calling for the Kenai Peninsula Borough Code of Ordinances, Title 4 – Elections, be amended to change the current election process to require that all ballots cast in person on Election Day be counted manually at borough precincts by registered Kenai Peninsula Borough voters, and eliminate the use of electronic voting tabulators, be enacted?

PROPOSITION NO. 2

ORDINANCE 2025-17: ESTABLISHING THE NINILCHIK RECREATIONAL SERVICE AREA

(To be voted on by voters residing in the proposed service area)

Background:

On May 19, 2025 the Borough Clerk received a petition for the establishment of a recreational service area in Ninilchik and surrounding area that emphasizes on funding the pool at Ninilchik School. After determining that the petition satisfied code requirements, the petition was forwarded to the Mayor on June 4, 2025. The Mayor issued his report to the Assembly on July 2, 2025 that addressed the need for the service area and the assessed valuation of the property in the proposed service area. Following receipt of the Mayor's report, the Assembly conducted a community meeting in the proposed service area on July 17, 2025 by a special Assembly committee. On August 5, 2025, public hearing on Ordinance 2025-17 was conducted and the Assembly enacted the ordinance, calling for the question to be placed before the voters in the proposed service area at the October 7, 2025 regular election.

Purpose:

Establishes the Ninilchik Recreational Service Area in Ninilchik and surrounding area with an emphasis on funding the pool at Ninilchik School.

Key Provisions:

1. Establishes a Ninilchik Recreational Service Area
The service area will have recreational services powers with a focus on community pool services at the Ninilchik School
2. Enacts a chapter of code titled the "Ninilchik Recreational Service Area"
The new chapter of Kenai Peninsula Borough Code of Ordinances, Chapter 16.90, provides the legal description, powers and duties, and other functions and obligations of the service area.
3. Implementation Date:
Ordinance 2025-17 will be effective upon approval by a majority of the voters residing within the proposed service area at the October 7, 2025 regular election.

Fiscal Impact:

It is estimated that, if approved, the newly established Ninilchik Recreational Service Area will initially need approximately 1 mill to operate a community pool facility for 12 months at the Ninilchik School, which equates to \$100 for each \$100,000 in taxable value, or a lesser mill rate for 9 months.

BALLOT LANGUAGE

As approved by the Assembly August 5, 2025

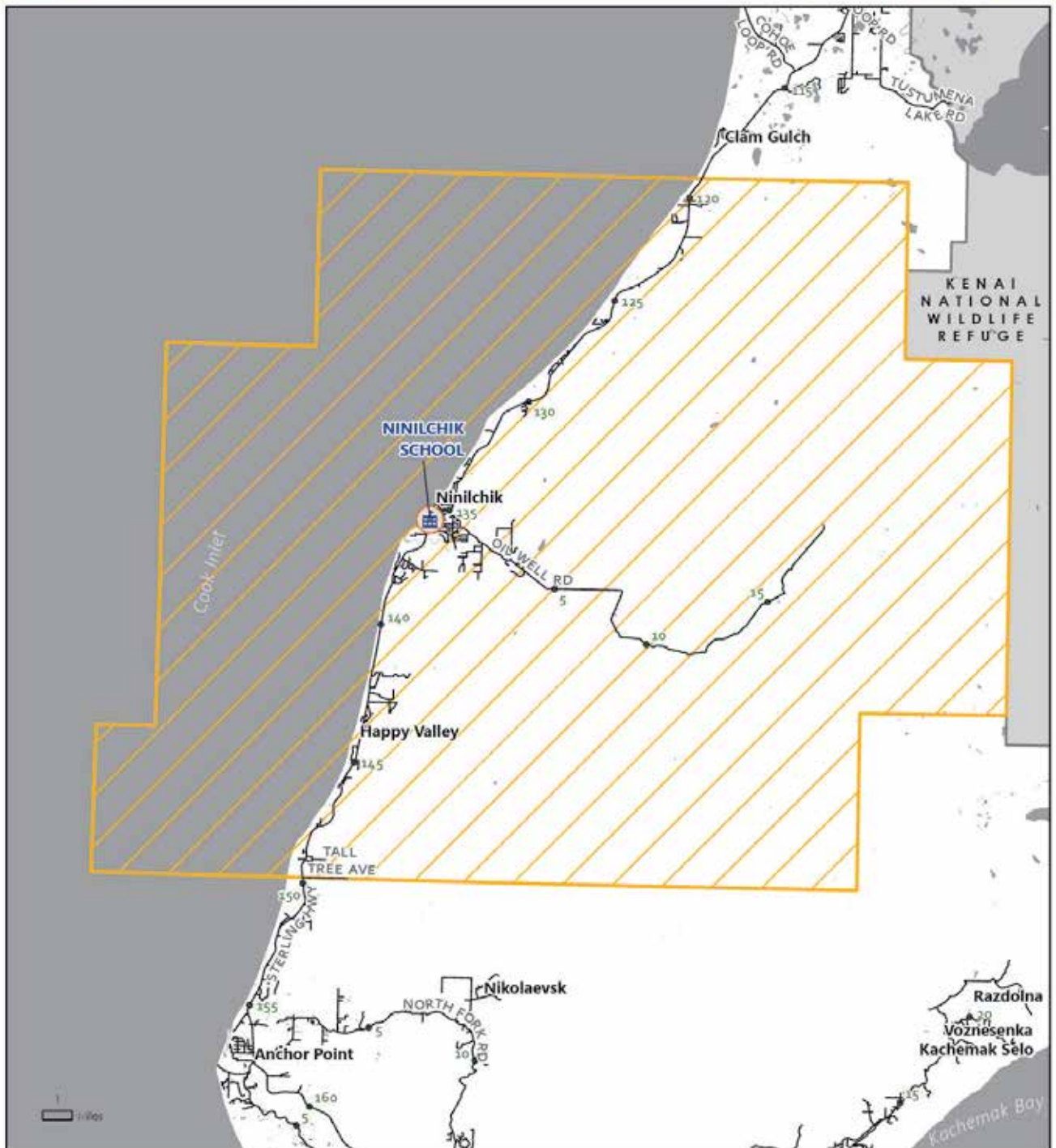

PROPOSITION NO. 3

ORDINANCE 2025-16: RESIDENTIAL PROPERTY TAX EXEMPTION CHANGE

(To be voted on by all borough voters)

Purpose:

Amends Kenai Peninsula Borough Code of Ordinances 5.12.115 to increase the residential property tax exemption for owner-occupied primary residences within the Kenai Peninsula Borough from \$50,000 to \$75,000 in assessed value.

Key Provisions:

1. Increases Residential Property Tax Exemption
If approved by the voters at the October 7, 2025 election, Ordinance 2025-16 will increase the residential exemption by \$25,000.
2. Implementation Date:
If approved by the voters at the October 7, 2025 election, Ordinance 2025-16 will be effective on January 1, 2026 for Fiscal Year 2027.

Fiscal Impact:

Eligible property owners could see a reduction in their annual property tax liability due to a larger portion of their permanent place of residence assessed value being exempt from taxation.

2. The payment of rent for real or personal property will continue to have a maximum taxable amount up to \$500 per transaction.

3. Implementation Date:

If approved by the voters at the October 7, 2025 election, Ordinance 2025-14 will be effective on April 1, 2026.

Fiscal Impact:

Adjusting the sales tax maximum amount every five years end, retaining the \$500 maximum sales tax for rental transactions will result in increased revenue from sales tax.

Purpose:

The proposed citizen Initiative Ordinance 2025-01 seeks to amend the Kenai Peninsula Borough (KPB) Code of Ordinances, specifically Title 4 – Elections, to change the current election date to align with the State of Alaska

Key Provision:

1. Change of Regular Election Date. The proposed citizen initiative ordinance changes the regular borough election date from the first Tuesday of October to the first Tuesday following the first Monday in November.

Fiscal Impact:

The full fiscal impacts are unknown. Changing the election date will impact the availability of polling locations as well as the availability of election workers since the State of Alaska has stated separate election workers are needed for each election, and will require purchasing election equipment such as voting booths, signs, tables and chairs for each polling location.

BALLOT LANGUAGE

Back then, our harbor was smaller, our streets quieter, and you could still hear the clatter of the boatyard over the gulls. In the decades since, I've watched our fair city change — sometimes slowly, like the steady pull of the tide, and sometimes suddenly, like a storm rolling in from Resurrection Bay.

I've seen City Council members come and go, each bringing their own vision for Seward. Some worked hard to strengthen our community. Others, in my opinion, carried personal agendas that didn't always serve the greater good. Over the years, I've learned that in a small town, politics is never just about policies — it's about people, personalities, and the trust we place in those who represent us.

It is with this understanding that I have decided to run for City Council. I believe I can make a difference — not by pushing my own agenda, but by listening to the people of Seward and carrying their voices into the room where decisions are made. 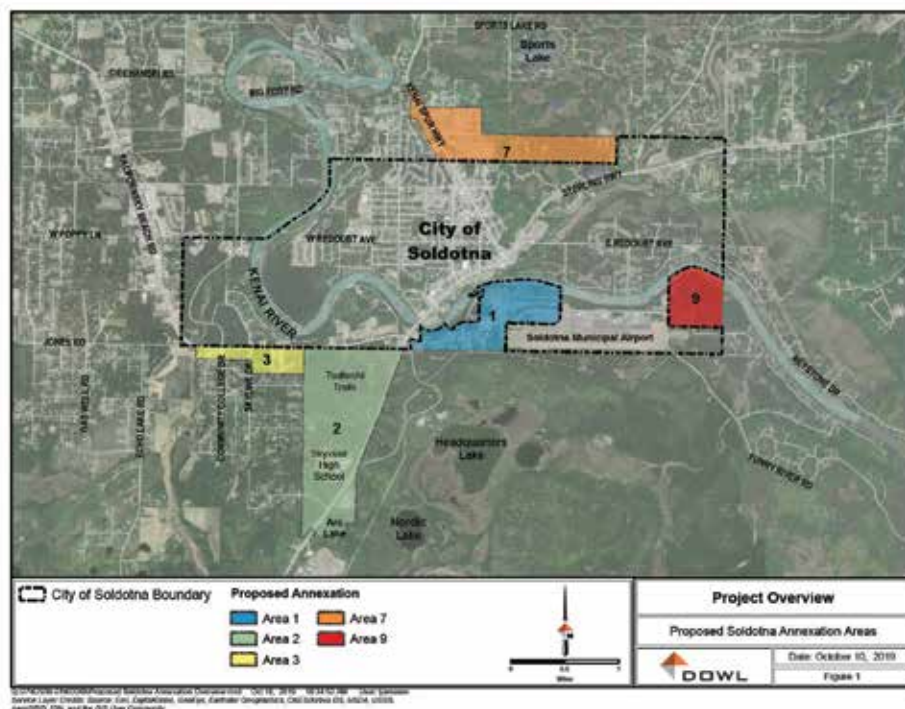

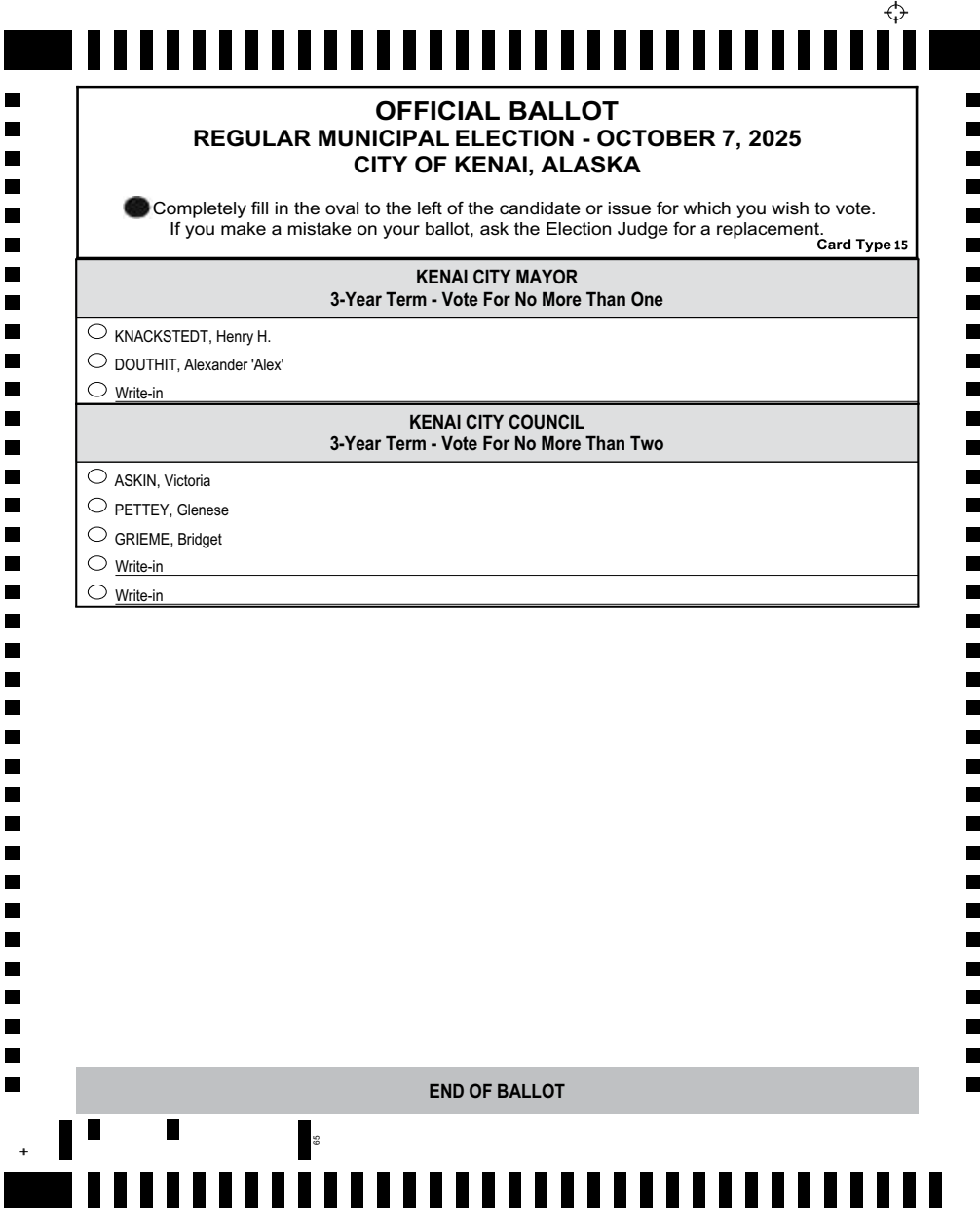


Kenai City Ballot
