


PUBLIC COMMENTS UPON MATTERS ALREADY ON THE AGENDA

Mayor Hornaday displayed his cloth bag he won at the senior dance.

Brenda Dolma, city resident, supports Ordinance 12-36(A).

Deb Lowney, city resident, supports Ordinance 12-36(A). She noted the amount of trash in various areas of town. She discouraged people from picking up dog feces in the plastic bags; biodegradable bags should be used instead.

Roberta Highland, city resident, supports Ordinance 12-36(A). She opposes Resolution 12-081 as some people do not want or need natural gas. It is still a fossil fuel and still leaves a carbon footprint. She urged people to build smaller homes and wear long johns in the house.

Megan Murphy, Homer resident, supports Ordinance 12-45 as the HERC building can benefit many sectors of the community. She supports Ordinance 12-36(A) in conjunction with the Climate Action Plan.

Ralph Brosches, city resident, supports Ordinance 12-36(A).

Kevin Walker, Kachemak City resident, commented on Ordinance 12-36(A) and Resolution 12-081. He supports the ban on plastic bags. At the Kachemak City council meeting last week he learned the natural gas tariff is \$17 per ft., \$34 in Kachemak City, and \$31 in Homer. Enstar should tell us why the cost is so much greater than the tariff.

Rachel Lord, city resident, advocated for Ordinance 12-36(A). As a community we have a responsibility to know where trash goes. We should increase individual responsibility of waste management.

David Raskin, Kachemak City resident, supports Ordinance 12-36(A). Homer is dependent on ocean resources and halibut and salmon are contaminated by plastic bags. A simple solution is to use cloth bags.

Jack Wiles, Homer resident, supports Ordinance 12-36(A). The ban is for one category of plastic bags making it flexible for merchants and easy for the consumer. There are no places to recycle at McNeil, Anchor Point, or local businesses.

George Matz, Homer resident, supports Ordinance 12-36(A). He looks forward to having to change the plastic bag habit.

Billy Pepper, city resident, supports Ordinance 12-36(A).

Robert Archibald, city resident, supports Ordinance 12-36(A). He commented on Resolution 12-081 the gas pipe line that is funded by the State of Alaska and City of Homer. It will become the asset of a Canadian corporation. He is looking forward to more dialogue on the gas line.

Beth Cumming, city resident, supports Ordinance 12-36(A). We should eventually eliminate all plastics and all things dependable on petroleum, a non renewable resource.

Larry Sloan, city resident, urged Council to uphold the Mayor's veto of Ordinance 12-36(A). He opposes plastic bags because they are a blight on the landscape and degrade the environment. He suggested approaching it with a united front with everyone on board. Reintroduce it at the commission level and let it work its way up.

Sue Mauger, Homer resident, supports Ordinance 12-36(A). We are ready to get rid of plastics and the Council is not taking too much of a lead in banning the bags.

Rika Moew, city resident, supports Ordinance 12-36(A). It is either now or later. She admires the forward thinking of the Council in passing the ordinance once, consistent with the Climate Action Plan.

Sue Post, Homer resident and business owner, commented Costco has never used plastic bags and it has not affected their business. She supports Ordinance 12-36(A) and thinks it will be a great cottage industry for someone to make cloth bags.

Patrick Chandler, Homer resident, reported the Center for Alaskan Coastal Studies marine debris cleanup program removed thousands of pounds of debris from beaches, most of it plastics. He supports Ordinance 12-36(A) as a positive step with a long term effect on marine debris.

Will Slight, city resident, voiced support for Ordinance 12-36(A). He can't see viable businesses going under or anyone being burdened. Businesses will save money and the ban will enhance use of cardboard boxes. The sooner we take a small step to start, the better.

John Whittier, Homer resident, supports Ordinance 12-36(A) to create a healthy habitat and ocean. Banning plastic bags requires leadership and vision.

Kevin Kritz, city resident, supports Ordinance 12-36(A). The community of Modbury, England is similar to the size of Homer and a ban on plastic bags passed there. The ban will be successful, add revenue to the city, and makes good environmental sense.

Steve Collins, city resident, supports Ordinance 12-36(A).

Elizabeth Neumann, Anchor Point resident, supports Ordinance 12-36(A). There are no plastic bags in Portland, Oregon.

Ted Schmidt, Homer resident, mimicked Robert Archibald's comments on the gas line. The City and Borough are going to make out well with increased assessments on properties. People's finances are already stretched to the limit.

Amy Backus, city resident, supports Ordinance 12-36(A). Plastic bags have been banned in San Francisco for years.

Lee Post, Homer resident, supports Ordinance 12-36(A). Already 21 countries have banned plastic bag and 80 cities in the United States have banned bags. Homer is the first place to ban nuclear power.

Matt Tucker, Homer resident and teacher, supports Ordinance 12-36(A). Students will see progressive thinking and forward action.

Jeannie Walker, Kachemak City resident, supports Ordinance 12-36(A). She appreciates the argument that it should be education over legislation, but we have had decades of education with no impact.

Sharon Bauer, city resident, supports Ordinance 12-36(A).

Karin Marks, Homer resident and business owner, commented on Ordinance 12-36(A). Regardless of what happens there is a lot of good that has occurred. Small businesses seem to be singled out, but she will comply with the bag ordinance.

VISITORS

A. Old Town Neighborhood Association, Brianna Allen and Asia Freeman, Pedestrian Safety

Asia Freeman and Brianna Allen presented a project to improve pedestrian safety in Old Town. In 1965 was the beginning of neglect to the area as infrastructure moved up the hill to safer areas of town. The community has slowly embraced the beauty of Old Town as the entrance to Islands and Ocean Visitor Center and Bishops Beach. Infrastructure is not really in place to insure safety for pedestrians and bicyclists. The narrow road has 8 ft. wide areas for walkways, not making it feasible for paths to be maintained by the City. The people's garden project is underway with a

\$5,000 grant to purchase fruit trees and edible berry bushes. Revocable pedestrian easements for pathways are being sought for people to walk safely. Murals have been painted on the Bunnell Avenue as a pull towards community, safety, and beautification.

Sharon Whytal works at the Public Health office in Old Town. She is aware of pedestrians in the area and appreciates the efforts of gentle signage. It is at a point where more attention is needed in the area. Homer has set healthy lifestyle choices as a priority and the greatest health impact is through walking.

Asked about revocable easements and if they had thought about a LID/SAD (Special Assessment District) for the sidewalks, Ms. Freeman answered the revocable easements are a good faith effort without binding people. It is an opportunity to share land with pedestrians. People will walk in a designated space. It is hoped to win landowners over to the idea of a permanent easement. The association is less interested in the idea of maintaining the existing traffic pattern. They would like main walks and side drives. As people approach the beach they will slow down. The area will have visual reminders, aesthetic enhancements, and speed deterrents.

B. Center for Alaskan Coastal Studies, Patrick Chandler, Marine Debris

Patrick Chandler, Center for Alaskan Coastal Studies, made a PowerPoint presentation on the debris on the beaches and the impact the Japan tsunami has had on marine debris. Alaska has one of the largest coastal areas with marine debris. Before tsunami debris arrived there have been a significant number of debris problems. For decades we have been getting debris from across the Pacific, Russia, China, Japan, local commercial fishing debris, and recreational debris. This year brought special concerns with tsunami debris showing up. Monitoring efforts started with NOAA and the Marine Conservation Alliance Foundation. Significant increases of Styrofoam have been found in Yakutat and Sitka.

The Alaska Department of Environmental Conservation is doing aerial surveying from Ketchikan to Dutch Harbor coastlines. They are videoing all beaches from south to north, flying at 500 to 1,000 ft. but you can zoom pictures into a 10 ft. perspective. Montague Island guards half of Prince William Sound. It has accumulated significant amounts of debris. The entire rec line is white with Styrofoam, blue board insulation and yellow polyurethane. The debris is coming from houses and buildings that were destroyed by the Japan tsunami. Hundreds of large Styrofoam buoys used as aquaculture in Japan and Korea have washed up. An incredible amount of debris is out there with a huge amount of Styrofoam. In Kachemak Bay we are seeing scattered items, including kerosene canisters. There will be disposal issues with the big influx of marine debris coming in. Container spill debris and water bottles are also common in Alaska. As a Homer project, sculptures are being made of the plastic debris to promote awareness of marine debris. Citizens may get involved in the cleanup effort through the Center for Alaskan Coastal Studies.

C. Tidal Incubator Project, Representative Paul Seaton and Kris Holderied, NOAA

Representative Seaton and Kris Holderied of NOAA presented the Tidal Incubator Project, a collaboration of various entities for tidal energy research. The Homer test site will take

advantage of Kachemak Bay's model location for such a project, including its proximity to the electric grid, shore support, Deep Water Dock, extreme tides, clear water, marine trades and research institutions. Currently the group includes the City of Homer, Kenai Peninsula Borough, NOAA Kasitsna Bay Laboratory, University of Alaska Anchorage, Dean of Department Engineering Anchorage, private industry, Kachemak Bay Research Reserve, Homer Electric Association, Department of Energy, and Homer Chamber of Commerce. They are looking forward to developing a project that will be meaningful and receive funding from the State. Most cities around Alaska are on the coast and all have docks. If we can develop something that can utilize the dock structure we will be able to integrate it in. It will be a test bed for sensors and instruments. An anchoring system on the Deep Water Dock would be an area that people could plug into. Representative Seaton suggested Council might want someone from the Economic Development Advisory Commission to be involved. It will be a very big economic generator for the City. Significant amounts of money are put into developing tidal energy.

Kris Holderied, NOAA representative, added good site characterization is required for this kind of test bed. Homer already has a lot of what they look for. Tidal currents are close to the electrical grid, we have dock infrastructure, we have backbone information that includes sea floor mapping, far field and current meter data from NOAA, and a circulation model by NOAA. Kachemak Bay Research Reserve has weather, water quality, and habitat mapping data. There are local resources and partnerships between local, State, Federal, and University folks already in play. We have the place, group of people, expertise, and information. Benefits include the development of renewal energy for coastal communities and the ability to test marine sensors for research purposes, for the oil and gas industry, and for marine science and industry needs. It could be a good growth industry by bringing good jobs to the community.

HoPP (Homer Playground Project) recently had a workday at Karen Hornaday Park spreading gravel and wood chips. Public Works has been working on drainage at the park, but it will require more funding to find a solution. There is now funding for Jack Gist Park. The Spit trail is being engineered and designed and will be a real asset for the community. Mariner Park driveway will be removed and relocated. The old Beluga Slough Trail has been removed and the new material is going in. In budget preparations he hopes Council looks at parks and recreation funding favorably.

The schematic design for the new building is amazing with climate control, room for research on collections, and ease of getting exhibits in the building.

Carol Swartz, area resident, supports the Pratt Museum's new facility. The project promotes economic vitality by strengthening the arts industry and promoting arts as a complement to tourism and industry. She asked that the Pratt be placed as high on the CIP as possible. At this time 22% of the project cost has been secured in cash and pledges.

Mayor Hornaday closed the public hearing.

City Manager Wrede reported the Budget 2013 will be delivered to Council this week. There are parts of the budget he is pleased about, but other parts are a struggle. He is proud to say the water/sewer budget is balanced and looking good. The Port and Harbor Enterprise Fund is doing well. Fees were raised recently to grow the deprecation fund and pay for the bond sale. Fees for operations were not raised, but continue to go up. The General Fund is a different story. He is struggling with a \$300,000 deficit to balance it. There is an astronomical increase in the cost of health care insurance. It is causing us to put some things on hold that we should be doing.

City Manager Wrede noted Katie's memo on the Economic Outlook Forum. They will be holding their forum in Homer and it will draw a lot of people from all over. He asked for Council's input in spending \$1,000 to sponsor the event. It is customary for the sponsor of the event to pay a portion of the cost. There was no input or objection from the Council.

Mayor Hornaday called for a motion to override Mayor's veto of Ordinance 12-36(A).

LEWIS/BURGESS - SO MOVED.

Councilmember Burgess reminded everyone this only restricts the use of sellers providing a very specific type of thin walled plastic bags. You can still use plastic bags for fruit, vegetables, medicine, and a host of other items. The resolution ensures retailers can use their existing supplies until they are all gone, even past the implementation date. There is plenty of time before the plastic bag ban implementation date (January 1, 2013).

Councilmember Wythe will continue to oppose the plastic bag ban, not because she is a great supporter or non supporter of plastic bags. A number of people testified tonight in opposition and they themselves said they have difficulty using a cloth bag. If you are a prominent supporter of getting rid of the plastic bag and you cannot yourself use a regular shopping bag, that to her says something. We do not need to be forced to have a conscious decision as to how we treat our environment. There is a petition signed by over 300 people and that is their point too. It is not that they are opposed to plastic bags; they are opposed to being required to do something by this Council. Every person has the choice. People do not want Council telling them what they can or cannot do.

Councilmember Roberts will continue to support banning plastic bags. She has thought about it a lot and talked about it to many people. The ordinance as written could have some changes. She would like to hear from the business community. The Climate Action Plan was passed and many of the goals in the plan are similar to the plastic bag ban. Another councilmember commented that the business community can take care of this. Two years ago Councilmember Lewis brought forward a similar ordinance to charge 25¢ per bag and there have been no changes since then.

Councilmember Howard will support the Mayor's veto. She thanked the writers of the ordinance for bringing it forward. She has pledged to her children to use cloth bags; she just doesn't like the idea of being told to do it.

Councilmember Burgess commented it is an issue of public health and greatly impacts the maritime community. He asked that a viable alternative be brought forward from the public if they have one.

VOTE: YES. ROBERTS, ZAK, BURGESS, LEWIS

VOTE: NO. WYTHE, HOWARD

Motion carried.

Ordinance 12-36(A) stands as adopted August 27th with an effective date of January 1, 2013.

Mayor Hornaday called for a motion for the adoption of Resolution 12-081 by reading of title only.

BURGESS/LEWIS - SO MOVED.

Councilmember Wythe recused herself due to her ongoing conflict of interest on the natural gas line. Mayor Hornaday excused her from participation.

City Manager Wrede reported we are on a tight time schedule to have any chance of starting construction next year. We are targeting the end of January to have the Special Assessment District (SAD) approved if Council agrees to go that direction.

Charlie Pierce, Division Manager for Enstar, answered a question posed by Councilmember Lewis: If one subdivision opposed the district, could they opt out of the city-wide SAD? Mr. Pierce answered the gas would still need to go through the subdivision that opted out to make the gas flow; therefore it would not be possible to have areas throughout the city opting out. Enstar worked with the City Planners and looked for areas that could be served and eliminated areas that were undeveloped and not served.

Mayor Hornaday called attention to Kachemak Drive with its three separate water and sewer districts. There is a group in the middle that doesn't want water and sewer services and we have to slush water back and forth.

Council adopted Resolution 12-069 on July 23rd establishing natural gas as a city-wide SAD.

Mr. Pierce was asked by Councilmember Burgess to provide assurance to the public why we are taking public funds and giving them to a private entity to build the gas line. Mr. Pierce answered Enstar is a 50 year old company and has had numerous owners over that period. He has been with Enstar for 34 years. Enstar has established a reputable record with a history of running a conservative and safe company, and using the most modern materials for construction of facilities. They follow the most stringent current DOT codes and regulations for the design and construction of any facility. Enstar has some of the best employees in the industry that provide services every day.

Councilmember Burgess asked Mr. Pierce if Enstar encountered horrible economic catastrophe and was bought out by another company that did not hold Enstar's ideals, what is the worst case scenario for the City of Homer? Mr. Pierce answered utilities are generally very consistent and predictable. You do not have to worry about a utility going broke. The Regulatory Commission of Alaska (RCA) oversees and audits their books, and approves any new ownership. The RCA has approved AltaGas Ltd., Enstar's new owner. Prior to AltaGas Ltd., Enstar was owned by Semco Energy, Inc. and still remains a subsidiary of Semco. He doesn't see any concerns. If Enstar is not here running the utility there will be an operator here running the utility and the RCA will be overseeing the rules and regulations they operate under via the tariff.

Councilmember Burgess noted the benefits of a city-wide SAD are extremely low costs to the end user and low financing rates. If it was profitable for a private entity to build the gas line they

would have already done it. The alternative is for the City to become a utility and that would be bad. We are trying to get the best of both worlds. There are checks in place to ensure a private entity follows through with the commitment. Every councilmember is committed to reviewing the contract in detail to avoid fiascos such as the Seawall and other city projects.

VOTE: YES, NON OBJECTION, UNANIMOUS CONSENT.

Motion carried.

City Manager Wrede announced there are three neighborhood meetings for the natural gas line scheduled for October 16, 17, and 29 at the Homer High School Commons. The natural gas website is up and running: http://www.cityofhomer-ak.gov/naturalgas

We have a small turnout on a regular basis and she would like to see a larger number. As to the plastic bag ordinance, people should have the ability to choose and select. She hopes it does not turn into a bigger issue and that we can all move forward for it.

Councilmember Lewis asked everyone to get out and vote please.

Appropriation/Funding Recommendations

During the last legislative session, \$100,000 was appropriated in the form of a grant to the City for the dredging of the Fishing Lagoon. The City had originally requested \$255,000, the estimated cost of returning the Lagoon to its original depth. Public Works, with the assistance of the Harbormaster, has prepared a plan and submitted for the required environmental permits to allow for the work to proceed this Fall.

We estimate that to return the Lagoon to its original depth, approximately 25,000 CY of material will need to be removed. At \$10.20/CY the total cost of the project is \$255,000.

Total Project Cost = \$255,000 Legislative Grant = \$100,000 Additional Appropriation Required =\$155,000

Not all of this additional required funding will be needed. The 25,000 cubic yards of material can be sold at \$5 per yard, which will generate approximately \$125,000 (especially if the Council authorizes the use of the material off the Spit).

Additional Funding Required = \$155,000 Revenue from Sale of Material = \$125,000 Actual Additional Funds Required = \$30,000

Although \$155,000 needs to be appropriated for the project; only \$30,000 will ultimately need to be spent to complete this project. The construction contract will be offered to potential bidders with the ability for the successful bidder to take ownership of the material as part of the bid price (which would reduce the contract amount significantly, but still require some additional City funding)

Recommendations: The City Council pass an ordinance amending the 2012 Operating Budget appropriating \$155,000 from the General Fund for the completion of the Nick Dudiak Fishing Lagoon Dredging project.

Construction Contract Award Recommendations

Public Works recommends that a non-competitively bid, negotiated, sole source contract be awarded for the completion of the widely supported dredging of the Nick Dudiak Fishing Lagoon.

The City's Procurement Policy and Procedures Manual authorizes negotiated procurement following unsuccessful efforts to obtain competitive bidding; when utilizing an existing government contract; or when approved by the City Council as in the best interests of the City.

Dredging of the Fishing Lagoon cannot be completed during normal summer construction windows. This work has to be completed when fish are not present, when other Kachemak Bay critical habitat wildlife are not present, and when winter weather does not negatively impact cost and productivity. Costs can be greatly reduced if the proper equipment has already on the Spit. The bids for mobilization for the Corps annual (2010 -2012) dredging contract ranged from \$190,000 to \$480,000 just to mobilize the necessary equipment onto the Spit.

Public Works evaluated two approaches to completing the work – land-based operations (construct a cofferdam across the lagoon opening, pump out the lagoon, and remove material utilizing dozers/backhoes), and barge-based suction dredging operation (similar to how the entrance to the small boat harbor/USCG berth is dredged annually.

The Corps of Engineers and the Alaska Department of Fish and Game have indicated agreement with the decision to utilize the barge-based suction dredging operation in an October timeframe recommended by Public Works. The decision by Public Works was based on belief that a barged-based operation would reduced the potential for sediment transported into Kachemak Bay and minimize negative impacts to wintering eiders and other endangered species.

Two barged based dredging operations currently have the equipment on the Spit that can accomplish the work in the timeframe established - the Contractor finishing the annual Corps of Engineers harbor entrance dredging contract (Alaska Marine Excavation, LLC) and a Contractor storing their equipment in the English Bay barge basin. These two contractors are in the best position to accomplish the work as scheduled and at a reasonable cost.

Using contractors already mobilized on the Spit is in the best financial interest of the City.

The Corp's Contractor has provided Public Works with a quote to complete the lagoon dredging work (at a lower unit cost than the negotiated bid for this year's Corps annual dredging work). Negotiated bid unit prices for this year's Corps annual dredging work per cubic yard ranged from approximately \$21 to \$17. The bid per cubic yard provided by the Contractor for the Fishing Lagoon dredging work is \$13.50. The lump sum mobilization bid proposed by the Contractor is \$5,000.

The other Contractor was contacted, but did not show interest in providing a bid to complete the proposed dredging work.

The City Council should approve the award of a non-competitively bid, negotiated, sole source contract to complete the proposed dredging for the following reasons:

- Environmental permits require barge-based dredging in October,
- Public Works was unsuccessful in obtaining competitive bids from Contractors in a position to effectively complete the work within the established timeframe,
- The proposed sole source Contractor's unit price bid is consistently lower than the Corps of Engineer's negotiated bid for similar annual dredging maintenance contract work,
- It is in the best financial interest of the City to take advantage of equipment already mobilized to the site.

Recommendations: The City Council pass a resolution awarding the contract to dredge the Nick Dudiak Fishing Lagoon to Alaska Marine Excavation, LLC of Anchor Point, Alaska in the amount of \$367,500 and authorize the City Manager to execute all appropriate documents.





This is all that is left of the "red shed" at <u>Karen Hornaday Park</u>. Once removed, excavation will begin to provide a gravel parking area.

Summary: Request for the Kachemak Drive Trail to become a City of Homer construction project, and use HART funds to help pay for it.

Introduction

There is a long held desire in the community for a trail along Kachemak Drive. The project is currently in the City Capital Improvement Plan (CIP), and one of the top 15 projects. In the CIP, the project is categorized as one the City expects the State to construct.

The Parks and Recreation Advisory Commission formed the Kachemak Drive Path Committee, which has been meeting regularly since December 2010. The Committee, via the Commission, forward two resolutions to Council in 2011. The City Council approved Resolution 11-90(A) in May 2012, asking for more information and a recommendation of the Transportation Advisory Committee.

The Parks and Recreation Advisory Commission, (P&R) and the Kachemak Drive Pathway Committee have subsequently worked hard to better define the project, and explore the idea of the City building the trail.

The Project

The project consists of approximately 3.5 miles of separated path, adjacent to Kachemak Drive. Most of the trail would be an eight foot wide compacted gravel trail, similar in design to the Homer Spit Trail.

The project would be split into phases for design and construction. The first phase would be from the end of the current Spit Trail at Kachemak Drive, east along Kachemak Drive to the long term airport parking lot. The City and the State are the only two property owners in this section and it's the most heavily traveled section of road. All three advisory bodies feel this first phase is the most important for public safety.

The remainder of the trail would follow utility easements where possible. Property owners would need to grant trail easements to the City for most of the route. Requesting easements from property owners could take years and not all property owners may want to grant easements. This could affect the location and design of the trail.

Ouestion #1. Should the City design and build this trail? Or should it be left to the state?

- The state will not build this trail in the near future. It has been a project on the CIP for some time, and no action has been taken by the state. The state has limited right of way, and has shown no interest in acquiring more right of way in order to build a trail.
- This is an important project and merits the City's efforts to build it, rather than waiting on the state.
- A city project means city staff time, and city taxpayer expense, rather than state employees and state funds.
- The City Council's approval is required if this is to become a city rather than a state project.

Requested Action 1: City Council approval of the City pursuing construction of the trail

Ouestion #2: If the City builds this trail, how will it be paid for?

HART Trail funds can be used to provide matching grant funds, pay for design, or pay for the whole project. This is a large project that will likely be planned and constructed in phases; its not necessary at this point to identify all funding sources. Staff always looks for grants and other funding sources to leverage Homer taxpayer dollars.

Requested Action 2: Approve the concept of using HART funds. Budget requests will follow the ordinance process.

Other information requested via Resolution 11-090(A)

Costs and funding

Costs - Project costs are likely to exceed \$2,080,000. Some sections will likely be substantially more expensive than others. As with any project, design alternatives will be considered in those areas. The initial proposal is to use HART funding for project design, and then use HART funding to leverage grants and other outside funding sources.

Per Carey Meyer:

18,750 LF of 10' wide gravel Kachemak Drive Trail should cost \$85/LF

Design Cost = \$ 150,000 Construction Cots = \$ 1,600,000 Contingency (15%) = \$ 240,000 Inspection Costs = \$ 60,000 Administration Costs = \$ 30,000 Total Project Cost = \$ 2,080,000

Funding - There are several possible sources of funding for this project including grants, state legislative appropriations, and sales tax revenue via the HART program. As with any project, once design work is completed, the project is more likely to be successful with grant and legislative funding. With Council approval, HART funds can be used to initiate and leverage additional monies for this project.

This project will likely need to be completed in phases and may take several years. It has taken over ten years to build water and sewer along Kachemak Drive to date. The city would likely take the same approach with the trail: design the whole project, and implement it in stages as funding and easements are in place. The section between Homer Spit Road and the airport parking is considered "Phase One" and is the highest priority.

Maintenance

At this time, the City of Homer provides minimal winter maintenance on trails (with the exception of the Spit Trail). In the summer, City maintenance is generally limited to trash removal and brush clearing. Staff and volunteer efforts will be needed to accomplish summer maintenance.

Permitting

Acquiring federal, state and local permits for a trail is time consuming, and can be costly. But its not insurmountable. Please consider the permit process as part of the project cost. One of the first steps in this project will be a scoping letter to the various agencies, to find where the problem areas and issues are. The trail can be designed with these issues in mind.

Examples of permits

- Army Corps of Engineers
- State of Alaska Right of Way

What this project will take if the City Council approves this project becoming a city project:

Design Phase - funded via HART funds and other grants as available

1. Permitting. The first step is a scoping letter to the various agencies. They will provide comments about their concerns. With their comments early in the design process, the city can incorporate their concerns. This will smooth the official permit process later in the project.

Cost: Staff time.

- 2. Design. Basic design work to determine the exact route and easements needed.

 Cost: Engineering design contract for cost estimating and easement requirements.
- 3. Easement acquisition. Request easements from property owners.

 Cost: significant staff time, recording fees, possibly some easement purchases

Construction Phase - funding via Hart funds and grants

- 1. Acquire permits
- 2. Contract with an engineering firm for engineer cost estimates and bid drawings
- 3. Acquire construction funds
- 4. Issue bid documents
- 4. Build!

Construction Contract Award Recommendations

Public Works recommends that a non-competitively bid, negotiated, sole source contract be awarded for the completion of the widely supported dredging of the Nick Dudiak Fishing Lagoon.

The City's Procurement Policy and Procedures Manual authorizes negotiated procurement following unsuccessful efforts to obtain competitive bidding; when utilizing an existing government contract; or when approved by the City Council as in the best interests of the City.

Dredging of the Fishing Lagoon cannot be completed during normal summer construction windows. This work has to be completed when fish are not present, when other Kachemak Bay critical habitat wildlife are not present, and when winter weather does not negatively impact cost and productivity. Costs can be greatly reduced if the proper equipment has already on the Spit. The bids for mobilization for the Corps annual (2010 -2012) dredging contract ranged from \$190,000 to \$480,000 just to mobilize the necessary equipment onto the Spit.

Public Works evaluated two approaches to completing the work – *land-based operations* (construct a cofferdam across the lagoon opening, pump out the lagoon, and remove material utilizing dozers/backhoes), and *barge-based suction dredging operation* (similar to how the entrance to the small boat harbor/USCG berth is dredged annually.

The Corps of Engineers and the Alaska Department of Fish and Game have indicated agreement with the decision to utilize the barge-based suction dredging operation in an October timeframe recommended by Public Works. The decision by Public Works was based on belief that a barged-based operation would reduced the potential for sediment transported into Kachemak Bay and minimize negative impacts to wintering eiders and other endangered species.

Two barged based dredging operations currently have the equipment on the Spit that can accomplish the work in the timeframe established - the Contractor finishing the annual Corps of Engineers harbor entrance dredging contract (Alaska Marine Excavation, LLC) and a Contractor storing their equipment in the English Bay barge basin. These two contractors are in the best position to accomplish the work as scheduled and at a reasonable cost.

Using contractors already mobilized on the Spit is in the best financial interest of the City.

The Corp's Contractor has provided Public Works with a quote to complete the lagoon dredging work (at a lower unit cost than the negotiated bid for this year's Corps annual dredging work). Negotiated bid unit prices for this year's Corps annual dredging work per cubic yard ranged from approximately \$21 to \$17. The bid per cubic yard provided by the Contractor for the Fishing Lagoon dredging work is \$13.50. The lump sum mobilization bid proposed by the Contractor is \$5,000.

The other Contractor was contacted, but did not show interest in providing a bid to complete the proposed dredging work.

The City Council should approve the award of a non-competitively bid, negotiated, sole source contract to complete the proposed dredging for the following reasons:

- Environmental permits require barge-based dredging in October,
- Public Works was unsuccessful in obtaining competitive bids from Contractors in a position to
 effectively complete the work within the established timeframe,
- The proposed sole source Contractor's unit price bid is consistently lower than the Corps of Engineer's negotiated bid for similar annual dredging maintenance contract work,
- It is in the best financial interest of the City to take advantage of equipment already mobilized to the site.

Recommendations: The City Council pass a resolution awarding the contract to dredge the Nick Dudiak Fishing Lagoon to Alaska Marine Excavation, LLC of Anchor Point, Alaska in the amount of \$367,500 and authorize the City Manager to execute all appropriate documents.

WHEREAS, Mobilizing for Action through Planning & Partnerships (MAPP)of the Southern Kenai Peninsula (SKP) community efforts have been underway since November, 2008; and

WHEREAS, The mission of MAPP of the SKP is to improve community health and quality of life through community strategic planning and collective impact; and

WHEREAS, MAPP of the SKP offers a direct benefit to individuals, families, organizations, and businesses within the City of Homer and Southern Kenai Peninsula; and

WHEREAS, MAPP of the SKP has primarily been funded through Service Area Board funds to assist in conducting a Community Health Needs Assessment and to develop partnerships and workgroups to address priority health outcomes; and

WHEREAS, Health Resources and Service Administration (HRSA) funds would provide administrative costs that are otherwise difficult to procure; and

WHEREAS, HRSA funds would be utilized to formalize the MAPP of SKP health network and carry out strategic planning activities in order to (a) achieve MAPP of SKP network efficiencies; (b) expand access to, coordinate, and improve the quality of essential health care services; and (c) strengthen our rural health care system as a whole; and

NOW, THEREFORE, BE IT RESOLVED that the Homer City Council supports the pursuit of a Rural Health Network Development Planning Program grant from the Health Resources and Service Administration for the MAPP of SKP.

BE IT FURTHER RESOLVED that the City of Homer endorses the MAPP of the SKP collaboration as an essential element for ensuring a framework for community strategic planning and community health improvement through shared goals and collective impact.
