PUBLIC COMMENTS UPON MATTERS ALREADY ON THE AGENDA

Roberta Highland, city resident, supports Resolutions 12-079(S) and 12-85. She commented on the Endeavour jackup rig and Buccaneer's failed public relations with the community.

Frank Mullen, Homer resident, commented on Buccaneer's presence and the need to have access to information on their drilling plan.

Kevin Walker, Kachemak City resident, supports Resolution 12-079. He hopes Buccaneer explains their business plans for land and water.

Bumppo Bremicker, city resident, supports Resolutions 12-079 and 12-079(S). He commented on the last jackup rig that put its legs down in Kachemak Bay and got stuck in the mud.

Nina Faust, Homer resident, commented on allowing the jack-up rig to be stored in accordance with the critical habitat plan. Buccaneer is lacking in transparency and is here to cash in on the State's multimillion dollar subsidiary.

Amy Christensen loathes looking at the jack-up rig in Kachemak Bay and is upset it was allowed. It is the City's job to question it and the Council's job to stand up.

Megan Murphy, city resident, thanked Mayor Hornaday for starting the Climate Action Plan. She asked Council to support Resolution 12-085.

Robert Archibald, city resident, supports Resolutions 12-079 and 12-079(S). He commented on Buccaneer's West Eagle project and where it will lead and expressed doubt of the jackup rig and its repairs.

Deb Lowney, city resident, supports Resolutions 12-079 and 12-079(S) for the trail and Resolution 12-085 for MAPP.

Beth Cumming, city resident, thanked Councilmember Wythe for help on Resolutions 12-079(S). She supports the first work on the trail and hopes Council will too.

VISITORS

A. Marc Landt, **Buccaneer Energy**

Marc Landt of Buccaneer Alaska Operations, LLC told Council their company works hard to integrate with the community, including sourcing services for the Endeavour-Spirit of Independence jackup rig anchored in Kachemak Bay. The Endeavour is a world class jackup rig operating in Alaska waters and generating income. It has been at the Homer dock for longer than anticipated due to a few unforeseen issues. They are working to get the rig fit for its purpose. That includes replacing the fast rescue craft, the old general alarm system, and repairs to the firefighting system. Once the repairs are completed the Endeavour will depart for the Cosmopolitan. Buccaneer places a premium on safety as paramount importance; the safety of the crew comes before profits.

Mr. Landt introduced Christina Anderson, the local point of contact, and Donna Aderhold, Homer resident, who is working for Buccaneer.

In Cook Inlet Buccaneer acquired the initial acreage in March 2010. They drilled their first well at Kenai Loop in April 2011. Buccaneer established gas sales to Enstar in January 2012. In August 2012 the Endeavour-Spirit of Independence jackup rig arrived in Cook Inlet.

Buccaneer is currently drilling Kenai Loop No. 4 Well, the West Eagle project. The West Eagle Exploration project includes one well planned for spring 2013. West Eagle No. 1 Well is 21 miles to Homer; 6.7 miles to McNeil Canyon School; or 3 to 4 miles to the Russian Villages. The well is at 1,900 ft. elevation, above the tree line. It is an exploration well primarily gas with a

possibility for oil. If successful, it will provide a gas pipeline to either Armstrong's North Fork field or Hilcorp's RED well and 3D seismic to delineate future locations.

Buccaneer's Glacier drilling rig is currently drilling at the Kenai Loop project. The rig is lightweight and transportable in up to 40 truckloads. There is a possible need to improve East End Road for its transportation. Buccaneer plans outreach meetings for the McNeil Canyon School and Homer areas.

Council commented and asked questions of Mr. Landt on the following subjects:

- The need to hold public meetings as soon as possible due to public interest.
- Local hire Buccaneer has 81 hires, 47 Alaska, 9 welders, 5 electricians, 3 plumbers, longshore and guards from Homer. 17% of the crew is from Homer.
- For the West Eagle drilling operation next year they will look to Homer residents first.
- A contractor from Kenai is responsible for truckers to safely drive the Basargin Road for the West Eagle operation. All large loads will have escorts; there will be smaller truck traffic. Buccaneer will work with DOT as to how to best manage the traffic.
- Homer Steel Fabricators is currently working on the Endeavour jackup rig in the Homer harbor.
- The West Eagle is a 55,000 acre exploration project; there have only been two wells drilled there in the past. There could be multiple pads, but Buccaneer will try to limit the number.
- Buccaneer will improve East End Road at their responsibility and costs.
- Buccaneer does not have a mutual aid agreement with another rig if they run into a difficult drilling situation. They would look for the first available equipment in the inlet, likely another jackup rig.
- Buccaneer's contingency plan is available for public review.
- There will be no fraking at the West Eagle project; a well depth of 10,000 ft. is projected.
- The need to get the information out to the community as people here like to know what is going on. Open an office in Homer and hold a job fair.

A. Borough Report

Bill Smith, Kenai Peninsula Borough Assemblyman, reported the results of the recent election. Kelly Wolfe will be the new Assembly member from the K-Beach area. Liz Downing was reelected to the School Board. The Assembly met to extend the Mayor's disaster declaration for the Borough and to put forward \$500,000 to help with recovery efforts of the recent flooding. Most of those funds will be returned by the State and Federal government. There are concerns about the habitat protection district ordinance prohibiting people from rebuilding along anadromous streams. Prior existing uses are allowed to continue or be rebuilt. Those regulations have been in place for the last 10-14 years along the Kenai River and in 24 other areas. People needing disaster assistance can contact offices set up in Anchor Point, Seward, and Soldotna. On the State of Alaska website, contact the Division of Homeland Security and Emergency Management.

The Borough will be having local meetings to ask unincorporated communities for Legislative priorities. For the communities of Fox River, Diamond Ridge, and Fritz Creek, the meeting will be October 20th at 10:00 a.m. at McNeil Canyon Elementary School.

Assemblyman Smith thanked Mayor Hornaday for his service to the community.

This has been researched thoroughly by Port and Harbor Director Bryan Hawkins and Public Works Director Carey Meyer. Dredge spoils will be sold at \$5 per yard and there is no shortage of buyers. We are confident we will get \$100,000 back.

CITY MANAGER'S REPORT

A. City Manager's Report

City Manager Wrede reported the Library Advisory Board is concerned about the four upcoming vacancies on the board. He encouraged people to consider serving on the LAB. He apologized for the poor quality of pictures showing the Public Works projects. They were to be in color. The projects include removal of the red shed at Karen Hornaday Park, the new Beluga Slough Trail, and new road to Mariner Park.

Council commented on the serious situation of no signage for the new entrance to Mariner Park. Public Works Director Meyer said signage will be posted at the new entrance this week.

Councilmember Burgess thanked the City Manager and staff for the budget. It is a conservative approach that leaves wiggle room. As we move forward, staff already has a lot on their plate. He would like to see a certain amount of staffing built in to what we ask to spend money for, including the gasline. A full time person to assist the public on gasline questions could be

recovered by the project. Large vessel moorage fees currently are determined on the length and he would like the fees based on tonnage.

City Manager Wrede answered a budget ordinance will come before Council at the October 15th meeting. A temporary part time position is included for Finance and the Clerk. Administrative and direct costs have been added to the cost of the LID (Special Assessment District). We will be reimbursed for those things, but they won't be reimbursed for two years through assessments if the LID goes forward. During that two years we may have to make a bond payment and pay staff and will need the money to cover those expenses. Discussion will follow at a subsequent meeting.

Bumppo Bremicker, city resident, commented on the gasline and asked if the City has looked at the possibility of HEA building an electrical generating plant and heating it with gas. The electrical line will be needed to generate tidal and wind power.

Aaron Selbig, Homer resident and News Director for KBBI, thanked and said goodbye to Mayor Hornaday. It has been an interesting and at times entertaining time with the Mayor at the helm of the council meetings. Mayor Hornaday is a wise person and terrific leader in the community and he wished him the best of luck as he moves forward.

Linda Anderson, Anderson Group Lobbyists, commented she was late getting here and has a full schedule tomorrow. Mayor Hornaday will be missed in Juneau terribly and Homer is lucky to have him.

City Manager Wrede congratulated the new and re-elected officials. He has had a fun eight years with Mayor Hornaday and will miss him. Although they didn't always agree they had a lot of fun disagreeing. He wished him luck in his future endeavors.

COMMENTS OF THE MAYOR

Mayor Hornaday congratulated the newly elected officials and thanked them for their courage in running. It is a disappointing election turnout.

COMMENTS OF THE CITY COUNCIL

Councilmember Wythe congratulated the new and re-elected councilmembers and thanked Councilmember Zak for his participation in the mayoral race. She will save her comments to Mayor Hornaday until October 15th when we have a glorious going away party for him.

Councilmember Lewis echoed his remarks on those that ran and those that were elected. It has been interesting, educational, and entertaining serving with Mayor Hornaday and an era passing by with the new coming in. Mayor Hornaday had the stories of before Statehood.

Councilmember Zak thanked the people that ran, those that won, the voters that came out, Clerks, and staff that make elections run smoothly. It is unfortunate a low number turned out; there was not a lot on the ballot. In Australia if you don't vote in a couple elections you get fined. That may be good for us. She said a special thank you to the Clerk's office for the special work they did for the volunteer appreciation event last Friday night. That event would not have happened without them.

Councilmember Burgess will save his congratulations to the Mayor until Monday. He thanked the candidates for running and all the people who voted. You make the democracy go around. He thanked staff for the volunteer event. It was fun and he thinks we should do it again.
