

15	WHEREAS, The City of Homer maintains and operates state of the art water and sewer
16	treatment plants and an extensive distribution and collection system; all of which is very
17	expensive; and

19	WHEREAS, The Water and Sewer Special Revenue Fund is operated like an Enterprise
20	Fund in the sense that the costs of maintaining and operating the system is supported
21	entirely by user fees; and
22	
23	WHEREAS, Less than one half of all structures within the Homer City limits are
24	connected to the piped water and sewer system resulting in public safety and environmental
25	concerns; and
26	
27	WHEREAS, Many Homer residents would like to be served by the water and sewer
28	utility for a variety of reasons, including, but not limited to, failed septic systems, tainted
29	wells, erosion issues, reduced property values, and the inability to get financing; and
30	WHIEDEAC From the right the City of the Ci
31	WHEREAS, Even though the City of Homer will subsidize 25 percent of the cost and
32 33	offer attractive financing under the Water and Sewer Special Assessment District program, it
34	remains prohibitively expensive to extend water and sewer into some of the rural residential neighborhoods; and
35	neighborhoods, and
36	WHEREAS, Fixed costs that continue to rise combined with a stagnate customer base
37	that is not growing is a business model that is destined to fail; and

WHEREAS, The City Council has discussed the need to promote "in-filling", expand the system, and find other ways to increase the customer base; and WHEREAS, It is important for the Council to address this issue and thoroughly explore all options available to it to expand the system and the utility customer base; and WHEREAS, One option for expanding service which deserves discussion is to construct water and sewer main lines in a loop which goes up West Hill Road, extends across Skyline Drive, and returns to downtown via East Hill Road; an idea that might make neighborhood Special Assessment Districts more attractive and stimulate development. NOW, THEREFORE, BE IT RESOLVED that the City Manager is directed to produce a report on the estimated costs, financing options, policy considerations, and feasibility of constructing a "loop" water and sewer connection that extends up West Hill Road, across Skyline Drive, and down East Hill Road. BE IT FURTHER RESOLVED that the report shall be presented and discussed at a future worksession to be scheduled by the City Council. #### PUBLIC COMMENTS UPON MATTERS ALREADY ON THE AGENDA

Michele Miller, city resident and Public Arts Committee Member, commented she is available for questions on Resolution 14-023.

Bumppo Bremicker, city resident, commented on Resolution 14-023. He thinks the statue is a good idea, although Brother Asaiah would say to figure it out on your own.

Jim Lavrakas, Executive Director of the Homer Chamber of Commerce, expressed approval of Ordinance 14-16. The appropriation for the publication is a reasonable amount of money over four years. He urged Council to check with other cities on the idea.

Larry Slone, city resident, commented on Resolution 14-023. No one has done as much as Brother Asaiah has to develop a sense of community spirit. That spirit is what brings people here, along with the beauty of Kachemak Bay and the people here.

Steve Zimmerman, city resident, Port and Harbor Advisory Commissioner, and Lease Committee Member, commented on Resolution 14-043. The Lease Committee met last Friday and made recommendations for the Snug Harbor lease to include: fair market value for the lease, amendments to seafood buying, and deadlines for required improvements. He urged Council to review the lease before approving it. He questioned the point of not having a Lease Committee when leases do not go before the Port and Harbor Advisory Commission.

Kevin Hogan, city resident, commented on Resolution 14-043 and the Lease Committee. He suggested giving the committee full information and let them do their job without any side deals and under the table leases. It is wrong to eliminate the Lease Committee and let Administration handle it; public assets need public oversight. Additionally, Ordinance 14-14 is very disturbing as it does not protect the citizens' interests of someone in violation of the ethics statute. No statute of limitations is needed for someone that may have used city resources or funds fraudulently.

4. Parks and Recreation Advisory Commission

Matt Steffy, Chair of the Parks and Recreation Advisory Commission, welcomed Peter Roedl, the newest member. They now have a full commission with the exception of a student representative. A high school person is interested in applying for the vacant seat. Community Recreation Coordinator Mike Illg will be speaking at the Citizens Academy this week with a presentation on community recreation. The spring and summer recreation program is out and is available at various locations throughout town or online. Today was the first PARC (Parks, Arts, Recreation and Culture) committee meeting to review the RFP (Request for Proposals). They will have two meetings before finalizing it. They hope to have the RFP out by the end of the week with a contract award by the end of May. They are anticipating completion of the survey by the end of April 2015. Councilmember Roberts clarified the ethics code only affects elected city officials and the city manager. She appreciates hearing Mr. Hogan's concerns. Most of the elected officials have no access to taking money. The consequences in the ethics code for a violation are not really as effective once a person has left office. If someone was criminally negligent she would hope the City would go after them in criminal court.

Councilmembers Lewis and Van Dyke indicated there is a need for a time limit since most crimes need a time limit. You could rob a bank and be done with that if you elude for seven years. The only crime that doesn't have a statute of limitations is murder.

#### CITY MANAGER'S REPORT

#### A. City Manager's Report

- 1. Parks and Recreation Needs Assessment: The Parks and Recreation Commission will hold a special meeting on Thursday, March 20 to discuss the Needs Assessment. The Commission has been briefed on this project before but this meeting is significant because it will be the first public meeting and hearing focused mainly on the needs assessment. The focus will be on the mission statement and the goals for the research project. This is the first big chance for the pubic to weigh in. On March 24, the PARC Committee will meet to finalize the draft RFP in anticipation of it going out at the end of the month.
- 2. Citizens Academy: We are now moving into session 5 on Thursday the 20<sup>th</sup>. The focus of this session will be the Police and Fire Departments. Presentations will start at City Hall and then tours will be given for the two facilities. Last week's session at Public Works seemed to be well received. The participants seemed particularly interested in the Sewer Treatment Plant, and we spent a lot of time there.
- 3. Kachemak Bay Research Reserve Funding Threatened: Work continues in the attempt to get state funding restored, at least for the next year so that a new State partner can be identified. An effort to restore the money to the Senate Operating Budget ppeared to be successful at the time this was written. Senator Micciche, Senator Stevens and Representative Seaton are working hard to get the funding restored. The City is providing staff and lobbying support where appropriate. Some of the information provided is attached.
- 4. Intergovernmental Agreement with Kachemak City. Attached is a letter from Kachemak City regarding sewer rates for your information. At the time this report was written, I had not yet responded. My intent is to send a letter confirming that we have accepted partial payment, a statement of the balance owed, and the amount of interest that will be applied to the unpaid balance.
- 5. Bay Welding / Overhead Power Lines / Kachemak Drive and East End Road Area. Attached is a letter from Bay Welding Services which is signed and endorsed by 13 businesses which are located and do business in the general area of the Northern Enterprises Boat Yard. Overhead power lines in the area are restricting business operations and potential growth, expansion, and diversification. The businesses cannot afford to pay the entire cost of putting the lines underground themselves. HEA has policies and tariffs it needs to follow and it cannot simply absorb this cost and pass it on to ratepayers. Bay Welding is looking for some sort of compromise solution and because this could have significant economic development implications, is asking the City for assistance. Please let me know how and if you would like the City to proceed.
- **6.** HERC Building: At the last meeting we discussed the land allocation plan. During that discussion, one of the things that came up was whether we could put out an RFP to

lease the HERC Building. I could not remember, and my notes were not clear, whether this was just a general discussion, or whether the Council as a body wanted us to do that. I think the discussion was during the workshop and I do remember some talk about bringing a resolution authorizing an RFP to this meeting or attaching words to that effect to the land allocation plan approval resolution which is before you. If Council wishes to do this, I hope we can have some discussion first. It seems like we are moving on too many tracks all at once when it comes to the HERC building. I would suggest that we wait at least until the Public Safety Building site selection process is complete before we RFP again. A long term lease where the lessee makes significant improvements to the building is inconsistent with using the site for a public safety building. Short term leases for uses that pass Fire Marshall muster could work if that is what the Council had in mind.

- 7. Employee Health Insurance: You will recall that we discussed bringing the employee health insurance issue back to you at around mid-year. The idea was to address the issue before we started budget preparation in the fall. Right now, we are targeting the first meeting in August or a special meeting / workshop on an off-Monday (preferable). This would be a workshop forum. Jeff Paxton, our broker would be present for a presentation. The idea would be to present the data we have for the first 8 months of the new plan to look at impacts on costs and employee utilization. We would also present you with the bids we have received from private sector insurance companies. The goal would be for Council to be able to make an informed decision going forward re: staying self-insured vs. the private sector. Starting the process this early will help with budget preparation, will give us time to make all of the necessary transfers, and give employees adequate notice.
- 8. PERS: As you know, the Governor has proposed transferring \$3 billion into the PERS account to reduce the unfunded liability, reduce future payments, and improve the state's credit rating. The Council has passed a resolution in support of this. The Legislature is currently discussing this proposal. One proposal that is being discussed is raising the municipal contribution from 22% to 24% in exchange for transferring the \$ 3 Billion. This idea is being opposed by AML and the Muni's. If this proposal were to be implemented, it would cost the City an additional \$114,000 per year. Not good.
- Kachemak Drive: Enstar is having difficulty obtaining the easements it needs to construct the proposed gasline along Kachemak Drive. Some property owners say they will only grant easements if the line is bored in front of their property (expensive). Some are just flat refusing to grant an easement. At last report, they had about 75% of the easements they needed but the remainder parcels are difficult. If this issue is not resolved in a timely manner, it could mean that some or all of Kachemak Drive might not receive gas as part of this assessment district. Kachemak Drive is part of Phase II and it will be one of the most expensive sections in the City. Putting this line in now as part of the assessment district is a real bargain and it will be tough to explain to the property owners who want it that they might not get it because a handful of their neighbors are not inclined to be cooperative. The project is due to wrap up in late August. Pushing the Kachemak Drive work off to year 3 is not a viable option for a variety of reasons including cost, contractual obligations, and loan agreements with the Borough.

Washington DC Trip: The City of Homer prevailed in the Auction Block v. City of Homer case as was previously reported. Auction Block has decided to appeal that decision. A hearing for oral argument has been scheduled before the Federal Maritime Commission on April 3, in Washington DC. City Attorney Holly Wells has requested that I be present for the hearing. While there, I will also take the opportunity to visit with the Congressional Delegation to discuss capital projects and federal issues of concern to the Homer City Council. I will take some personal leave while on the East Coast, in part to attend a memorial service, and will be back in the office on April 16. I will miss the April 14 Council meeting.

City Manager Wrede reported on Item #5 Bay Welding/Overhead Power Lines/Kachemak Drive and East End Road Area within his report. Bay Welding is asking if the City would help them with costs of taking down the overhead power lines. It was suggested that a compromise be explored with Homer Electric Association.

Enstar is having difficulty getting easements on Kachemak Drive for the gas line. Some folks want their property bored and others are flat opposed to the line going in. They are missing 13 easements at this time. Many of those are folks Enstar has not been able to get ahold of. City Manager Wrede encouraged Council to contact the absent property owners if they know someone. The gas line could potentially wind up with the same situation as water and sewer; gas on each end without any service in the middle of the road. There are no utility easements on Kachemak Drive and it is difficult to purchase them if the price is too high or people don't want to sell. We hope to get the word out to those who are away. The gas line is being constructed on the bay side of Kachemak Drive.

#### **COMMENTS OF THE AUDIENCE**

Larry Slone, city resident, commented on Resolution 14-043 and the importance of an independent review. If we are doing away with the Lease Committee it is important to have another set of eyes looking at it.

Scott Simmons, Homer resident, made a request for Public Works to sweep the streets before the first tourist arrives. He commented on an ambulance bill he recently received for a ride for

his daughter in 2013. His insurance company did not pay it. The City billed for advanced life support emergency instead of a basic life support ride. The City has since corrected it, but he expressed concern that this may happen often.

Jim Lavrakas, Executive Director of the Homer Chamber of Commerce, thanked the Mayor and City Manager for coming to the luncheon last week at the Alibi and speaking on the state of the city and plans for this year. He commented on the successful Winter King Tournament, the best tournament in last the last 21 years. There were 906 anglers, 270 boats, with 202 fish caught. More than \$130,000 in cash was awarded to winners of side bets and the top ten fish. Next week the webcam will be operating on the Chamber's website. Spit Spots placed the webcam free of charge on the Harbor Grill overlooking Ramp 3. He urged folks to go to kachemakshorebird.org to sign up for the Shorebird Festival. The Chamber will be at the sportsman show in Anchorage this week.

Ken Landfield, city resident, commented on Resolution 14-023. It was important there was a community conversation on the subject prior to the statue being created. He was surprised at the comments that surfaced at the Public Arts Committee. Mr. Landfield commented on the excellent classes offered at the Citizens Academy and thanked Council for making it possible. A new source of revenue for the City could be extending the \$500 cap on sales tax.

Councilmember Burgess responded he looked into an increased sales tax cap. The City of Seward tried to increase theirs. Since the Kenai Peninsula Borough collects sales tax for all the municipalities they told the City of Seward they would charge them \$48,000 to \$50,000 to increase the limit since it would cost the Borough money to modify their software. If more cities were involved the Borough's fee may be lower.

#### COMMENTS OF THE CITY ATTORNEY

City Attorney Klinkner was not present.

#### COMMENTS OF THE CITY CLERK

City Clerk Johnson had no comment.

#### **COMMENTS OF THE CITY MANAGER**

City Manager Wrede will look into the discrepancy of the ambulance billing. He is pretty sure it is a mistake. He assured the public we are not systematically overcharging insurance companies. At the last Port and Harbor Advisory Commission meeting the commission expressed concerns about leases. He plans to attend the next commission meeting to address the issues, many of them have to do with enforcement of violations of the zoning code.

#### **COMMENTS OF THE MAYOR**

Mayor Wythe commented on the acceptance of the bust of Brother Asaiah, noting it was the second time in three years a request for a memorial placement was made. She requested some type of regulation to accept or not accept memorials. At the next meeting a Worksession has been scheduled to provide an update on the water and sewer loop and the potential for Lillian Walli subdivision property to open for small development in water and sewer. Public Works may be getting the sweeping equipment ready to address the dust issue. She thanked the Homer Chamber of Commerce for inviting her and City Manager Wrede to their meeting to provide the "State of the City" address. She outlined all the fun things the City is doing while Walt talked about the finances. The Alibi provided a great meal. She learned they are trying to develop a family community place there.

#### COMMENTS OF THE CITY COUNCIL

Councilmember Van Dyke expressed disappointment in the Mayor's decision not to allow the ex-commissioner to speak. It is Council's duty and responsibility to hear from all the people of the community. He was more disappointed Ms. Sarno left the meeting and did not address Council at the proper time. He thanked everyone that stayed and gave input.

Councilmember Zak had no comment.

Councilmember Roberts thanked Lindianne Sarno for three years of service on the EDC. Our Mayor's job is to run the meeting and she must make difficult decisions sometimes. The Mayor did nothing purposeful as she encouraged Ms. Sarno to stay to the end of the meeting to speak to Council. That is the appropriate time to give a personal comment. She is sorry that Ms. Sarno did not remain as she suspects we would be interested to hear what she had to say.

Councilmember Burgess echoed the sentiments of Gus and Francie. He thanked Lindianne for her three years of service on the EDC. There is a functional and motivated Council now who is trying to get things done. Tonight Skyline Fire Station was approved, something we have been working on since annexation. Natural gas is going in the streets. Public Works has lots of projects to support quality of life in town. The resolutions and ordinances that we pulled this evening as a result of public comments show that we are listening to the people. When you come to this Council you will be heard. The Mayor made the right call in asking that the comments be made at the appropriate time. He likes the idea of maintaining the Lease Committee. It has a minimal amount of oversight and the sets of public eyes bring things to the table that are valuable. On the health insurance and ambulance issue you try to tackle it different ways; so long as 30% of healthcare dollars go to support health care insurance billing you are going to have issues. The more middlemen there are, the more cuts. He appreciated the dialogue on the Brother Asaiah statue. Lots of people rejoiced to him that they got to come out and talk about the February issue. He looks forward to the next February issue.

Councilmember Lewis echoed the comments of Beau, Francie, and Gus. The past couple of weeks two of Homer's tier two hockey teams, the Squirts and PeeWees won State. The ice rink

is in financial trouble. We can win State because we have real ice and it keeps the money here. We need to come up with a way to keep the rink open and it is not going to be easy.

Councilmember Howard thanked the port and harbor for the work they did for the derby. She did not hear the Chamber make one announcement that the City waived the harbor fees of \$2,500 to \$3,000 and provided police, harbor, and fire assistance. She would have appreciated a thank you from the organizers.

#### **ADJOURNMENT**

There being no further business to come before the Council, Mayor Wythe adjourned the meeting at 7:34 p.m. The next Regular Meeting is Monday, April 14, 2014 at 6:00 p.m., Committee of the Whole 5:00 p.m., and a Worksession at 4:00 p.m. All meetings scheduled to be held in the City Hall Cowles Council Chambers located at 491 E. Pioneer Avenue, Homer, Alaska.

**SUBJECT**: Lease Committee

The City Council has been discussing ways to reduce expenditures, redundancy, and overlapping jurisdictions by eliminating some committees and lowering the number of meetings for others. The staff currently spends a very significant amount of time providing support to the various Boards, Commissions, Committees and Task Forces and this can make them less productive with respect to their regular duties. The City budget cannot accommodate additional staff members so it is wise to maximize the time of the current staff. As one organizational policy expert put it, if your goal is inefficiency, gridlock, and employee burnout then appoint lots of committees!

The Lease Committee is one of the Committees under consideration for elimination; at least in its present form. I have been asked to summarize the reasons given for eliminating this Committee as it is presently structured.

- Redundancy: This committee is one of several that has been charged with reviewing the adopted Lease Policies and making recommendations to the Council. The Economic Development Commission and the Port and Harbor Commission have both undergone extensive reviews of the policies. This creates unnecessary confusion. One of the standing Commissions can handle review and recommendations regarding the Lease Policies.
- <u>Efficiency</u>: Business people and prospective lessees often complain about how long it takes to get anything done with the City. Streamlining the permitting and leasing process is in line with the "Open for Business" approach espoused by the Council. Lease applications can be reviewed, evaluated, and presented to the Council by the Administration. That is the way it used to be. This would save many weeks and is more consistent with the Administration's fiduciary duties under the Code.
- <u>Legal Concerns</u>: The City Attorney has expressed concern about having public members on a Lease Committee that reviews, evaluates, and participates in the lease negotiation strategy process. This is the fiduciary responsibility of the City Manager

under the Code. According to the City Attorney, inclusion of public members on the Lease Committee is problematic because of the Committee's role as advisor to the City Manager in the evaluation of lease proposals and the negotiation of lease terms with prospective lessees. In performing these functions, Lease Committee members may become privy to confidential information regarding the business plans, finances and operations of prospective lessees, and the City's strategy in negotiating with prospective lessees. The likeliest candidates to be public members of the Lease Committee are persons who may have business interests in competition with prospective lessees, or may themselves hold leases of City property in the harbor area, resulting in inherent conflicts of interest, the potential for misuse of confidential information, and opportunities to engage in various forms of anticompetitive behavior. Even if this conduct occurs without the City's knowledge or consent, the role of the actor as a Lease Committee member could expose the City to potential liability for that conduct. Another concern is that the Lease Committee, in its present form, may be subject to things like the Open Meetings Act and Ex-Parte Contact. It is impossible for the Staff members of the Committee to comply with those laws because of their other duties in the process, including frequent contact with the applicant and collaboration on evaluating proposals and lease administration generally. In other words, staff members talk to each other regularly and are privy to information that the other members of the Committee are not. Having the Lease Committee return to an Administration function eliminates that concern.

#### RECOMMENDATION:

Change the Lease Committee membership by eliminating public members and including only members of the Administration. The revised Lease Committee would have sole responsibility for evaluating lease proposals, negotiating terms, and making recommendations to the Council. The Council could request advice from another standing Commission, like the Port and Harbor Commission, on the Lease Policies, if it thought that to be appropriate.

SUBJECT: SPRING REPRESENTATION

First, allow me to apologize for the lateness of this report. It has been a busy spring and opportunities to represent the community in a variety of ways have been many.

First, I had the privilege of speaking at the Kenai Peninsula Economic Development District's annual industry forum again. This year the forum was in Kenai. We spent two days hearing about a number of exciting prospects for the Peninsula in the coming few years including the gas line terminus in Nikiski. This forum provided an opportunity to highlight the work the City has done to make good on our "open for business" initiative by sharing the upgrades to the harbor and discussing the deep-water dock expansion and the potential for the new East harbor.

Walt and I also had the opportunity of providing a state of the City address for the Homer Chamber. Walt did a great job of presenting the financial state of the City and talked about the legislation to release the harbor from the critical habitat area, and I enjoyed sharing similar information to what was presented at the industry forum with our local business owners.

Copies of my notes for each of these events are attached for your reference. The presentations did not go exactly as the notes are printed, but this generally represents what I talked about.

In addition to these two opportunities, we made two trips to Juneau which appears at first blush to have been quite profitable for the City. On our first trip, Katie, Linda and I met with Senators Micciche and Stevens, Speaker Chennault and also with Representative Seaton. We shared information about the new format for our Capital Improvement Projects List and the top five projects included there. We also requested support for the bills being presented by Senator Micciche and Speaker Chennault regarding the removal of the harbor from the critical habitat area. Meetings with the Coast Guard and DOT were canceled in favor of sitting in on the House sessions the Bill was finalized. This was an interesting process to observe and we also had the honor of observing the swearing-in of the new Representative for Juneau.

Ultimately our representatives decided to just go with the Senate bill, which worked out quite well and moved rapidly thorough both the Senate and the House to be the first piece of legislation passed this year. Congratulations to Senator Micciche and many thanks to Speaker Chennault and Representative Seaton for their support were provided at our follow-up visit in February. We also thanked Senator Stevens for signing on in support.

Acting City Manager, Jo Johnson attended the second trip to Juneau with me. This was her first trip in this capacity and we had a great time. We were able to meet with Senators Micciche and Stevens again as well as Representative Seaton. While they would not provide any advance information regarding the capital budget initiative, Senator Micciche did say he did not think we would be disappointed. Indeed, after reviewing the proposed budget, it appears that Homer has made a good showing again this year.

In addition, on our second visit we were able to make the appointments with the Coast Guard and DOT, both of which were encouraging. The Coast Guard staff representatives that we met with were all new this time, but they were very familiar with Homer. We discussed the East Harbor project and were provided with some new recommendations for potentially garnering Coast Guard support for the project. While it is not probable that we will be able to get a long-term letter of commitment, Captain Jack Vogt did encourage us to pass a Resolution for our State and Federal delegation to carry forward stating the many benefits of our location, ice-free port and developing oil & gas industry in the Nikiski area as key indicating factors for continuing to maintain the Cutter and for proposing that one of the new Rapid Response Vessel be ported here. Including information about the savings for not having to dredge that may be possible with the new harbor was also recommended. Captain Vogt indicated that Homer is a preferred station by their crew members and is often selected as a retirement port of call. We knew this, but it is always nice to have confirmation. Notes on this will be passed to Walt and Katie.

Our meeting with Commissioner Kemp and his new Policy & Program Specialist, Tyson Gallagher, also proved to be encouraging. They will be taking a tour of the State road systems this summer and anticipate visiting Homer in May. The Commissioner also indicated that he enjoyed the tour last summer, but is looking forward to a less formal and closer look at the projects that have been completed, those proposed and specifically the Spit Road. Tyson will be in contact with Jo when they determine their travel schedule.

All told, with the passage of the legislation and nearly two million dollars of capital improvement funding, these two trips to Juneau appear to have been well worth the time and investment. Thank you again for the opportunity.

## **2014 Industry Forum**

- Last year at the 2013 Industry Outlook Forum I had the privilege of addressing you in Homer and delivering the message that Homer is open for business. I am happy to report that Homer continues that message and has been working to improve our facilities in order to attract and retain the diverse economic factors that make up the fabric of our community.
- ➤ The Homer Port and Harbor is an important economic engine in Homer and this year work began to complete over 10 million dollars of facility and system improvements including:
  - replacing floats,
  - electrical systems, and
  - ramp 3, which a primary access point for harbor users.
  - Design work is also underway for an extension of the Deep Water Dock.
- ➤ The Homer port and harbor enjoys a diversity of uses from tourism and charter fishing, to commercial fishing and freight handling. The Port also provides an access point for research, and oil and gas support vessels.
- ➤ There are many current and potential City of Homer Port and Harbor service customers here today. Our harbor provides safe moorage and access to many local services including our excellent marine trades' professionals. Homer is also conveniently accessible by road and air.
- ➤ We want to make it absolutely clear; the Homer Port and Harbor is open for *your* business.
- ➤ In order to allow wider use of the deep water dock facilities, the City is working with Speaker Chennault and Senator Micciche on legislation to exempt the municipal lands associated with the Port and Harbor from the Kachemak Bay Critical Habitat area.

- ➤ This exemption will allow oil and gas drill rigs to moor at the Deep Water Dock and eliminate unrealistic permitting requirements for vessels that drop anchor or moor in the Port and Harbor for more than 14 days.
- ➤ We thank our Peninsula legislators for seeing the value to industry and the enhanced environmental safety for Kachemak Bay of allowing this exemption.
- ➤ 2013 was a banner construction season for Homer and we are gearing up for another one in 2014.
- ➤ Over 20 million dollars in State and Local infrastructure projects were completed in 2013 including:
  - repaving 23 miles of the sterling highway
  - building several new rest rooms and other facilities for cruise ship passengers and other visitors,
  - and construction of 65 miles of natural gas main line.
- ➤ 2014 will bring the completion of the natural gas service line build-out in Homer, but many natural gas meters are already spinning; although this years' warm weather will make it difficult to compare home heating costs from previous years.
- ➤ 2013 provided excellent summer weather which lured many visitors to Homer. We were pleased to count a number of our Alaskan neighbors in the numbers that chose the "Cosmic Hamlet by the Sea" as their vacation destination.
- > The community is already gearing up for a greater advertising presence in 2014.
- ➤ Increased City funding to the Homer Chamber of Commerce was provided to help them expanded marketing efforts on our behalf.

A public hearing was held by the Planning Commission March 19, 2014 on the proposed ordinance. One person provided public testimony. A motion to exclude the additional language added at the City Council was made. Several issues were raised, most revolving around septic systems including:

- The value of notifying neighbors to help document local concerns.
- Concern for contamination or preclusion of nearby wells or well sites.
- Adequacy and documentation of current systems in relation to proposed expansion of septic.
- The wording of the amendment conflicts with standards for dwelling provisions for onsite water and wastewater (40,000 sf per dwelling w/o city services).
- The uncertain follow through and documentation of AKDEC.
- The ability of the city to inspect conditions and final work.
- The ability of a CUP hearing to address unique concerns of individual applications and apply appropriate conditions.

### Recommendation:

The Homer Advisory Planning Commission recommends to <u>not</u> amend Ordinance 14-09.

Note: While the City Council is not bound to the recommendation of the Planning Commission, this ordinance, as written, presents conflicting language with other provisions of title 21. If the concept is adopted, I strongly recommend a consultation with myself and

## Background

After recommendation of the PC, the City Council affirmed the proposal of allowing, "One detached dwelling unit, excluding mobile homes, as an accessory building to a principal single family dwelling on a lot serviced by City water and sewer services in compliance with Title 14 of this code."

In addition, a motion was made to amend to "allow an accessory detached family dwelling on any rural residential lot over one acre without access to city water and sewer."

This amendment was then forwarded to the PC for review. We plan to have a public hearing next meeting.

## Discussion

If the Commission wishes to affirm recommendation for the concept, we need to adjust the language to be consistent with other provisions of the title.

Concept: One detached dwelling unit, excluding mobile homes, as an accessory building to a principle single family dwelling (in the rural residential district regardless of water and sewer status).

### Items for discussion:

- Dimensional requirements already handle the amount of land necessary. No reference to amount of land is necessary unless some other requirement might be considered by the commission.
- Similarly, access to city water and sewer really does not provide any other direction than is already provided by code.
- If other considerations are not unique in relation to access to city services, the concept could be combined into one code amendment that omits reference to services.
- Is there any benefit to handle such a request as a CUP?
  - o Notice of neighbors?
  - Special conditions or considerations for review?

City Planner Abboud reviewed the staff report.

The Commission discussed the proposed amendment to include lots over one acre not serviced by water and sewer. City Planner Abboud explained that city reviews the plan approved by DEC and that it is being installed by a certified installer.

The general consensus of the group was that it should remain allowable as a conditional use. They expressed concern about ensuring adequacy of the system in place being able to accommodate the additional housing. It was also suggested that there be a separate system in place for the additional dwelling. Another issue raised is that generally people living in the rural district don't want a lot of density in their neighborhoods, and leaving it as a CUP gives people an opportunity to be noticed and give feedback about the development.

The Commission will hold a public hearing at their next meeting and make their recommendations after they hear public input.

B. Staff Report PL 14-23, Heliports March 2014

Chair Venuti noted that they addressed this during the worksession.

Question was raised whether the hospital heliport will be squared away before they take on the rest of this. City Planner Abboud said there are different ways this can be addressed and he will work with the attorney on the best way to resolve it.

Commissioner Highland expressed her opposition to helipad in the rural office district, with exception of the hospital, and in the bridge creek watershed area. She would be supportive of it in GC<sub>2</sub> and marine industrial with a special temporary permit that could be acquired from the Planning Department, but not as a use through a CUP.

Regarding the Bridge Creek Watershed area, City Planner Abboud said he would be reluctant to disallow it as there are areas that are difficult to get to and he doesn't think it would impede on the 4

City Planner Abboud reviewed his staff report. There was brief discussion relating to the Board of Realtors comments about relaxing the Bridge Creek Watershed District regulations. He reviewed his trip to Denver for the New Partners for Growth Conference and discussion ensued regarding regulations of marijuana sales, as it may be happing soon in Alaska.

City Planner Abboud reviewed his staff report.

Chair Venuti opened the public hearing.

Ted Schmidt, city resident, said at first blush he was concerned because over the last few years he has heard Council comments about how the water and sewer has trouble has financing their infrastructure because one of the problems is that there aren't enough residents tied in to it. He is also aware of a desire to bring water up West Hill to complete a loop in the system. He doesn't think it is a financial possibility in some of these areas because of larger lot sizes. People knew that when buying those lots and it was their preference when they bought them. He feels like this is a left handed way to say you can't do this with your property because you aren't on city water and sewer. He thinks each lot should be examined on its own basis as there are a lot of steep slopes and wetlands.

There was discussion with the City Planner about the process already in place for a conditional use permit process for the larger rural residential lots. Mr. Schmidt raised issue of an action by a previous planning commission approving two duplexes with a community septic system in an area where there were wells less than 200 feet away on other properties. City Planner Abboud said he couldn't speak for to a past action, but it is a reason that these should come for review by the Commission through the CUP process.

There were no further comments and the public hearing was closed.

HIGHLAND/SLONE MOVED TO RECOMMEND COUNCIL ADOPTION OF ORDINANCE 14-09 AN ORDINANCE OF THE CITY COUNCIL OF HOMER, ALASKA, AMENDING HOMER CITY CODE 21.12.020, "PERMITTED USES AND STRUCTURES", TO EXPAND THE PERMITTED USES IN THE RURAL RESIDENTIAL DISTRICT TO INCLUDE THE ADDITION OF A DETACHED DWELLING UNIT AS AN ACCESSORY TO A SINGLE FAMILY DWELLING ON A LOT SERVICED BY CITY WATER AND SEWER SERVICES.

Commissioner Highland said she moved to adopt the ordinance without the amendment based on the concerns raised at their previous meeting. The lots that are not serviced by water and sewer should get conditional use permits because of issues with soils, water, and review of the best interest for the area. The CUP process gives notice to property owners in the area and special conditions or considerations for review. Those are some of the reasons they had discussed previously as to why they felt lots without city water and sewer should still be addressed through a CUP.

Commissioner Slone agrees with disapproving the amendment. His main reasoning is because of lots that are not large enough to accommodate sewer systems that won't contaminate wells on adjacent properties that are downhill from the development.

Commissioner Stroozas agreed that those are valid points.

Commissioner Stead commented that the way it's written now, you have to have two acres so saying a lot that is 1.1 acres can automatically have an accessory use doesn't fit. He doesn't think it is very well thought out amendment to what the Commission sent to Council, and supports the motion to adopt the original ordinance as written.

Commissioner Bos doesn't think it could be permitted outright regardless of how big the property is. He recognized that septic's are rated based on bedroom count. He raised concerns about being able to add another residence to a property with a septic when you don't know the status of the drain field, unless you ask the applicant to have it investigated. It will just add to the "buyer beware" list that the next person will have to deal with. He is adamant that we need to stop those situations.

City Planner Abboud reviewed the process by the City and by DEC relating to septics which includes an engineered plan to be done by a certified installer. There has to be a space for the septic and enough space to replace it, and hopefully in those spaces they won't harm a neighboring well.

There was brief discussion relating to building inspections and that if the City had a building inspector it would be much easier to do something like this.

This memo contains the planning staff review of the zoning code amendment as required by HCC 21.95.040.

21.95.040 Planning Department review of code amendment. The Planning Department shall evaluate each amendment to this title that is initiated in accordance with HCC 21.95.010 and qualified under HCC 21.95.030, and may recommend approval of the amendment only if it finds that the amendment:

**a**. Is consistent with the comprehensive plan and will further specific goals and objectives of the plan.

Discussion: Comprehensive Plan Chapter 4, Goal 3 Object A states: "Create a clear, coordinated regulatory framework that guides development." One of the implementation strategies states: "Provide a clear and predictable approval process for every development including organizing project review and permitting and providing appropriate staff review."

Staff response: This amendment is consistent with the Comprehensive Plan.

<u>b.</u> Will be reasonable to implement and enforce.

*Staff response:* This code amendment will be reasonable to implement and enforce. The amendment relaxes a more stringent code requirement.

**c**. Will promote the present and future public health, safety and welfare.

Staff response: A Conditional Use Permit will still be required for more than one dwelling unit that is not connected to City Water and Sewer.

unit as a permitted use

**Requested Action:** Conduct a public hearing and forward a recommendation to the City Council.

#### **GENERAL INFORMATION**

In 2011, the City Council adopted Ordinance 11-44(s), which allowed a single accessory dwelling unit on a lot as a permitted use. Previously, a conditional use permit was required if a homeowner wanted to build a cabin, or other detached dwelling unit, on the same lot a s primary single family home. Duplexes, or a single structure with two dwelling units, were allowed as a permitted use. The result of these regulations was the increased cost and regulatory process requirements for the applicant to build a detached dwelling opposed to an attached dwelling. The Commission considered many such conditional uses over the years, with few if any denials, and few conditions. It was not a productive use of Commission time, or the applicant's money. Ordinance 2011-44(s) allowed these accessory dwellings as a permitted use, with the issuance of a zoning permit.

At the time, the Commission did not allow this use in the Rural Residential District. It was felt with the prevalence of onsite wells and septic systems, greater oversight for public health concerns was warranted. In the past few years, several water and sewer line extensions have been completed in the rural district. This has allowed land owners to apply for conditional use permits, because their land now meets the dimensional requirements for more than one dwelling unit per acre. Staff recommended the Commission allow these accessory dwelling units as a permitted use, where both city water and sewer serve the property. This allows rural residential land owners with city water and sewer to enjoy the same rights as those in other residential districts, and also continues to provide Commission review for those applications not served by city utilities.

#### STAFF COMMENTS/RECOMMENDATIONS:

Conduct a public hearing, consider testimony, and make a recommendation to the City Council.

BOS/HIGHLAND MOVED THAT THE PLANNING COMMISSION APPROVES THE DRAFT ORDINANCE AMENDING HOMER CITY CODE 21.12.020 AND 21.12.030 TO ALLOW AN ACCESSORY DWELLING UNIT AS A PERMITTED USE AND RECOMMENDS ADOPTION BY CITY COUNCIL.

Commissioner Slone commented that it brings up a good point whether the accessory dwelling will be put on a separate meter. It would be a significant consideration with respect to the income the city derives of the water and sewer system. It isn't a major consideration relating to this action, but is something to think about. Another point is that we are doing some infilling based on infrastructure and additional usage of water and sewer would be beneficial to the city.

- 1. Increase the size of lot 2 to meet the dimensional size requirement of 10,000 square feet. Elimination or reduction in size of Park A to meet this requirement is acceptable.
- 2. A development agreement is required.
- 3. The shared driveways shall meet fire department access requirements.
- 4. The developer shall clarify with Public Works prior to final platting which creeks shown on the plat have a drainage easement and the width of the easements.
- 5. Continue the 15 foot utility easement around the bulb of Sophie Court
- 6. Work with the City of Homer and the Kenai Peninsula Borough address officer on E911 compliant street names
- 7. During the first phase of construction, build Nelson Ave and Ronda Street from East End Road all the way to the intersection with South Slope Drive, and that portion of South Slope Drive within the subdivision.
- 8. Construct fire hydrants as part of the subdivision.
- 9. Dedicate the area shown as Park "A" as future right of way providing access to the south of the subdivision.
- 10. A fire department accessible shared driveway provides reasonable access to lot 8, and Tract A, AA Mattox Sub 1958 Addn, in lieu of a full right of way dedication to these lots.

SUBJECT: ENACTING A TIME LIMIT FOR ETHICS CODE COMPLAINTS

Upon review of the Board of Ethics provisions I discovered there was no time limit for filing a complaint of a violation of the City's Ethics Code. The current code leaves a retired city official or city manager in a perpetual state of uncertainty. The more time that passes after an individual held office diminishes the benefit of enforcing the ethics code.

The State of Alaska has a five-year limitation from the date of the potential violation to file a complaint of a violation of the Ethics Code. It is recommended the City of Homer enact a time limit for filing an ethics complaint that is consistent with the State's provision.

### **RECOMMENDATION:**

Adopt Ordinance 14-14 to set a time limit for filing a complaint of a violation of the Ethics Code.

Following the October 2013 election a defeated candidate requested a recount of the votes. The process for the recount last year was vague in that it followed the Alaska Statutes for State elections. Homer City Code Chapter 4.45 Election Recount simply states:

### 4.45.010 Election recount.

A recount of an election may be called and, if called, shall be conducted in substantially the same manner as provided for State elections in the Alaska Statutes, including the requirement of a deposit. The City Clerk shall oversee the recount.

This resulted in an inordinate amount of confusion and attorney assistance for a straightforward procedure that can be outlined within the City's code.

### **RECOMMENDATION:**

Adopt Ordinance 14-15 to define the City's election recount procedure.
