Amendment One Cooperative Agreement Number 12-085 Title: Homer Harbor Boat Launch Facility Renovation

Between: Alaska Department of Fish and Game Division of Sport Fish

and

City of Homer

The purpose of this amendment is to revise the original agreement dated April 2012 to add funding for Phase II (construction phase) in order to complete the Homer Harbor Boat Launch Renovation project. Except for the following changes, all provisions of the original agreement remain unchanged and in full effect.

## 1. Change paragraph II.1 to read as follows;

1. To reimburse the CITY for accomplishing the purpose of this agreement in an amount not to exceed \$2,983,300.00. The source of funding shall consist of \$2,237,475.00 (75%) from the Federal Aid in Sport Fish Restoration Act (Dingell-Johnson/Wallop-Breaux) and \$745,825.00 (25%) from state matching funds. Availability of these funds shall be subject to approval of the project by the Federal Aid Office of the U.S. Fish and Wildlife Service (USF&WS).

## 2. Change paragraph III.1 to read as follows:

1. To dedicate to this project, CITY owned uplands and/or tidelands under and immediately adjacent to the launch facility. The parcel shall be used exclusively for boat launch ramps, boarding floats, a parking area for vehicles with boat trailers and other improvements incidental to this project. The parcel is shown on Attachment A.

The CITY warrants that it has the right, power, and authority to construct and maintain the improvements on the parcel and that there are no restrictions, covenants, easements, rights-of-way, or uses which would prevent the CITY from constructing and maintaining the improvements on the parcel.

To provide funds in the amount of \$800,000 for Phase II. The CITY will be required to provide not less than \$800,000 for Phase II. The CITY shall provide all additional funding needed to complete activities covered by this agreement.

## 3. Change paragraph III.2 to read as follows:

2. To complete the construction phase of the boat launch facility funded by this agreement prior to December 31, 2015. In the event the funding provided by ADF&G is not sufficient to cover all costs incurred by the CITY in completing this project, the CITY shall provide all additional funding that may be needed.

To manage and maintain the launch facility for public use until December 31, 2036. The launch facility will be managed primarily for the benefit of the recreational boating and sport fishing public in providing access to public waters; consistent with current management. No change in this use will be made without prior written approval of ADF&G.

Management activities and maintenance services shall ensure orderly public use and keep the facility clean and in a good state of repair. Management and maintenance may be adjusted seasonally commensurate with seasonal public use.

ADF&G will consider the facility closed to the public if the CITY physically denies access, fails to provide adequate management or maintenance or allows incompatible uses of the facility that effectively limits public use by recreational boaters and sport anglers.

## 4. Change paragraph IV.3 to read as follows:

3. ADF&G will reimburse the CITY for accomplishing the purpose of this agreement in an amount not to exceed \$2,983,300.00. The CITY will provide funds in the amount not less than \$800,000.00.

The CITY will be reimbursed only for the cost of work actually completed which is directly related and allocable to the project and which ADF&G has approved. The CITY will not be reimbursed for administrative work or overhead it incurred while completing the project. Reimbursement will be made within 30 days of receipt and approval, by ADF&G, of a request for reimbursement from the CITY. All requests for reimbursement shall be adequately documented. Documentation may include copies of materials invoices, payroll ledgers, equipment logs, contract payments, etc. In the event of a late payment, ADF&G will not pay late fees. Requests for reimbursement shall be mailed no more frequently than once a month to Paul Cyr at:

The CITY shall maintain a separate set of accounting records for this project and shall retain these records for a period of three years from the termination of the agreement. These records shall be made available to the state for audit purposes.

The initial reimbursement request will be in an amount exceeding \$800,000 in order to account for the CITY's contribution. With the exception of the initial and final payment, requests for reimbursement shall be in amounts not less than \$25,000. If the CITY chooses to make monthly billings, such billings will be held by ADF&G until the total amount reaches at least \$25,000.

#### 5. Change paragraph IV.6 to read as follows:

6. The design life of the facility is 20 years; therefore, this agreement shall remain in effect until December 31, 2036.

#### 6. Change paragraph IV.7 to read as follows:

7. Either agency may terminate its involvement in this agreement by written notice to the other at least 90 days in advance of the date on which termination is to become effective. In the event that an agency terminates its involvement in this agreement, defaults in its duties under this agreement or this agreement expires, disposition of the sport fishing access improvements shall be accomplished by whichever of the following contingencies is appropriate:

a. Agreement expires on December 31, 2036:

ADF&G shall have the option to negotiate an extension of this agreement with the CITY for the continued use of the facility for public sport fishing access. ADF&G shall have 90 days after the expiration of this agreement in which to notify the CITY of its intent to exercise this option. If ADF&G does not exercise this option, all improvements shall become the property of the CITY.

b. ADF&G terminates its involvement:

If prior to December 31, 2036, ADF&G finds that there is no longer a need for the sport fishing access improvements covered by this agreement, then this agreement shall be terminated. Improvements funded by ADF&G shall become the property of the CITY at no additional cost to the CITY.

c. The CITY terminates its involvement:

If prior to December 31, 2036, the CITY closes the facility to the public, does not comply with the requirements of this agreement or terminates its involvement in the purpose of this agreement, this agreement shall be terminated and the CITY shall reimburse ADF&G for:

1) the total funding ADF&G provided at the rate of 5 percent for each full year between the date of termination and December 31, 2036.

2) the appraised fair market value, on the date of the City's default, of any land acquired for the project with ADF&G funds.

This agreement shall be terminated when the City's reimbursement to ADF&G is completed. The CITY shall not be required to reimburse ADF&G in the event the facility must be closed to protect public safety because of casualty damage arising from a catastrophic occurrence.

Brianna Allen, Old Town Development Coordinator has requested the Parks and Recreation Advisory Commission support a recommendation to City Council to accept the following for placement at Bishop's Beach Park in the desired locations indicated on the applications.

The Commission reviewed the proposal donations at their regular meeting on June 19, 2014. The following discussions and motions ensued:

## Fanciful Loon Sculpture

Chair Steffy requested discussion before making a recommendation. Commissioner Archibald stated he has received several comments from the public regarding the artwork and it was not favorable. Commissioner Lowney offered favorable comments on the previous work of the artist. Ms. Krause provided information on placement next to the boardwalk from the Public Arts Committee. It was recommended to place in an area away from the boardwalk.

A discussion ensued surrounding the location and that it should involve more public input on the sculpture.

Chair Steffy requested a motion.

LOWNEY/BRANN - MOVED TO APPROVE AND RECOMMEND PLACEMENT OF THE SCULPTURE IN THE SECOND LOCATION RECOMMENDED BY PUBLIC WORKS.

Further discussion on visiting the park and reviewing the sites suggested. The commission expressed concern with placement in the park due to soil conditions. Commissioners MacCampbell, Archibald and Roedl wanted to visit the site. Commissioner Roedl felt location #3 would be better. Commissioner MacCampbell suggested another park would be appropriate such as Karen Hornaday. He expressed concern regarding the placement of such as heavy piece in that environment.

Phil:

Here is a quick summary of what happened:

- 1. There will be a second reading and a public hearing on the sewer rates at the next meeting, June 23
- 2. The Council repeated its interest in finding a way to meter K-City residences. I told them that I and the Public Works Department would continue to work with you on that issue. They are aware that the metering option would be an added administrative burden and that it would likely result in less revenue for the water and sewer fund. However, they think that is really the only way to determine what is fair and equitable.
- 3. In response to your letter, several Council members expressed interest in serving on a Committee with K-City Council members to work on this. The Mayor said that if there was interest in doing that, interested members should bring a resolution to the next meeting that created the committee and appointed members. I can't say if that will happen or not.
- 4. The Council asked the attorney to do some research and report back on the Kodiak model. Kodiak provides water and sewer services to subdivisions and other areas outside of its City limits. The difference is that Kodiak acts more like a regular utility and bills all of the customers directly, even if they are outside of the City limits.



# MANAGER'S REPORT June 23, 2014

TO: MAYOR WYTHE / HOMER CITY COUNCIL

**FROM:** WALT WREDE

**UPDATES / FOLLOW-UP** 

NOTE: Some of these items appeared in the last report. I have updated them and brought them back in case the Council wanted to discuss.

- 1. <u>Town Center Clearing</u>: The Community and the Police Department continue to struggle with illegal activities that are taking place in makeshift camping areas. One of the biggest problem areas for camping and illegal activity is on City land in the Town Center. One of the City lots, directly behind the laundry, is very densely wooded and it is difficult for the Police to see in there, or to leave their vehicles and walk in there safely. We are proposing to do some clearing in that area. The small, densely packed black spruce would come out. Tall healthy trees would stay but be limbed high enough that the police can see in. Carey is talking to the Corps of Engineers about possible permits due to wetlands and to various local contractors about mechanized clearing vs. hand cutting. We will have cost estimates and maybe an action item at the next meeting. Police Chief Mark Robl is prepared to discuss this problem with you in detail. This is a public safety issue that the Police feel should be a priority.
- 2. PARC Committee: This Committee is scheduled to meet on June 18 to provide final guidance on the contract with the selected consultant re: the needs assessment. The guidance will include the scope of work, benchmarks, deliverables, timetables, etc. Once I get that information, I will negotiate and execute the contract.
- 3. Load and Launch Ramp: This agenda contains a resolution which if adopted, would approve an amendment to the Cooperative Agreement between the City and ADF&G regarding repair and replacement work at the boat harbor load and launch ramp. The purpose of the amendment is to clarify and more specifically spell out how Phase II of the project, the construction phase, will work. ADF&G, Sport Fish division has taken responsibility for all of the pre-construction work, engineering, design, permitting, through the bidding process. The City will manage the construction phase. The amended Cooperative Agreement will work like a reimbursable grant to the City. We can get into this in a little more detail at the meeting.
- 4. Green Dot Program: The City has provided support to the Green Dot Program in several ways. You may have noticed the big green dot outside of City Hall. On June 24<sup>th</sup>, I will meet

with Tara Schmidt to talk about Green Dot Training for City staff. I believe this will be important for all City staff members but I want to concentrate first on staff members that have high contact with the public could be in positions where intervening could be helpful. The Library comes immediately to mind.

- 5. <u>E-Cigarettes</u>: Apparently, there is quite a bit of discussion going on about e-cigarettes and whether they should be included as part of smoking ban rules in public spaces. I have to admit, I am clueless on this subject and will have to get more information. Library Director Ann Dixon informed me that there is a discussion going on among Library Directors and Library Associations about how to handle this. Several Libraries have already included e-cigarettes as part of their smoking regulations, including Palmer and Juneau. Ann thought it would be wise to get out in front of this because it is only a matter of time before somebody lights up an e-cigarette in the library (or City Hall for that matter). Ann wanted to know if the City's current code on smoking was applicable and enforceable. Tom Klinkner is looking into that. So, this is just a heads-up that you might be hearing more about this later. The LAB will discuss it as a policy matter at the next meeting. If we change the code, or decide that the current code covers it, it would likely apply to all city buildings, not just the library.
- <u>Safety Training</u>: On Wednesday, June 25, the City will conduct an almost all day safety training for new employees and summer temporaries. We are working hard to create a safe working environment, improve awareness of safety generally, and reduce the City's risk. The City recently formed a safety committee that includes representatives from all departments.
- 7. <u>HR Position</u>: The advertising period for this position closed on June 15<sup>th</sup>. Interviews will be conducted the week of June 23. We hope to have that position filled. In the meantime, Andrea Petersen is still on the payroll and helping us from Reno. Andrea Browning is filling in and helping also, where appropriate.
- 8. <u>Natural Gas Distribution Project</u>: You have probably noticed that the contractors are making good progress on phase two, the bluff area. It is possible that construction of the distribution system could be completed by early August. They will still be working on tie-ins, restoration work, clean-up, and service lines during that period. Only one easement remains to be obtained on Kachemak Drive and we are hopeful work can begin there soon. I think the contractors are doing an excellent job and most of the feedback I hear from property owners is very positive about what they are doing. Enstar reports that they have about 1,500 service lines either installed or applied for and around 900 meters that are "spinning." At the July 28 meeting, I hope to have a progress report for you. This will include a look at the actual build-out, the status of the project budget, preliminary assessment roll adjustments, and information about the assessments. The report will also include a recommended course of action with respect to assessments for condominium buildings.
- 9. <u>Mercer Meeting</u>: On June 17<sup>th</sup>, John Li and I met with Mercer Company representatives to discuss the status of the Health Insurance Plan. They provided us with a comprehensive set of statistics which were very informative. I won't go into great detail here but so far, it looks like the changes made to the program are resulting in significant cost savings for the City. On June 19, 2014 bids were received for the **Homer Harbormaster's Building / Deep Water Dock Trail Boardwalk** project. This work was advertised in the Homer Tribune, Peninsula Clarion and the Anchorage Daily News during the month May.

These projects will consist of constructing a new 4,778 Sf. Harbormaster's Office building located on the Homer Spit's Freight Dock Road directly adjacent to the Seldovia Fast Ferry terminal. The new office building will consist of a concrete foundation and wood framed structure that will extend 15' over slope of the Homer Harbor banks.

The Deepwater Dock Trail Boardwalk will consist of structural cast in place concrete columns and beams that will carry a wood framed boardwalk out and around the southwest side of the Harbormaster's office building carrying trail pedestrians and bicyclists out over the Homer Harbor.
