Hello City of Homer Council Members,

I am writing to express my concern over the developing process to select a building site for the proposed police and fire station. The committee that was tasked with studying and developing a recommendation for a suitable site was given a restrictive set of parameters to which they had to adhere. In doing so it allowed for only one site to be considered: the HERC site. I ask that this single possible choice be expanded in number by liberalizing the criteria that a site must adhere to. Many Homer citizens have made similar suggestions as well.

Another concern that I have is the possibility of the recreational HERC site be rendered unusable and the gym be demolished before it is certain that local support and funding will be solidly in hand to allow a new fire and police station to be built. I am also concerned that it a far distant target to guarantee funding for a replacement recreational facility. I ask that the Council members make a greater effort to avoid sacrificing one community asset to achieve another. I feel that we need the recreational opportunities that we already have as well as agree with the need for better facilities for community fire and safety.

I read in the newspapers today that the continued drop in the price of oil is going to mean even greater decreases in state oil income and ever larger budget deficits. It concerns me greatly that I do not hear from city council members any talk of adopting a more conservative fiscal attitude. How many times can we expect to go before the legislature with our hand out for money to build these public safety facilities and then come again with our hand out asking for more money to build a replacement recreational facilities?

Please reconsider this course of action and know that the community values its access to a safe, effective place to exercise.

To the Homer Gity Council,

I cannot attend tonight's meeting because I am teaching a Community Recreation Gymnastics class. My afterschool Beginning Gymnastics class is currently being held at the HERC building and is full with 18 children and a waiting list. My Intermediate and Advanced classes are held at the High School Mat room in the evenings only, and are also full. These classes are cancelled from time to time with a two week (hopefully) notice due to High School scheduling conflicts.

I have spoken to the Council and the Public Safety Committee that is currently advising the City Council, about my concerns over the speed and one-track method that is being used to select a site for a new Public Safety Building.

I strongly oppose adoption of the resolution to choose the site where the current HERC building is located. Without the support of the public, bringing this proposal to the legislature to ask for money to move forward with this project will be counterproductive. One of the reasons for not supporting the choice of this site is due to the need for community recreational facilities outside of the public schools. Currently the HERC building is filling some of these needs, and a new recreational facility is a far off and not easy to accomplish dream.

I am very concerned that only one site has been chosen for consideration to be used for a new Public Safety Building. A rubric for assessing sites was established. Being over 4 acres was worth 5 points out of 100 but all other sites were eliminated, and not evaluated at all, due to being less than 4 acres. I do not understand why the rubric was not used for all sites, as there was at least one other very feasible site that came close to 4 acres (3.6). There were also lease options that were on the table until the City Council presented and passed a resolution in one meeting, stating that the site for the future Public Safety Building must be owned by the City of Homer.

I am pleased to see that the conversation about recreation in Homer, and its importance to the health and safety of our community, is beginning to see the light of day. I would like to speak to the misinformation being spread by people calling the HERC facility "derelict" and "un-safe". When the subject of asbestos is brought up, it needs to be understood that the asbestos in the HERC building has been encapsulated and is safe. The hazard (and expense) to the public comes when the asbestos is disturbed, as it would be if the facility were to be torn down. Older buildings can be safely used, especially when there is no other option available in the near future.

I would like to refer the council members to the information on the site for the United States Consumer Product Safety Commission <u>http://www.cpsc.gov/en/Safety-Education/Safety-</u> <u>Guides/Home/Asbestos-In-The-Home/</u>. This site covers information about asbestos in homes or buildings, and recommends encapsulation rather than removal of asbestos. Here is a quote from that site:

"THE BEST THING TO DO WITH ASBESTOS MATERIAL IN GOOD CONDITION IS TO LEAVE IT ALONE! Disturbing i may create a health hazard where none existed before. Read this before you have any asbestos material inspected, removed, or repaired."

Where is the flexibility needed to address the inadequacies that face our police and fire department without pitting our citizens against public safety if they are for recreation? How expensive and unsafe would it be to dismantle the present facility? Why is the City Council willing to make a decision to dismantle this facility without waiting for the results of the recreational needs assessment? Why is a shared site for a new Public Safety Building the only option being looked at, if there is only one site that fits the acreage requirements? Why is the process being funneled towards this site and this site only, with little regard to the people bringing their concerns up about the site being chosen? Where is the Democratic Process?

There are so many questions and concerns not being addressed. I am asking the City of Homer to please slow down and come up with answers before moving on with choosing a site for this project. The results from the Recreational needs assessment will be coming out in April, which will provide everyone with a lot more information about the recreational needs of the Homer area. I believe that recreation and public safety are two pieces of the same equation. It would be better to move slowly and have a plan that is based on good information than to go quickly and leave out important pieces that we will regret in the future.

MANAGER'S REPORT October 27, 2014

TO: MAYOR WYTHE / HOMER CITY COUNCIL

UPDATES / FOLLOW-UP

NOTE: Some of these items appeared in the last report. I have updated them and brought them back in case the Council wanted to discuss.

- <u>MAPP Request for Support</u>: Mobilizing for Action through Planning and Partnerships (MAPP) is applying for a \$200,000 Federal HRSA grant to support their work on family issues in Homer. The City Council passed Resolution 12-085 in 2012 in support of the previous HRSA grant application which was funded and was used for strategic planning. MAPP has requested a resolution of support for this grant application as well. Unfortunately, a communication malfunction prevented a resolution from making it on this agenda and the application deadline will have passed by the next time the Council meets on November 24. Therefore, I will go ahead and write a letter of support on behalf of the Council and the City, unless there are objections from Council members.
- 2. <u>PARC Needs Assessment Update</u>: At the last meeting, Matt Steffy, the PARC Chair fielded some questions regarding the PARC initial needs assessment survey. After the meeting, I realized that the Council had not been briefed on the full assessment strategy and the thinking behind it. I asked Julie to write a memo summarizing the research methodology for the Council. That memorandum is attached. I have scheduled a PARC visitor presentation for the meeting on November 24. The purpose of that presentation is to provide an update on how the Needs Assessment is progressing so far. Updates on the community meetings will be included. Also, several Council members have asked recently how arts and culture got added into this assessment when the original intent of the Council was parks and recreation. This was explained to the Council at a presentation early on by Matt Steffy but you may not recall. This issue can also be addressed non November 24. I understand that a PARC representative may also be present at this meeting to make some comments on this topic.
- 3. <u>Harbor Electric Upgrades</u>: As some of you may be aware, the electrical upgrades installed in the harbor had some unintended consequences and the harbor staff have been scrambling to find a solution. Attached is a memorandum from the Deputy harbormaster

to vessel owners explaining that the state has granted a temporary grace period for implementing GFI protection and the requirements of the electrical code.

- 4. <u>Budget Memorandums</u>: The budget is scheduled to be introduced by ordinance at this meeting, October 27.Resolutions on the fee schedule and the Port and Harbor tariff are attached to it. A budget briefing and discussion is scheduled for both the 4 PM Special Meeting and the 5 PM Committee of the Whole. After the ordinance is introduced, it becomes the Council's budget and can be amended as Council deems appropriate. As always, we should have more current revenue information later in November.
- 5. <u>Benefits Consultant RFP</u>: This agenda contains a resolution sponsored by Council Member Burgess which calls for an RFP for benefits consultant services. In most circumstances, I would be totally in agreement with this. Our current contract with Mercer has been for three years. Seeking proposals would be a good idea if we thought we needed these services again in 2015. However, if the Council agrees to move to a fully insured private plan, we may not need a consultant at all. And if we do need one, it would be for a significantly reduced fee and scope of work. This is what we recommend. Given that the contract would be smaller, we have an already established relationship with Mercer, Mercer is familiar with the City, its benefits, and its employees, and we could use help with the transition, we recommend a smaller contract, for six months or a year, and that we stay with Mercer. In my view, they have provided excellent service.
- 6. <u>Natural Gas</u>: We are working with Enstar to finalize the total construction cost, checking the preliminary assessment roll, and other activities. Council can expect a report on the Natural Gas Special Assessment District at the next meeting on November 24.

Recently, a few more questions about the needs assessment have come up; what about the HERC building, and why are we assessing art and culture. The purpose of this memo is to address them as time allows. A full project update will be presented to Council at the November 24th meeting.

The HERC and the Needs Assessment

With the decisions about the new Public Safety Building, there is also a discussion about the HERC building. These discussions will continue as options are explored on that site. The Needs Assessment is not going to answer all our questions about the HERC building, nor should it. The Assessment WILL provide our community and decision makers with information, from which to make these future decisions about the HERC.

The consultants wrote a little bit about the HERC:

"The needs assessment provides an opportunity for us as a community to step back from individual projects and look at the universe of PARC programs and facilities in the Homer area. This allows us to see where participation has been shifting among programs and facilities, and where the potential lies for new ways in how we coordinate our PARC amenities. It is relatively easy – and useful – to focus attention on a physical building as a future home for our community's dream programs. The prospect of a physical space, helps us to imagine and define in very real, concrete terms what we hope to achieve. However, there may be other alternative spaces that could work as well or even better than a proposed new facility for the programming we are trying to maintain. These types of opportunities will be explored through the needs assessment, and will lead to better facility management down the road, whether for new or existing facilities."

Art and Culture as Part of the Needs Assessment

(With input from Kate Crowley, ReCreat Rec)

Funding for the needs assessment was awarded after the budget discussions last year. The Pratt was on the chopping block and the City was expressing the need to address the constant lack of funding for what they referred to as "extras". With the inclusion of the Arts and Culture community in the funding discussion, it seemed relevant to try and problem solve the lack of municipal funding from year to year. Also, the research and comparisons of Recreation Departments in similar sized cities are not just Parks and Recreation departments anymore...they include Arts and Culture. Reliable municipal funding for such programs helps to secure other sources of funding and can cancel out duplicity of asking and giving to such programs.

Attention Vessel Owners and Operators:

The Homer Harbor has temporarily disabled the GFI protection on the new shore power electricity in the mooring area known as system 5 (accessible by ramp 8). This is the dock utilized by crabbers, tenders, and freight vessels.

The state of Alaska recently granted the Port of Homer a grace period through August 15, 2015, to disable the GFI protection and allow for our customers whose ships' electrical systems are not compatible with a GFI protected electricity, the time to plan and budget for the work necessary to retrofit their electrical systems in order to become GFI compatible. The state recognized the urgency of the situation, that being, even if all of our affected vessel owners were ready to proceed, the source of materials and professional expertise are limited in our community, and the work could simply not be completed before winter sets in.

The bottom line is, we have completed our shore power electricity system upgrade per the state of Alaska electrical code requirements, effectively tripling the number of services available, and our fleet currently has the access to the shore power it needs.

Subject: It is proposed that Heliports and Helipads will be allowed a Conditional Use Permit in General Commercial 2 along Kachemak Drive, and that Helipads will be allowed a Conditional Use Permit in Marine Industrial on the Spit.

Reasons for additional numbers of helicopters to land and take off along Kachemak Drive is not given, therefore passing an ordinance to allow these helicopter landings makes no sense. Helicopters are already allowed on the airport where they already obtain fuel, so why would one need any other locations to do the same things within just a mile or two? Helicopters are very noisy as are all the airplanes that use the airport, which decreases the property values of all of the private residences in that area. It makes no sense to allow for the increased amount of traffic and noise for those landowners to tolerate.

The use of helicopters on the spit is not explained either, but whatever the reason might be it is not likely to prevent the helicopters from beginning and ending at the airport like the others. The presence of large numbers of shorebirds on the spit is a good reason not to allow the use of helicopters there, especially in the spring months. But there are shorebirds along with several other species present on or near the spit nearly ten months of the year. The portions of the spit labeled conservation cannot be separated from the non-conservation areas to allow the presence of helicopters near one and not the other, which makes it difficult to use helicopters across the spit without affecting all of the various portions.

The Homer area has become home for a large number of eagles since they were artificially fed on the spit over winter for many years. This was a result of human activity. The use of helicopters is another form of human activity. The large number of predatory eagles has lead to an annual loss of some prey hird species. The presence of the airport also has an effect on hirds of various species during the year, and the effects are always negative. The airport is being tolerated hecause it provides more advantages than disadvantage for the people overall. The addition of helicopters in more of the area than they presently use would just he another prohlem for the birds. Many helicopters are already flying out of the airport every day. We cannot keep affecting wildlife in negative ways without decreasing their numbers even more than we already are in too many ways throughout their ranges across their world. There has to be a limit. I think this limit is close to being met here, at least with all the eagles, airplanes and helicopters.

I must ask that these requests for ordinances be denied.

I want to add my concern and objections to allowing helipads and heliports to Kachemak Drive and to the Homer Spit.

I have lived in Homer almost 20 years and am newly retired. This summer I spent a considerable amount of time on the spit and around Beluga Lake. I was amazed at the amount of birds and wildlife I observed, and amazed at the number of tourists that I met. I noticed that while the floatplane activity had no effect on the various birds in and around the lake, any helicopter activity stirred them up, causing most to take flight. I witnessed a helicopter practicing picking up huge loads of water on different days, disturbing the shorebirds that were in the grassy area at the east end of the lake. The helicopter was not near them when it picked up the water, but disturbed them as it flew over. With the critical habitat on the spit I am fearful that allowing helicopter landings out there will disturb and/or destroy nesting birds and resident birds. This is turn hurts the economy of Homer, as this area is well-known as a birding hotspot. Many of the tourists I met were here specifically to 'bird.'

We have an airport and there is plenty of space there for helicopters. If there are tourists or residents who would like to charter a flight across the bay, the helicopter company merely needs to do as the fishing charters do...set up an office and advertise on the spit, or around town, and then transport their clients to the helipad at the airport. In addition, in case of an accident, emergency responders would have easy access in case of an emergency, as would clean-up crews in case of environmental problems.

As a resident of this city I strongly object to helicopters taking off and landing anywhere other than the airport. I live right next to the hospital and I know exactly how much noise and wind (and the duration of both) a helicopter causes. While I have no objection to the helipad at the hospital I see no reason for helicopters to be based anywhere other than the airport.

I am opposed to heliports in areas of Homer other than the airport and the hospital. I do not support allowing helipads in the Bridge Creek area. Even though Conditional Use Permits (CUPs) will be required, I object to the additional noise helicopter take offs and landings would bring to parts of town that are now relatively quiet, the increased hazards to surrounding properties in case of an accident, potential reduction in property values nearby residences may suffer, and finally, the lack of certainty for property owners as to whether or not their properties may have a heliport nearby.

Helicopters are a contentious issue. Other communities have grappled with this problem. One common complaint about helicopter businesses, particularly flightseeing, is noise. I can imagine the frustrations property owners who currently enjoy relative peace and quiet but are adjacent to areas that were zoned commercial by the city will have if a helipad is granted a heliport CUP nearby. I believe the city is better served by keeping this noisy and potentially dangerous activity in the airport area where there are already emergency response vehicles in case of a crash or fire.

If the business requesting a CUP is a flightseeing business, the noise from many take offs and landings will be a huge annoyance to all neighborhoods surrounding the helipad. Conflicts will increase as Homer grows.

Bringing helicopter flights to other parts of the community that were not meant to be a flight zone for frequent helicopter landings is an unreasonable use to impose on those that would have to live with it. These helipads could conflict with and impact nearby Conservation Areas set aside for bird habitat. Also, the FAA would not be controlling the take offs and landings at heliports, an added concern. The airport is in a convenient location, so it would be sensible for companies needing helicopter support to be sited there.

Let's not mix this incompatible use right into the midst of our community. We are truly fortunate not to have this noisy industry plunked down in commercial zones where there are already people living in nearby neighborhoods who have invested in their homes. Dear Commission Members:

Kachemak Bay Birders, a Homer-based birding club, wishes to comment on the Conditional Use Permit Application 13-07 from Eric Lee to establish a heliport on the Homer Spit. Based on our knowledge of birds in the Homer Spit area, we believe that a heliport meant for general aviation (which is what is being proposed) poses a very high risk to both people and birds. In addition, we know from our observations on the Homer Spit that low flying helicopter traffic is more disruptive to migrating birds than planes, often causing evasive flight.

Not all species of birds pose significant risk to aircraft but large, gliding birds definitely do. Gulls and eagles, which routinely glide up and down the spit at low elevation while foraging, will be particularly risky to helicopters that are landing and taking off on the spit. This situation is totally dismissed by the applicant when he says; "The helicopter creates no more of a hazard than the many aircraft that fly transit the spit to get to and from both the Homer Airport." The aircraft he refers to are not flying at the same elevation as these birds. Not being aware of these subtle differences seems to us to increase the potential for a helicopter/bird collision.

For the past five years the Kachemak Bay Birders has been monitoring the spring shorebird migration on the Homer Spit. Our protocol asks the observer to note any disturbances to shorebirds. From these observations we know that helicopters are more disruptive than planes because their flight pattern approaches flocks of birds feeding and resting in the intertidal area. Only planes taking off are noisy and their flight pattern and noise is away from, not directed to the birds. Numerous scientific studies (available upon request) have documented the disproportional impact of belicopters on migratory birds, compared to fixed-winged aircraft. Again, the applicant over generalizes and does not seem to be aware of what is or is not a risk or disturbance.

We are concerned that the disturbance of a helicopter pad on the spit to migratory shorebirds might reduce the value of Homer as a destination for eco-tourists and birdwatchers, especially during the shorebird festival. Other communities in the region (e.g. Kenai, Seward, Cordova, Yakutat) are beginning to cash in on their migratory birds to attract visitors, sometimes in direct competition to our popular Homer events. Increased helicopter traffic on the spit would devalue Homer as a destination for human and avian visitors alike, resulting in very tangible negative impacts for the Homer business community.

Unfortunately, the FAA does not oversee development of heliports for general aviation use. The FAA says in its Part 139 Airport Certification document that "it is not in the public interest to certificate heliports at this time and has exempted operators of heliports from complying with Part 139 requirements... Heliports typically are used by general aviation operators and serve very few air carrier operations....Congress has not given FAA the authority to certificate facilities serving general aviation operations." This means that the burden and knowledge needed to avoid the risks and liabilities associated with this Conditional Use Permit Application now rest with the Homer Advisory Planning Commission. We urge that unless you feel absolutely certain that there will be no risk or nuisance resulting from the proposed heliport that you take the rational precautionary approach and deny the Conditional Use Permit 13-07.

Also, we note that denying this permit application does not preclude offering helicopter services in the Kachemak Bay area. Helicopter service will still be available at the Homer Airport. Though travel of an extra mile or two from a cruise ship may not be as convenient, the extra convenience of a heliport in the middle of the spit is not at all worth the risk and nuisance to the public and birds.

I am opposed to helicopter facilities in additional areas of Homer, that is, in any other area besides the hospital and the airport. Permission should not be given for any additional facilities on the Spit or on Kachemak Drive.

I believe additional helicopter sites in Homer would have a major impact:

Increased noise over the town, especially bad in adjacent neighborhoods and below the flight path for takeoffs and landings. Research has shown that helicopters are much more disruptive to people and wildlife than fixed-wing plane flight noise.

Increased danger to neighborhood residents and property and to small planes in the vicinity. Away from the airport, there would be no flight control.

Decreased property values surrounding each facility and the threat to future neighborhood development of not knowing where/when these might be built.

Decreased desirability of Homer as a tourist destination. Homer would eventually become a very noisy place to visit especially out on the spit.

Potential negative effect on and disturbance of migratory birds and wildlife in these areas.
