SUBJECT: TASMANIA COURT SEWER IMPROVEMENT WITHDRAWAL OF

OBJECTIONS - RESOLUTION 21-045

At the May 24, 2021 City Council meeting Council postponed action on the Tasmania Court Sewer Improvement Special Assessment District at the request of City Staff as an effort to hold a neighborhood meeting to provide new information regarding the project. At that time, property owners who would bear 50% or more of the assessed costs had filed written objections.

The neighborhood meeting was held on June 3, 2021 and property owners were given until June 13, 2021 to advise the City if they wished to withdraw their objection.

Three property owners withdrew their objections bringing the ratio below 50%. The estimated total cost to property owners is \$222,200 and the property owners objecting is reduced to \$60,600, which is below the 50% outlined in City Code.
