SUBJECT: SUGGESTED AMENDMENTS FOR ORDINANCE 22-74 AND 22-82

These proposed amendments are based on Council's discussion at the November 14th worksession.

Amend Ordinance 22-74 as follows:

I move to amend Ordinance 22-74 to make the current section 2 new section 3 and a new section 2 to read - The City Manager is authorized to negotiate and execute a contract with Alaska Industrial Services for installation of the required ammonia lines and valves.

Amend Ordinance 22-78 as follows:

I move to amend Ordinance 22-78 lines 22 through 26 to read - Whereas, Revenues from day use fee parking in the lots that adjoin the State Right of Way may only be used for to reimburse the Port Enterprise fund for parking improvements; and

Whereas, Those revenues will be transferred back into the Port Reserves to reimburse the enterprise for the infrastructure improvement expenditure at the end of the year budget close out; and
