#### **COMMENTS OF THE CITY MANAGER**

Interim City Manager Jacobsen stated that the Clerk's Office was interested in discussion items for the Joint worksession with Port & Harbor Advisory Commission on April 15<sup>th</sup> at 5:00 p.m. noting that the Commission did not have any pressing topics to suggest and Councilmember Erickson recommended discussion on the large cruise ship scheduled for end of June and the infrastructure available to support the landing.

Mayor Castner complimented the Interim City Manager on a job well done. He provided the vacancies on the Commissions and Boards as follows: Parks, Art Recreation and Culture Advisory Commission, Library Advisory Board, Economic Development Advisory Commission and the ADA Advisory Board.

## COMMENTS OF THE CITY COUNCIL

Council member Lord commenting she was loving the sunshine and expressed her appreciation for Melissa and Staff during this interim period, it was super appreciated. Commented on the Homer Foundation and the process used for the grants provided under the City Grant Program. Ms. Lord commented on the services and value the non-profits provide to the City although they are somewhat derided in this town as there are so many, but that those same non-profits bring in 7.1 million dollars in revenue, 100 employees with 4.1 million in payroll within the city of Homer, noting that was a big deal. Ms. Lord expressed her thanks to Council for allowing her the opportunity to travel to Washington DC to lobby on behalf of the City and expressed her thanks for Ben being willing to hold down the fort while she was gone; commented on presenting to the House Transportation Committee, noting that it would be via Zoom, not in person and when she has more information will share with Council and the Community. Ms. Lord suggested that Councilmember Davis and her have discussed briefly about a financial plan or policy with the Port and Harbor Advisory Commission and could try to pull some draft language to consider.

Councilmember Venuti reported attending a Deaf & Hearing Training Event at KPC and confirmed with Ms. Krause the availability of closed captioning for city meetings and recalled the times that there was many non-profits attending the Council budget meetings to lobbying for funding and expressed her appreciation the work of the Homer Foundation putting a shout out to Mike Miller for his service as he is leaving the Homer Foundation to spend time with family and the ability to provide funding through that grant process. She thanked Councilmember Lord for taking on the trip to Washington DC. Ms. Venuti expressed her appreciation for the successful event on how to run for public office and that if someone was interested but maybe not quite ready to run for public office they could serve on one of

the Commissions or Boards to get some experience. She reminded everyone again of the vacancy on the ADA Advisory Board.

Councilmember Aderhold reported on attending the How to Run for Public Office event noting it was nice not to be in the hot seat, that the event was great and she expressed the discussion was interesting. Ms. Aderhold expressed her hope that they can get that last seat on the ADA Board filled soon as she almost shouted out that the event when Ms. Jacobsen mentioned the vacancies on the Commissions and Boards that it was the most fun. She also reported attending the Open House for the Comp Plan and was impressed on the number of people who attended the event and while she did not comment on anything she did look at the comments that others provided and it was evident that people are really thinking, expressing that she is looking forward to future events and appreciates everyone who had participated. Ms. Aderhold announced a film showing of Uniting America developed by the organization Braver Angels at the KPC College Campus hosted by League of Women Voters April 19<sup>th</sup> 5:30-7:30 p.m. A film about the political divide in this country.

Councilmember Davis commented that spring was in the air, and there is all this sunshine, the bees are waking up, there is nothing out there for them yet, but they're flying around looking for it. He reported that he will be at the Library from Noon to 1pm on Tuesday, April 9, 2024 for the last Lunch with a Councilmember and he was looking forward to meeting with people.

Councilmember Erickson commented on the recent nice weather enjoying the sun as everyone else. She noted the start of the springtime sports and seeing the kids running around and that they will soon be seeing more bikes and fun stuff happening with everyone anxious to be outside again without all the ice. Ms. Erickson wished everyone a nice couple of weeks.

Councilmember Hansen commented on the Popeye Wrestling being a recipient of a grant from the Homer Foundation and then reported the Anchor Kings holding tournament on April 19-20<sup>th</sup> and that it has been a little while since it was last held and it will be something worthwhile to watch. She then issued a warning to anyone walking their dogs and the plan their route as she took an hour longer than expected due to a moose blocking her intended route.
