DISCUSSION TOPIC(S)

a. FY26/FY27 Budget Discussion – General Fund – Please refer to Supplemental Packet

City Manager Jacobsen and Finance Director Fischer facilitated discussion on proposed draft General Fund Budget for FY26/FY27. It was noted that this proposed budget was focused on the general fund only, did not include any capital projects or reserves. The following points were discussed, questioned, or noted:

- Revenues expected:
 - Property Taxes
 - steady increase year over year
 - bulk of the revenue has been received
 - increase in \$1 million over budgeted amounts
 - Sales & Use Taxes
 - Based on a three-year average
 - Provide more details on the specific components of Line item 13, Sales Tax Comm.
 - Proposed Budget Transfer to HART
- Clarification on the significant increase in Line Item 36, Police Special Services.
- Confirm the pending payment for Line Item 34, Prisoner Care from the State for FY25 reflected amount is approximately ½ of the previous year's fee.
- Possibility of renegotiating Line Item 39 Pioneer Avenue maintenance agreement with the State DOT
- Provide a breakdown of overtime Line 5105 increases for FY27
 - o particularly for the police and fire departments.

- Retirements
- Personnel vacancies causing gaps and overtime is required to do this
- health insurance costs once the benefit broker bid results are received, estimated 12% increase included
- details on the property tax revenue projection model for Council review.
- Prepare a draft budget for the next meeting,
 - o status quo version and a version with potential cuts.
 - Will be meeting with Department Heads regarding potential budget cuts
- Increased line items are due to inflationary pressures
- Deficits for FY26 is \$694,563 and FY27 Is \$596,563
- Does not reflect transfers for Capital Projects or CARMA funds
- Proposed budget does include 2.2% COLA for FY26 amounts to \$186,555 and FY27 is \$190,336
 - o The City reviews COLAs every year
 - o Employee Committee has recommended a 2.2% based on the Consumer Price Index (CPI)
- Concerns expressed on maintaining a conservative budget

- Clarified the intent and purpose of this ordinance was to reimburse property owners for the lift stations they paid for but did not receive since there were no structures on their property.
 - o Cannot install lift stations on vacant land due to effects of freeze and thaw to infrastructure.

Ordinance 25-30, Amending the FY25 Capital Budget by Appropriating an Additional \$57,073.12 from HAWSP for the Purpose of Reimbursing Six Property Owners in the Bunnell Ave/Charles Way Special Assessment District for the Cost of E-One Lift Stations.

- Clarified the intent and purpose of this ordinance was to resolve the issue for property owners within
 the Special Assessment District who improve their properties and install lift stations and reimburse Mr.
 Long for his expenses installing his lift station.
 - Mr. Long's reimbursement was higher due to the extended period he waited while the City figured this issue out.
 - o This also sets out the period of time for reimbursement.

Ordinance 25-17(S) Accepting and Appropriating an FY24 Transportation Program Grant in the Amount of \$1,100,000 from the Denali Commission for the Purpose of Completing Design and Permitting for Homer Harbor Critical Float System Replacement Project with a Local Match of \$1,105,000 and Authorizing the City Manager to Execute the Appropriate Documents.

- Expressed appreciation for the memorandum provided by Special Projects and Communications Coordinator Carroll and did not have any further concerns.
- Reaching out to our Congressional Delegation to express how important these projects are and the grant funding as the City has put a lot of work and effort towards these grants to be told yes then maybe.
 - Meeting with Murkowski office to review concerns

- May be able to amend the grant to work for complete streets and safety component that would comply with Executive Order guidelines.

- Property Assessments have been distributed and deadline for appeals is April 1st contact the Assessors
 department at 907-714-2230 with questions and concerns, sometimes they can address things right
 away over the phone.
 - Board of Equalization Hearings will be scheduled for mid-April for items not able to be addressed by the Assessor department informally.

- There was a lot of new construction on the southern peninsula specifically Anchor Point, Homer and East End and folks are still building. There was a 4% increase in vacant land in Homer or on city lots.
- Budget presentations have started with service areas meeting with the Mayor, emergency departments asking for additional staffing and may result in a mil increase on property taxes
 - o 2-2.5% inflationary budget
 - o School District Budget is a really big topic and the request should be presented in mid-April
 - Comments received regarding a similar action employed in California regarding valuation freeze and that is a State action, the Borough cannot effect that action only the State can freeze the amounts.

COMMENTS OF THE MAYOR

Mayor Lord had a fun weekend with her family at the Winter King Tournament, enjoying food trucks and watching people participate. She also attended a performance of "Singing in the Rain" by Homer High School students. She mentioned challenges faced by people wanting to get involved in the community, suggesting options like the Chamber of Commerce and arts communities.

COMMENTS OF THE CITY COUNCIL

Councilmember Hansen commented on attending the Kachemak Bay Recovery Connection meeting, and the amazing program and services that are provided for the Homer area.

Councilmember Erickson shared excitement for the outdoor activities in this favorite time of year, including events like The Epic with 125 attendees, Snomads Fun Run utilizing ATVs due to snow absence, the Slush Cup, Singing in the Rain musical, upcoming family fun day at Caribou Lake, and anticipating April blooming.

Councilmember Davis praised the Homer High School Choir, with his children involved, for their exceptional performance. He also announced a job fair on March 28th, organized by the Chamber of Commerce and Marine Trades Association, and a documentary screening about the Israeli-Palestinian conflict in April.

Councilmember Aderhold recently discussed the Exxon Valdez oil spill anniversary and a captivating radio play at Porcupine Theater, soon to air on KBBI. She acknowledged the outdoors' appeal but highlighted recent tragic deaths and accidents, advising caution due to hazardous conditions like avalanches and melting ice in the high country. Aderhold emotionally attended the decommissioning of the Naushon, a significant Island Class cutter with a remarkable Coast Guard history, describing it as a poignant and tearful event.

Councilmember Parsons praised city commissions and boards, highlighting a recent Planning Commission meeting, actions on the Farmwald right of way vacation that garnered no public comment compared to a similar action, and Library Advisory Board addressing the IMLS issue. He thanked the Clerk's Office for their service and appreciated the City Manager's work.

Councilmember Venuti discussed the Chamber of Commerce's handout, events calendar, donations, and peony plants. She shared memories of the Exxon Oil Spill and the 1964 earthquake, prompting concerns about the city's water supply. She advised listeners to prepare emergency kits with pet food and wished everyone a happy spring.
