# Western cities try to cut light pollution


# Hitting the dimmer switch on city light helps animals and skygazers, too.

The next best chance for Westerners to see shooting stars is coming soon, between April 16 and 25, when the Lyrids meteor shower, one of the oldest known, will streak across the sky after midnight. In May the Eta Aquariids arrive, followed by the Delta Aquariids in July, and then the most spectacular of the year — the Perseids, fast, bright meteors, up to 200 an hour during Aug. 12 to 13, and the Geminids, kid-friendly because they show up soon after dark, from Dec. 7 to 17. But none of these, of course, will be visible without sufficiently dark skies.

For most of us, that will mean traveling far outside city limits to a place away from streetlights and other artificial illumination. But in some less-populated places, like *High Country News*'s western Colorado hometown of Paonia, the Milky Way's glow can be seen on any clear night. That's because Paonia is a tiny town in the high desert, with just 1,500 residents surrounded by public lands, orchards and farms.




Map of North America's artificial sky brightness. The New World Atlas of Artificial Night Sky Brightness

Natural darkness is important for a lot more than just stargazing, though. It's also vital to scientific astronomy studies, migrating birds and night-flying insects. And exposure to blue-rich light at night, from computer screens and outdoor LED lights, <u>disrupts people's sleep cycles and may even contribute to cancer</u>. At its January meeting, the American Astronomical Society <u>passed a resolution</u> "affirming that access to a dark night sky is a universal human right, making quality outdoor lighting a worldwide imperative."

Some bigger Western cities have put a lot of effort into curbing and redesigning their light usage so that they can have dark skies, too. Flagstaff, Arizona, passed the nation's first dark-sky ordinance in 1958, to preserve starry conditions necessary for research at the Lowell Observatory.

That nearly six-decade-old effort seems to have paid off. Today, <u>nighttime images</u> captured by the National Park Service show that Flagstaff emits far less artificial light than other cities of its size. The 65,000-resident city uses sodium street lights. In contrast to LED lights, which save energy but produce bright blue and white light that washes out stars and planets, sodium lights emit a warm red-yellow light that doesn't contribute much to overall sky glow. Flagstaff also banned commercial searchlights and shielded outdoor lights around schools and shopping centers. In 2001, it became the world's first international dark-sky city, as designated by the nonprofit International Dark-Sky Association.




Nighttime observations taken in July and August 2016 show light pollution from Flagstaff, top, and Cheyenne, Wyoming, bottom. National Park Service

Other Western cities, following Flagstaff's lead, are making an effort to turn down the wattage and return to darker skies. Last year, Phoenix voted to replace the 90,000 lights on its streets and parks with LEDs that have a more yellow hue than the standard blue-white LEDs. Los Angeles also adopted a plan to phase in warmer-colored LED lights, as did Montreal, Canada. "No one is saying that cities shouldn't be well lit," noted astronomy author Bob Berman recently told NBC. "Everything has its time and place, and the same is true of light and darkness. And there is a place for darkness, and, I think that is slowly being realized."

That's true for national parks as well. Because dark skies and all that they entail are such an integral part of an outdoors experience, and because parks offer some of the darkest skies still to be found, the National Park Service is studying how different types of lighting affect the natural world. Its Natural Sounds and Night Skies division has tracked light pollution in parks for years; development and <u>oil and gas production are driving the largest increases</u> in nighttime glow. Some public lands are trying to cut down on the artificial light – near northwestern Colorado's Dinosaur National Monument, energy companies will have to <u>shield bright lights on rigs</u>. (Congress, however, is moving to <u>weaken the National Park Service's ability to oversee oil and gas drilling</u> within park boundaries.)

To monitor light pollution, the agency has developed a special panoramic camera that produces a 360-degree view of the sky and horizon. It measures the light emitted by cities near national parks such as Flagstaff and Las Vegas; staffers presented the data gathered at the American Astronomical Society's meeting in January. The information will help the agency work with city managers to reduce light pollution. Cities up to 250 miles away contribute to lighter skies in the parks. The neon glow of Las Vegas can be seen from eight national parks, including Death Valley.

Flagstaff's dark-sky efforts, along with those of nearby Oak Creek and Sedona, earned all three towns certification from the IDA as Dark Skies Communities during the past few years. And they contributed to Grand Canyon National Park getting provisional Dark Sky Park designation last summer (to gain full status, it will have to retrofit two-thirds of its roughly 5,000 outdoor light fixtures, which it plans to do by 2019). Three national monuments near Flagstaff, Sunset Crater Volcano, Walnut Canyon and Wupatki, were also designated as International Dark Sky Parks in 2016. The designation recognizes "an exceptional or distinguished quality of starry nights and a nocturnal environment that is specifically protected for its scientific, natural, educational, cultural heritage and/or public enjoyment." About <u>30 U.S. parks have been so designated</u>, most of them in the Southwest.

Nevada's Great Basin National Park gained Dark Sky Park status in spring 2016, and is one of the least-lit places remaining on the continent. That made it the perfect place for the <u>first-ever research-level observatory</u> built in a national park. The Great Basin Observatory, constructed in cooperation with four universities, opened last August. Its 28-inch telescope will be used by researchers all over the country as well as students at universities and high schools, who will aim it remotely through the internet.

Here are a few handy tools for those inspired by the night sky:

The <u>New World Atlas of Artificial Night Sky Brightness</u>, published by Science Advances, draws on NPS research and on-the-ground measurements of night sky brightness, amassed over the past decade of fieldwork in over 100 national park areas. <u>Clear Dark Sky</u> provides forecasts for specific observation sites. <u>Astronomy Calendar of Celestial Events</u> tracks comets, moon phases, meteor showers, eclipses, and more. <u>Dark Sky Weather app</u> that lets you know if it's going to rain or snow in your location in the next hour.

# Some in Government Hill hate a new LED streetlight

Dan and Regine Berube noticed right away when the new LED streetlight appeared on a small side street beside their Government Hill home.

At night, bright white light flooded into the windows and backyard. Regine, a native of France used to softer tones in streetlights, started to have trouble sleeping.

That was in November. Now, at night, the Berubes cover many of their windows with light-blocking shades. They also huddled with next-door neighbors. This month, they made the decision to ask the city electric utility, Municipal Light and Power, to remove the light entirely.

City officials are now reviewing the request after the Government Hill Community Council formally backed it this week.

As ML&P crews swap out 4,000 orange sodium-vapor streetlights for the blue-white, energy-saving LED bulbs this year, a priority for Mayor Ethan Berkowitz, such battles may become more common.

At the community council meeting, Dan Berube didn't get support from all his neighbors. Both the council president and vice president voiced concern about the security implications of removing a light.

Municipal efforts to strike a balance between safety, energy efficiency and "dark skies" preferences have played out in other U.S. cities, including New York. A New York Times story last summer chronicled the split between the neighbors who saw LED streetlights as effective in deterring crime and those who saw LEDs as a nuisance.

To manage those issues, the Anchorage utility is turning to technology. This week, ML&P started installing wireless controllers on LED lights in Mountain View and near Merrill Field. The controls allow the lights to be dimmed or brightened remotely. ML&P can also learn which lights have gone out, cutting maintenance costs, officials say.

The dimmers won't be coming to Government Hill until the end of summer or early fall, based on the schedule, Gary Agron, division manager of engineering at ML&P, told the council at its Thursday meeting.

Berube said he'd accept the light being dimmed or repositioned. But he said he was told that removal was the only option in the short term.

Berube works as an energy management consultant for Alaska Community Development Corp., a nonprofit that specializes in energy efficiency and weatherization projects around the state. He's changed a lot of lights in his career.

In his house in Government Hill, Berube purchased a mix of incandescent and halogen lights. He also installed a LED light directly above a shelf by the kitchen.

But there, the light is pointing directly downward, he said.

"You try to direct the light," Berube said.

Berube said he isn't against LED streetlights, which he said are far more efficient and longer-lasting than the old sodiumvapor bulbs. The ML&P project is slated to save about \$350,000 in energy costs and \$50,000 in maintenance each year.

But he has a problem with how white the new lights are, which he says isn't healthy. He believes the city should change the lights to emit softer, warmer light on the red side of spectrum, going from 4,000 kelvin to 3,000 kelvin.

"It becomes a bigger picture, a bigger question as to how the city will look lit up, more white," Berube said.

The city's engineering design manual calls for the LED lights to emit light around 4,000 kelvin. ML&P officials say that's appropriate for Anchorage — they say streetlights aren't used in the summer and there's little difference in the glare from snow between the whiter and the softer light.

Berube also said the lights should be properly designed and positioned in the neighborhood. On his kitchen table, Berube spread out photos, where an oval overlaid on an aerial photograph showed how the LED light was hitting him and his neighbor, Steve Gerlek.

Berube and his wife complained about the old sodium-vapor streetlight, too, which Berube said was installed long ago at the request of another neighbor who has since passed away. ML&P installed blinders to direct the light downward, he said. The new LED streetlight does not have the blinders.

At Thursday's Government Hill Community Council Meeting, Berube made his case. Kyle Stevens, the vice president of the community council, was unconvinced. That side street is dark and Anchorage is facing an uptick in crime, he said.

"Removing and creating a darker spot, where in other areas we're trying to increase lighting ... I'm concerned about the overall impact to the community," Stevens said.



But a former president of the council, Stephanie Kesler, was on Berube's side.

"Do we want to have a Wal-Mart light on every single corner?" Kesler said.

Kesler also questioned who would make the call to ML&P about dimming or brightening lights if neighbors send in opposing complaints.

"It's great we have the technology, but operationally, I think there might be some issues with it," Kesler said.

Agron, the division manager of engineering at ML&P, said complaints about brightness aren't new. People thought the sodium-vapor lights were too bright, and he said the utility expects the same for LED lights.

With Berube's complaint, ML&P staff will review the request with city traffic engineers and street maintenance workers to decide the best way forward, Agron said.

The wireless controls on streetlights are designed to respond to a variety of concerns more quickly and efficiently, Agron said.

Referring to law enforcement's way of alerting the public to a kidnapped child, he said, "If we have an Amber Alert, we can brighten up the whole place so people see it much brighter."

"Or between midnight and 5 a.m., when there's not as much traffic, we can dim even further to achieve greater savings for the city," he said.

The president of the council, Melinda Gant, voted against sending Berube's letter to ML&P. She also said she was concerned about safety, pointing to a crime assessment conducted last fall by an Anchorage police officer who said the neighborhood's alleys were very dark.

The officer, Robin Nave, recommended that residents install motion-sensor lights at the back of private property to light up alleys, as well as "motion or steady lights aimed into parks or wooded tree lines, for homes that are across from them."



Gant was worried that the removal of the light could coincide with an uptick in crime. It would be difficult to go back to ML&P and ask for the light to be re-installed, she said.

"I'm not against security, a safe neighborhood," said Berube, who disputed that crime could prevented by bright lights.

He's against being awake at night with white light coming in the windows, he said.

Correction: The original version of this story indicated that some residents were concerned about the brightness of LED lights as measured in lumens. The residents were rather complaining about the white light emitted by the LED streetlights, as expressed in units of kelvin.

RE: Resolution 17

I am disgusted with the action of three of our council members for introducing this unnecessary and improper resolution. There is not a problem currently, so why make one now. The city is not a social services agency nor a shelter, especially for illegal immigrants. Council needs to focus on more important things such as funding the city, rather than this type of "social justice" resolution, which in itself is divisive of the community - even in it's present toned down form.

There is no discrimination ongoing in the city that I am aware of, and this resolution serves no useful purpose.

I am especially troubled by the councils position on illegal immigrants [take note of the word illegal - they broke federal law when they entered the country].

If this misguided resolution manages to survive in any form, I would request that the following section be amended as follows:

"Be it further resolved that the City of Homer will cooperate with Federal agencies in detaining undocumented immigrants when court-issued federal warrants or immigration detainers (DHS form I-247)<sup>1</sup> or when detainers are issued for "aliens" not in custody [8 CFR 287.7(d)] are delivered."

It should be noted that detention <u>for persons not in custody</u> under 8 CFR 287.7(d) <u>detention is not optional</u>, the federal regulation reads "shall" maintain custody. If the City fails to honor a detainer in those matters, the City is clearly violating federal law.

During my career with the city, I was personally involved with contacting immigration in cases when a known illegal immigrant was in custody. Immigration responded appropriately, and frequently took custody of those subjects. The city did not go out looking for them, but when one came into custody for any number of reasons, we appropriately followed up. I do not know if the current policy has changed, but I sincerely hope not.

Illegal immigrants are not a protected class. If they wish to remain lawfully in the country, they have the option of returning to their country of origin and applying at the US Embassy for a Visa, green card, or to initiate the lawful immigration process, and stand in line like the numerous other individuals seeking lawful entry.

Deportation of illegal immigrants is not harassment. It is merely the enforcement of existing federal law. If you don't agree with the law, then go through the process of changing it, but in the interim don't try to obstruct federal officers from performing their sworn duties.

I am additionally troubled by the current language:

"Be it further resolved that the city of Homer will declare itself a safety net for the most vulnerable members of and visitors to our community"

If that verbiage is intended that the City will shelter illegal immigrants, in effect becoming a "sanctuary city", I strongly oppose that provision. Such action, if applied to sheltering illegal immigrants will almost definitely result in loss of certain federal funds, and I will personally contact DHS and others to request that such funds be withheld based upon your action. You seem to forget that these individuals already broke federal law by entering the country illegally. We need not protect them.

Please return to more productive and less controversial city business, and leave the feel good resolutions alone.

8 CFR § 287.7 Detainer provisions under section 287(d)(3) of the Act.

(a)Detainers in general.

Detainers are issued pursuant to sections 236 and 287 of the Act and this chapter 1. Any authorized immigration officer may at any time issue a Form I-247, Immigration Detainer-Notice of Action, to any other Federal, State, or local law enforcement agency. A detainer serves to advise another law enforcement agency that the Department seeks custody of an alien presently in the custody of that agency, for the purpose of arresting and removing the alien. The detainer is a request that such agency advise the Department, prior to release of the alien, in order for the Department to arrange to assume custody, in situations when gaining immediate physical custody is either impracticable or impossible.

(b)Authority to issue detainers. The following officers are authorized to issue detainers:

- (1) Border patrol agents, including aircraft pilots;
- (2) Special agents;
- (3) Deportation officers;
- (4) Immigration inspectors;
- (5) Adjudications officers;
- (6) Immigration enforcement agents;

(7) Supervisory and managerial personnel who are responsible for supervising the activities of those officers listed in this paragraph; and

(8) Immigration officers who need the authority to issue detainers under section 287(d)(3) of the Act in order to effectively accomplish their individual missions and who are designated individually or as a class, by the Commissioner of CBP, the Assistant Secretary for ICE, or the Director of the USCIS. (c)Availability of records. In order for the Department to accurately determine the propriety of issuing a detainer, serving a notice to appear, or taking custody of an alien in accordance with this section, the criminal justice agency requesting such action or informing the Department of a conviction or act that renders an alien inadmissible or removable under any provision of law shall provide the Department with all documentary records and information available from the agency that reasonably relates to the alien's status in the United States, or that may have an impact on conditions of release.

(d)Temporary detention at Department request. Upon a determination by the Department to issue a detainer for an alien not otherwise detained by a criminal justice agency, such agency <u>shall</u> maintain custody of the alien for a period not to exceed 48 hours, excluding Saturdays, Sundays, and holidays in order to permit assumption of custody by the Department.

(e)Financial responsibility for detention. No detainer issued as a result of a determination made under this chapter I shall incur any fiscal obligation on the part of the Department, until actual assumption of custody by the Department, except as provided in paragraph (d) of this section.

and:

§ 5. Oath of Office All public officers, before entering upon the duties of their offices, shall take and subscribe to the following oath or affirmation: "I do solemnly swear (or affirm) that I will support and defend the Constitution of the United States and the Constitution of the State of Alaska, and that I will faithfully discharge my duties as . . . to the best of my ability." The legislature may prescribe further oaths or affirmations.

To the Homer City Mayor City Council members:

I would respectfully request that the resolution 17-019 not be passed by the City of Homer's elected officials. The city council and the mayor are not elected to be a political entity nor express a given political agenda of one party or another. No one is running for city council based on party affiliation. Being elected to the city government does not give the elected members permission to use that position for political grandstanding. Using an elected city position to promote a political agenda is an abuse of power. Political activism was not the intended power given by the citizenry to elected city officials. The officials are elected to focus on issues that concern the city, not addressing national politics.

It should be noted that this whole resolution came about because of the change of administration in Washington D.C. - a change that has not been welcomed by some of the council members and a segment of residents in Homer. I appreciate that there has been acknowledgement that the majority of voters in Homer who chose to vote supported the current administration and therefore the resolution was rewritten. However, amending this resolution to make it more palatable to those who are opposing it doesn't hide the true meaning and intent of what is being proposed. The resolution does not represent the majority of Homer citizens that chose to vote in the November election. Nor does it represent the majority of Homer community. Because of the scope of this resolution, representation is implied to the community of Homer as a whole and not just the city itself. This is a gross abuse and overreach of power that affects many citizens of the community who don't have the ability to vote regarding city business and city official appointments yet are affected greatly by those decisions and appointments.

The city council needs to put its energy into strengthening our community through opportunities to unite the citizenry instead of further polarizing and dividing our community by proposing politically motivated resolutions.

The bottom line for me, and the reason I am asking that this resolution not be passed, is the Homer City Council's political structure as an elected body does not confer the right or power to use that structure as a venue for expressing disillusionment with the current administration in Washington D.C.

Dear Mayor Zak,

I live outside the city limits of Homer, so I understand if my voice is not given the same weight as a city resident. However, I work in Homer, pay sales tax every week I shop, and do my part for the community of Homer.

I am writing to express my extreme disappointment with the resolution coming before the council on February 27, listed in the agenda under New Business, Resolutions, A.

I understand the feelings of anger and outrage and hate that created this resolution. Many of us felt the same way eight years ago. The pendulum of power always swings, and it is so sad that both sides do so much to foment more and more hatred with each swing. Now the pendulum of power has turned, and this resolution takes hateful, divisive "opposition" to a new level.

I cannot find any constructive purpose that this resolution serves except as a broad declaration of what a monster President Donald Trump is. He may be unlikeable, but he is the legitimate President of our nation. Is this the best way to heal and bring people back together? Is this the best way to govern for all citizens of Homer?

I was not and am not now a supporter of Donald Trump, but I was appalled by many of the blatant lies this resolution contains. Some examples include:

- The assertion that President Trump intends to ban Muslims form entering the US. Most of the billions of Muslims worldwide may enter on visas. Trump only ordered a temporary halt on citizens from terrorist rich zones. This would include Atheists and Christians from those same zones.

- The clause regarding the ACA asserts that the act provides coverage to millions, but fails to mentions the tens of millions, myself included, who lost our insurance because Obamacare phased it out. Many of us have been unable to find replacements.

- The resolution states that the President has issued executive orders to rescind certain women's rights. It is noteworthy that it did not spell out an example, for there is none. President Trump has, as of this date, issued no order restricting birth control in any form, or lowering pay for women, or anything else one might label a woman's issue.

Those are a few examples of many.

Lastly, I wish to point out that the resolution begins by stating the President was elected with no popular mandate. I would remind you that you represent the people of Homer, who voted decisively for Donald Trump as President. This is not the way to heal our divisions. This will only divide further and provoke a great deal more hatred and animosity.
