A RESOLUTION OF THE CITY COUNCIL OF HOMER, ALASKA, ACKNOWLEDGING THE RESULTS OF THE CITY OF HOMER SPECIAL ELECTION HELD JUNE 13, 2017 TO DECIDE THREE QUESTIONS; QUESTION 1. SHALL DONNA ADERHOLD BE RECALLED FROM THE OFFICE OF HOMER CITY COUNCIL?; QUESTION 2. SHALL DAVID LEWIS BE RECALLED FROM THE OFFICE OF HOMER CITY COUNCIL?; AND QUESTION 3. SHALL CATRIONA REYNOLDS BE RECALLED FROM THE OFFICE OF HOMER CITY COUNCIL?; AND CONFIRMING THE CERTIFICATION DATE OF JUNE 19, 2017.
