A. KPBSD After School Program - Eric Waltenbaugh, Principal West Homer Elementary, Todd Hindman Principal Fireweed Academy, and Eric Pederson, Principal Paul Banks Elementary (10 minutes)

Principals Waltenbaugh, Hindman, and Pederson presented to the Council on the need for consistent after school programs that addressed the hardship of afterschool care for our students. The data in the packet from the most recent survey still shows a lot of support from families. They met with the Boys and Girls Club, it was their desire for the club to come in and use the schools and partner with them, but they have declined to open a clubhouse here. They reviewed some of the after school programs available through the schools currently, but they operate two or three times a week for a limited time. What they are hearing from parents is it doesn't meet the need for consistent, quality afterschool care they can count on. The Borough

has agreed to partner and support the program in covering costs for the use and maintenance of the buildings. Their request for the City is to partner with the schools to develop a program like Boys and Girls Club and provide financial assistance for the program. The estimate for the cost of running a program at both buildings will be about \$95,000 per year in personnel salary. The amount is offset based on a competitive pricing of the program.

Brief discussion followed, and Councilmembers Lord and Venuti commented they would discuss this with the City Manager and consider this request.

ANNOUNCEMENTS/PRESENTATIONS/BOROUGH REPORT/COMMISSION REPORTS (10 minute limit per report)

Assembly member Cooper commented the afterschool program is a wonderful plan and envisions it would eventually become a non-profit that could accept donations and funds. She looks forward to hearing more. She reported on the upcoming final budget worksession and reviewed the proposals being considered. The Mayor's budget proposes-

- \$820,000 for the Kenai Peninsula College, it's lower than last year's budgeted amount
- \$100,000 for Kenai Peninsula Tourism and Marketing Council Mayor's a cut from \$306,000
- \$100,000 for Kenai Peninsula Economic Development District up from \$75,000
- \$100,000 for Small Business Development Center from \$94,000

Other budget items being considered by the Assembly meeting-

- School district funding which is still \$658,000 below the cap
- Mil Rate for this year and a 5% sales tax increase
- Facing a \$4 million deficit this year
- Flat sales tax and mil rate for 10 years
- A proposal to raise the mil rate six tenths of 1 mil for this coming year, then half percent sales tax increase on the ballot and if it passes the mil rate reverts back to the 4.5; and if the Borough ever raises mil rate above 4.5, the half percent sales tax sunsets.
- The Mayor's \$4.5 million land trust transfer is up for reconsideration, it failed with the assembly last time.
- Kachemak Silo deed funds are \$8.9 million, the bond issue on the ballot will be for \$3.5 million. It equates to \$1.05 per \$100,000 of taxable value on properties.
- A laydown has been presented for a 12% bed tax, and it would be exempt from Borough sales tax.
- An ordinance to appeal the sales tax exemption for non-prepared foods.

She heard loud and clear from municipalities last week, when the Borough does large or multiple sales tax increases, we hurt the city's ability to raise funds they need. She shared other features of the proposed budget and said the final hearing on the budget will be June 5<sup>th</sup>. She also reported the ordinance amending the hospital boundary has been postponed to June 19<sup>th</sup>.

The Homer City Council passed Ordinance 17-05(A) and 18-24 in the amount of \$671,053 and \$79,452 for the purpose of completing the Greatland Street Extension Improvements. These improvements include extending the road up to Pioneer Avenue, including sidewalks and concrete curb/gutter on both sides, street lights, signing and striping for safe bike lanes, and other improvements identified by the Council.

On May 10, 2018, bids were received for the project. The project was advertised in the Homer News on April 19 and 26 and in the Peninsula Clarion on April 21. Competitive bidding was completed in accordance with the City's procurement regulations.

Two responsive bids were received from qualified firms. The bid results were evaluated and the results are as follows.

Responsive Bidder's Names Amount
Clark Management \$ 665,078.73
Arno Construction, Inc. \$ 702,361.60

Engineer's Estimate \$ 621,194.00

The City's 5% local bidder's preference does apply to this award. Neither bidder meets the definition of local bidder.

The low bid is not within the project budget approved by the City Council. To bring the project in conformance with the budget, Public Works proposes to not award the expensive MMA Traffic Marking bid item (\$68,000). Traditional paint striping will be substituted through a change order. This will bring the project within budget without compromising project intent. Public Works expects the work to commence in June and be completed by August.

### Recommendation:

City Council pass a resolution awarding the construction contract for the Greatland Street Extension Improvement project in the amount of \$597,078.73 to Clark Management, Anchor Point, Alaska and authorize the City Manager to execute all appropriate documents necessary to complete this project.

# Dear Property Owners,

I am writing to provide you with an annual update on the seawall maintenance and finances. As City Manager, I provide this update every January to keep homeowners aware of the status of repairs to the seawall. The report is also shared with Council.

## 2017 Maintenance Costs:

Several storms in 2017 caused significant damage. Due to immediate need to proactively maintain the wall, the City contracts with East Road Services. In 2017 the repair work totaled \$102,125.

## Funding for the maintenance:

There are two accounts dedicated to fund seawall maintenance: 1) the Seawall Reserve Account which is general fund (City) money and 2) the Ocean Drive Loop Special Assessment (ODLSSD). Based on linear feet, the property owners are responsible for 82% of the wall and the City is responsible for 18%. Ordinance 18-05 is before City Council on Monday, January 8th authorizing the maintenance expenditures for 2017.

 The seawall reserve account is general fund (City) money and includes a transfer of \$60,000 in 2012, plus \$10,000 annually (including 2012).

A combined \$273,653 has been set aside for seawall maintenance since 2012 while \$173,678 has been spent, leaving just shy of \$100,000 available for repairs at the end of 2017. Transfers in the 2018 budget (\$10,000 from General Fund and an estimated \$25,000 from property owners) will help replenish the reserves, as long as the weather is kind to the wall in 2018.

<u>Procedure for Maintenance</u>: The City facilitates maintenance, though most of the seawall is on private land and the seawall is not a public improvement. The most effective oversight is for land owners to call when repairs are needed, 235-3170. These observations are invaluable. Due to the unpredictability and the immediate need to do repair; the City hires a local contractor to do the repairs.

<u>No insurance</u>: As mentioned before, because the seawall is not publicly owned, the City cannot insure it and there are no funds available for replacement or major maintenance. Purchasing insurance as a group, as in a Homeowner's Association, maybe available through commercial independent insurance brokers.

Homeowner's Association (HOA): There are many advantages to forming a legal, non-profit Homeowner's Association (HOA). An organized HOA can leverage grant funds for repairs and upgrades. A HOA provides a united voice when quick concurrence from a majority of the property owners is needed. In 2010 articles of incorporation and bylaw were drafted and I encourage you to resume that conversation.

# Ocean Drive Loop Seawall Maintenance Activities Overview

January 2018
Prepared by Homer Public Works Department

<u>Background</u>: The Seawall was constructed in 2002. For the first 5 years it was the Contractor's responsibility to maintain and repair the wall. Since 2008, Public Works has assumed responsibility for maintenance initially using funds provided by the Council – more recently using monies from the Special Service

District.

All maintenance work is completed by East Road Services (Troy Jones) under the direction and supervision of the City Engineer (Carey Meyer). Public Works inspects the condition of the seawall in the fall and in the winter to identify needed repairs. Property owners provide additional, valuable eyes on the wall and call Public Works if repairs are needed.

This year, the wall experienced significant damage, requiring the highest annual expenditure since the wall was constructed, \$102,125. Up until this year, most repairs were along the eastern half of the wall (where storm wave forces are greatest), but repairs have been necessary over the entire wall length. This year, damage occurred along all portions of the wall, including the western and middle portions. Most damage is seen in the bottom third of the wall, little damage has been seen in the upper third of the wall.

The key to prolonging the life of the wall is protecting the fiberglass sheet pile form wave/sand abrasion and making sure that the tie rods/concrete blocks buried behind the wall remain buried. The timber face protects the sheet pile from wave action. When this wood face is damaged or erosion at the toe of the wall exposes the sheet pile, the wall is in jeopardy. Of equal concern, the sheet pile is held in place by the tie rod system; erosion of material behind the wall exposing the anchored blocks could lead to catastrophic failure.

Inspections concentrate on identifying erosion in front of and behind the wall, damaged or misaligned horizontal timber planks, lag bolt damage, and vertical support members deterioration.

### Homer Lead On Youth Group Bio



SUBJECT: DONATION OF A MURAL FOR BEN WALTER'S PARK

At the April 19, 2018 regular meeting the Commission reviewed and discussed and recommended acceptance of the Gift Proposal of a Mural on the Restroom Facilities in Ben Walters Park.

The Commission expressed appreciation for this donation and the youth wanting to take the ownership of the space and is fully supportive of the project.

The Commission voiced concerns regarding the frequent incidents of graffiti, and recommended that an alternative to painting the mural on the building itself be considered by the group. The Commission wanted to make sure that the group was very aware of the propensity of future damage to a mural placed on this facility.

Lastly, the Commission suggested the youth work with Rotary, who has adopted the park and put many hours of hard work into the park.

#### Recommendation

City Council accept the donation of a mural from the REC Room/Kachemak Bay Family Planning Clinic entitled, *Rooted in Respect* with the understanding that the mural could be damaged by future graffiti; the Artist(s) should consider protective measures for the artwork and convey their ideas to the Rotary group who have adopted this park.

She stated that a lifetime of fifteen years is unrealistic because it will most likely become damaged or covered in graffiti. They should have a contingency plan on how to handle the graffiti when it happens.

Commissioner Sharp stated that he likes the idea and believes it would be a good addition to the park.

Commissioner Harrald stated that she appreciates that these kids are taking the ownership of public space. She does have the same concerns that have already been stated as well as another concern for the timeline that they have proposed. She thinks if they are aware of the graffiti in the area and that there is a possibility that their art could be covered, then she doesn't see the harm.

Commissioner Archibald stated he agrees with Commissioner Harrald and he feels that they need to correspond with the Rotary on what they have planned.

Commissioner Fair stated that he agrees with Commissioner Harrald and Archibald. He thinks that it is a positive idea that could benefit this area.

Chair Lowney stated that there is going to be a piece of art that will be done on wood and placed on the pavilion at Bishops Beach. She suggested that the Commission suggest to the artists that they do something like this so they are able to move it and it may be harder to damage.

The Commission discussed the possibility of asking the artist to paint a mural on some sort of platform instead of the wall.

ARCHIBALD/ASHMUN- MOVED TO APPROVE THE MURAL ON THE BEN WALTERS PARK RESTROOMS.



SUBJECT: Land & Water Conservation Fund Grants Project \$263,340.00

I am happy to report that the National Park Service recently approved the Alaska State Recreation Trails Advisory Board's recommendation for Land & Water Conservation Funds (LWCF) to assist the City with replacing Ramp 2 public restroom. The grant will provide \$263,340 in 50-50 matching funds for construction.

Attached is the Grant Agreement and an Ordinance to accept the grant and obligate City of Homer project funds as match. Per Ordinance 17-19 and Resolution 17-067, the City match will come from accumulated Commercial Passenger Vessel (CPV) pass-through grant funds and a loan from the Port & Harbor Reserve account, which will be reimbursed over time from future KPB and State of Alaska CPV pass-through grant distributions.

To minimize construction disruption on the Spit during the busy summer season, the rebuild is planned for the early fall 2018. With design for the new facility currently at 65% and with the LWCF grant agreement in hand, we are on schedule for a fall build.

A 50-50 matching grant from the LWCF in 1972 helped construct the Ramp 2 Restroom we have today. LWCF requires that that there be access to a dedicated public outdoor recreation area which the Ramp 2 restroom would serve. The original grant documents from 1972 dedicated the land immediately surrounding Ramp 2 Restroom for public recreation use. The grant documents also indicated that the restroom would be supporting "beach" activities. Attached is the map of the beach area and access to be dedicated, guaranteeing that the public has access to the waterfront for beachcombing, wading, fishing, sight-seeing, and other outdoor activities.

We are pleased to continue our partnership with the LWCF to upgrade the restroom in support of Homer's exceptional outdoor recreational opportunities.

Vessel owners or operators may obtain a seasonal permit for \$130.00 <u>plus a \$50.00 parking</u> <u>fee</u> entitling a specific vessel and owner to launch from April 1 through October 15. (Reserved stall lessees exempt for the boat assigned to and registered to the reserved stall only, not for other boats owned by the same individual.)

Vessel owners or operators eligible to obtain a seasonal load and launch permit for \$130.00 are now obligated to pay an additional parking impact levy of \$70.00 at the time of purchase parking assessment. Permit entitles a specific vessel and owner to launch from April 1 through October 15 (Reserved Stall lessees are exempt for the boat assigned to and registered to the reserved stall only, not for other boats owned by the same individual.)

Parking assessment is valid for up to seven (7) consecutive days, after which vehicles, boats, trailers must be removed from all port and harbor property for a minimum of 24 consecutive hours in order to be eligible to resume parking.

BE IT FURTHER RESOLVED that the Port of Homer Terminal Tariff No. 1 is amended as follows:

### **RULE 12 - VEHICLE PARKING**

 12.01. VEHICLE ACCESS LIMITED ON DOCKS – It shall be unlawful for any person to operate any vehicle within the Port area except for the purpose of loading or discharging freight or passengers, or while actually engaged in the performance of necessary duties which require the presence of such vehicle on Port property. Any vehicle shall be under the constant attendance of the operator and subject to the rules in this Tariff. It shall be the duty of such operator to immediately remove such vehicle from the wharf or pier upon the completion of the transaction of necessary business. The Harbormaster has the authority to remove any vehicle in violation of this rule at the sole expense of the owner and may be refused further access to any Port property at the discretion of the Harbormaster.

12.02. STORAGE OF VEHICLES – It shall be unlawful for any motor vehicle to be stored on any wharf unless such vehicle shall first have been drained of all gasoline or other liquid petroleum products, except at such places as the Harbormaster may designate.

12.03. VEHICLE WARNING LIGHTS/ALARMS – Maintenance or vehicles working on piers or in Terminal yards, when moving or stationary, in working areas shall display an operating overhead warning light. All maintenance vehicles shall be equipped with backup alarms.

12.04. VEHICLE ACCESS TO VESSEL – Access to a berthed vessel by taxi, van, bus or other vehicle shall not be granted by the vessel without permission of the Harbormaster or designee.

- 12.05. SPEED LIMIT ON PORT PROPERTY Any person operating a vehicle on any wharf area, within any transit shed, warehouse, marine terminal area, or in any other area where cargo is handled, shall not operate at a greater rate of speed than ten (10) miles per hour, unless otherwise posted. During cargo handling or other operations, no person shall operate a vehicle at such speed or in any manner so as to endanger life, limb or property.
- 12.06. PARKING OF VEHICLES It shall be unlawful for any person to leave or park a vehicle upon any portion of any City property outside of designated parking areas or without the permission of the Harbormaster. The Harbormaster shall erect and maintain appropriate signage giving notice that no parking is allowed in restricted areas. Parking of motor vehicles, other than motor vehicles that are cargo, shall be permitted only in those areas designated for such parking. Vehicles are only permitted on wharf areas with the permission of the Harbormaster.
- 12.07. PARKING LIMITS Parking of motor vehicles in areas designated for parking shall be for the time limits specified and posted for those areas. The parking of motor vehicles in areas in which parking is prohibited or the parking of motor vehicles in areas designated for parking beyond the time limits specified are subject to ticketing and towing or impound in accordance with applicable law.
- 12.08. PARKING FEES (SHORT TERM) Parking fees are to be collected at Ramp 1, Ramp 2, Ramp 3 and Ramp 4 seasonally (Memorial Day through Labor Day). Parking fee is \$5 per calendar day. Posted parking time limits will be established and enforced as per Homer City Code.
- 12.09. PARKING FEES -VEHICLES WITH BOAT TRAILERS (7 DAYS) The City owns and provides access to 7 day public use parking for vehicles with boat trailers. Persons with vehicles and boat trailers using the load and launch ramp are obligated to pay a \$7.00 levied parking impact fee at the time of load and launch pass purchase. Persons purchasing a season Load and Launch pass are similarly obligated to pay a \$70.00 levied parking impact fee.
- 12.010. LONG TERM PARKING PERMITS Vehicles over 20' are not eligible for long term parking permits.
- a. Seasonal permits for day use parking (Ramps 1-4): \$250.00.

- b. Long Term parking permits required for vehicles 20' or less parked in excess of seven (7)
   consecutive 24-hour days.
- 121 c. Long Term parking annual permit fee for vessel owners paying annual moorage in the Homer 122 Harbor: fee \$100.00.
- d. Long Term parking annual permit (January 1st through December 31st): fee \$200.00.
- e. Monthly parking permit for vehicles less than 20': fee \$70.00 for 30 consecutive days.
- f. Monthly parking permit for non-commercial vehicles over 20': fee \$85.00 for 30 consecutive days in a portion of Lot 9 only.
- 127 g. Long term parking will be enforced year around.
- h. Parking lot restrictions for long term parking, May 1 through October 1, as depicted on harbor map (Resolution 11-036(A)).

- i. Existing code definitions for restricted parking, vehicles, junk vehicles, and fines for violations apply. Fines, \$25.00 per calendar day, provided that the fine for overtime parking in long term parking area will be limited to \$250.00 fine per calendar year, with \$200.00 of the fine credited towards the long term parking annual permit.
  - j. Failure to pay violations will result in an additional \$25.00 fee per month and any other legal or collection fee authorized by law.

### **RULE 34 – SMALL BOAT HARBOR PUBLIC LAUNCH RAMP**

34.01. BOAT PUBLIC LAUNCH RAMP – The City owns and provides access to public launch ramps. The principal intended use of the LAUNCH RAMP is the launch and recovery of small, boats on trailers. An authorized subsidiary use is the incidental, noncommercial, loading or unloading of goods, supplies or materials. Rate for a single launch is \$13.00 plus the addition of a \$7 levied parking impact fee for a total of \$20.00(see also 12.09); a season pass covering April 1 to October 15 is \$130.00 with the addition of a \$70 levied parking impact fee for a total of \$200.00(see also 12.09). The person who is obligated to pay the fee for using the load and launch ramp must make the ticket verifying payment available upon request, or display the seasonal permit on the port side of the permit holder's vessel. There is a \$20.00 per hour fee for vessels that are left unattended on the Launch Ramp and are blocking ramps. Reserved stall holders are exempt from launch fees for the vessel assigned to and registered to the stall only, not for other boats owned by the same individual. At the Harbormaster's discretion, reasonable restrictions may be placed on the use of the public launch ramp.

TARIFF AND PARKING FEES FOR THE LOAD AND LAUNCH RAMP

The Port & Harbor Advisory Commission reviewed the proposed Resolution 18-041 under New Business at the regular meeting on April 25, 2018. The following is a summary of the amendments to the resolution proposed by the Commission along with an excerpt from the minutes of that meeting:

Adopting the amendments proposed by the Harbormaster as amended by the Commission as follows:

- Striking Lines 25-28 under Public Launch Ramps and inserting the following: Launch ramp customers will be charged \$13.00 per launch plus a \$5.00 \$7.00 per launch parking assessment. Parking Assessment is valid for up to seven (7) consecutive days, after which vehicles, boats, trailers must be removed from all port and harbor property for a minimum of 24 consecutive hours in order to be eligible to resume parking anywhere on public property on the Homer Spit.
- Striking Lines 30-33 and inserting the following:
   Vessel owners or operators may obtain a seasonal permit for \$130.00 plus a
   \$50.00 \$70.00 parking assessment. Permit entitles a specific vessel and owner
   to launch from April 1 through October 15 (Reserved Stall lessees are exempt for
   the boat assigned to and registered to the reserved stall only, not for other boats
   owned by the same individual.)
  - Parking assessment is valid for up to seven (7) consecutive days, after which vehicles, boats, trailers must be removed from all port and harbor property for a minimum of 24 consecutive hours in order to be eligible to resume parking.
- Striking Lines 54 -58 and inserting the following:
   A \$5.00 \$7.00 parking fee will be collected in addition to the \$13.00 per day launch fee when launching a vessel at the Public Launch Ramp. A \$50.00 \$70.00

parking fee will be charged when purchasing a \$130.00 Annual Launch Ramp Pass. Existing (posted 7 day maximum) parking signage will apply to all users.
Implementing the proposed changes as soon as practical allowing staff to change out signage, documents, etc.

### Recommendation

Approve Resolution 18-041 with the proposed amendments from the Harbormaster and Commission.

Excerpt from the April 25, 2018 Port & Harbor Advisory Commission Minutes:

### **NEW BUSINESS**

A. Resolution 18-041, A Resolution of the Homer City Council Amending the Fee Schedule under Port and Harbor Department and Port of Homer Terminal Tariff No. 1 to add a Parking Fee for Vehicles and Trailers Utilizing the Small Boat Harbor Public Launch Ramp.

Harbormaster Hawkins explained that this was on the Committee of the Whole meeting agenda and reported that this resolution will allow them to apply a fee to cover parking for vehicles with trailers at the load and launch ramp.

Harbormaster Hawkins further clarified that this will apply to the Load & Launch Ramp Parking it will be \$13 to launch your vessel and an additional \$5 parking fee, which will be valid for 7 days for a boat trailer. Due to the new system being used they can track things now. Last year if this was applied in 2017 for 7405 day launches and 314 season passes sold in 2017, all of this would have generated \$52,725.

The Commissioners offered comments on potential for complaints regarding the new fees.

Harbormaster Hawkins acknowledged that they will be challenged on the new rates by a faction of the Lunch user group.

Discussion ensued on the free parking areas, parking costs at the top of the ramps and Long Term Trailer parking areas; parking limitations and amendments to the resolution.

HARTLEY/STOCKBURGER - MOVED TO APPROVE RESOLUTION 18-041 AMENDING THE TERMINAL TARIFF FOR PARKING FEES.

Harbormaster Hawkins provided a copy of Resolution 18-041 with amendments that he would like to substitute in response to comment from Commissioner Hartley on proposing amendments to the resolution. He requested the commission review his proposed amendments before making additional amendments to the resolution.

Deputy City Clerk Krause provided copies to the commission.

Dialogue on the following issues ensued:

- Where parking will be allowed
- The seven day rule would still apply
- Additional fee should be viewed as a parking impact fee as such the expenses incurred to enforce the parking requirements
- The proposed fees are allowed by the State as long as revenues are kept separate
- Comparison with Whittier and Seward parking fees.

HARTLEY/STOCKBURGER - MOVED TO INCREASE THE PARKING FEE TO \$7.00 FOR THE SEVEN DAY PERIOD AND INCREASE THE SEASONAL RATE FEE TO \$70.

Discussion followed on the proposed rate; expected complaints; this parking fee structure provides revenue that can be used to fund the improvements; this is step in the process to optimize the space that is available around the Harbor; potential to run into a problem in the future as things get progressively busier; there is minimal is any use of the long term trailer storage on the spit; expanding the paid parking areas; parking within the right of way can be fee parking however revenue must be dedicated to improvements only per the State; the time limit can be modified to correct issues of parking in the right of way; clarification was provided on parking term and removal from port and harbor property for a period of 24 hours before coming back and parking again.

SUBJECT: RESOLUTION 18-041 AMENDING THE PORT AND HARBOR PARKING FEES TO INCLUDE

A PARKING IMPACT LEVY

The Port Commission met on April 25 to discuss Resolution 18-041. Their Motion is included, with proposed changes to 18-041, in a Memo from Deputy City Clerk Renee Krause.

As we all know, the load and launch ramp was recently rebuilt, and in an agreement with Fish and Game 75% of the funding was provided through a federal (Dingle Johnson) sports fish access grant.

Prior to the Port Commission meeting staff had verbal communications with the F&G program manager confirming that proposed changes to collect parking revenues at the Launch ramp would be acceptable. However post commission meeting upon further review of the contract between F&G staff noted that we are required to have, "in writing", the approval of Fish and Game before levying any new charges or fees at the launch ramp.

Staff has prepared the contract amendment between Fish and Game and the City of Homer detailing the proposed parking levy collection at the load and launch ramp, and depending on council's actions will work with Fish and Game to get the amendment signed as soon as possible.

In their motion to city council the Port Commission stated that the new parking fees be implemented "as soon as practical" I would advise that we allow for a two week public notice period, prior to implementation to the current version of resolution 18-041, but I leave that decision with council to discuss and/or change as they see fit.

### Update on Kachemak Bay Critical Habitat Area Plan

Deputy City Planner Engebretsen has been attending meetings on behalf of the City on updating the Kachemak Bay Critical Habitat Area Plan. To date, conversation has focused on docks, floats and permitting. Over the summer, there will be smaller topic specific working groups to work on Fox River Flats trail, Fox River Flats grazing, shore fishery leases, aquatic farms, on bottom mariculture and shellfish seeding, kelp harvesting, etc. Of interest to the City will be discussion on harbor dredging spoils (which is an important aspect of the Large Vessel Harbor project) and Homer Spit specific issues such as erosion control. Harbormaster Hawkins will also participate in these conversations. In the fall, the main working group meetings will reconvene, and review the work from the smaller working groups. ### Lot 3 Adjacent to Jack Gist Lot Sold

In 2016 Resolution 16-133 approved the City Manager to enter into negotiations on the purchase of Jack Gist Subdivision lot 3 to enhance Jack Gist Park. I worked with the City's broker, Angie Newby of Homer Real Estate, on negotiating with the sellers to purchase the lot. In the May 30, 2017 City Manager report I reported that after multiple offers and counters, I believed both parties were still quite a ways apart and requested guidance from Council. The parcel is 2.33 acres on the uphill side of Jack Gist Park and was at the time listed for \$69,500. The 2017 assessed value was \$40,600. The lot has value to the City as property adjacent to Jack Gist Park, however there were no immediate plans to develop the park in that direction. This prompted Memo 17-090 from Councilmember Smith through the Homer City Council directing the Parks Art Culture and Recreation Advisor Commission (PARCAC) to provide development plans for the lot if acquired by the City of Homer. The Commission responded with a number of ideas for the expansion of Jack Gist Park. They also were cognizant of the cost of land and the impact the purchase would have on Parks and Recreation reserve funds and recommended pursuing the lot only if the price fell within 10% of assessed value (\$44,600). The lot recently sold for significantly more, though competitive with some of the previous offers the City had made. The cumbersome nature of our process can be a stumbling block in negotiation. All this means that if Council is very hot on a piece of property in the future, authorization to negotiate and purchase can be given in advance. On the up side, the party who purchase the lot may be interested in bringing water and sewer to

their property and closer to Jack Gist, which would be beneficial to the park as this is a major cost barrier in getting additional amenities at the park.

### Homer Elks Plans to Freshen Up Skate Park

The Homer Elks Club has applied for and received a grant from Elks National Foundation to improve the skate park at the HERC. Local Elks will work with Park Coordinator Steffy to spruce up the park with paint, materials and sweat equity. The park definitely needs some TLC and it is great to see a local organization working on improving youth recreation opportunities.

### Homer Airport Busy for 2018 Season

The next time you fly in-out of the Homer Airport you may observe some changes in the terminal.

- Flying Whale Coffee and Gifts has doubled their square footage offering gifts and coffee. (Resolution 18-030)
- RAVN Airlines has increased their lease area to include more cargo space in the west end of the airport. (Resolution 18-022)
- Alaska Ultimate Safaris helicopter tours will be leasing a ticket counter as a check-in location for bear and glacier tours. This is a short term lease, Alaska Ultimate Safaris will be sharing the space with Pen Air as they don't plan on initiating operations until September.
- Kansas State University is leasing a booth next to Pioneer Car Rental to conduct a survey for the National Park Service regarding visitors experience at Lake Clark and Katmai National Parks and Preserve. This is also a short term lease.
- Pen Air is seeking approval to lease a ticket counter, office and baggage areas, the Resolution to approve entering into negotiations is included in this packet.

The burst of economic activity at the airport is great news for the sustainability of the airport, and has been a major goal of my office. The economic benefit of having a variety of tenants is great for all the businesses and the residents of Homer. That being said, the City still has more space to sublet at the airport terminal. Interested parties can call 907-435-3102 to inquire or visit the City website for information regarding pricing and availability.

### New Police Station Public Education Campaign

Preparations for the public information campaign for the new police station and special election Tuesday, June 26 are in full swing. Thank you to all of you who are taking on parts of this campaign. Upcoming events include KBBI Coffee Table on June 6 at 9am with Chief Robl, Councilmembers Smith and Aderhold; weekly reports on Radio Realty with Tom Stroozas; and a presentation to the Homer-Kachemak Bay Rotary Club June 14<sup>th</sup>. In addition, you will be seeing ads in the local papers, updated articles on the City of Homer website, opinion pieces in the papers written by many of you (thank you!) and public service announcement/advertisements on local radio stations. A post card to all registered voters in City limits will go out just before early voting opens on June 11. I have included the most recent talking points and encourage the public who has taken a great interest in this project to use them when talking to their friends and neighbors. Many thanks go to Special Projects and Communication Coordinator Carroll who has been working with single minded focus on preparations since the passage of Ordinance 18-27(A).

### Promoting the Large Vessel Harbor

Governor Walker was in Homer on Thursday, May 17<sup>th</sup>. Mayor Zak, Harbormaster Hawkins and myself had the opportunity to spend some time with him at the Port and Harbor Building

discussing the Large Vessel Harbor Project. He put us in touch with Commissioner of the Department of Commerce, Community and Economic Development, Mike Navarre. As former Mayor of the Kenai Peninsula Borough, Mayor Navarre is in a great position to have firsthand knowledge about the need for a large vessel harbor on the Peninsula. Getting this project on the administrations radar is important for inclusion in any future major infrastructure bill or bond bill. I also met with Senator Murkowski's State Director, Leila Kimbrel on Tuesday, May 23 and gave her an update on our Large Vessel Harbor project. She had some great advice on how the delegation can participate with the Army Corps of Engineers. As you are aware, our first step in reinitiating this project is the analysis of economic indicators by the Corps approved by Council in Ordinance 18-03. Tuesday the 29th the Mayor, Harbormaster and myself will be meeting with Senator Sullivan's Chief of Staff on the same topic.

### First Quarter Financial Report

Attached is a first quarter financial report for all City of Homer funds. In the future, you can expect quarterly reports in the manager's report for Council review approximately 6 weeks after the end of each quarter (this gives time for expenditures to be property entered, credit card transactions to appear in the accounting system, and bank reconciliation). One thing this report demonstrates is the nature of the cash flow at the City. For General Fund, we are on target with revenue at 21% and operating expenditures at 21%. However, the seasonal nature of business at the Port and Harbor is reflected in the gap between revenue (11% of budget) and operating expenditures (20% of budget). This document is an important way for the City to make sure we are on track throughout the year, don't have painful surprises, and can help forecast trends. Please let me know if you have specific questions regarding the report, as you become more comfortable with the format and the story that the numbers tell will be easier to read. Keep in mind the disclaimer I use whenever discussing unaudited numbers and that they are subject to change.

The treasurer's report is also a useful snapshot of where City of Homer money is invested. You will see that currently 28% is kept liquid in the Alaska Municipal League fund. This fund is accessed regularly when we need cash for regular expenditures (payroll, accounts payable). About 2% is in a money market waiting to be invested long term, and the remainder is distributed among low risk bonds and other investment that are backed by the Federal Government or FDIC. The Finance Director and I are taking a careful look at when bonds mature and holding more cash assets in order to have enough cash on hand to begin spending on the new police station project with passage of Proposition 1 in late June.

Subject: Lot 3 land acquisition north of Jack Gist Park

Via Memorandum 17-090, Council requested PARCAC review the acquisition of Lot 3, adjacent to Jack Gist Park. The Commission discussed the purchase in light of Council's questions at the August 17<sup>th</sup> meeting and September 21<sup>st</sup> meetings. The Commission's conclusions were:

- 1. The land purchase should only occur if the City can buy it at fair market or assessed value. It is not a usable enough piece of land for recreation to justify a high price tag.
- 2. The land could be used to relocate the disc golf facility.
- 3. Land acquisition would help avoid future conflicts with neighbors.
- 4. The Commission would like more greenspace.
- 5. Jack Gist Park does need additional park land.
- 6. The Commission recognizes the need for a long term Jack Gist Park Plan.

In conclusion, if the opportunity arises in the future to purchase this land at no more than 10% over the assessed value, the purchase should be considered.

### 1. Public safety is one of the City's most important obligations.

- Police officers take on great responsibility and face unpredictable, often dangerous circumstances as part of their daily job to serve and protect.
- Our police station provides critical support for their work and public safety.
- Our 39 year old police station is not up to the task. The need is great and has been a top priority for years.

## 2. For the past year, Council has dedicated themselves to listening to the public's concerns and carefully crafting a new plan to bring before the voters. The new plan:

- Keeps costs down by building a smaller facility than the one proposed before, while also meeting essential public safety needs. Cost of the proposed 12,800 square foot building is \$7.5 million.
- Uses a design that allows for future expansion.
- Doesn't displace other uses location is a vacant, City owned lot at corner of Grubstake and Heath
- Maximizes City investment to keep costs to the public as low as possible. We have set aside \$2.5 million (a third of the cost) as an upfront investment, bringing the total amount of construction financing down to \$5 million.

### 3. Council is asking voters for their support of this plan at a Special Election on June 26th. Vote yes on Prop 1.

- Prop 1 asks residents to authorize the City to issue \$5 million in general obligation bonds to finance the remainder.
  - It proposes a year-round 0.35% increase in City sales tax to pay off the bond debt. (35¢ on every \$100 spent.)
  - After the bond debt is paid, most of the tax goes away. 0.05% will remain on the books to fund ongoing maintenance costs of the building. (5¢ in sales tax for every \$100 paid.) These funds are important to adequately maintain the building, protect the public's investment and insure the building will serve us far into the future.

### 4. Reasons why the need is critical.

- Antiquated design creates serious health and safety issues for staff and visiting public.
  - HVAC system routes air from jail cells to rest of the station, passing airborne communicable disease.
  - Prisoners have access to staff areas when being transported; visitors at lobby window can hear patrol office conversations; visitors walk by jailer area creating safety and confidentiality concerns.
  - Prisoners being transported to the visitor area can freely access the exit door, prompting escape attempts.

### Police department has outgrown the current station:

- Over time, call volume and arrests have more than quadrupled. Police personnel has doubled to handle the workload. Staff has been creative at maximizing the space and has adapted to get the most out of the facility, significantly extending the life of the building. But it is overcrowded; areas for expansion have been used up.
- Electrical and mechanical systems we rely on for dispatch and coordinating emergency response have exceeded their capacity and fail to meet the demands of today's technology. Cramped and non-ventilated storage causes premature and costly equipment failures.
- Requirements for processing and properly storing evidence has evolved over the past 40 years too. Evidence
  processing and storage rooms have been filled beyond capacity for many years; we now store evidence in
  Conex trailers on the back of the lot.

### Police station does not meet some basic construction/accessibility standards:

- Not ADA accessible.
- Jail does not meet state and federal standards for separating juvenile and female prisoners.
- Building does not meet today's seismic standards designed to insure our public safety building is up and running when our community will need it most during a major earthquake.



Subject: Composition of HERC Task Force

At the last (May 14th) City Council meeting several citizens expressed concern that no member of either the City Council or the PARCAC was recommended for appointment to the HERC Task Force. At first blush it seems like a no-brainer to include representatives of those bodies. However, in re-reading the terms of Resolution 18-036 establishing the Task Force (April 23 City Council Meeting) it clearly places a heavy emphasis on the TF reviewing the financial considerations necessary to jumpstart the facility into a productive community asset or benefit. This is a skill-set that I doubt any member of those two bodies have any special insight into.

1. Incorporating a member of the PARCAC into the Task Force.

Although the Resolution allowed for the appointment of a PARCAC member, it was not a requirement. Most of the Resolution does not emphasize education or recreation, but directs the TF to explore using the HERC "... to its fullest potential ... " (task 3). Task four, however, does mandate exploring "... building a new facility that meets the recreational needs of the community ... ".

That statement, coupled with the City Council's awareness of the community's strong interest in retaining the HERC for education and recreation purposes is a good argument for allowing a PARCAC member on the TF. Should the Mayor decide to appoint one - and the Council approve - then I believe that Deb Lowney, the PARCAC's selection as their representative, would be a good choice. She seems a thoughtful, reasonable person who's engaged with and committed to enhancing the community.

2. Incorporating a member of the City Council in the TF:

I agree with Councilman Smith's statement from last council meeting that a council-person should not be a member. I think such a member would unduly restrict the free flow of independent thought from other members who would likely feel a sense of deferment. Or the council-person might, in turn, unbalance the discussions by feeling obligated to carve-out a

wider swath in the deliberations of the body than that apprehended in the Resolution.

Lastly, of course, is Councilman Smith's point about the impropriety of having a councilperson vote on approving their own work product.

3. Reference the number of members of the TF, it should be an odd number so that the Chair may break a tie vote. I believe that seven is the magic "Goldilocks" number. Nine would make it too unwieldly, five would unnecessarily dilute the diversity of opinion as well as compromising the ability to maintain a quorum.

As a reminder, I am an applicant for the TF.
