He noted Mr. Ruffner's qualities including his scientific background and objectivity, and he makes decisions for the fish. He's always prepared, asks appropriate questions, is approachable, and explains his point of view and backs up his decisions with factual evidence.

Matthew Alward, commented in support of Resolution 19-004. In his opinion Mr. Ruffner is the ideal board member. He comes from a scientific background, meets with everyone on all sides of the issues, does his homework, and always looks out for the fish, which is number one. He noted Mr. Ruffner would be here tonight, but he's at a Board of Fish meeting.

Tim Moore, commercial fisherman, small business owner, and city resident, commented in support of Resolution 19-004. He's participated at Board of Fish meetings with Mr. Ruffner and his real qualification is his strong interest in supporting habitat issues which is important to the sustainability to our fisheries and the people of Alaska. That's what sets him apart from others.

Steve Zimmerman, city resident, posed a question on Resolution 19-003, if it would also mean any other businesses in the state, such as people sending stuff down from Anchorage, will also be subject to collection sales tax for the Borough or is it just for the online people. He hopes the Council will have some discussion on this resolution.

The Board did some visioning of the library's future and the kinds of qualities they'd like in the next director to bring those vision to fruition. Ms. Finn also noted there is a job posting for a Library Technology Specialist and with the appointment of the new Board member tonight they now have a full board. She also thanked the Homer Bookstore, Spenards, and the public for their Giving Tree contributions, and reported on Flipster Digital Magazines and the upcoming Big Read events at the Library.

- 2. Homer Advisory Planning Commission
 - A. Memorandum from City Planner Re: Update of Transportation Plan

Planning Commissioner Roberta Highland reported the Commission approved a conditional use permit amendment to a site plan and two preliminary plats at their last meeting. She noted their memo to council to start work on a Transportation Plan update. The Commission is working on a coastal bluff analysis, and they've provided support to the Department of Geological and Geophysical Survey for the submission of a two page project summary for FEMA's Cooperative Technical Partners Grant. This will assist the City in reviewing and making policy recommendations regarding development near Homer's coastal bluff. They are also working on a medical district, and will be reviewing their worklist on Wednesday.

Councilmember Lord commented in reference to the Transportation Plan, noting a letter Council received from AKDOT regarding the intersection at Lake and Pioneer on the driveway positioning and its relation to the current plan. She questions if some of the underlying assumptions of traffic engineering changed in the last 15 years or remained the same.

3. Economic Development Advisory Commission

Councilmember Smith reported the Commission continues their work on the Streetscapes and Wayfinding project. They also have talked about the Transportation Plan update and recognize its

importance to the economic development and flow of how things happen around here. They would like to see it move forward.

4. Parks Art Recreation and Culture Advisory Commission

Parks Art Recreation and Culture Advisory Commissioner Robert Archibald, reported the Commission had their last meeting in November. He noted they discussed the two new porta potties on the Spit Trail and additional ADA accessible porta potties will be placed at Mariner Park in the summer, the City taking over lawn maintenance at the parks, and an event to highlight the improvements at Ben Walter's Park on February 8th. More details will be forth coming on that.

He noted he spoke to Public Works Director Meyer about the re-routing of Mariner Park Lagoon outfall so hopefully the Mariner Park beach will improve itself over the rest of the winter.

5. Port and Harbor Advisory Commission

Port and Harbor Advisory Commissioner Steve Zimmerman thanked Council for introducing the ordinance on the LED light improvements, noting the cost savings that will benefit the harbor, and approving the resolutions for lease transfers for the Sport Shed and Happy Face. The Commission discussed both of the leases and support the transfers.

6. Americans with Disabilities Act Compliance Committee

Councilmember Aderhold reported at their last meeting the Committee heard presentations on the new Police Station and gave feedback on accessibility features of the project; and on the universally accessible Poopdeck Trail project. They also discussed timelines for the Transition Plan and hope to review a final draft in March.

PUBLIC HEARING(S)

A. Ordinance 18-52, An Ordinance of the City Council of Homer, Alaska, Amending Homer City Code 4.35.020, Votes Required to be Elected, to more Clearly Define how a Plurality of Votes is Calculated in Councilmember Elections. Smith/Aderhold. Introduction December 10, 2018, Public Hearing and Second Reading January 14, 2019.

Mayor Castner opened the public hearing. There were no comments and the hearing was closed.

Mayor Castner called for a motion for the adoption of Ordinance 18-52 by reading of title only for second and final reading.

ERICKSON/VENUTI SO MOVED

There was no discussion.

VOTE: YES: VENUTI, SMITH, ADERHOLD, LORD, STROOZAS, ERICKSON

Motion carried.

ORDINANCE(S)

A. **Ordinance 19-05,** An Ordinance of the City Council of Homer, Alaska, Amending Homer City Code 2.08.100-2.08.120 Regarding Telephonic Participation at Meetings. Erickson. Recommended dates Introduction January 14, 2019, Public Hearing and Second Reading January 28, 2019.

Mayor Castner asked for a motion for the introduction of Ordinance 19-05 by reading of title only.

ERICKSON/VENUTI SO MOVED

LORD/ADERHOLD MOVED TO AMEND AND STRIKE LINES 72 TO 74, LINE 78, AND LINE 137 THROUGH THE WORD TRAVEL.

Councilmember Lord commented this will maintain the components that clarify that there is some recourse for Council to be able to cut off telephonic participation if there is a bad connection, and will strike the language that requiring Council disclose their reason for telephonic participation.

There were comments in support of the amendment and noting other lines relevant to the amendment that could be deleted as well.

ADERHOLD/LORD MOVED TO STRIKE LINES 13 AND 14.

There was brief comment related to the motion.

VOTE (secondary amendment): NON OBJECTION: UNANIMOUS CONSENT.

Motion carried.

There was no further discussion on the amendment as amended.

VOTE (primary amendment): NON OBJECTION: UNANIMOUS CONSENT.

Motion carried.

STROOZAS/ADERHOLD MOVED TO AMEND LINE 135 TO REMOVE MAXIMUM OF TWO AND GO BACK TO THE MAXIMUM OF THREE.

Councilmember Stroozas commented that allowing three opportunities to participate telephonically has seemed to work. He doesn't feel anyone on this body has abused it and there can be consequences when a member has to miss a meeting.

Councilmember Erickson shared her concern that it's important that members be here. She also has concerns that it costs more when an IT person has to be here on overtime, it's harder when you can't see the person, and sometimes it's hard to hear the person on the phone and she doesn't feel

comfortable cutting them off. It's made the meetings longer because of the telephonic process. She wants to use telephonic as a tool, but not an easy way to be gone.

Councilmembers Aderhold and Lord both commented that they have participated telephonically, they agree that it's challenging to be the one calling in as well so it isn't something members typically do unless they have to. They both commented in support of maintaining the allowance of three.

VOTE (amendment): NON OBJECTION: UNANIMOUS CONSENT

Motion carried.

Councilmember Erickson thanked everyone for the good discussion.

VOTE (main motion as amended): NON OBJECTION: UNANIMOUS CONSENT

Motion carried.

CITY MANAGER'S REPORT

A. City Manager's Report

City Manager Koester commented on two items that were not in her report. First, the Borough has requested City participation in an Election Stake Holders Group. City Clerk Jacobsen will be participating and they've requested a Councilmember participate. She encouraged anyone interested to contact her or Mayor Castner. Second, she reported on legislative updates she's received from AML and encouraged Councilmembers to reach out to her about what they'd like to officially comment on by resolution before traveling to Juneau.

City Manager Koester noted a change in the location of the Senior Officials Workshop & Crisis Leadership and Decision Making Seminar from the college to the council chambers on February 21st.

Councilmember Venuti asked about the City noticing that federal employees who are having difficulty paying their water bill due to the shutdown can contact the city about working with them on deferring payment and not being assessed late fees or shut off fees. City Manager Koester commented the City has been approached by a federal organization and will work with any customer on payment and will post something on the website.

Councilmember Aderhold commented she's willing to participate on the Election Stake Holder's Group unless someone else is interested in taking it on.

Councilmember Lord noted this was also on the Borough Assembly agenda and she appreciates AML's proactive step forward on this, it's something we've talked about a lot. She asked City Manager Koester if she had any feedback on question raised earlier during public comments.

City Manager Koester commented the scope of this project is broad and has to do the the Wayfair decision and how the state can collect from online retailers. She understood the comment to be related to a circumstance where the Borough would be the regulatory body regarding outside city retailers retailing goods inside city limits.

In response to a question on local representation with the AML group, City Manager Koester explained she has participated in the teleconferences and they are meeting at the AML meetings. She can look at other possibilities as the working group develops and report back.

There were further comments in support of AML moving forward looking at state online sales tax.

VOTE: NON OBJECTION: UNANIMOUS CONSENT

Motion carried.

COMMENTS OF THE AUDIENCE

Robert Roth commented he heard discussion on the radio that federal workers don't have to pay their water bill if they have trouble, but when other people have trouble that isn't offered. He also questioned why are they are trying to raise taxes on Amazon and other things when they are offering for people not have to pay their bills.

Debbie Speakman, Homer Chamber of Commerce Executive Director, said she's encouraged by the discussion on sales tax for online sales. She reported the Chamber is working hard on the Winter Carnival coming up on February 9th. With the current government shut down, they are hoping the 50th anniversary of the Coast Guard being here in Homer can go on as planned. She invited organizations and community members to submit their events to the Chamber. The theme this year is Coasting into Winter. She invited everyone to come celebrate and honor the Coast Guard.

Robert Archibald, Prince William RCAC representative, commented they will be holding their board meeting on January 23rd in Anchorage, and will be going to Washington DC and Juneau in March. He encouraged people to contact him if they have any questions about PWRCAC and opportunities available through the organization. He will report back after the Board meeting.

Steve Zimmerman, city resident, clarified his earlier question that he's more concerned about sales in general that come down from outside the Borough that don't get taxes charged on them. It may not fit into the AML project, but it might be something that needs to be addressed. He has a small business in town and has been caught up in some of this as he consolidates freight in Washington and they have a sales tax. People are trying to charge him 10% sales tax on things he's having delivered to a freight forwarder in Washington. It's a lot of money and if the City is giving suggestions to AML, he'd like to suggest they make sure that re-sale is addressed. They have Borough re-sale cards and it's important as it's a hassle on the vendor's side.

COMMENTS OF THE CITY ATTORNEY

City Attorney Wells was not in attendance.

COMMENTS OF THE CITY CLERK

City Clerk Jacobsen had no comment.

COMMENTS OF THE CITY MANAGER

City Manager Koester had no comment.

COMMENTS OF THE MAYOR

Mayor Castner commented five weeks seemed like a long stretch without having a Council meeting. He has an upcoming speaking engagement with the Kachemak Board of Realtors on Wednesday. He thanked everyone for a very nice meeting.

COMMENTS OF THE CITY COUNCIL

Councilmember Stroozas commented he is unable to attend the AML Winter Conference as noted in Memo 19-003. He also commented that Saturday, January 26th from 5:30 to 8:00 p.m., Kachemak Bay Masonic Club is hosting the 4th Annual Spaghetti Feed at the Elks Lodge to benefit Hospice of Homer. Its \$10 in advance \$15 at the door and there will be a silent auction.

Councilmember Aderhold commented she attended Lunch with a Councilmember today. Assembly member Willy Dunn was there as well along with 2 members of the public and they had good conversation about the HEA power line arc fire and City response, Ordinance 19-05, and moving forward with HERC and its benefit to the community. She thanked KPEDD for holding the Industry Outlook Forum in Homer and also the businesses that presented, it was great information and she wished more people had attended. Councilmember Aderhold also congratulated Nita Reardon, a Homer resident who received a 2019 Governor's Arts and Humanities Award for Arts Education. It's a privilege to get to live in a community of people who are so interested in sharing their cultural knowledge through art.

Councilmember Erickson commented she recently worked with Port and Harbor staff on EMT and First Aid type training and our Port employees are really impressive. Not only was it a lot of fun but it's great to know we have such qualified people at the end of the spit. It was great getting to know the staff and see what they do. She enjoyed the Industry Outlook Forum, it was informative looking at what's going on within our state, and great to watch the next generation taking hold of their own businesses and moving Homer forward in some really exciting ways. She shared how much she appreciates what people are bringing to our community, it's an exciting time to be living and being a part of what's going on.

Councilmember Lord thanked KPEDD for the Industry Outlook Forum, it was fun, interesting, and diverse. Next weekend the Alaska Peony Grower Association Winter Conference will be in Homer at Land's End. There will be some pre and post events, she'll be teaching a floral design class, and there will be Lean Farming Management workshop. Council got to see the 35% design of the Police Station tonight and she encouraged the public to take a look at the information and reach to Council or staff with questions or comments. Councilmember Lord commented about her grandmother having a severe stroke over a year ago and passing away recently and the significance of the family caregiving effort. The Big Read book this year, *Can't We Talk About Something more Pleasant?*, is directly related and is an amazing read. The events the Friends of the Library have planned over the next two months addressing these topic are really amazing. She's realizing how common it is for people in our society to be caring for family members at home and appreciates this subject.

Councilmember Smith commented the KPEDD Industry Outlook Forum was enjoyable and also wished they'd had better attendance. He thanked Representative Seaton for his years of service to the community and for the recognitions for Roberta Highland and Robert Archibald. He congratulated Chris Perk for being elected into the Alaska State Sports Hall of Fame. Councilmember Smith also recognized people in Anchorage who were impacted by the recent earthquake. In talking with co-workers who live up there, there are people who have been severely traumatized by the experience and whose homes are no longer safe to live in. These are things we didn't see here, but that may not be the case next time. He gave a shout of support to those impacted by the earthquake encouraged that we need to be prepared to come together when things like this happen.

Councilmember Venuti commented she's happy for the recognitions of Roberta Highland, Robert Archibald, and Representative Seaton. She also commented about the Big Read and that there is so much to do here in the winter. She thanked the people who come to the meetings and those who comment, she appreciates them.

There being no further business to come before the Council Mayor Castner adjourned the meeting at 7:35 pm. 

The purpose of this memo is to authorize the Homer Advisory Planning Commission to spend up to \$5,000 in consulting/engineering services for developing a scope of work and eventual request for proposal for updates to the Homer Transportation Plan.

The Planning Commission reported at the January 14th City Council meeting that they would like access to some of the scoping funds approved in the FY2019 City of Homer Budget to explore different scenarios related to the level of the update including cost estimates. These funds would be used to assess recommended updates and will take into consideration variables such as:

-How transportation planning engineering has changed since the adoption of the plan and how that might influence the plan

-In what ways the plan has outlived its usefulness

-Ability to partner with ADOT and/or KPB with plan updates

The requested funds will be used to present Council with different scenarios that vary on level of effort and cost for a full update of the plan. Every effort will be made to minimize costs associated with this work. Engineering and consulting services will be provided by one of the two firms that has the City of Homer term contract for transportation engineering, Kenny Engineering or HDL Engineering.

The Planning Commission spoke to Mayor Castner about their desire to update the 2005 Homer Area Transportation Plan and added the item to their worklist. Mayor Castner proposed and received approval for funding of scoping activities that could further efforts to update the plan.

The Planning Commission has found that the plan has outlived most of its usefulness. Estimates of population used for the plan have not been accurate and some of the recommendations of the plan have lost support. They would also like to have the plan make more pointed recommendations regarding the usefulness of setbacks on specific streets found in the Central Business District. An updated classification of streets would also be useful for future Right-of-way design.

The undertaking of updating the plan will require an understanding of the costs associated with the levels of work that may be proposed. Initially, the scoping funds might be used to work up cost estimates for likely scenarios. After a recommendation is made about the extent of the plan, funds will needs to be identified to support the update efforts.

Scoping can incorporate funding sources and other opportunities. Our scoping efforts will have to consider the ability to partner with AKDOT. The AKDOT intersection study is of the same time frame and could benefit from updated data and a joint effort to recognize future transportation needs. Funding for the document (a component of the comprehensive plan) may also be available from the borough. In consideration of the likely costs, several methods of funding may have to be considered including accumulation and appropriation of future planning reserves. We may want to plan around the results of the 2020 census and work on funding until the data is available.

I suggest that we utilize funds to scope the costs of the project and develop a timeframe that will be most beneficial for project development and funding.



It has come to our attention that structures subject to increasing regulatory requirements for flood elevation may become noncompliant with height requirements due to circumstances out of their control.

Homer's participation in Federal Emergency Management Association (FEMA) Flood Insurance Program requires that new and rebuilt structures must elevate the bottom floor. This elevation is subject to change and is subject to increases in the future. Compliance with FEMA's Flood Insurance Program is critical for area wide insurance ratings and eligibility for FEMA funding.

The purpose of this memo is to request that the Planning Commission review the topic and consider a height allowance based on FEMA elevation requirements and prepare a draft Ordinance for review by City Council.

REPORTS

A. Staff Report 18-72, City Planner's Report

City Planner Abboud provided a summary of his report.

Introduction : Two adjacent property owners have requested the vacation of a portion of Eric Lane. The requested area is the entire portion of Eric Lane, lying west of West Hill Road, and is approximately 250' long and 80' wide.

Analysis - Relevant Sections of Borough Code:

20.70.170 - Vehicular access.

The planning commission shall not approve the vacation of a right-of-way unless an equal or superior right-of-way for vehicular access exists or will be provided in exchange. Where two or more access points are necessary for large vacant or semi-vacant areas of land, the commission shall consider density, use, projected development, and maintain sufficient rights-of-way to serve potential use.

Staff Response: The proposed portion of Eric Lane to be vacated currently provides public access for a total of three lots. All three of these lots have alternative public access; two of the lots front West Hill Road and a larger 11.5-acre lot has access to Hillside Place.

The 11.5-acre lot is encumbered by a strict conservation easement that prohibits any subdividing or development beyond the existing improvements (a single-family home). The conservation easement prohibits many uses including subdivisions, construction of structures (including additions to existing buildings), construction of roads, and construction of trails/boardwalks. Normally, a lot this size would benefit from alternative access, but due to these restrictions on development, alternative access via Eric Lane is unnecessary for this lot.

20.70.180 - Other access.

Other lawful uses that exist or are feasible for the right-of-way shall be considered when evaluating a vacation request. When such uses exist or could exist within rights-of-way which are not suited for general road use, the commission shall not approve the vacation request, unless it can be demonstrated that equal or superior access is or will be available. The planning commission shall consider whether alternate uses present public safety issues which support approval of the vacation.

Staff Response: No other uses for this right-of-way have been identified.

20.70.190 - Utility provisions.

All existing and future utility requirements shall be considered when evaluating a vacation request. Rights of way which are utilized by a public utility or which logically would be required by a public utility shall not be vacated, unless it can be demonstrated that equal or superior access is or will be available. Where an easement would satisfactorily serve the utility interests, and no other public need for the right of way exists, the commission may approve the vacation and require that a public utility easement be granted in place of the right of way.

Staff Response: All utility entities will have an opportunity to request adequate easements. A 10-foot utility easement, centered over Eric Lane, is proposed. The City has requested an additional 15-foot easement (see public works comments below).

C. The subdivider shall dedicate easements or rights-of-way for sidewalks, bicycle paths or other non-motorized transportation facilities in areas identified as public access corridors in the Homer Non-Motorized Transportation and Trail Plan, other plans adopted by the City Council, or as required by the Kenai Peninsula Borough Code.

Staff Response: City plans do not identify this portion of Eric Lane as a public access corridor.


VICINITY MAP ON REVERSE

ANALYSIS: The applicant is proposing to construct five 18' x 28' dwellings for monthly or nightly rentals, in addition to one 24' x 32' home for use as a full time residence.

Density: In the Rural Residential District (RR), each lot shall contain a minimum of 10,000 square feet per dwelling when city water and sewer are provided. The proposal meets this density requirement by providing 65,340 square feet of lot area for the six dwellings.

Parking: 7 parking spaces are required for this proposal. The proposal includes five 2-vehicle parking areas, plus an additional parking area, totaling 10+ spaces.

Impervious: The proposal would create approximately 15,300 square feet of impervious surface, or 23% of the lot coverage. The project requires a level one site plan and is subject to the level one site development standards. The proposal creates less than 25,000 square feet of impervious surface and the development activities are not expected to trigger a Stormwater Plan.

The criteria for granting a Conditional Use Permit is set forth in HCC 21.71.030, Review criteria, and establishes the following conditions:

a. The applicable code authorizes each proposed use and structure by conditional use permit in that zoning district;

Analysis: The Rural Residential zoning district allows for more than one single family dwelling on a lot as a conditional use, per HCC 21.12.030(m). Lots served by City water and sewer may have increased density up to one dwelling unit for every 10,000 square feet of lot area, per HCC 21.12.040(a)(3).

Finding 1: More than one single family dwelling on a lot is authorized by conditional use permit.

Finding 2: This 65,340 square foot lot, served by water and sewer, may have up to 6 dwelling units based on dimensional requirements of code.

b. The proposed use(s) and structure(s) are compatible with the purpose of the zoning district in which the lot is located.

Applicant: The maximum structures on my lot can be six kitchens. Over time I plan to build all 6 kitchens on my 1.5 acre lot.

HCC 21.12.010 Purpose: The purpose of the rural residential district is primarily to provide an area in the City for low-density, primarily residential, development; allow for limited agricultural pursuits; and allow for other uses as provided in this chapter.

Finding 3: The proposal is compatible with the purpose of the district by meeting density requirements and providing residential development in the City.

c. The value of the adjoining property will not be negatively affected greater than that anticipated from other permitted or conditionally permitted uses in this district.

Applicant: My project will up the value of the area.

Analysis: Other allowed uses in this district, such as an apartment building or an assisted living home could dominate the site in terms of bulk, height and intensity more so than this proposal. The proposed dwellings could have a positive effect on adjoining property values by retaining a rural nature when compared to the previously mentioned uses by limiting both the size of structures and the total development area.

Finding 4: The value of adjoining property will not be negatively affected greater than multi-family dwellings or a conditionally permitted assisted living home.

d. The proposal is compatible with existing uses of surrounding land.

Applicant: The lot below is also in the process of building rentals.

Analysis: The lots to the north and across West Hill Road to the east are vacant residential lots, the lot to the west has a single family home, and the lot to the south has a single family home and has an approved CUP for 6 additional dwellings.

Finding 5: The proposal is compatible with the existing uses of surrounding land.

e. Public services and facilities are or will be, prior to occupancy, adequate to serve the proposed use and structure.

Finding 6: Existing public, water, sewer, and fire services are adequate to serve the proposed development.

f. Considering harmony in scale, bulk, coverage and density, generation of traffic, the nature and intensity of the proposed use, and other relevant effects, the proposal will not cause undue harmful effect upon desirable neighborhood character.

Applicant: No, it will not change the environment that is currently portrayed on W. Hill.

Analysis: Six dwellings on this lot will be in line with the neighborhood character in terms of scale, bulk and coverage. The increased traffic will be easily handled by the site's access to existing city streets. While more density will increase the intensity of this lot's current use, the increase is not expected to cause any undue harmful effects.

Finding 7: Considering harmony in scale, bulk, coverage and density, generation of traffic, the nature and intensity of the proposed use, and other relevant effects, the proposal will not cause undue harmful effect upon desirable neighborhood character.

g. The proposal will not be unduly detrimental to the health, safety or welfare of the surrounding area or the city as a whole.

Analysis: The permitting process will require the applicant to meet Federal, State and local standards.

Finding 8: The proposal will not be unduly detrimental to the health, safety or welfare of the surrounding area and the city as a whole when all applicable standards are met as required by city code.

h. The proposal does or will comply with the applicable regulations and conditions specified in this title for such use.

Analysis: No relief from code is sought from the applicant. All known applicable regulations will be addressed through the permitting process. The proposed parking plan meets the standards of HCC 21.55 "Off-Street Parking." The proposal shall comply with all applicable regulations and conditions when the permitting process is successfully navigated as provided in the CUP and permitting process.

Finding 9: The proposal will comply with applicable regulations.

i. The proposal is not contrary to the applicable land use goals and objectives of the Comprehensive Plan.

Analysis: This proposal promotes Goal 5: Objectives C and D by providing infill of affordable housing in a location with existing road, water, and sewer infrastructure.

Finding 10: The proposal does not appear to contradict any applicable land use goals and objectives of the Comprehensive Plan. The proposal aligns Goal 1 and Objectives A and B and no evidence has been found that it is contrary to the applicable land use goals and objects of the Comprehensive Plan.

Condition 1: Outdoor lighting must be downward directional and must not produce light trespass or glare per the CDM and HCC 21.59.030.

Finding 11: Condition 1 will assure that the proposal complies with level one lighting standards and the Community Design Manual








Building elevation drawing









VICINITY MAP ON REVERSE





Chlorine for the disinfection of the City's drinking water is generated on-site using a chlorine generation cell. This cell failed late in 2018. Public Works shipped the cell to the manufacturer in hopes that it could be refurbished. The cell cannot be rebuilt and replacement is necessary.

In the meantime, water treatment personnel are batching chlorine to provide for disinfection.

Public Works has been exclusively using Miox chlorine generation equipment. The purchase of a new cell will be a sole source procurement. The cell is being purchased directly through the manufacturer, providing the City with the best possible price.

The estimate attached as back up is for \$23,200 and staff has confirmed the shipping cost is \$400, bringing the total cost to \$23,600.

Recommendation: The City Council amend the 2019 capital budget to create a Water Treatment Plant Chlorine Generation Cell Replacement project, and authorize the expenditure of \$23,600 to purchase a replacement cell. The authorization should include approval for a sole source procurement.



SUBJECT: Spit Fish Grinder Renovation

The annual inspection of the Spit Fish Grinder Lift Station by Public Works, at the end of 2018, reveled significant corrosion of the pumps and pump rails. The rails need to be replaced and pumps need to be rebuilt.

This fish grinding lift station is located adjacent to the Fish Grinding Building on Fish Dock Road. All sport caught fish carcasses collected from around the small boat harbor (in the summer) and fish waste from fish processers (during the fish processing season) are ground up in the Fish Grinding Building. The lift station then pumps all fish waste to the Bay.

The City Council authorized the completion of a lighting energy audit on six City buildings (City Hall, Animal Shelter, Airport Terminal, Library, Harbormaster Building, and Public Works). The Energy Conservation Plans were completed (see attached City Hall audit as an example) and the costs and benefits of upgrading the lighting at each facility have been determined and are summarized below:

Public Works proposes to utilize the Revolving Energy Loan Fund to finance the lighting upgrades at these facilities. The Fund was created by the City Council in 2010 to funds energy conservation projects, with departments repaying the loan over time to allow the fund to finance future projects. The operating budget associated with each facility will reimburse the Revolving Energy Loan Fund in three equal payments (2020, 2021, and 2022).

Labor to install would be completed by either building maintenance staff, a new temporary employee, or by contractor (as time allows, in the most cost effective manner). All work would be completed in 2019.

Recommendation: The City Council authorize the use of the Revolving Energy Loan Fund to finance the proposed City Building Lighting Upgrade project as described above, and authorize expenditures from the 2020, 2021, and 2022 City Operating Budget to reimburse the Fund for the cost of completing the project which will reduce energy costs and carbon emissions.

As a doctor and provider of MAT services in Homer and the surrounding area I am well aware of the issues surrounding addiction and the need for treatment services. Our agency serves these individuals struggling and in need of help. The ability to collaborate with substance abuse providers is essentially to our clients and our community. Furthermore, the potential to refer individuals for residential treatment when needed will improve the overall health and wellness of Homer and other Kenai Peninsula residents. We intend to collaborate and partner with Set Free Alaska for the mutual benefit of our shared clients. Specifically, this collaboration will take place by serving individuals who are in Set Frees program who need MAT services. We can provide the MAT while clients are receiving services at Set Frees residential or outpatient programs. We have case manager's and peer specialists who will work with Set Free staff to coordinate appointments and other necessary communication.

The NTC community clinic offers an outpatient MAT program and recently received a SAMSHA grant to expand services. As a board certified Addiction Medicine specialist, I have been providing MAT in rural Alaska of 9 years, and I provide the medical expertise and prescribing for our MAT program. We offer both buprenorphine and naltrexone options for MAT, depending on patient preference and suitability, and also provide counselling services, case management and peer support services. We have struggled in the past to find local inpatient placement for our MAT patients who need the extra support to succeed in recovery, and are excited about this new option that will allow our patients to access both MAT and residential/IOP services locally. We are opening a part-time satellite clinic in Homer this month, so it would be easy for us to provide the MAT prescribing, support and monitoring for patients at a Homer treatment center.

Alaska Clean Water Actions (ACWA) Grant

I am happy to announce that the Department of Environmental Conservation recently awarded the City an Alaska Clean Water Actions (ACWA) stewardship grant. This 60-40 matching grant will help fund the City's development of the Stormwater Master Plan, a longtime prioritized project in the CIP. The project will produce baseline stormwater runoff information and identify low-impact development (or green infrastructure) opportunities for stormwater collection and treatment. Local planners, engineers, and the public will use this information to develop the Master Plan and highlight methods that can minimize the ecological, economic, and community impacts of stormwater runoff. The grant will also help construct green infrastructure features at our new Homer police station. These features will directly store and divert stormwater that might otherwise be left untreated and provide the City with an opportunity to publicly highlight the value of low-impact development. This demonstration project compliments mapping and runoff assessment activities and is foundational to community-wide planning and stormwater policy development. Many thanks to Councilmember Lord who was able to lend her water quality expertise to this project.

New Police Station Design Plan Open House at Cowles Chambers

The City will be hosting an open house on Monday, February 4th, to share the new police station 35% design plan with the public. We encourage community members to stop by Cowles Chambers anytime between 4:30 pm and 6:00 pm to review the schematic drawings, siding options, and carpet samples proposed for the building. Project Manager Pat McNary and City staff will be on hand to answer questions and receive feedback.

Budget Work Ongoing

Finance Director Walton and I have been meeting with Mayor Castner to work on the budget's fiscal issues while also making improvements to the City's budget process. This includes developing a fund balance policy, depreciation reserves policy, cash flow analysis, fund consolidation, and budget forecasting. We will keep Council appraised of progress as we work towards a more streamlined budget process for 2020. The final 2019 budget will be posted on the website by Tuesday, January 29th. Please let me know if you would like a printed copy.

January 22nd Alcohol and Marijuana Control Office (AMCO) Meeting

Councilmember Stroozas organized a meeting between local businesses and Jedidiah Smith, the Local Government Specialist for the Alcohol and Marijuana Control Office. The meeting was held to discuss the comprehensive overhaul of Title 4 (what governs Alaska's alcohol regulations) as proposed by Senator Micciche's legislation, Senate Bill 76. One element of Senate Bill 76 that has the ability to impact Homer businesses is the proposed changes to public convenience licenses. As defined in Title 4, a public convenience license allows a restaurant to serve beer and wine beyond the population limits if the restaurant owners go through the process of collecting signatures and petitioning the Alcohol Control Board. The City of Homer has more per capita public convenience licenses than most towns because of the large non-resident population we serve. The most recent version of Senate Bill 76 would replace the current public convenience license with a different license type (already known as REPL in Title 4), which would eliminate the onerous process of collecting the signatures needed to apply for a beer and wine license. Under Senate Bill 76, the public convenience license would be converted to an REPL and the number of REPLs would be capped at the combined number of current public convenience and REPL licenses. There would be a mechanism, however, for a local municipality to petition the Alcohol Control Board for more REPLs. Protecting local control is something many municipalities are advocating for. Senate Bill 76 did not pass during the last legislative session but Senator Micciche has indicated he is willing to sponsor a new version of the bill, which will likely look substantially similar to Senate Bill 76. The new version of the bill can be found here: http://www.legis.state.ak.us/PDF/30/Bills/SB0076F.PDF. Senate Bill 76 is a comprehensive reform bill that has many other elements capable of impacting our economy, business sector, and public safety. The City of Homer has been following this issue as the restaurant and beverage industry is a key component of our economic base; brings visitors to Homer; and enhances the quality of life for our year-round residents. I will be sure to update Council on Senator Micciche's bill as it moves through the legislative session.

January 16th KBBI Coffee Table Discussion Regarding AK-LNG

On January 16th at the KBBI studio, Tim Dillion from the Kenai Peninsula Economic Development District (KPEDD), Frank Richards from Alaska Gasline Development Corporation, and I discussed the potential impacts AK-LNG could have on the Homer area. With 12,000 temporary workers during a construction phase estimated to last up to 5 years and 1,000 full time employees, we could potentially see an increase in Homer's population along with a demand for skilled labor. KPEDD is currently working on a training program to recruit Peninsula youth for this project. With fifteen to twenty AK-LNG ships a month in the inlet, support vessels for the project such as export tugs and marine pilot boats will want to homeport in Homer, furthering the need for the large vessel harbor expansion project to be listed as a statewide priority. Seawall and the Ocean Drive Loop Special Service District (ODLSSD)

In the November 28th City Manager's Report, I brought up the need to have some discussion regarding Seawall maintenance and repairs. Over the last few years, winter storms have reduced the Seawall maintenance funding balance to below \$100,000. I have sent the attached letter to property owners requesting a neighborhood meeting to discuss the future of the Seawall. Two potential mitigation measures to extend the life of this 16 year old piece of infrastructure include increasing funding for annual preventative maintenance (rather than just repairs) and a potential major capital project to reinforce the toe of the wall where the most damage occurs. Any measure will require Council action and collaboration between the property owners and the City. To that end, I encourage any of you who are available to make it to the neighborhood meeting scheduled for Thursday, February 28th, at 5:30pm in Council Chambers. Dear Ocean Drive Loop Service Area (ODLSA) Property Owners,

The past two years have been tough on the Seawall.

Some major repairs in 2017 included using truckloads of cobble to fill in eroded areas, replacing broken off (or completely missing) horizontal and vertical face timber and steel, and adding reinforcement to the wall's exposed "toe."

2018 shares a similar story. The toe of the wall was excavated so additional timber could be added as reinforcement, boulders were arranged to protect vulnerable areas, cracks were reinforced with timber, exposed fiberglass sheet piling at the toe was covered, and fill material was replaced.

Seawall maintenance expenses for 2017 and 2018 combined totaled \$147,510, leaving only \$95,409 remaining in the fund used to repair the seawall. The revenue for this fund has been collected from ODLSA property owners and the City. If any powerful storms cause damage like we've seen these last two years, this fund could easily be depleted. Once depleted, it is very likely emergency repairs could not happen.

The trend has been to spend money when seawall maintenance is already needed or when there is an emergency. The wall is showing its age (16 years old), which is increasing the amount of needed repairs. I am concerned the fund used to pay for Seawall maintenance is at an unsustainable level.

I would like to host a neighborhood meeting with ODLSA property owners on <u>Thursday</u>. February 28th at 5:30 P.M. in <u>Council Chambers at City Hall</u>. At this meeting, I will discuss options including preventative Seawall maintenance and reinforcing the Seawall's toe. A written summary of the meeting will be mailed out to all property owners in case you are unable to attend. In the meantime, I have attached a table listing all revenue and expenditures incurred since the fund was formed.
