SUBJECT:	Staff Input on City needs in regards to CARES Act Funding

On June 17<sup>th</sup>, I met with Councilmembers Aderhold and Lord to discuss the materials developed for today's worksession concerning CARES Act funding.

A request was made for staff input on the City's needs as a result of and in response to the pandemic. With the short turnaround time, exact dollar amounts could not be provided for all suggestions and input from all Leadership has not occurred. I would like to have more time to work with Leadership through an internal worksession to further define recommendations; the list before you was developed mainly in consultation with Incident Commander Kirko.

The hiring of additional personnel is a recommended priority for improving the City's response and services, ensuring staff sustainability, and reducing overtime costs. City staff are participating in weekly calls organized by City Managers from the Kenai Peninsula/Southern Kenai Peninsula, while also following how the Borough is developing its program, to get a sense of what capital improvements and expenses other municipalities are using their CARES ACT funding for, to see how this could relate to the City of Homer.

As the pandemic persists, the City's needs may change and require a plan and purchases different than what has been proposed.

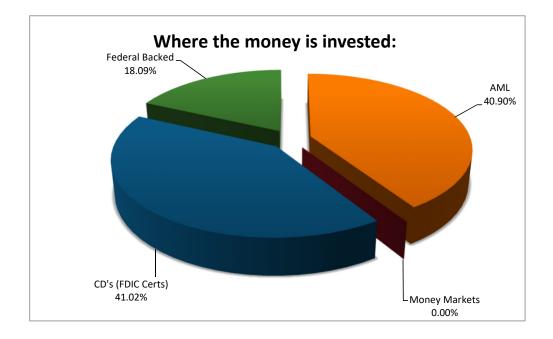

Dear Acting City Manager Abboud,

We've encountered a major culvert failure on Fairview Avenue at Waddell Creek, which is near the entrance to Karen Hornaday Park. The culvert corroded and bent, allowing gravel from the roadbed to flow into the culvert, get washed away and create a sinkhole. The first 4 of the attached photos show the sink hole, the debris in the culvert and the corrosion in the culvert. (You can actually see holes in the culvert caused by the corrosion.) In the 5th culvert, you can see one of our operators, Mike, standing in the roadway. The sinkhole is right in front of him.

We have closed the Fairview Ave in this location. Dispatch has been alerted and traffic control signs are being put out.

Dan Gardner is researching a repair, which will involve "slip lining" the two culverts that cross under the road. There is one vendor, in Anchorage, that does this and on Tuesday, he will be giving us an estimate for the work. At that point, we need to be prepared to execute a contract with the vendor in a timely manner. The lead time on this kind of repair is 4-6 weeks, so the sooner we execute the contract process, the sooner the permanent repairs can be made.

I respectfully you be prepared to ask for emergency authorization to execute the contract with the vendor once we get his estimate. Again, this will be a sole source contract because there is only one vendor in the state that does this. The option is to open the road, remove both existing culverts, replace the culverts and rebuild the road. Rebuilding the road will involve rebuilding the existing concrete bulkhead as well. A project of this magnitude would cost at least a couple hundred thousand dollars and take multiple weeks. With the slip lining, we can make the repairs in days, rather than weeks.

In the meantime, we will make a temporary repair to cover the sinkhole, so we can get the road open. This will happen next week.

FYI - This is the reason we're asking for a Small Works Drainage Fund, to be proactive about fixing these kinds of

culvert problems. The last 2 photos are examples of other culverts that have failed in city roads. This is a pervasive problem. I would like a way to show all these photos to the City Council so they can visualize the problem.

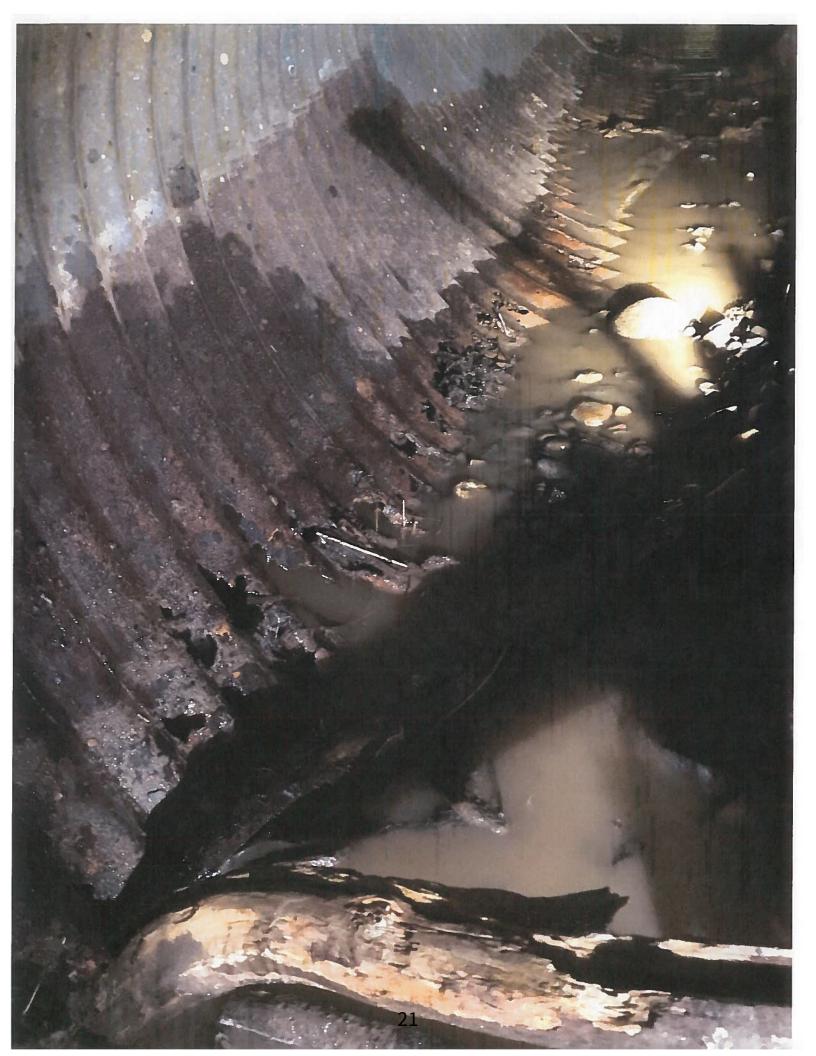

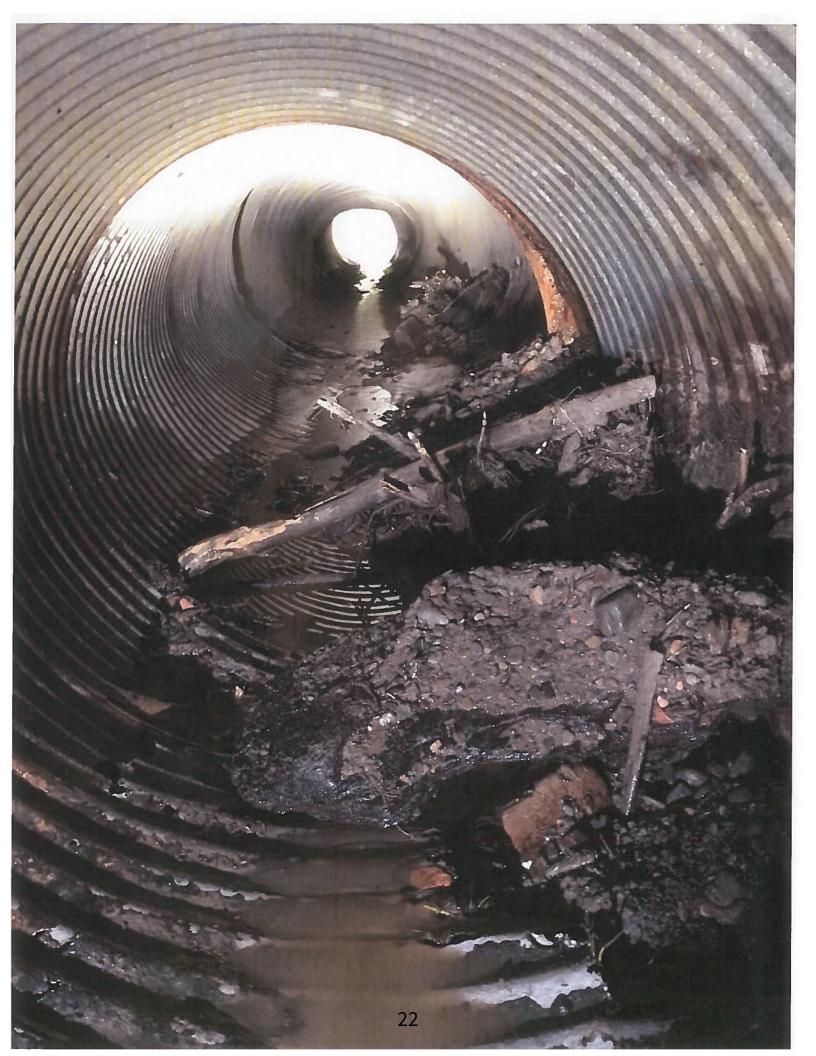

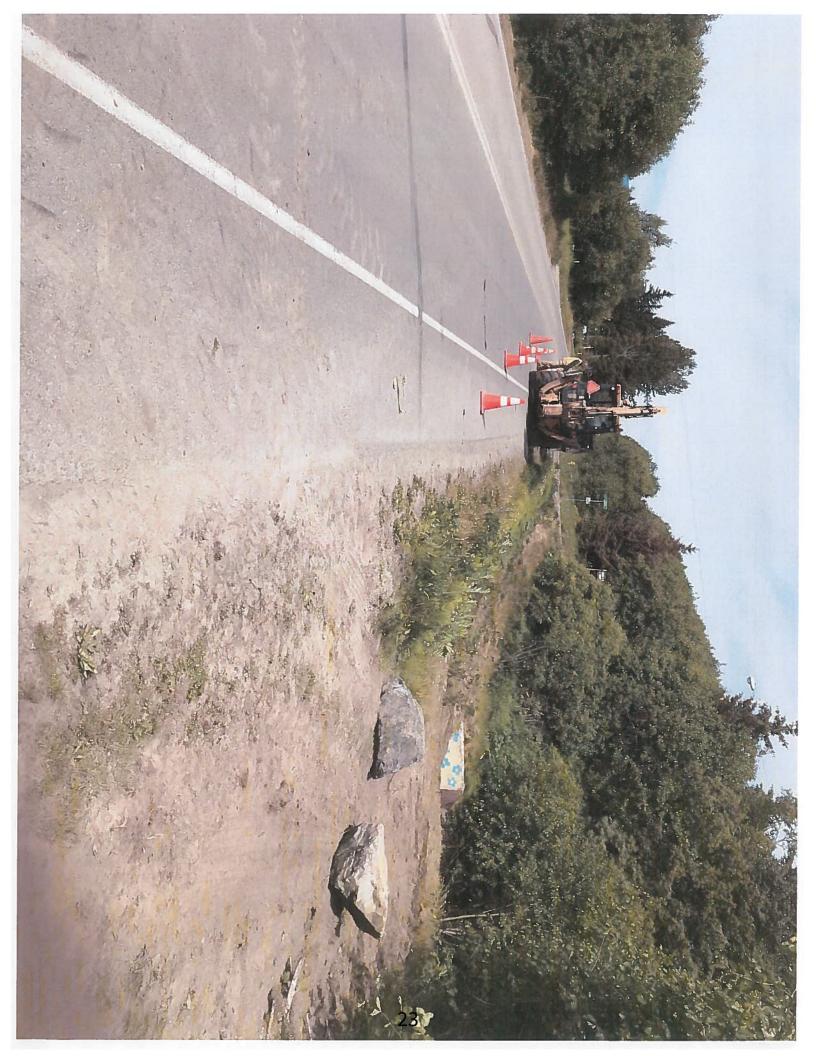

Dear Homer City Council & City Manager Office,

My name is Robbi Mixon and I'm the Local Foods Director for Cook Inletkeeper, and have also directed the Homer Farmers Market for the last decade. I am writing today on behalf of the Alaska Food Hub, an online farmers market that facilitates the sale of locally-grown products in Homer, Ninilchik, Seldovia, and Soldotna, and features 100% locally grown and harvested products. We are a Local Foods Program of Cook Inletkeeper, a community-based nonprofit organization formed in 1995 that combines hands-on scientific research and monitoring with strategic advocacy, organizing and education to protect water quality and salmon habitat throughout the Cook Inlet watershed.

Our vision for the future includes clean water, healthy fish and wildlife habitat, lasting jobs and renewable energy. Vital to this vision is increasing food security and reducing food miles, while supporting regenerative local economies and greater community resilience. The Alaska Food Hub provides socially distanced opportunities for Kenai Peninsula producers and consumers to connect in a way that will create benefit for both, as well as strengthen the Kenai Peninsula economy, increase food security, and reduce the carbon footprint created from importing food.

We officially opened our doors at the Alaska Food Hub in April 2016. Since then, we've seen growth every season, but nothing like we've seen in 2020. The COVID19 pandemic has pushed many growers to reassess how they operate their businesses, while customers are exploring new ways to shop locally. The Food Hub has experienced a three-fold growth in participation, and has left us needing a new aggregation and customer pick-up site.

Under the advice of Councilwoman Rachel Lord, we are requesting the use of a portion of the upstairs HERC building – one classroom and the hallway, every Wednesday from 9am – 6:30pm to operation the Alaska Food Hub. Below is a brief outline of how the space would be used during the 2020 Season, which runs April – mid November:

- 9am employee(s) arrives to sanitize and set up invoices/tables/etc
  - We would like to use the hallway for Homer orders; we would set up the folding tables down each side of the hall
  - Classroom would be used for orders going to Seldovia, Ninilchik, and Soldotna
- 10:30am to 1pm producers drop off ordered items; employees sort by order and location
- 3-6pm customers pull up to curb and call (number is listed on a sandwich board outside pick-up area) employee to bring out their order; order is placed on on table and customer pickup
- 6-6:45pm area is sanitized and employees leave; any unclaimed orders will be left outside for afterhours pick up (this does not occur very often)

Other considerations:

- All customers, volunteers, employees will be masked at all times during operation
- All surfaces are sanitized between producer drop offs
- Orders picked-up through no-contact procedure
- We will need to leave tables, shelving, bins, cleaning products, food products on site, hopefully in a lockable area
- We have liability insurance to cover mishaps during the Food Hub operation day (we can provide a copy of this policy to the City of Homer; if requested, we can name the City of Homer as an additional insured)
- We collect and pay city and borough sales tax

We are hoping to move locations as soon as this request can be reviewed and additional questions or concerns be addressed. Thank you so much for your consideration.

SUBJECT:	Follow-Up to Resolution 20-050 – Capital Projects

Council directed the City Manager to work with Departments and assess approved capital projects in order to protect the fiscal health of the City and the City's ability to continue providing essential services. Through this effort, I am using staff recommendations to delay 10 capital projects listed below until FY2021 (1 project no longer requires funding) with all others detailed in the attached spreadsheet permitted to proceed. Almost all capital projects for the years 2018-2020 are included because capital projects, once approved, have a lifespan of three years. I have also presented approved projects for 2021, since any 2018-2020 delayed projects may have a trickledown effect on work slated for next year. I welcome and encourage Council's input regarding projects recommended for delay or for those recommended to proceed. Administration and Finance will then revisit this topic with Council after the first and second fiscal quarters' revenue is booked to determine if projects recommended for delay can resume or if additional delay of projects is needed.

As an aside, mid-year adjustments typically have occurred in August or later (after review of the 2<sup>nd</sup> Quarter Sales Tax Report is complete and staff have a general a sense of the audit). Additionally, budget amendments can occur throughout the year. Any funding requests made will take into account the direction provided by Resolution 20-050.

I have also reported the ways in which departments are addressing a conservative fiscal approach to their operating needs in the June 22 Manager's Report and will share additional input provided by Department Heads on this topic to Council in future Manager's Reports.
