Homer Planning & Zoning Update Report to City Council June 13, 2016

This report will bring you up to date on the Homer Advisory Planning & Zoning Commission activities over our last two sessions.

May 18, 2016

 This meeting was devoted to reviewing the expansion plans for the Hickerson Memorial Cemetery. The Planning Commission would like to move forward in addressing a phased approach at expanding the cemetery which would include consideration for various types of memorial options, such as cremains plots, a Columbarium (niche wall for urns), more compact grave layout and a memorial plaque area. We are seeking a concurrence of the council before we spend too much more time on the issue. A memo is included in the City Manager's report that outlines the direction that we support.

June 1, 2016

- The Commission held a public hearing on a proposed ordinance that would accept the latest revision in the FEMA flood maps. The area of the latest study updated the shore lands above the spit. One person testified and encouraged the Commission to forward a recommendation for the City Council to approve the new maps, which we did.
- We recommended approval of a preliminary plat which combines two lots together, just east of the Senior Center; this was a requirement of a previously approved CUP that allows the replacement of multiple cabins on the site.
- We reviewed some initial revisions to the Parks and Recreation section of the Comprehensive Plan, some recommendations were made and we will be reviewing it again in the future.
- We also learned that Commissioner Erickson will not be reapplying for another term to the Planning Commission because of family obligations. We are seeking another Commissioner, who does not have to live in the city, and if anyone who is listening is interested please contact the City Clerk. We are aware that an applicant residing outside the City of Homer has filed for appointment.

Dear Homer City Council Members:

I am writing to urge you to reject the mooring rate structure proposal currently before you drafted by the Homer Port and Harbor Commission. Instead, I urge you to adopt a rate structure recommended by your consultants, Northern Economics, that is fair to all classes of boats, both large and small, that reside in the harbor.

Although I am a boat owner and use harbor facilities, I am addressing you today as a citizen and property owner of the city. In this capacity I am concerned that in all of its deliberations, including this one, the Council embrace solutions that consistently adopt a doctrine of fairness. A community with fair minded policies attract fair minded people to live there. And that is the type of community and people that most of us want to be around. For the most part, I've been pleased to see that this has been your track record in the past. Only through a consistent application of such a doctrine in all of its policy decisions, including this one, will our beautiful community continue to thrive into the future and be the place that all of us are proud to live.

You will hear from others the detail of how the current Harbor Commission's rate structure recommendation falls drastically short of fairness, particularly to the owners of small vessels, and how the study that you commissioned from Northern Economics rectifies this shortcoming. I urge you to review this material in depth and believe that when you have, you will render a rate structure decision that is impartial and fair not just to all users of the harbor, but, in a broader sense, to all of the residents who call this place home.

Dear Ms. Johnson:

I am writing regarding the upcoming City Council meeting and the ongoing discussion about harbor rates, particularly as they relate to small boat owners. I hope my comments can be included in the council's packet for the June 13th meeting.

My husband and I own a 23' recreational vessel, and we pay the annual slip fee of about \$1,000 to keep our boat in the harbor every year. As I understand it, Northern Economics was hired as a consultant to review the harbor's current rate structure, and in October of 2015, issued a recommended "fair and equitable" rate structure after determining that the harbor's current rate structure does not meet a fair or equitable threshold (since small boats are shouldering the load of the harbor costs). Although Northern Economics is a neutral third party in this matter, the Port and Harbor Commission has chosen not to adopt its recommendation.

As a small boat owner and supporter of the harbor, I have no qualms about paying for the services I receive. But the rates I pay should be fair and equitable. The Port and Harbor Commission's rationale for continuing the current rate structure is a hard pill to swallow, and does not strike me as fair or equitable. According to the Commission, since large boat owners "provide a lot of income into the community and drive a lot of the economy," they should be entitled to pay a lesser harbor fee. I know a significant number of small boat owners who use the harbor and pay the annual slip fees, and each one of them is a contributing member of our community, and each helps drive our economy. Furthermore, the small boat owners I know all live in Homer (which cannot be said of all large vessel owners), and do not use a majority of the harbor facilities that are used by large vessels. So having the small boat owners shoulder the cost burden does not strike me as fair or equitable, nor does the commission's rationale take small boat owners' contributions to the harbor and our community into consideration.

I am once again writing in support of adoption of a graduated rate method for annual moorage fees in the Homer small boat harbor.


I own the private f/v "Winter King", a 34 foot catamaran moored in the small boat harbor. Reviewing Robert Howard's analysis of the current Homer harbor moorage rates, it is obvious that the owners of small boats are paying disproportionally more for harbor moorage than large boat operators. Large boats are wider and occupy much more real estate per linear foot than smaller boats. I see no reason why small boat owners should pay disproportionately more for moorage than larger boats.

A truly fair and equitable rate structure for harbor moorage would be to charge by the square foot. However I feel that a reasonable compromise would be adoption of the graduated rate structure over a period of years suggested by Mr. Howard.

Homer has by far the nicest harbor in the state. It takes money to keep it that way while making it even better. All harbor users need to pay their fair share. I believe the gradual adoption of Mr. Howard's proposed moorage rates will help the Harbor meet its long term revenue goals while minimizing the impact to all boat owners and the local businesses that support them.

After reviewing the the Port and Harbor Commission's result on changing fees for our port and comparing it to the recommendations placed forth by the Northern Economics consultant, I strongly urge the Council to take action and adopt the recommendations made by the consultant. The P&H Commission's recommendation places a greater financial burden on smaller vessels than the larger vessels creating a disproportional burden on small boat owners. This is unacceptable. The P&H Commission's had a great opportunity this past winter to study and create an equitable solution to address existing disparities in the rate structure; but instead, further exacerbated those disparities with their proposed recommendations. It appears they ignored or did not even consider the Northern Economics study.

The following summarizes our activities as City Attorney during the month of May 2016.

<u>City Council</u>. I attended the May 11 Council meeting.

<u>City Clerk.</u> I worked with the City Clerk on understanding the revised Department of Justice preclearance requirements and how these changes affect City of Homer ("City") elections.

<u>City Manager</u>. Thomas Klinkner worked with the City Manager regarding fees and penalties associated with payment of property taxes and the costs associated with foreclosing on properties with delinquent tax payments. He also worked with her regarding an ordinance to expand election financial disclosure requirements and on an update to the fine schedule and minor offense schedule. I worked with the City Manager regarding the City's sales and excise tax options and limitations. Additionally, I worked with the City Manager on conflict of interest questions and drafted memoranda to the City Council and the City Manager addressing the City's conflict of interest and partiality procedures and prohibitions. We worked with the City Manager and the Police Chief regarding the repeal and revision of drug paraphernalia provisions and drafted a memorandum regarding the nature and reason underlying the recommended revisions. Amy Walters worked with the City Administration regarding personnel matters. I also attended the staff meeting held on May 25, 2016.

<u>Marijuana Regulation</u>. We drafted a memorandum providing the Cannabis Advisory Commission ("CAC") with an update on the City's ability to tax the marijuana industry within the City and resources regarding taxes imposed on the marijuana industry in other jurisdictions. We attended the Marijuana Control Board meeting and observed the license application procedure and researched pending licenses within or near the vicinity of the City.

<u>Planning Department</u>. Leila Kimbrell worked with the Planning Director on signage violations and enforcement. I reviewed the pending tower regulation ordinance with the Planning Director and we worked together on changes. Katie Davies worked with the Planning Director regarding small claims actions brought by the City.

<u>Public Works Department</u>. We drafted an ordinance regarding fire hall improvements and construction of a new police station and authorization for bonds and taxes to fund these new projects. Adam Cook and I worked with the City Manager regarding the request for proposal process for build-design contracts and Mr. Cook drafted a memorandum regarding the little Davis Bacon wage requirements on City property and/or funded projects.

<u>Port & Harbor</u>. We continued revising the crane usage agreement for the Small Boat Harbor with the Harbormaster and worked with him on revising the harbor citation process. We also worked with the Harbormaster on drafting and reviewing contracts for the creation/implementation of a software program for managing Port and Harbor services, fees, and documentation. Additionally, we worked with the Port and Harbor team on upland lease matters.

<u>H.A.R.T. Program</u>. We revised a resolution regarding the effective date of the change in H.A.R.T. support for road SADs and consulted with the City Manager regarding this matter.

<u>Griswold v. City of Homer litigation</u>. We drafted oppositions to Mr. Griswold's motions to supplement the record and his motion for contempt as well as several other procedural pleadings filed by Mr. Griswold. We also responded to Mr. Griswold's correspondence and requests to the Alaska Supreme Court clerk.

<u>Clear Creek Cat Rescue v.</u> City. Thomas Klinkner drafted initial disclosures and began analyzing the claims raised.

I will be available to answer questions regarding these matters at the June 13, 2016 Council meeting.
