Baycrest Overlook Improvement Committee

Meeting Synopsis

December 11, 2012 Cowles Council Chambers

The *purpose* of the meeting was to discuss the progress of the Baycrest Hill Overlook Interpretive Plan. The following is a synopsis of the discussion:

- The bulk of this meeting focused on the interpretive subthemes. Originally, seven themes were
 identified at the meeting held in mid-September. However, it was decided that two of the
 themes were not relevant enough, so the number was reduced to five subthemes. Those
 subthemes are the spit, volcanoes, bay and inlet, wildlife and habitat, public lands and waters,
 and glaciers.
- Subthemes do not dictate the language of each panel to be developed, but they provide guidance for individual panel development.
- It was decided that the committee should review the subthemes and provide comments to Emily Lochart by December 21st.

DRAFT INTERPRETIVE THEMES

PRIMARY INTERPRETIVE THEME:

Homer, with its famous Spit, reaches into Kachemak Bay, inviting us to explore public lands, waters, and diverse communities beyond the end of the road, while drawing us back to the "Cosmic Hamlet by the Sea."

SUBTHEMES:

The Spit: The Homer Spit is a striking geologic feature that has been shaped by a receding glacier, impacted by an earthquake, and shored back up to maintain our vital link to the bay.

Volcanoes: Perched on the Pacific Ring of Fire, Homer is witness to our dynamic earth's simultaneous powers of creation and destruction as evidenced by the active volcanoes seen across Cook Inlet, and the continuously rising Kenai Mountains, which dominate the horizon across Kachemak Bay.

Bay and Inlet: Kachemak Bay and Cook Inlet are wild, ecologically diverse, and expansive estuaries shaped by dramatic and dynamic forces, like earth movements, tides and currents.

Wildlife and Habitat: Visitors may view a diverse range of terrestrial and marine life and their habits from Baycrest Hill.

Public Lands and Waters: The surrounding public lands you can see from Baycrest Hill have been designated as special places that allow a seemingly endless list of recreational opportunities.

Glaciers: Fresh water from the glaciers of the Kenai Mountains mixes with salt water in Kachemak Bay, creating a rich estuarine soup, but as these rivers of ice recede in our changing climate, the rich marine life that thrives in this unique ecosystem may drastically change.

- Replace the existing Gold Rush interpretive panel with up to eight new interpretive panels
 using the identified themes and a unified design scheme. Place them in or adjacent to the
 planters with one by the Halibut sign or spread them out based on the theme. If necessary
 and useful, provide a QR code on the panel for more information.
- Replace the existing wood carving of Kachemak Bay with multiple metal sculptures. The
 sculptures should be a piece of art that can withstand the elements and depicts and
 identifies the natural features that can be seen from that specific vantage point. The new
 metal art should use the long fence line, but should not obstruct the view. Details such as the
 type of metal and how it is applied to the fence should be left to the artist.
- To benefit visitors and residents, add picnic tables to the overlook. One option would be to
 place a couple between the planters. However, after new interpretation is added, picnic
 tables may clutter the area. To avoid this, another option would be to create a picnic area to
 the east and west of the core area of the overlook where cars currently park.

- Replace restrooms with an eco-friendly, lower maintenance, and weather-resistant alternative that is more aesthetically pleasing
- Add recycling containers and make all trash and recycling containers bear-resistant
- Remove or cut back vegetation that is impeding the view (i.e. alders behind the Halibut sign)
- Consider using interpretive art at necessary structures such as restrooms and benches, and even in the ground along sidewalks.
- Alter the fence and railing so that there are more areas that are lower to allow more
 opportunities for unobstructed viewing by visitors in wheelchairs as well those of small
 stature such as children.
