Session 12-0 a Regular Meeting of the Public Arts Committee was called to order on August 9, 2012 at 5:05 pm by Chair Angie Newby at the Homer City Hall Cowles Council Chambers located at 491 E. Pioneer Avenue, Homer, Alaska.

Chair Newby requested approval of the minutes.

# STAFF & COUNCIL/COMMITTEE REPORTS/ AND BOROUGH REPORTS

A. Staff Report

Ms. Krause commented on the laydown provided regarding the design of the magnet that will be given to the attendees at the Open House event. Previous designs submitted were vetoed by Printworks because they were "too busy". Even pictures submitted of new city hall exterior were turned down for the same reason.

General Comments were that the design is appropriate and the cost will be from the \$1500 to be appropriated by Council. Ms. Aplin noted that there was no indication that this was City of Homer and if the word Homer could be put on the magnet before City Hall.

There was a brief discussion on concern for advertising the Open House Event.

PUBLIC ARTS COMMITTEE REGULAR MEETING AUGUST 9, 2012

Ms. Wolfe provided a brief update on the refurbishing the Mural on Heath Street. There was a discussion on the expended amounts to date. Ms. Wolfe noted where she has previously distributed the rack cards. The members approved of the relocated artwork in the Council Chambers that was lowered. Ms. Wolfe noted the additional work that she and Ms. Krause have been working on and getting completed for the Open House.

There was a brief discussion on the Request for Proposal Selection Committee appointments and the recommendations submitted. Ms. Krause noted that the following are appointed to the Selection Committee for the Restroom RFP and Spit Trail Completion:

Restroom - Carey Meyer, Angle Otteson, Dana Harrington, Rachel Tussey, Lisa Ellington, Deb Lowney, and McBride

Spit Trail - Carey Meyer, Angie Otteson, Dana Harrington, Rachel Tussey, Lisa Ellington, Tricia Lillibridge, Deb Lowney, and Robert Archibald

Vice Chair Wolfe noted the possibly having or stretching their money if they can incorporate the design into the structure. Some of the art costs can be offset by the budget established for that portion of the construction budget such as flooring and fixtures. Mr. Meyer provided some ideas regarding siding exchange for tile murals, etc.

There was no further discussion.

#### PUBLIC HEARING

#### PENDING BUSINESS

A. Gateways Project – Baycrest Hill Status Update

Ms. Aplin had not further updates on the project. Chair Newby commented on the process for receiving the funding from the city. She will send an email regarding meeting schedule and keep the other committee members advised so they can attend. This will be a Fall/Winter project and will look good on the report to Council.

B. Airport Lettering – Progress Update

Ms. Krause conferred with the City Clerk and Council members and the idea of vinyl stickers did not go over well and if new letters can be obtained then that was preferable.

She took the liberty to research some pricing and this is the best she has found. The information provided includes painted, powder coated aluminum. Ms. Krause noted that she needed a verbal go ahead since the price quoted with shipping is over the line item amount designated by the committee. Brushed aluminum is available also.

The committee discussed the various options available, letter size and font. Chair Newby commented that she was open to a more artsy, script type font. Not the standardized font. The font size information was not available and Ms. Krause reported that she needed to arrange with Mike Riley to measure the letters but that if they reviewed the chart included it was opined that at 16 inches in height they are viewable from 350 feet. There is a sample of some fonts. Ms. Miller opined that she preferred a more traditional letter, more elegant in style. Ms. Aplin preferred a legible. Ms. Krause was asked to see if the company would provide samples of lettering. Discussion continued on different colors for the words or different fonts. The committee requested samples of font suggestions from staff and then there were various finishes in metal also. The metal maximum size is 15 inches. Ms. Krause stated the company is Woodland Manufacturing and comes in at \$1078.00. The committee agreed that the budget can handle and shipping is between \$56-113.00. The committee agreed that this is an outstanding issue but there was not a consensus of expedited shipping costs.

Mr. Meyer assured the committee that they can get the work scheduled when they receive the letters. He inquired how the letters would be mounted or attached. It was explained that there were a number of options. Ms. Krause will email a link to Mr. Meyer for review to determine the best options. She will arrange to meet with Mike Riley on the position and attachment issues. Mr. Meyers pointed out the issue would be scheduling the installation in between flights.

There was no further discussion.

# C. Open House Final Arrangements Update

Vice Chair Wolfe commented that they are doing quite well. They are waiting on the ordinance to be approved by Council on Monday August 13, 2012 for the funding. The Boy Scouts are willing to participate and perform the Flag ceremony but declined participating in any other manner. The Girl Scouts were happy to participate and thanked us for including them. Brownie Troop 564 will be taking care of refreshment service and assisting visitors.

The food will be provided by numerous vendors in the area including Two Sisters, Fritz Creek Bakery, Mauras, Save U More, Safeway, and Cosmic Kitchen. The committee agreed on serving coffee and punch. Ms. Wolfe outlined the following for the Open House:

- She will purchase the mix for the punch lemonade, slices of lemons, seltzer or club soda, coffee will also be provided and carafes of water; three punch bowls one for each station
- performances by the Ukulele group they will be staged in the Admin Area and Council Chambers
- The overall ceremony will be 10-15 minutes. This will be done in the Council Chambers since it is the more formal area.
- There was a brief description of the process but no definite outline Ms. Wolfe will work on that aspect.
- It was previously discussed to have food stations in Planning, Upstairs and Council Chambers.
- The committee members role is to circulate and talk to the visitors, explain the 1% for the Arts Program
- Staff will complete and finish the name tags for the event
- Ms. Krause is creating a plaque for the Sister City Conference room
- Department Heads will be available to answer questions from the Public regarding changes to the individual areas

Ms. Miller had a prior appointment and left the meeting at 6:00 p.m.

Ms. Aplin volunteered to assist in cleaning also, the other committee members also agreed to be vigilant in picking up and cleaning and potential messes. Committee members were requested to arrive at least 15 minutes prior to the event.

It was mentioned that if someone who is knowledgeable about the Sister City Program would be nice to have in that room.

# NEW BUSINESS

A. Budget Requests for 2013

Chair Newby stated that they need to consider the budget and report what they have accomplished so far and should come up with some projects to request funding for; after discussion on the amount of funds still remaining it was agreed not to ask for additional funding this budget cycle however depending on future projects they reserve the right to submit requests for funding during 2013. B. Scheduling a Special Meeting for September for Budget Discussion

The committee discussed the necessity to schedule a meeting. Staff can send some dates via email for availability. Further discussion on whether a meeting would be needed continued. It was determined that

the meeting could be set on September 13, 2012. Staff strongly recommended that if they submit a budget request they should have some backup to explain the request to Council. It was explained that they could send a memorandum to Council explaining that due to the current economic climate they would not be submitting a request but will have individual projects that may require some funding. The committee then discussed signage and it was mentioned that Parks & Recreation was also working on signage and has included signage for Jack Gist Park in their budget request.

Chair Newby recommended waiting to see the outcome of the Parks & Rec meeting on joint efforts for signage and then determine if they should have a meeting otherwise they will send a memo to Walt.

Ms. Aplin had a prior appointment and left the meeting at 6:15 p.m.

B. Budget Requests 2013

The PRC has inquired and requested the PAC to work together on this project and would like the PSC to include a funding request for Uniform Signage Design in their 2013 Budget Request to Council. Ms. Krause explained that the PRC felt the PAC had a better batting average with Council in getting their budget requests approved. Staff further explained that Mr. Meyer, Public Works Director and Angie Otteson, Parks Maintenance Coordinator will be including small amounts in their budget requests for Signage also this year.

Chair Newby requested a motion.

APLIN/MILLER – MOVED TO SUBMIT A BUDGET REQUEST IN THE AMOUNT OF \$2000 TO CITY COUNCIL FOR UNIFORM SIGNAGE DESIGN FOR PARKS AND TRAILS.

There was a brief discussion on the merits of pooling the PRC and PAC efforts on signage with those of the department efforts and if the amount would be appropriate.

The committee reviewed the project description provided by staff and Ms. Aplin added some information that was discussed at the Baycrest committee meeting on September 18, 2012 that spurred this request to be included on the city's CIP recommendation to the Legislature for possible consideration of project funding.

Chair Newby expressed a positive outlook that getting the Council to include the project in the top recommendations would provide the Legislature some small "shovel ready" projects for funding next year according to comments and information provided to the Baycrest Overlook Improvement Committee at the recent meeting.

# VISITORS

Kachemak Bay Water Trail, Robert Archibald

Chair Newby provided some background on this item.

Robert Archibald, city resident, member of the Kachemak Bay Water Trail Steering Committee provided a brief background and handout on the Water Trail. He noted that they have received a grant to create an interactive website; they have many organizations that think this a viable project and expressing support for the project. They have recently received the support of the Kenai Peninsula Borough. Mr. Archibald had a slide show of pictures depicting areas where the Water Trail would visit. He indicated the possibility of opportunity for private businesses to be involved or part of the trail. Currently a 2014 opening is planned and they are currently 2 months behind schedule. The website in in the process and will be interactive showing weather and all stops whether it is public private and amenities available.

There is a site review form that anyone can share information about places they have visited. They are hoping to have the community on board the more it gets developed.

The purpose on approaching the PAC is to get input on sign design for the signage at the launch site which will hopefully be in the area of the Pier One Theater. They intend to have a kiosk and the location would be either corner of the parcel that pier one sits on where there is either a small Day Use area or along where a proposed barge haul-out is to be. Using a map displayed he located the areas.

Ms. Krause clarified that Cruise Ship funds were allocated to existing or new projects.

PUBLIC ARTS COMMITTEE SPECIAL MEETING OCTOBER 10, 2012

Mr. Archibald wanted to get the PAC up to date on the Steering Committee's efforts. Using the map of the Pier One Parcel he indicated the areas they would like to establish a launch with a small kiosk.

Chair Newby stated that the PAC was supportive of collaborative efforts and once the location is firmed up they would be very interested in assisting.

Mr. Archibald responding to an inquiry on signage design and color also noted that this sign would be at every stop to notify those using the water trail. He would be more than welcome to come to another meeting to inform the PAC the progress of the Steering Committee. He further noted that there are two artists with the National Parks to do a rendition of the area. He provided a timeline of their efforts for review.

Committee member Miller departed the meeting at 6:00 p.m.

B. Committee Updates on the Baycrest Overlook Improvement Project

Ms. Aplin provided a brief summary of the last meeting of the committee and the Planner Emily Lochart provided the synopsis in the packet and is in the process of developing the sub-theme which should be ready for the October 23, 2012 meeting.

Chair Newby provided comments on the fantastic working group they have on this project and the funding from the ADF&G and the City of Homer. It was noted that signage could be included regarding the Water Trail.

C. Selection Committee Unapproved Minutes for September 13, 2012

There was no comment regarding the Selection committee meeting or minutes included in the packet.

A. Review and Recommendation on Amended Request for Proposals Incorporating Art into Four new Restrooms

1. Unapproved Minutes from the September 13, 2012 Selection Committee

Ms. Krause explained the reasoning for amending the agenda and stated that she herself has not had time to fully review the amended proposal document. She stated that Ms. Tussey provided the amendments.

Ms. Miller stated that the proposal documents were even more confusing than before and does not allude to allowing the intended purpose that was originally created allowing the proposers to bid on one or all. She noted that the first sentence under Scope of Services and include this in the very first paragraph.

Ms. Newby confirmed that the intention was for each restroom to have individual art incorporated into the project. She agreed that the artists needs to know that they can submit only one design if they wanted.

It was agreed that the artists should be allowed to submit one or more designs and should not be limited to one for each restroom.

Ms. Miller inquired who or where it was advertised to get such a minimal response. Ms. Krause responded that she did not have the Anchorage contact information but that this was advertised in the local papers and with the Homer Council on the Arts. She did note that this will be forwarded to the Plans Rooms also and she will check with the City Clerk on getting it advertised in the Anchorage newspaper.

B. Kachemak Bay Water Trail

There was no further discussion on this item or further recommendations.

C. Recommendation to Appoint New Public Arts Committee member to the Selection Committee for Restrooms

# **Background**

Budget - Well our request for the 2013 Budget was granted so there will be an additional \$2000 for starting uniform signage. This item is listed on the agenda under Pending Business so more discussion can be held on it at that time.

Other Budget related news - In reviewing our current funding we have expended a total of \$4,936.51. This amount of course is unaudited according to the Regina Mauras, Finance Director. There is still \$3,181.49 left in our budget before adding the \$2000.

Now for the not so bad news. Apparently the way the funding was done - asking for specific amounts to accomplish specific goals like, the Fisherman's Wall or \$2000 for Educational Materials restricts the PAC to how it is used. The PAC has the funding but we need to request the City Manager to sign off on a new designation for those funds and transferring amounts to the projects that have gone over or will be expected to go over such as the Fisherman's Wall.

Example 1: The PAC budgeted and requested funding for new airport lettering in the amount of \$1000 Council approved this; PAC approved and expended \$1202.55.

Example 2: The PAC budgeted and requested funding for Guide/Educational Materials in the amount of \$2000 Council approved this; PAC changed from a tri-fold brochure to a rack card and expended only \$302.97.

The PAC approved the changes and bought the Art ID plaques, the case for the swords for the Sister City Collection and the overage on the airport lettering from the remaining funds designated for Educational Materials. The total amount expended on other items was \$633.54. This leaves \$1063.49 that must be re-appropriated and reallocated.

Mrs. Mauras informed me yesterday that unless these funds are designated to a general overall usage such as miscellaneous expenses and projects of the Public Arts Committee, Office Supplies, etc. that technically we are not supposed to spend the funds on other "unapproved" projects; the City Manager has the authority to make those changes and must do that in writing.

During the final summer of Committee member Wolfe's service she informed the committee that the Fisherman's Wall was going to cost approximately \$500 more due to the rise in material cost and possible labor costs. She also wanted to create a history wall at the entrance to the Upstairs Lobby and was considering a Senior Project. This option may need some funding put towards it for supplies, framing and such.

# RECOMMENDATION

Make a Motion to request Staff submit a Memorandum to the City Manager requesting approval to reappropriate and re-allocate the \$2000 Educational Materials in the following manner:

- Fisherman's Wall Allocate an additional \$500.00

- Homer's Historical Depiction, \$200.00

- Committee Activities - Fourth of July Parade, Street Faire, Registrations, Hanging Artwork, Identification Plaques, etc. \$363.49

- Rack Card \$302.97
- Locking Display Case for Sister City Swords \$165.94
- Airport Lettering Overage \$202.55
- Artwork identification for City Hall \$265.05

#### **Background**

At the September 25, 2012 meeting the Committee members had a brief discussion on the issue of Uniform design for City of Homer parks, recreation areas and trails. The Parks and Recreation Advisory Commission have requested the assistance of the Public Arts Committee and Deb Lowney has agreed to be the Liaison between the two.

It has been a long standing issue on both the Committee and the Commission's Strategic Plan. The Commission has acquiesced the task of requesting monies to the Committee as they have a proven track record with Council approving their budget requests.

Additionally, Carey Meyer has included signage in his budget this year as has Angie Otteson with Parks Maintenance. If everyone's request is granted there should be an overall amount of approximately 4-5000 which includes the PAC request of \$2000, however most of the requested budget currently is designated for Jack Gist Park as that seems to be the next Park Improvement Project on everyone's horizon.

I recommend that this item be postponed until the Budget is approved that way no time will wasted if the Council decides not to fund these requests this year.

Once the budget is approved then special meetings can be scheduled to discuss an overall methodology on achieving a City of Homer Uniform Recreational Sign Design that complies with city, borough and state laws.

The City Council has approved the Budget for funding signage for the Public Works and has approved additional funding for Parks and Recreation Commission regarding signage.

#### RECOMMENDATION

Make a motion to have Staff coordinate a meeting date to work on Uniform Signage with Parks and Recreation Commissioner, Angie Otteson and Planning Personnel.

# Rasmuson Foundation Grants for Individual Artists is Open

Calling all Alaskan artists: Rasmuson Foundation has opened the application process for its annual Individual Artist Awards grant program, and this year the awards are more substantial than ever. The foundation has increased the amount of money to be awarded to Alaska-based artists for the first time since the program's inception in 2004.

Individual Artist awards are designed to support Alaskan artists in ten artistic disciplines at various stages of their career and creative development and are available in three categories. This year the foundation will provide grants of \$7,500 for project awards, meant for artists with short-term project needs; \$18,000 for artist fellowship awards, given to mid-career and mature artists to advance their career; and \$40,000 for the Distinguished Artist Award, in recognition of creative excellence and superior accomplishments. Rasmuson Foundation created the Individual Artist Awards to encourage the growth of serious artists, helping them continue to create, experiment and contribute art to Alaska communities.

This year the fellowship category includes awards for choreography, crafts, performance art, folk and traditional art, and literary arts/scriptworks. In addition to these discipline areas, Project Award applications are welcomed from artists working in media arts, multidiscipline/new genre, music composition, presentation/interpretation, and visual arts.

Applications may be filed online on the Rasmuson Foundation website and must be submitted by 11:59 p.m. March 1, or sent by mail and postmarked by March 1, 2013.

Eligible applicants are Alaska residents of two or more years who have not won an Individual Artist Award in the past three years and are 18 years or older. Interested applicants can receive more information and apply online at <u>http://www.rasmuson.org</u>.

The NEA grant opportunities listed below are for projects anticipated to take place in 2014. Grants for Arts Projects consists of Art Works and Challenge America Fast-Track programs and constitutes 75 percent of the NEA's annual direct grantmaking. These matching grants help support projects that involve the creation and presentation of artistically excellent work - both new and established.

#### Art Works

Art Works is the NEA's largest funding category. These matching grants range from \$10,000 to \$100,000 and cover a broad range of projects across all disciplines. Projects include commissions, residencies, rehearsals, workshops, performances, exhibitions, publications, festivals, training programs and literature fellowships. In FY 2012, the NEA supported more than 1,790 grants totaling \$102 million through this category.

#### Challenge America Fast-Track

Challenge America Fast-Track grants support primarily small and mid-sized organizations for projects that extend the reach of the arts to underserved populations--those whose opportunities to experience the arts are limited by geography, ethnicity, economics, or disability. All of these awards

are \$10,000 matching grants. Projects include commissions, residencies, rehearsals, workshops, performances, exhibitions, publications, festivals and training programs. These grants feature an expedited review process with approximately six months from application to notification. In FY 2012, Challenge America funded 153 grants totaling \$1.53 million.

### Meet MK MacNaughton: Executive Director of the AAEC

The Alaska Arts Education Consortium (AAEC), a statewide non-profit organization whose mission it is to promote high achievement for all Alaskan students in and through the arts, has a new Executive Director. MK MacNaughton of Juneau was hired in January to lead the organization as it continues its work in Alaska. Recently, MK spoke with us about her professional path to this work, her own experience in the arts and education, and what she hopes for the future of Arts Education in Alaska.

MacNaughton has been working in social services, art and education in Juneau and Alaska for 23 years. Like so many adventurers, she came to Alaska for the summer . . . and stayed. She is a visual artist at the core, but has diverse experiences in the arts. She credits her early experiences in the arts with her willingness to work outside any box.

"My love of arts began when I was a child. I realize now, I had wonderful influences. I was encouraged and never told I couldn't try any medium, so I spent a lot of time making inventions and drawing and felt that kind of magical connection to losing yourself in the art. I also learned, teaching in schools, that art is a wonderful medium for all children, of all abilities-there are lots of different mediums, and different kids are attracted to different kinds of art. Some like drama and movement, some like really tactile arts. That led me to working with people who experience developmental disabilities, and expanded my scope as a teacher."

MacNaughton spent six years as director of The <u>Canvas</u> in Juneau. The Canvas is a multidiscipline, mult-generationally focused, art studio that provides a supportive environment to foster creativity and inclusion of adults with disabilities through shared art experiences and exhibitions. MacNaughton has also ventured into the performing arts in Juneau with organizations such as <u>Perseverance Theatre</u>.

"With my involvement in Perseverance Theatre as an emerging actor, I've been lucky to watch experienced actors and one of the main things I've learned from them is that they go for it. They let themselves go for it. Sometimes it works and sometimes it doesn't, but it's always fun to watch. And that is a great gift that the arts give us."

"Often we're attracted to things that are a little bit of a challenge for ourselves. I think that can be a good stretch, and I probably was--I know I was--a very shy student in school, so I became involved in dance. I learned, as a shy student, to speak publicly, as well. That's an important job skill, and not necessarily one we always learn in school. The arts have given me some of the most important work skills that I have," MacNaughton said.

With a background in visual art and psychology, MacNaughton has also seen how the arts can support the field of social services and strengthen communities. Her career has encompassed work with survivors of domestic abuse and sexual assault. "Arts are a wonderful way to get conversation going. In working with survivors of domestic violence and sexual assault--sometimes in a support group---it's hard to start with the words and art can open the door to conversation."

Most recently, MacNaughton has taken a year to focus on her own artistic process. It is not uncommon in Alaska to find artists whose practice includes a diverse range of pursuit: studio work, education, administration and commercial work. As entrepreneurs, Alaskan artists are some of the most creatively energetic, resourceful and diversely skilled citizens of the state.

"I've been working as an independent artist for the last year, to focus on increasing my own bodies of work. That has been a great treat...the AAEC schedule is part time, so I'm going to be able to continue keeping my studio alive. I have several shows planned in the upcoming year, and I'm

excited to start connecting with AAEC."

So what is MacNaughton looking forward to as Executive Director of the AAEC?

"I've learned to respect and learn from my predecessors--the people who already work in the field-and so I'm hoping to enter this position with the same respect for the board. Within our communities there are artists and elders who have a lot to share, so as an organizer, I hope to tap into and learn about what's happening on a statewide level."

The AAEC is an affiliation of school districts, organizations and individuals committed to preparing and supporting educators so that they can teach the arts across the curriculum, and is now in its second decade. As it has grown-the membership of the AAEC is largely comprised of Alaska school districts and other partners-the organization has built several programs through which it works to accomplish its mission and purpose. The Summer Institutes for teachers have developed in communities across the state: Juneau, Fairbanks, Anchorage, Kenai and this summer institutes will be offered in Sitka, Nome and Kodiak. On March 22nd, the AAEC will convene an afternoon symposium in Juneau for school administrators and board members interested in how the arts can support and enrich education.

"I'm heartened by what I see happening in Alaska. I recently was invited to Unalakleet by the Bering Strait School District, to do an inservice for teachers on the weekend, about integrating the arts in school. Teachers from villages around Unalakleet came in, and I learned that the Bering Strait School District had a couple of teaching positions and decided to fill them with art teachers. I think that's really exciting," MacNaughton told us.

"The arts are a great way to keep kids engaged in school--a reason to come to school, and to stick with school--and I think in Alaska there are a lot of people who recognize that...who are finding ways to integrate the arts into different kinds of learning-math, literature, social studies--and also for the pure love of enjoying art experimenting."

### Annual Arts Curriculum Development Workshop to be Held in Anchorage February 22 & 23 - Travel Assistance Stipends Available!

Does your school district have a standards-based, sequential, arts curriculum? February 22 and 23, the Alaska State Council on the Arts (ASCA) will convene the third annual Arts Curriculum Development Workshop in partnership with the Alaska Department of Education and Early Development (DEED).

"The Department recognizes that the arts are an important component of a well-rounded education, that the arts enhance student learning by engaging students in creative thinking. The arts help students to problem-solve, take intellectual risks and work collaboratively with their peers. Most importantly the arts engage students and often keep them in school."

"In addition to ensuring that Alaskan students have a rich, comprehensive education, the Department is committed to helping districts balance the emphasis on tested content areas and the presently 'non-tested' areas. This is the third Arts Curriculum Development Workshop presented in partnership between the DEED and the Alaska State Council on the Arts (ASCA). This convening grew out of the realization that, according to the 2009 publication On Thin Ice, 72% of responding Alaskan districts did not have any arts curriculum to guide instruction. An arts curriculum provides a basis for ongoing arts instruction over the course of a student's education. An arts curriculum offers resources and guidance for both arts specialists and classroom teachers in the provision of the arts as part of instruction over the long term."


