Session 11-02 A Regular Meeting of the Public Arts Committee was called to order at 5:05 P.M. on February 10, 2011 by Chair Angie Newby in Mayor's Conference Room located at City Hall, 491 E. Pioneer Avenue, Homer, Alaska.

ABSENT: COMMITTEEMEMBER MILLER (EXCUSED)

STAFF: DEPUTY CITY CLERK KRAUSE

A Worksession was held prior to the regular meeting 4:00 p.m. to 4:55 p.m. Items discussed were funding opportunities for the Gateways Project at Baycrest Hill.

AGENDA APPROVAL

WOLFE/APLIN - MOVED TO APPROVE THE AGENDA AS WRITTEN.

The agenda was approved by Consensus of the Committee.

PUBLIC COMMENTS REGARDING ITEMS ON THE AGENDA

There were no comments.

Chair Newby noted that this is the first regular meeting since the last regular meeting. She requested a motion to approve each individually or altogether.

- A. Staff Report dated February 3, 2011

PUBLIC ARTS COMMITTEE REGULAR MEETING FEBRUARY 10, 2011

Ms. Krause reported that Council requested the exhibits mentioned in the Guidelines be included. Ms. Krause explained to the committee that she has located and included Exhibit A, Sample Request for Proposal; Exhibit C, Art Selection Proposal Review; and Exhibit D, Sample Contract between City of Homer and Artist. She stated that Exhibit B, a brochure entitled "Special Considerations for Art in Public Places" has not been located. A review of minutes dating back to the inception of the committee shows that there was discussion on creating this brochure and including it with all requests for proposals issued.

Discussion ensued on what the content of this brochure might contain and if there were any mention of a draft document or would this need to be created from scratch and if this should be added to the Strategic Plan for 2011. Staff stressed the importance of completing this document before the end of the year since it is a requirement of Council to include in the revised Guidelines.

APLIN/WOLFE - MOVED TO ADD CREATION OF BROCHURE ENTITLED SPECIAL CONSIDERATIONS FOR ART IN PUBLIC PLACES.

There was no discussion.

VOTE, YES, NON-OBJECTION, UNANIMOUS CONSENT.

Motion carried.

Ms. Wolfe will work on a draft of the brochure. She will research previous forms and documents used for past RFP's issued and bring to the next meeting for review and comment.

The next item in the report was the Municipal Art Collection catalog. Discussion included the following points:

- This was to be a bound document to contain documentation of all artwork owned by the City.
- How to catalogue all items of artwork such as Sister City items.
- It is not a project that needs to be completed this year but does need to be started.
- Quality pictures are needed on each of the items.
- Uniform signage for the artwork such as a display in a museum would have on it is needed.
- · What budget is there for art display information and identification plates?
- Could they issue a Request for Proposal Does not require a professional photographer can be amateur or offer as an opportunity for a Homer High School Senior Project.
- Road Map What do we need to do first?

Chair Newby requested this to be on the next agenda under pending business. Further discussion postponed to the Gateways Pending Business item on whether to have a special meeting or worksession.

Ms. Krause reported that she was working on the Art Walk Brochure. She has many samples and most depict the simple layout showing picture and location, along with a simple street map. Ms. Krause stated she would have a draft ready for the next regular meeting in May for approval. She will contact Ms. Erickson on having the brochures on her tour bus.

Chair Newby stated that they held a discussion on the selection committee jury during the worksession and Michele Miller volunteered to be the PAC member for the selection committee. The committee reviewed the requirements for the makeup of the selection committee. Chair Newby noted they needed a representative from each department plus an artist. Comments made by the Committee members were noted offering the opportunity to each department. Staff stated that the department heads were on the Task Force and could be the members on the selection committee.

A brief discussion ensued on proposed design, locations for each department in the building and that this project was part of the 1% for the Arts Project due to the dollar amount involved in the renovations and building addition but the \$15,000 allocated would not purchase much. Suggestions included one signature piece or proper display of existing artwork in the building. Ms. Miller will be invited to attend the City Hall Renovation & Expansion Task Force meeting on March 21, 2011. Along with other members appointed to the selection committee. Staff explained that the expedited schedule for design and construction start added

additional obstacles such as composing the selection committee, issuing a request for proposal for art and then review and selection, all before final design. This item was requested to be on the agenda for the next regular meeting.

There was no further discussion.

PUBLIC HEARING

PENDING BUSINESS

A. Gateways

Baycrest Hill Rest Area

Chair Newby stated they discussed this in depth at the worksession and Special Projects Coordinator Anne Marie Holen offered to find funding opportunities for Baycrest Hill as long as she received the blessings of the City Manager. Ms. Aplin will contact Roger McCampbell with the Alaska State Parks regarding the history and information on the Baycrest rest area; Terry Thompson with the Research Reserve has volunteered to locate funding for signage.

Chair Newby indicated that they will try to speak with Ben Ellis, Director of Alaska State Parks and Joel Hard, Superintendent, Lake Clark National Park, will be contacted during the Airport Mural dedication to see if they would be interested in collaborating with the Public Arts Committee on the revamping of Baycrest Hill. Chair Newby commented that former committee member Carol Harding has been very helpful in advising where and who the Committee can contact to get the revitalization of the Baycrest Hill pull out started.

The committee discussed having a worksession next month, March 10, 2011 at 4:00 p.m.

There was no further discussion.

2. Airport

a. Grand Opening

Ms. Marianne Aplin stated that she has been able to coordinate a date of February 17, 2011, 5:00 p.m. for the Ribbon cutting ceremony at the Homer Airport.

Dignitaries invited are Mayor Hornaday, Airport Manager Sheri Hobbs, Steve Delehenty, Refuge Manager, Alaska Maritime National Wildlife Refuge; Ben Ellis, Director Alaska State Parks; Roger McCampbell, Homer; Kathlene Rowell and Meg Anderson, Project Coordination and Design; Joel Hard, Superintendent, Lake Clarke National Park; and Elaine Wasserman with the National Park System.

Ms. Aplin reported that a press release was forwarded to the local newspapers regarding the celebration being held to recognize the efforts and the Public Arts Committee will be included. Michael Armstrong with the Homer News was invited to the event. Although Ms. Aplin stated she is still waiting for confirmation of attendance for some of the invited dignitaries.

The committee discussed providing refreshments and Ms. Aplin was waiting a response from Mr. McCampbell. She will notify staff if this will be required. Ms. Fellows requested removing the chairs from the area during the dedication.

Chair Newby congratulated Ms. Aplin on her success again and for spearheading this project.

The Committee members commented on the relatively short time line from conception to completion of this project.

There was no further discussion.

3. Ferry Terminal

Chair Newby summarized the current status of this gateway. The land is leased but the building is state owned. It will be up to the state to implement something. It was agreed to keep this on the agenda and to check with the State Council on the Arts to see what would be accomplished.

Chair Newby inquired if additional discussion was needed. She thanked staff for taking control on this project and not leaving it languishing. The Committee looked forward to seeing what staff created for them.

Chair Newby stated this was an important event and everybody should attend if their schedules permitted. Ms. Wolfe commented that she would be attending this event.

Ms. Krause noted she received a recent email from the State Council on the Arts that contained information on grants and may offer possible funding alternatives to projects and requesting interested parties to complete a survey. Ms. Krause will forward the email to the committee members and to Ms. Holen.

There was no further discussion or comments.

There was a brief discussion on the changes implemented regarding the makeup of the committee and the number of members being reduced from seven to five. Ms. Wolfe expressed a concern with limiting the resident/non-resident membership on the committee. The committee members appreciated the idea of needing only three members for a quorum. They discussed briefly that Councilmember Zak volunteered for the position on the committee. Chair Newby commented that she would contact Mr. Zak regarding the next meeting.

It was unsalvageable; since the sign, was anchored in cement, there was no intrinsic value after Public Works personnel completed the job. It is one more item task completed on the Strategic Plan.

Ms. Fellows this has been a good meeting and she will try to attend the ceremony at the airport. She hopes the chairs will be removed. She would like to have a meeting prior to the first cruise ship landing in May or June to finalize the Art Walk Brochure.

Ms. Aplin stated it is so exciting and thanked Ms. Krause for all her hard work.

Ms. Wolfe was glad to be back and making such progress on the projects; completing one and taking on another; she agreed that the airport should be kept on the agenda because the letters for the sign are in terrible need of replacement or some kind of attention.

A brief discussion on this project being considered art for funding of replacing the letters on the sign. The existing letters are plastic and cannot be seen due to the fading and color.

Additional discussion on scheduling a worksession in March and Special Meeting in April was held and since the matters of Baycrest Hill and the Art Walk brochure were time sensitive the committee agreed by consensus to schedule a worksession for March 10, 2011 at 4:00 p.m. and the Special Meeting for April 14, 2011 at 5:00 p.m.

Session 11-03 A Special Meeting of the Public Arts Committee was called to order at 5:05 P.M. on June 10, 2011 by Chair Angie Newby in Cowles Council Chambers located at City Hall, 491 E. Pioneer Avenue, Homer, Alaska.

PRESENT: COMMITTEEMEMBERS NEWBY, FELLOWS, APLIN, AND WOLFE

AGENDA APPROVAL

Chair Newby noted that items not on the agenda would not be allowed so to hold until the members comments at the end of the meeting and requested a motion to approve the agenda.

WOLFE/APLIN - MOVED TO APPROVE THE AGENDA AS WRITTEN.

There was no discussion.

VOTE, YES, NON-OBJECTION, UNANIMOUS CONSENT.

Motion carried.

PUBLIC COMMENTS REGARDING ITEMS ON THE AGENDA

There were no comments.

RECONSIDERATION

There were no items for reconsideration.

APPROVAL OF MINUTES

(Minutes are only approved during regular meeting.)

Chair Newby noted that this is a special meeting so there were no minutes for approval.

VISITORS

There were no visitors scheduled.

STAFF & COUNCIL REPORT/COMMITTEE REPORTS/BOROUGH REPORTS

A. Staff Report dated June 1, 2011

Ms. Krause summarized her staff report and noted that the project manager and contractor have stated that the project is ahead of schedule. She noted the departments that have relocated to the old middle school building. She further noted that Rick Abboud, City Planner was nominated/appointed to the selection committee and the contractor, Todd Steiner will fill the position on the selection committee under the "design team member" position. A brief discussion on the members of the task force really supporting the concept of an outdoor, visual 1% of the art that can be enjoyed by all members of the public.

Ms. Krause further explained that the area that was mentioned would be central and viewed by a majority of the public visiting the City Hall. The Committee held a discussion on the meaning and effect of the intent to

donate artistic architectural element for the project by Ms. Wythe. The committee was concerned that even as a donation she must follow the guidelines recently established regarding making donations.

The Task Force recommended that the Committee members consider nominating the person to fill the Artist role on the selection committee. It was even suggested that another member of the Public Arts Committee fill that position. It was noted that Ms. Wolfe would do that but she did have a few people in mind that she will approach. It was clarified that the Public Arts Committee person would not be the chair of the Selection Committee. It was discussed at depth that it was not the intent of the PAC to have any influence over the selection but would be a member only of the selection committee. However, if no other artist would like to sit as a member of the selection committee Ms. Wolfe will perform that task. In the interim, Ms. Wolfe will inquire about interest to serve on the committee. Ms. Krause confirmed the selection committee members at this time consisted of Rick Abboud, Walt Wrede, Todd Steiner, and Michele Miller. Ms. Wolfe will try to find someone available to serve July through January, February.

Discussion developed on the period for the implementation of the 1% of the Art Program, to include the actual budget, the concept, advertisement, review, selection and recommendation of the concept and/or piece.

Ms. Krause described briefly the changes and possible location for the central piece or public art ensued along with the ideas for the new landscaping, rain garden, etc. The Committee was adamant that the new piece, if chosen for exterior placement was determined, was not to be tucked away in a corner. The possible schedule for the meetings of the Selection Committee to draft the Request for Proposal advertisement, allowing the appropriate timeframe for submittals, review, and decisions plus then approval by council. Installation would be next April or May.

There was no further discussion.

Ms. Krause explained that she is at a standstill with the Walking Art brochure. She explained that she requires the exact locations that the public art is located around the city, a little history on the art itself and she requires the mapping ability or even just having a free hand drawing of the City streets. It was noted by Chair Newby that most of the artwork was on Pioneer, the Homer Spit, the Sterling Highway, and the Airport, etc. It was noted that if it is done "right" it might be a revenue producer. It was agreed that this could be readdressed in September or later in the year.

Discussion on the benches installed in front of the mural, and public works, and adding the old machine that is down by Public Works to the collection. Ms. Wolfe commented that the bench installed at the entrance to Public Works has only been installed a short time and has been damaged.

Ms. Fellows expressed concern over the removal and packing of existing artwork in the departments that are being renovated.

Discussion ensued on the opportunity of creating a committee to address placement and cataloguing the existing artwork to include getting better pictures for a catalogue. Ms. Krause explained that the Administration department was currently in the progress of relocating to the intermediate school. It was questioned where and how the artwork was going to be transported and if it could be made accessible to take pictures for the collection. Ms. Aplin commented on the gargantuan task that would be to accomplish. Ms. Wolfe noted that there was a difference between documentation, such as pictures of the harbor, past councils, etc. and paintings or sculptures, etc.

Further discussion on the purpose of the municipal catalogue and the pictures that have been taken in the past, it was questioned if they had enough monies in the budget to pay a photographer to come in and take pictures. Comments by the committee were related to a preference to expend funds on a banner over a photographer were noted.

Chair Newby agreed with the suggestion of taking pictures and put them on a CD suggested by Ms. Aplin. She believed the intent of the catalogue was just to have a record of items and that would suffice. There have been a number of years since pictures have been taken and Ms. Krause noted that the pictures they currently

have on file are unsuitable for print reproduction and it was noted that several items have not been catalogue. The committee members entertained continuing discussion on the following:

- intent of the book or compilation of the municipal art catalogue
- who is packing up the art in each department
- placement of artwork upon completion of the renovations and expansion
- what is considered quality artwork and personal or documentation
- the responsibility of cataloguing the existing collection belongs to the Public Art Committee
- the selection committee's task is limited to selecting and making a recommendation to Council on artwork selected to fulfill the 1% for the Arts Program.
- recommend staff submit a memorandum to the City Manager requesting user departments consider placement of existing artwork to enhance the piece, prominent display of important pieces in public spaces. The Chair will meet with staff to compose the memorandum.
- there will be more public viewable spaces for display of city owned artwork and this could be addressed in the fall or closer to completion of the project. Staff will obtain a project schedule and/or timeline.

Ms. Krause then addressed that budget time is coming up and cited the advancements of the Parks & Recreation, which is getting a lot of attention from the Council. Therefore, she wanted to have the committee keep the momentum going since they did have two successes.

There was no further discussion.

PUBLIC HEARING

This is on the back burner for consideration, due to no funding at this time. Therefore, they can address it next year depending on the various impacts, departments, etc., involved.

Chair Newby requested a motion to approve.

A discussion on purchasing a banner for use during the Homer Street Faire and 4th of July. It was determined it would be a good expenditure of funds. The visual stimulation and educating the public on the purpose of the Committee and the value to the community that public art gives back.

Ms. Newby, Ms. Wolfe and Ms. Fellows will split up the time working the Street Faire.

COMMENTS OF THE CHAIR

Chair Newby stated that Tom Reed is back in town and he is willing to do a small dedication for the wall at no charge. She will contact him about this if it was agreeable by the committee. There was no dissent voiced. The new owners of the old Smokey Bay Natural Foods building has the sign and if anyone is interested in this piece of art can contact the new owners. They had contacted the artist but he was not willing to change the

sign. The next item she commented on was the mural or wall at the Homer High School, there is a huge retaining wall toward the left. She would like to consider this wall when thinking about public art.

Chair Newby inquired if anyone would be available for a special meeting in July to sort of catch up on some things. There was misinformation in meeting time to 5:00 p.m. today. Questions were posed on if there work to be done in July compared to in August they have the budget. There will be a worksession prior to the next regular meeting at 4:00 p.m.

She will also draft letter to Councilperson Wythe, City Manager Wrede and Public Works for the benches but also a subtle reminder on the shrubbery.

Chair Newby inquired if the Committee was agreeable to allocate up to \$150.00 for a banner. A brief discussion what the banner would say, such as Public Art Matters or Public Art Rocks occurred. This banner would be direct marketing, visible, and out there. Mrs. Wolfe will contact Printworks and work on the design.

COMMENTS OF THE COMMITTEE

Ms. Aplin stated it is so exciting and thanked Ms. Krause for all her hard work. She asked if there was an existing policy on how public art would be added to City Hall. She commented on the policies put into place when they moved into their new building so it is not cluttered up. She can bring the policies they have for review at the next meeting.

The committee members were very interested in that idea and encouraged adding this to the August agenda. This would be a great opportunity to implement a new policy.

Ms. Wolfe commented that the wall at the school was another showing of how art affects our life similar to the walls at the Aloha Drive-In. She thanked everyone for hanging in there it has been a long spring.

A brief discussion ensued on the date of the last regular meeting.

Status Updates

1. 1% for the Arts Program

During the last meeting of the Public Arts Committee there was some misunderstanding on some of the concepts and requirements of the 1% for the Arts Program. I have reviewed the Ordinance, Homer City Code and the Administrative Guidelines and the following is excerpts from those references.

The amount designated for the program:

- 2. Project cost is defined as the cost of the <u>original contract awarded</u>, excluding land acquisition, site investigation, environmental cleanup or remediation. Subsequent change orders and <u>amendments to the contract</u> do not increase or decrease the amount of funding available for artwork.
- 3. The art budget will include all costs associated with design, construction, installation, and acquisition of works of art.

This is interpreted as the original contract amounts for construction of the addition and renovation of the existing building. The budget for the 1% for the Arts includes advertising costs related to issuing a Request for Proposals too. If the selected work of art requires a base or foundation those costs must be considered also. So even though the budget is \$18,000 plus; that is not the total funding available to an artist for a piece of artwork.

The artwork under the program is not limited to new artwork either.

A copy of the ordinance has been included for review.

The Public Arts Committee will <u>submit to the Council for its approval members of a new Jury</u> for each eligible project. Appointments will be made as <u>early as possible in the construction process</u> to <u>encourage integration of art into the architecture of the building</u> and design of the outdoor spaces.

2. Budget Considerations/Support

These statements or requirements were found in the Administrative Guidelines and could possibly aide in getting financial support for getting the 2012 budget approved.

Public Arts Committee will plan events and promotional tools that invite residents and visitors to enjoy the City of Homer art collection. These might include walking tour maps, guest lectures, online catalogue, etc. (Reso. 10-80, 2011.)

3. Other funds appropriated by the council for public art.

The Public Arts Committee annually shall prepare a plan for expenditures from the public art fund for approval by the city council. (Ord. 09-51(A), $\S1$, 2009.)

I recommend reviewing the budget prepared last year by Committee member Miller and revise as needed. This is included as New Business Item A.

Some budget items to consider strongly advocating for are advertising/awareness. This can be done by participating in such events as the Street Faire, Concert on the Lawn, Winter Carnival plus other annual City events.

Creating and Printing a tri-fold brochure that has a map of viewable Public/Private Art.

This document can be created in house but the materials and staff time should be accounted for properly.

Additional items to consider is the proper display and identification of City owned artwork.

The committee has talked about hiring a photographer even having a student take this on as part of the Senior Project but would need to have funds for equipment, etc. This can be incorporated into having a "book" created showing all City owned Art.

I suggest discussing and listing all the reasons why Council should allocate the funds the committee is requesting.

Appoint (or volunteer) for each committee member to attend one Council meeting during the next few months during the budget process. This way Council does not see the same person before them. Direct staff to write a memorandum containing the recommendations resulting from this meeting and distribute to each committee member. They can reference this document when speaking to council about funding.

18.07.010 Purpose. The State has recognized through the enactment of AS 35.27.010, and the City of Homer hereby recognizes by the enactment of this chapter, the responsibility of government to foster the development of culture and the arts through the purchase or commissioning of works of art for municipal buildings and facilities. It is therefore declared to be municipal policy that a portion of appropriations for capital expenditures for municipal buildings and facilities be devoted to the acquisition of works of art to be permanently placed or incorporated in such buildings or facilities. (Ord. 02-25(A), 2002.)

18.07.020 Definitions. The following words, terms and phrases, when used in this chapter, shall have the meaning ascribed to them in this section, except where the context clearly indicates a different meaning:

"Art" and "work of art" mean all forms of original creations of visual art, including but not limited to the following:

- 1. Sculptures: in the round, bas relief, high relief, mobile, fountain, kinetic or electronic, in any material or combination of materials.
- 2. Painting: all media, including portable and permanently affixed works, such as murals.
- 3. Graphic arts: printmaking and drawing.

- 4. Mosaics.
- 5. Photography.
- 6. Crafts: in clay, fiber and textiles, wood, metal, plastics and other materials.
- 7. Calligraphy.
- 8. Mixed media: any combination of forms or media, including collage

"Construction, remodeling or renovation of municipal buildings and facilities" means any capital improvement projects paid for wholly or in part by the municipality to build, rebuild or improve any decorative or commemorative structure, park or parking facility or any building.

"Total cost of construction, remodeling or renovation" means the total allotted funding for the subject project at the time of award of contract, exclusive of the costs of land acquisition, site investigation, and environmental clean up or remediation. (Ord. 02-25(A), 2002.)

- 18.07.030 Art funding requirements for public buildings and facilities. a. Plans and specifications for the original construction, remodeling or renovation of municipal buildings and facilities resulting in proposed capital expenditures exceeding the sum of \$250,000 shall contain and provide for the inclusion of works of art of a value of one percent of the total cost of the construction, remodeling or renovation project. All appropriations for capital improvements falling within the provisions of this chapter shall be deemed to include funding to implement the requirements of this section.
- b. If there is a change in the total cost of the project resulting from a change order or amendment to the project budget after the time of the award of the contract, the amount of funding for the artwork will not be changed.
- c. Expenditure of sums required to be allocated to works of art under subsection 18.07.030 (A) shall be limited to all costs associated with design, construction, acquisition and royalties for the works of art, excluding all contract administration and project administration costs.
- d. Municipal funding of art projects for capital expenditures will be capped at \$70,000.00 (seventy thousand dollars). Art projects for capital expenditures exceeding \$7,000,000.00 (seven million dollars) will not be greater than \$70,000.00 (seventy thousand dollars) unless funding beyond \$70,000.00 (seventy thousand dollars) is from private contributions.

- e. Private funding contributions for art projects in public buildings is encouraged and this funding is not considered part of the one percent. (Ord. 02-25(A), 2002.)
- 18.07.040 Implementation. a. During the preliminary design review of any project for construction, remodeling or renovation covered by this chapter any contractor, department or instrumentality of the municipality charged with the design preparation of this project shall consult with the Public Arts Committee regarding the implementation of section 18.07.030 (A).
- b. The Public Arts Committee shall develop and recommend to the administration and the Homer City Council administrative regulations setting forth the manner in which the requirements of this chapter shall be carried out. After the receipt and consideration of such recommendations, the City Manager will adopt administrative regulations, which will become effective upon City Council approval.
- c. The requirements of section 18.07.030(A) shall not be waived except as provided for in section 18.07.070. (Ord. 02-25(A), 2002.)

- 18.07.050 Selection. a. Where the construction, creation or commissioning of works of art are to be incorporated in the building or facility or its grounds, such works of art shall be selected and recommended to the Council for approval by a jury of at least three members consisting of the architect or project designer, a representative of the user department, a representative of the Public Arts Committee and any other persons as may be designated by regulation and recommended to the Council for approval.
- b. Where there will be an acquisition of existing works of art or the commissioning of works of art which will not be incorporated into the project design, selection shall be made or approved by a jury of at least three members consisting of a representative of the user department, one or more representatives of the Public Arts Committee and other persons as may be designated by regulation and recommended by the Council for approval. (Ord. 02-25(A), 2002.)
- 18.07.060 Program Administration; Public Arts Committee. a. The City Council shall appoint a Public Arts Committee consisting of five members. Prior to making appointments, the City Council may solicit nominations from the Pratt Museum, community arts groups, and the public. Appointments will be for two year terms. Initial terms shall be staggered as follows: Four two-year terms; three one-year terms.' In

the event of a vacancy on the Public Arts Committee, the Mayor shall appoint a person to fill such vacancy for the unexpired term, subject to confirmation by the City Council. Members serve at the pleasure of the City Council. (Ord. 02-25(A), 2002; Ord. 07-19 §1, part, 2007.)

- 18.07.070 Exemptions. If it is found by the Public Arts Committee or City Manager that the inclusion of works of art in any specific project, as required by this chapter, would not provide any aesthetic benefit to the community or to the principal users of the building or facility, the Committee or City Manager may recommend to the City Council that there be granted a waiver from the requirements of this chapter in whole or in part. The Council shall make the final determination in any disputes arising from the administration of this section. (Ord. 02-25(A), 2002.)
- 18.07.080 Miscellaneous provisions. a. Sums allocated for the acquisition of works of art under the provisions of this chapter shall be deemed to be part of the construction costs of the project.
- b. Where federal or state grant funds are to be used to match municipal funds for a construction, remodeling, or renovation project covered by this chapter, the grant application shall, where applicable and where permitted by the granting authority, be made for the total cost of such project, including portions to fund works of art under this chapter. Unless prohibited by the terms of such grants, any money received may be used to implement the requirements of this chapter. (Ord. 02-25(A), 2002.)
- 18.07.090 Public art fund. a. A public art fund is established as a separate, interest bearing account in the city general fund to receive money for the public art program from the following sources:
- 1. Funds for public art fees received from private development.
 - 2. Funds donated to the city for public art.
 - 3. Other funds appropriated by the council for public art.
- b. Money in the public art fund shall be used solely to pay the costs of selecting, commissioning, acquiring, installing, maintaining, public education regarding, administrating, removing and insuring the works of public art, and any other expense related thereto.
- c. Interest earned on money in the public art fund shall be deposited in the public art fund.
- d. The public art fund is administered by the city with the advice of the public arts committee.

- e. The public arts committee annually shall prepare a plan for expenditures from the public art fund for approval by the city council. (Ord. 09-51(A), \S 1, 2009)
- 18.07.100 Ownership and management of works of public art. a. Ownership of all works of art acquired by or on behalf the city shall be vested in the city.
- b. The city shall place or construct public art at locations that are open to the public and where the public art shall be visible to the general public during, at a minimum, normal business hours.
- c. The removal from display by the city of public art owned by the city shall follow established guidelines for deaccessioning and shall be subject to review and recommendation by the public arts committee with final approval by the Council. (Ord.09-51(A) § 2 2009)







What makes any town a desirable place to live or visit? It is beauty. There is almost always abundant natural beauty surrounding the place, and often there is beautiful architecture. Painters, sculptors, fiber artists, woodworkers, and writers all leave their work to be appreciated for decades or even centuries, but what about the work of performing artists? Just a few decades ago, in the days prior to the widespread and common use of video and sound recording devices, these performing artists were working hard to enrich the lives of both residents and visitors with plays, concerts and performances of drama and comedy and dance. Back then, once the performance was complete, it was lost in time--resonating only in the memories of those who witnessed the event.

This mural is a reminder of those performances, and a gesture of appreciation to those artists who dedicated themselves to enriching our quality of life. The artists portrayed here are well-known in this community, but they are only a few of the many performers that have delighted Homer audiences over the years.

Where do you live and how does it influence your art?

I live in Juneau--my hometown. The place where I live influences how I think, how I see the world, and how and what I write.

Do you have a favorite neighborhood?

I often imagine myself living back downtown on the tiny piece of property at the edge of the Juneau Indian Village where I lived for the first several years of my life. The property is still there, but the house was torn down many years ago when my mother and I were living down south. Added to that, the fractionalization of Indian property has made re-building a house on that old property virtually out of reach. But it rests at the base of Mt. Juneau, near the waterfront, within walking distance of all the old places. My childhood resides there in that favorite neighborhood that, like my youth, now exists only in

lemory.

xplain what versatility means to you and why it matters in your work.

ersatility, I suppose, is the ability to be creative in composing any manner of writing. Such a skill matters a great sal to me, since I invest a lot of imagination into such things as my syllabi, my emails, and my lessons. Versatilit terms of work can mean teaching different levels of classes by different methods using different techniques. I ach pre-college classes through graduate classes on campus and online, and I strive to make use of effective chnologies and methods--which means I stay away from a lecture-only class as much as I can.

/here would you send visitors to your community and Alaska in general?

my community: on a walking tour of downtown Juneau and on a bus ride to Douglas for a view of Juneau. In laska: on the waters of Southeast Alaska--the Inside Passage.

he Alaska State Council on the Arts hosted three traditional northern Athabascan snowshoe masters and operatices to work in the Smithsonian Arctic Studies Center the first week of May. The program was part of SCA's ongoing Living Cultural Treasures Program. The residency was designed to strengthen infrastructure for laska's Folk and Traditional Arts and artists and included in depth documentation of the cultural knowledge of pecific individuals about endangered Athabascan art forms.

laska Athabascan master snowshoe makers, Alaska State Council on the Arts, and its partners, the Smithsonia rctic Studies Center and the Anchorage Museum worked together to preserve, teach, and celebrate significant and endangered forms of traditional indigenous art. The residency responded to urgent recommendations from laska Native communities to connect older and younger generations of artists through apprenticeships and ands-on training.

killed master Athabascan snowshoe makers were matched with serious apprentices to convey their snowshoe aking expertise and craftsmanship. Koyukon Athabascans, George Albert of Ruby and Butch Yaska of Huslia structed apprentices in two traditional Koyukon snowshoe styles. Gwich'in elder, Trimble Gilbert (Arctic Village) scussed the art and practical use of snowshoes in his Native language.





The program incorporated Koyukon and Gwitch'in Athabasca story telling, documented both languages, and captured the rich vocabulary, traditional knowledge, and northern Athabascan stories throughout the week long residency. The Anchorage Museum collections staff provided the master and apprentice teams with access to onsite objects in the collection for analysis and study.

ASCA, the Anchorage Museum Education Department, and the Arctic Studies Center facilitated an accompanying school science education program for almost two hundred Anchorag School District pupils and their teachers. The public was provided access to snowshoe makers' demonstrations and presentations.

The Anchorage Museum at the Rasmuson Center "Living Oul Cultures, Sharing Our Heritage: The First Peoples of Alaska," exhibition features 600 historic masterworks of Alaska Native arts and design. It is a community resource for hands-on stud by Native elders, artists, and scholars and serves as a research facility and a public space for teaching, recording, and presenting indigenous knowledge.

ne Living Cultural Treasures Northern Athabascan Snowshoe residency was funded with National Endowment r the Arts, Folk and Traditional Arts Infrastructure grant and contributions from the Smithsonian Institution's ecovering Voices program. A five minute DVD of Snowshoe Residency highlights will be available at the end of agust.
