7.A. EDC Staff Report
Agenda Item Report EDC 23-004

Economic Development Manager Engebretsen spoke to her written report and answered questions from the commission. She confirmed with commissioners that March 14th, which is during Spring Break, will still work for the next regular meeting.

7.B. Mayor's Report

Mayor Castner reported on his work with the Port and Harbor Advisory Commission on the harbor expansion project, efforts to seek out funding sources to pay for everything, and securing approval from the U.S. Army Corp of Engineers to conduct a general investigation study.

There was discussion on City revenue sources through sales tax and bed taxes, the Mayor's goals regarding planning and zoning code updates, and responses to questions from the commission.

7.C. Homer Marine Trades Association (HMTA) Report HMTA Meeting Minutes 1/4/2023 HMTA Meeting Agenda 1/26/2023

Chair Marks noted the HMTA items in the packet and reiterated Economic Development Manager Engebretsen's efforts to get HMTA members to come to future meetings to give in-person reports.

9. PENDING BUSINESS

9.A. Housing and Short Term Rentals Agenda Item Report EDC 23-005

Chair Marks introduced the agenda item by reading the title. She reported on her involvement with a greater Homer housing event that is scheduled for March 25th at the Homer Community Christian Church. More details to come. It will be an opportunity for community stakeholders to come together and discuss solutions to the Homer housing issues.

Mayor Castner interjected to include additional housing issues, particularly related to worker housing, that the group should be addressing. He opined how a housing association should be established.

There was discussion on the purpose of the event, what kind of aspects commissioners would like to see addressed, and how individuals or professionals can participate in the event.

Chair Marks explained how she will be attending other advisory body meetings to share the event information.

10. NEW BUSINESS

10.A. Wayfinding and Streetscape: Banner Design Agenda Item Report EDC 23-006

Chair Marks introduced the agenda item by reading the title and deferred to Economic Development Manager Engebretsen.

Ms. Engebretsen spoke to the banner design work from Corvus Design and invited commissioners to give feedback. Commissioners shared their opinions on the designs, their support for the direction of the artwork, and their suggestions for using other animals or various aspects of Homer.

10.B. Land Allocation PlanAgenda Item Report EDC 23-007

Chair Marks introduced the agenda item by reading the title and deferred to Economic Development Manager Engebretsen.

Ms. Engebretsen explained the process for the EDC's annual review of the Land Allocation Plan. She gave an overview of staff's recommendations for removing Overslope Areas 2, 3, and 4 from Section A, land available for lease, and updating the descriptions for Lots 9A and 10A to reserve them for fisheries uses or short term leases. She facilitated discussion with the commission on the rationale for removing those overslope areas, or if there were ways to leave the areas on.

Chair Marks asked for a motion.

PITZMAN/CHEROK MOVED TO REMOVE OVERSLOPE AREAS 2, 3, AND 4 FROM SECTION A OF THE LAND ALLOCATION PLAN, AND RECOMMEND TO CITY COUNCIL FOR APPROVAL.

There was no discussion.

VOTE: NON OBJECTION: UNANIMOUS CONSENT.

Motion carried.

AREVALO/PITZMAN MOVED TO RECOMMEND TO COUNCIL THAT LOTS 9A AND 10A ON FISH DOCK ROAD BE DESIGNATED FOR FISHERY USE LEASES.

There was no discussion.

10.C. Chamber of Commerce Strategic Plan Worksession Agenda Item Report EDC 23-008

Chair Marks introduced the agenda item by reading the title. She noted the EDC Strategic Plan and the Homer Chamber of Commerce's Strategic Plan in the packet and explained the purpose behind the joint worksession will be to discuss their mutual economic development goals.

Economic Development Manager Engebretsen spoke to the structure of the worksession and that Adele Person will be facilitating the dialogue and asking the groups questions, so to come prepared.

10.D. EDC Mission Statement and Defining Positive Economic Development Agenda Item Report EDC 23-009

Chair Marks introduced the agenda item by reading the title and deferred to Economic Development Manager Engebretsen and Commissioner Perez.

Ms. Engebretsen summarized the EDC wanting to work on a mission statement and some guiding principles for what the EDC does, and Commissioner Perez volunteered to work on that statement.

Commissioner Perez explained his work behind writing the draft EDC mission and vision statement, what characteristics it should include, the sources he pulled from to come up with the vision, and then using that to write out the mission statement. He expects to have a final draft for the next meeting.

There was discussion on the document, the overall support of Commissioner Perez's work, and the commission's consensus to hold off on making a motion to approve the statement until their next meeting. Chair Marks asked commissioners to submit their input to Ms. Engebretsen before the next agenda deadline and that they would have it on the March agenda.

Scott Adams, city resident, commented on the banner designs for wayfinding and streetscape and how they tie into aspects of the community, and his experiences with the housing issues in Homer.

13. COMMENTS OF THE CITY STAFF

Deputy City Clerk Tussey noted the polls for the Borough Mayor Special Election were still open for a few more minutes if any commissioners had not voted yet. She announced reappointment notices will be sent out at the end of the month/early March to Commissioners Marks and Perez, and to complete the reappointment application that will be with that notice if they're interested in serving for another 3-year term.

Economic Development Manager Engebretsen wished the commission a Happy Valentine's Day.

14. COMMENTS OF THE COMMISSION

Commissioner Arevalo reported there is a new partnership between the college's new agriculture program and the Natural Resources Conservation Service that offers "Know Your Land" talks at the

college and online. There are free workshops coming up for those interested. She announced the Alaska Food Hub is reopening for the season; there won't be much food offered yet but there will be items such as microgreens and locally made food products. She encouraged everyone to support local farms by buying through the food hub.

Commissioner Arevalo left the meeting at 7:55 p.m.

Student Representative Pearson commented it was great to see the harbor expansion project design concepts; her mom owns a business out on the Spit so it would be good to see more traffic.

Commissioner Perez commented on the Kachemak Bay State Park has launched the new management plan and are rezoning for more recreational use among other things. He opined it's something the EDC should keep in the back of their head as far as development planning for that space that they could be promoting.

Commissioner Gamble wished everyone a Happy Valentine's Day and thanked Mayor Castner for attending.

Commissioner Cherok noted it was a good meeting and apologized for having to keep his video off while he is in the middle of traveling.

Commissioner Pitzman voiced his appreciation for the warm welcome as a new commissioner. He commented on the EDC materials he was reviewing and how it struck him how lucky our community is to have these incredible economic development spring boards to start with, and the amount of work that has gone on by people with their hearts in the right place to secure our bright future. He appreciates being here.

Chair Marks commented on the upcoming joint worksession with the Chamber of Commerce, highlighted the Library Western Lot project that the Friends of the Homer Library secured grant funding for, and looking forward to the new Chamber Visitor Guides that are expected to incorporate more wayfinding. She thanked the commission.

Mayor Castner thanked the commission for their service and his hopes that they will focus on the business elements of all the plans that the City is working on. There are a lot of things happening, stuff in the works, and encouraged them to stick with it and ask questions.

The Commission continues to work on platting issues and will review two conditional use permits at their March 15th meeting.

Homer Marine Trades Association Regular Business Meeting January 26, 2023 Harbor Master's Office

Call to order: The meeting was called to order at 6:15 p.m. by Vice President, Eric Engebretsen

Officers/Directors present: Eric Engebretsen, Jen Hakala, Cinda Martin, Kate Mitchell, Bruce Friend, and Mark Zeiset. Aaron Fleenor, Claire Neaton, Josh Hankin-Foley and Adam Smude were absent. Amy Woodruff was also present. A quorum was established.

Guests Present: Harbor Master Bryan Hawkins – presented a new conceptual drawing for the large vessel harbor plan prepared for their visit to Juneau. The new drawing shows a larger buildout to accommodate a deep-water dock looking to the future.

Approval of Agenda: Motion by Kate Mitchell to approve the Agenda with the addition of our Annual To-Do List under Old Business and the Letter of Support to Governor Dunleavey for the MXAK system upgrade, 2nd and carried.

Approval of Minutes of the January 4th, 2023 Meeting: Motion by Mark Zeiset to approve the minutes as written, 2nd and carried.

Treasurer's Report: Treasurer, Jen Hakala presented a current Statement of Financial Position, A/R Aging Summary as well as a 3-year Fiscal Year Comparison of Activity. She stated that we received the bill for the Anchorage Boat Show that we will be splitting with Bay Welding; our portion is \$12,450. She will be billing members for booth space next week (@ \$750 each) and paying the invoice. The Fish Expo deposit is coming up @ \$5,175. HMTA pre-paid some advertising that will be reimbursed by the Port & Harbor. With regard to the Activity Comparison, there are large differences primarily due to COVID and the shows being cancelled. Also, it seems that members have been slower to pay than in the past. Lastly the 990N is on Jen's radar but the IRS is not yet accepting them. Reports are attached for the record.

Committee Reports:

- Advertising Kate reported that we have paid Pacific Fishing and Fishing Magazine for the
 upcoming ads and submitted the bills to the City for reimbursement. We have not renewed any
 ad with Work Boat at this time. She will do an ad in the Homer News with a notice of all the
 member businesses attending the Anchorage Boat Show.
- Website/Social Media Mark reported that the website categories could use some updating; suggestion to create a cross reference alpha directory.
- Radio Mark details of Alpha Media ad pricing. In 2020 we did radio ads May thru August on the CBS sports station tagged onto the fishing report @ \$2,100. Discussion held regarding creating and presenting an easy way for our members to sign up for radio ads. Will look at KGTL as well as the Anchorage stations. Will discuss further at the next meeting.
- Workforce Development
 - FOLs no further contact from Walter; discussion held regarding the possibility of moving FOLs to the FLEX. Kate volunteered to contact Lindsey Martin there.
 - KPC courses Cinda will invite Jill to the next meeting to check status of courses.
 - Career Fair at KPC 3/3 Cinda is putting an HMTA panel together and would like to target welding, electronics, commercial fishing and boatyard work. She will send out an email to those target members with the Career Fair date/time information. Career Fair flyers are ready to distribution on our website and social media. Cinda will email to Amy.

- Scholarship Cinda reported that there have been no Marine Tech Series applications all year. It is time to get our spring scholarship advertised; Cinda will check the website for a current application and email to Amy and the schools.
- Membership Discussion held regarding potential new members. ACDC is interested in hosting
 a Round Haul, Bruce will put that together and shoot for March. Also discussed the need for an
 updated membership list imported into Mail Chimp; needs to be a priority and be sure all new
 members are included, several are still not receiving communications through that platform.

 - Set up Eric reported that cost is up this year but we have a little more space this year, could have had a lot more at a discount but didn't want to over-commit.  - Booths Bruce reported on the layout and will be sending out an information sheet to all HMTA participants.

Call to order: The meeting was called to order by President Aaron Fleenor at 6:06 p.m.

Officers/Directors Present: Aaron Fleenor, Eric Engebretsen, Kate Mitchell, Jen Hakala, Cinda Martin, Bruce Friend, Adam Smude, Claire Neaton, Mark Zeiset and Amy Woodruff. Josh Hankin-Foley was absent. A quorum was established.

Guests Present: Jill Burnam from Kenai Peninsula College; Amber Fleenor of A&A Boats; Troy Laky and Dave Inman from ACDC Electric; Homer Harbor Master, Bryan Hawkins

Guest Presentations:

- ACDC Troy Laky and Dave Inman reported that they offer marine electrical, solar systems, lithium batteries and Star-Link internet. They would love to host a Round Haul April 29th and will provide refreshments.
- Bryan reported that all the money is in place to move forward with the harbor expansion feasibility study and the City has already accomplished some of the tasks needed for the study; they should be getting a start date soon, anticipating spring 2023. They are also considering a full float system replacement project, estimated cost of \$72MM; federal funding provides 80% funding, they are investigating various grants for the balance. He also reported that the harbor is taking over the camping and parking and are looking at a new digital parking program where visitors can pay on their phones.

Approval of Agenda: Motion by Eric Engebretsen to approve the Agenda as presented, 2nd and carried.

Approval of Minutes of January 26, 2023: Motion by Mark Zeiset to approve the minutes of January 26th as written, 2nd and carried.

Treasurer's Report: Jen gave her report, a Statement of Financial Position was presented and reviewed, copy attached. The 1st half 2023 Fish Expo bill of \$5,000 has been paid. The storage unit annual bill will be coming due in August and it will be HMTA's year to cover the cost of \$900 (year on/year off with Port & Harbor). She also reported that we were \$992 short of covering the cost of the booth space primarily due to the last-minute cancellation of the Homer Charter Association; Bruce will have a conversation with them to discuss. Total 116 members to date with a couple of new members; Daigle Boat Works, Bob's Trophy Charters, and Mako's Water Taxi.

Communication's Director Report: Amy reported that she is planning to reconcile the membership lists against the invoice list and report back with who is unpaid and needs contact. She is also thinking of a better way to handle new members and smoother process. Website – she met with Grady and did a walk-through of the platform; she added the menu and uploaded current minutes. She plans to contact members in groups to have them review their profiles and make revisions, it will also give her a chance to meet the business owners and understand what they do. Social Media – has posted Career Fair flyers and updates about the HMTA panel; nothing coming up until the Round Haul but will post. Mail Chimp has been updated and linked to QB so that new members added in QB will automatically be added in

Mail Chimp. She plans to send out links to minutes and will be ready for any newsletter content. She will send out Scholarship Application news. She's met with Cinda and Jen. She's been keeping track of her time and is managing well. Regarding EDC, we are a standing agenda item and they do publish the minutes if sent. We don't have to attend but we should let them know if we want to stay on the agenda. Eric expressed an interest in attending.

Committee Reports:

- Advertising Kate reported that we have been reimbursed by the City for both print ads; she purchased an ad and sent in a story with the Homer News regarding our presence at the Anchorage Boat Show. She is keeping a scrap book of our history since 2011 to keep track of our history (3)
- Website See Amy's report above
- Radio Alpha Media ad Mark reached out to previous radio advertisers and 2 have said they
 would advertise again; Great Alaska Fishing Report details attached for the record. Ads
 generally include tags for Port and Harbor, HMTA and various members. We would need to
 submit our ad by May 1st to run May August. Need to choose station and length of ad.
- Workforce Development
 - FOLs Aaron reported that he spoke with Walter and he is willing to do FOLs, field trips are doable but the bus fees have increased; nothing scheduled and we are running out of weeks
 - O KPC Courses Jill Burham reported that they have the 100-Ton scheduled 3/17 4/9, 11 seats are full at this point. Anna Borland has agreed to teach the Deck Hand course; Adam Smude is scheduled to teach in April and Mark Zeiset will teach a Maritime Computer Navigation course in March. Brad is teaching a CAD class in April and an AB course will be scheduled in the fall. KPC/Kachemak Bay Campus can now proctor exams. They are trying to offer courses that complement the 100-ton course. They finally have welding courses set up in collaboration with Bay Welding and are working on offering pre-requisite welding courses in Kenai. She encouraged us to think about utilizing the college space for off-hours courses. She is willing to put together any classes we'd like to offer.
 - Career Fair Cinda reported on the Career Fair happening this Friday; reviewed panel
 questions for the HMTA panel happening at 1:30pm. HMTA will have a table and have a
 list of open jobs with members. Eric, Bryan and Aaron all have jobs to list and will email
 their information. Scholarship applications for the spring scholarship and Marine Tech
 Series will be available. Bryan will also email the Harbormaster's Scholarship
 application.
 - Scholarship marketing is on Amy's action list; upload current application to the website and drive traffic with a link

Old Business:

- Annual To-Do List attached; work in progress
- Anchorage Boat Show Eric recapped the show; bigger show and better attendance and had
 more conversations referring customers to other HMTA members for outfitting. Observation
 that the HMTA triangle sign was more effective than the double-sided sign hung at this show.
 Eric also mentioned that he is not opposed to the placement of boats in the center of the booth

- to allow members to circle around them, he is not set on being on the aisle. The mini aisles were okay but not the most efficient arrangement.

Vision Statements: What Do We Want to Become?

It is especially important for managers and executives in any firm to agree on the basic vision the organization strives to achieve in the long term. A **vision statement** should answer the basic question, "What do we want to become?" A clear vision provides the foundation for developing a comprehensive mission statement. Many organizations have both a vision and mission statement, but the vision statement should be established first. Examples of vision statements are provided in Table 2-1. The vision statement should be short, preferably one sentence, and as many managers as possible should have input into developing the statement. Recall Proverbs 29:18 that says "Where there is no vision, the people perish."

TABLE 2-1 Six Exemplary Vision Statements (paraphrased)

- Dr Pepper Snapple: to be the best beverage business globally; our brands are synonymous with refreshment, fun, and flavor today and tomorrow.
- IBM: to be the world's most successful information technology company focused on helping customers apply technology to solve their problems now and in the future.
- Hilton Worldwide: to fill the Earth with the light and warmth of hospitality by delivering exceptional experiences—every hotel and guest for all time.
- Starbucks: to be the premier purveyor of the finest coffee in the world while maintaining uncompromising principles as we steadily grow.
- Kellogg: to enrich and delight the world through foods and brands that matter today and tomorrow.
- Harley-Davidson: to fulfill dreams through the experiences of motorcycling for all time.

Characteristics of a Vision Statement:

- 1. Clear: Reveals type of industry and what firm strives to become
- 2. Futuristic: Reveals what the firm strives to become or accomplish within time frame
- 3. Concise: One sentence
- 4. Unique: Reveals firm's competitive advantage
- 5. Inspiring: Motivates the reader's to support firm

I relayed the Commission's comments on the banners to Peter Briggs (Corvus Design consultant). He commented about the desire to include a banner with reference to Alaska Native culture:

"As to Alaska Native, due to cultural appropriation sensitivity, we don't generate Alaska Nativeesque work unless we do have an Alaska native partner. Is there an Alaskan Native artist in the area we might reach out to for an idea we'd put into the same style?"

I asked Adele Person, as Bunnell has done a lot of work on culturally sensitivity and native artists. Her comment:

"I think it would be worth doing a training about cultural sensitivity and land acknowledgement. I can recommend Melissa Shaginoff as a person who conducts workshops like this. I know she is incredibly busy through May, but as a long term learning goal, this could be valuable.

The other person who might be interesting to reach out to is Ivan Encelewski, the Executive Director of the Ninilchik Village Tribe's governing body, the Ninilchik Traditional Council. Again, I think this is about relationship building.

Nadia Jackinsky might be another good contact. She is of the Ninilchik Tribe and works for the Ciri Foundation. She would be a good sounding board and even a person who could recommend artists down the line. She curated the Salmon Cultures exhibit at the Pratt Museum recently and is very knowledgeable. Her email is nsethi@thecirifoundation.org."

There is LOTs of potential for the City and private businesses to incorporate Native Alaskan topics through interpretive panels etc. It's a great idea. But we need to have an intentional and inclusive process. I asked Peter to move forward on the other comments so this project can keep moving. As of yet I do not have an Alaska Native artist to work with; if we can work something out we can include a banner in the future.

I hope to have revised banner designs at the meeting for EDC review.

Michael Daniels - Chamber Board. Has developed a workforce housing area. Veterans charity. Here to listen and learn.

Brad Anderson - Joined the HCOC in Dec 2019 as the ED. Recently updated HCOC Strategic Plan. Looking to support a more diverse economy.

Karin Marks- On EDC and KPEDD with Brad. Ran the Artshop for years and now has Artshop rentals. Interested in the Comp plan and updated zoning codes and the effect on the economy. Wants to think about downtown Homer just as much as Harbor expansion and other areas of town. Need to un-silo commissions, council and other entities to work together to solve our local challenges.

Julie Engebretson - 21 years at the City as planner and now Econ Dev Manager. No blueprint for that role so lots of opportunities.

Luke - owner of a year round business. Not always a tourist business. Sees workforce development as key. Very hard to find sufficient staff these days.

Nicole - Has lived in Homer for years and worked extensively in the food & beverage industry. Now at Homer Soil and Water Conservation District. Champions protecting our natural resources and habitats like water, wildlife and forest that bring many of us here.

2. (10 min) Role, mission & overview of the Homer Chamber of Commerce - Brad Anderson.

The Chamber is 99% small business. Are charged by the City for marketing. Also do advocacy. Hold events. Are Membership Based. Attend trade shows. Have 4 Visitor centers. Host working groups. Market trades. Trying to have an event / month that focuses on community, business, visitors on a rotating basis. There are 5 staff and 25 volunteers.

3. (10 min) Role, mission and overview of the City of Homer Economic Development department - Julie Engebretson

EDM has a standing seat on the HCOC board and is able to point people to good partnerships. City has not focused on business community extensively in the past. Comments on a big push to develop the Town Square that maybe took a lot of energy away from supporting Pioneer as sour downtown corridor. Now looing at Development and housing among other topics. City recently awarded a 1.2M green infrastructure grant. Applied for a RAISE/REACH grant to get to 65% design on some of our transportation challenges (KDrive, others)

4. (5 min) Role and current focuses of the Economic Development Advisory Commission - Karin Marks

EDC is a proactive commission that can be a great community sounding board. EDC was almost cut, but has really shown its value in the last few years. Ran the Wayfinding and Streetscape plan project. Recently conducted a SWOT analysis for Homer as a very first step towards the Comprehensive Plan. Working on Mission and Vision currently.

The Chamber does relocation, marketing, 4th of July parade, Winter parade, Winter King derby, other derbies, Tree lighting ceremony, Business meetup, Halloween. HCOC also provides key support for community efforts like the AK World Arts Festival, Shorebird, Peony festival, Pioneer Avenue Revitalization.

HCOC as an action arm of EDC. EDC as a sounding board and advocate for HCOC ideas.

8. Final thoughts and conclusions

Excited to work together and consider both economic and community development as synergistic efforts. Community Development is Economic Development. Excited to cooperate on our biggest challenges like housing, workforce, and seasonality. Learned a lot and shifted perceptions of what each entity does. Maybe we market less, but still not nothing. Must consider youth and perception that this is not a place they want to stay. Community events and keeping businesses open are important goals. Nice to think of community and business sectors coming together.

Sales Tax Update for 2022


Complete sales tax numbers for calendar year 2022 have been released by the Kenai Peninsula Borough. The 4th quarter (or 2nd quarter of Fiscal Year 2023) saw a 2.6% increase in taxable sales over the previous year and is expected to bring in approximately \$2 million in total sales tax revenue (not including remote sales tax). Year over year, the City's taxable sales increased 7.2% and should amount to approximately \$12.5 million in total sales tax revenue (not including remote sales tax).



TSUNAMI



Tsunamis are generated by a disturbance most commonly associated with earthquakes, which occur below or near the ocean floor. Other sub-marine landslides and volcanic eruptions can also generate a tsunami.

Tsunami waves are destructive and affect beaches that are open to the ocean, tidal flats and anything in their path. Secondary hazards occur from erosion, destruction of roadway embankments, foundations, cause damage to structures, roads, bridges and more caused from extreme floodwaters and debris. Toxic materials and sewage released from damaged wastewater treatment plants can pose health risks and contaminate water and food supplies. Tsunamis can cause the most devastating damage in a short time than any other hazard to a community.

The tsunami inundation zone for Homer is nearly the entire Homer Spit along with low-lying areas around Beluga Lake and to the coast, excluding the airport.

The 1964 Great Alaska Earthquake triggered several tsunamis between 20 and 40 minutes after the quake. Homer was struck between 2 and 5 minutes after the earthquake, which caused most of the deaths and damage here.

The Alaska Earthquake Center and University of Alaska Fairbanks created a model for tsunami waves and inundation map for Homer. You can read more about it in the **Local Hazard Mitigation Plan, Table 3-8:**Tsunami. They conducted several scenarios to simulate various degrees of inundation depending on the severity of the earthquake. The likelihood of a tsunami is hard to predict; however, previous events have shown that an earthquake-generated tsunami could impact the Homer community in the next five years (up to 1 in 5 chance of occurring).



Ice Plant Gets Update

The Ammonia replacement project happened this month at the Ice Plant. The first time in 40 years! Although the Ice Plant has been maintained very well since being built in 1983, bringing the plant up to date with efficiencies of today's technologies will have an exponential benefit to the overall operation system. The upgrade will also reduce operating costs, optimize energy savings, and give everyone peace of mind.

Ice Plant Manager *Del Masterhan*, (top photo), is shown masked up and working on the system during the project. New ammonia tanks (below right) were carried and put into place to replace the aging system.

The Ice Plant & Fish Dock produces over 3,500 tons of flake ice per year to preserve the quality of more than 20 million pounds of salmon, halibut, sablefish, and pacific cod landed at the Port of Homer.





Anchorage Boat Show

Installation is expected to occur this summer and the new siren will provide coverage to the inundation zone located on Kachemak Drive at the northeast end of the Beluga Lake Drainage.

Difference Between Flu and COVID-19

by symptoms alone because some of the symptoms are the same. Some PCR tests can differentiate between flu and COVID-19 at the same time. If one of these tests is not available, many **testing locations** provide flu and COVID-19 tests separately. Grant Award for Green Infrastructure Project

The City of Homer has been awarded a grant from the Alaska Department of Environmental Conservation's Alaska Clean Water Actions (ACWA) program to design and construct the Beluga Slough Green Infrastructure Project.

This project is one of the four green infrastructure storm water management projects introduced in early 2022. It will capture sediment and other contaminants from one of Homer's primary storm drain systems, before the water is discharged into Beluga Slough, which in turn flows into the waters of Kachemak Bay, a designated critical habitat area. The remediation will be accomplished through the use of green infrastructure strategies, including a sediment/pollutant collection device, bio-swales, and wetland vegetation.

The City has been collecting data related to water volumes to help with project scoping as well as design of the sediment/pollutant trap and swales. The City will collect water quality data before and after the green infrastructure installation to document treatment effectiveness. The grant agreement and request for matching funds will be presented to Council soon.


Budget Prep

Staff has been hard at work putting together draft numbers for the FY24/25 Operating and Capital Budgets. I have gone line by line through the General Fund, Utility Fund, and Enterprise Budgets with department heads and division managers.
