

DETERIORATING ROOF SYSTEM

- The condition of the roof has been a serious concern since 2007.
- Leaks occur over the elevator and in office spaces equipped with computers and electronics.
- With cracked beams, leaks throughout, and hazardous working conditions for staff, the Pratt Museum roof system must be replaced.



ROOF SYSTEM REPLACEMENT

A full roof system replacement is necessary, according to a thorough survey performed by Roof Construction Services, Inc. and Schneider Structural Engineers.

Roof Replacement consists of 9,143+/- square feet of roof removal and replacement with new insulation, new modified membrane roofing system and all related flashing and sheet metal work. • Complete removal of the granular surfaced modified built-up roof system, all insulations and underlying plywood, flashings, and trim metals.

 Installation of a new 3ply modified membrane roof system including new base sheet installed over a new 3/8-inch plywood substrate installed over the original tongue and groove wood roof deck.



 The project will also include new high thermal insulation, new perimeter edge metal detailing, new gutters and downspouts, and all associated accessories.

OUR ROOF SYSTEM REPLACEMENT PLAN

We respectfully request \$350,000, 26% of the total roof system replacement project cost of \$1,362,480.50. Without the support of the City of Homer, we are unable to secure major grants from charitable foundations and governmental appropriations.

Frequently Asked Questions

Why did the renovation in 2018 not include replacing the Roof System?

 The economic climate when the capital campaign began changed quickly and drastically during the fundraising process. As a result, government funding that had previously been expected fell through. The Homer Society of Natural History, Inc. board of directors and Pratt Museum team were then forced to adjust the original campaign and pivot to a two-phase renovation. Phase 1 occurred in 2018 and Phase 2, which included the roof system replacement, was put aside to be completed in the future.

What was the money from the original capital campaign spent on?

 The funds secured during the capital campaign were put to use completing Phase 1 of the renovation process, which included **critical updates** to the Museum's ADA Accessibility in the form of ramps and hydraulic lifts as well as **crucial restructuring** of the lower level of the Museum to include an expanded, climate-controlled space and cabinets for the collection.

Why is it so expensive to replace the roof?

- After carefully examining the roof and site, Roof Construction Services, Inc. and Schneider Structural Engineers determined a full Roof System Replacement is necessary at a cost of approximately \$1,362,480.50. The facility the Pratt Museum is housed in has 9,143 +/- square feet of roof to be considered. The Roof System Replacement Project consists of the following:
 - The complete removal of the granular surfaced modified built-up roof system, all insulations and underlying plywood, all flashing and trim metals.
 - The complete installation of a new 3-ply modified membrane roof system, which includes:
 - New base sheet installation installed over a new 3/8-inch plywood substrate over the original tongue & groove wood roof deck
 - New high thermal insulation
 - New perimeter edge metal detailing
 - New gutters, downspouts & all associated accessories
 - Allotment for an on-site Project Manager
 - Allotment for the cost of protecting and moving exhibits, cases, objects, workspaces, etc.

Dear Community of Homer,

The Board of Directors of the Pratt Museum requests your support for our roof system replacement project. The Pratt provides a gathering space for community members of all ages where art, science, and culture come together in the exploration of a wide range of topics and stories from traditional cultures to environmental concerns.

With support from the City of Homer, the Pratt Museum found a home in the community building constructed in 1967 as part of the state-wide centennial project celebrating the hundred-year anniversary of Alaska's purchase. Over the past fifty-seven years, the harsh Alaskan weather conditions have taken their toll on the building. The condition of the roof has been a concern since 2007, when the first of several comprehensive professional assessments (including infrared inspections) conducted by engineering firms clearly identified the need for the replacement of the deteriorating roof system.

While recent renovations focused on other critical upgrades including facility ADA compliance and collection stewardship, the replacement of the roof system, once again, was not addressed. To sustain the Museum's commitment to the community, the roof system replacement project can no longer be kicked down the road. Each gallery contains multiple water-collection buckets and at times water drips and splashes on the exhibits and display cases. Leaks also occur over the new elevator and in office spaces equipped with computers and electronics. The routine maintenance of the roof during the winter is a health and safety issue given that the roof needs to be hand-shoveled every time it snows. With cracked beams, leaks throughout, and hazardous work conditions for staff, the Pratt Museum roof must be replaced.

The Homer Society of Natural History, Inc. dba Pratt Museum needs your help. The Pratt Museum is a community museum. As such, we need the community to support this critical project. The estimated cost for the roof system replacement is \$1,362,481 (based on a full roof design and construction bid proposal originally prepared by Roof Consulting Services, Inc. in 2019 and updated in 2024).

A strategic plan for financing the roof replacement has been drafted. **Each level of the plan leverages support with the next solicitation.** In other words, the initial support from the City of Homer is the key to securing additional funds.

The following is a brief overview of the funding needed to be successful:

- 1. Capital Improvement Project Nomination with City of Homer for \$350,000
- 2. CAPSIS Request to the State of Alaska Legislature supported by Senator Gary Stevens for \$250,000

With cracked beams, leaks throughout, and hazardous work conditions for staff, the Pratt Museum roof needs to be replaced.





Health & Human Safety Issue

The basic care of the roof during the winter is a safety issue. The roof needs to be hand-shoveled by staff members. While no major injury has occurred, it is only a matter of time before someone will get injured.

Damaged Beams

Cracked beam-ends are held together with bindings and are one of the first things visitors observe at the main entrance to the Museum. Paint peels where water leaks through the porchroof and the flakes rain down onto the deck, pavement and occasionally visitors.



Water Dripping Throughout Galleries

Each gallery has multiple buckets and at times water splashes on the exhibits and display cases. Leaks also occur over the elevator which impacts use, and in office spaces where computers and technology are located.
