As a parent, grandparent, and great-grandparent I take exception with this decision. Issues regarding sexual education including sexual orientation and choices are matters between a parent and their child especially in their formative years.

Parents are given the responsibility of raising children. Serious and sensitive issues need to be presented by parents who have a grasp of the maturity and the understanding of the individual child.
