Chair Finn introduced the item by reading the title. She explained the reasons for potentially cancelling the December regular meeting including Library Director Berry being absent, the proximity to the holidays, and giving boardmembers enough time to read all the children and young adult materials in preparation for making a determination on the appeal at their January regular meeting. The items originally scheduled for the December and January meeting will be moved to the February agenda. She opened the floor for a motion or discussion.

FAIR/SPRINGER MOVED TO CANCEL THE LAB'S DECEMBER 20TH REGULAR MEETING.

There was no discussion.

There was discussion on whether another motion was needed to schedule a special meeting. The board mutually agreed to not hold a special meeting in December.

10.C. Appeal of Library Director's Decision Regarding Children and Young Adult Materials Agenda Item Report LAB 22-006

Chair Finn introduced the item by reading the title. She reviewed Section O of the library's Collection Development Policy which states a patron may appeal the Library Director's decision on a Request for Reconsideration of Library Materials to the Library Advisory Board, and read the overview of that section to clarify the intentions of reconsideration.

Chair Finn clarified the board's job is to be deliberate and focused as they take tonight's testimony and read and evaluate each book's appropriateness for the Children's Section of the Library. There are 54 books to be read so it is recommended both by herself and city staff that the board makes a motion to postpone their final decision to the January 17, 2023 regular meeting, and use this meeting to listen. She noted the board has heard from the Appellant during Public Comments, and their written statement is included in the packet on Page 25, and she will request the Library Director provide his comments in addition to his written recommendation that is in the packet.

Chair Finn recapped the purpose of this meeting is to listen and then during the next two months before the LAB's next meeting the board shall do the following:

- Read through the 54 books. Boardmembers will coordinate with Library Director Berry to check these books out since he'll be keeping them in his office during this time.
- While reading these materials, keep in mind the library's Collection Development Policy while evaluating each book.
- Come to the January 17th meeting prepared to discuss the question on whether to uphold or overturn the Library Director's decision. The board will have three options: Uphold the Director's decision in full, which leaves the materials where they are; Reverse the Director's decision in full, which means interfiling the items with the adult books; or Consider items on a title-by-title basis, moving some items and leaving others.

Chair Finn reminded everyone to refrain from discussing this matter outside of the meetings, remain bipartisan, and any questions regarding procedure can be directed to Deputy City Clerk Tussey. Ms. Tussey will continue forwarding all written testimony to the board and it will be included in the January meeting packet. She asked Library Director Berry to speak to his written recommendation, as per the appeal process, and then for a motion.

Library Director Berry thanked the board and public for staying late. He shared how he agrees with the petitioners, and specified which aspects he does not agree on.

FAIR/MCKINNEY MOVED TO POSTPONE A FINAL JUDGEMENT ON THE APPEAL OF LIBRARY DIRECTOR'S DECISION OF LIBRARY MATERIALS TO THE LAB'S JANUARY 17, 2023 REGULAR MEETING SO THE BOARD MAY HAVE TIME TO REVIEW THE MATERIALS.

Boardmember Kuszmaul asked what the process would be if in the situation the LAB is unable to make a decision at the January meeting. Ms. Tussey explained that at that time they would make another motion to postpone the agenda item to their February meeting.

Boardmember Springer inquired on the logistics of getting the books from the Library Director. Mr. Berry explained how the books would be checked out to boardmembers in batches, with him tracking which ones have been read/unread and sending out updates via email.

Boardmember Baily requested legal guidance on ensuring our policy is within legal rights. Ms. Tussey noted that the current policy has been approved by City Council and vetted through the City Attorney, so it is legal, and that she will verify it with the City Attorney after the meeting and notify the board.

VOTE: NON-OBJECTION: UNANIMOUS CONSENT.
