#### Written Testimony

Dear Library Advisory Board Members:

I am writing to reiterate my support for the manner in which the Homer Public Library staff has managed books relating to LGBTQ+ people and issues. I strongly oppose requiring the staff to move any books out of the children's section and support leaving such decisions in their capable hands.

The request to have those books moved is a statement of unfounded prejudice and to make that move would be a huge step backward in the marginalization of LGBTQ+ people. Our past has far too much hate, prejudice, and assault directed toward that group of people, and we do not want or need to move back in time.

For one group to dictate to the larger community how to segregate and discriminate against gay people is simply wrong. Though others may cling to some of the views of yesteryear, they have no right to impose those views on the rest of us.

The Library Advisory Board has chosen an evenhanded approach that leaves totally open the avenue for parents to make choices about their children's reading and exposure to books. No one is forced to use the books some parents don't want their children to see, and none of their rights are violated in the current situation.

Please stand up to prejudice and support the current library policies. If we take this step backward, that action will open the door to additional and even more extreme demands for marginalizing LGBTQ+ people.

#### Written Testimony

To the Library Advisory Board members,

Thank you for this opportunity to express my concern regarding the relocation of the targeted books from the children's section. I would like to reiterate my comments that I submitted electronically for the last meeting. As a long time patron of the Homer Public Library, I support the Library's policies regarding the procedures of placing books in the age appropriate locations. Presently, the library offers inclusive and free access to its patrons regarding the selection of the materials. Children's books are housed in the children's section of the library and in order to provide free access, that's where ALL the children's books should remain. The proposed request to remove or relocate particular books from the children's section would deny equal access. The library serves ALL members of the community, regardless of political affilations/religious beliefs. No one has the right to prevent other families from reading/reviewing books, which includes making it more difficult to access particular books.

When my child was younger, it was MY job to supervise her reading selection, her media exposure and her interactions with the world outside of our family home. I, as most parents, took that responsibility to heart, by being actively involved in reading choices and information access. I continue to maintain that it is up to the parents to oversee what their child is reading. It was our family's choice to raise our child in an inclusive environment and the children's library's diverse reading selection helped foster that.

Relocating the targeted books will be marginalizing a particular group of people, implying that they are "less than." Relocating these books is contrary to a democractic society where all members are equal. The proposal to relocate is a gateway to banning said books and many more! There are books in the library that are not aligned with my belief system. I simply choose not to read them.

Please support the Library Director's decision to keep the targeted books where they belong...as part of the overall children's reading selection. Our library needs to serve all patrons by providing free access to all materials. Thank you.
